WHEREAS, The increased cost and reduced flow of campaign communication on broadcast television and radio has created an unfair advantage for wealthy candidates and candidates with access to monied special interests, an unhealthy development for our democracy; and

WHEREAS, The broadcast airwaves belong to the people; and

WHEREAS, The people, through their federal government, have provided exclusive licenses to broadcasters to operate within assigned frequencies on these airwaves, but only on the condition that they serve the public interest; and

WHEREAS, This "public interest" standard must include providing opportunities for candidates to deliver, and citizens receive, a free and open flow of information just prior to elections so that citizens can cast informed votes; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support a proposal endorsed by the Free Air Time Coalition that calls on the federal government to require that all broadcasters provide increased coverage of campaigns and elections and a reasonable amount of free air time to candidates just prior to elections as a condition of receiving their broadcast licenses.

WHEREAS, Former Chicago White Sox star left fielder Orestes "Minnie" Minoso is one of the 25 players eligible for election in 2003; and

WHEREAS, Minnie Minoso is a true son of Chicago and has lived here most of his adult life; and

WHEREAS, Minnie Minoso spent 12 full seasons with the Chicago White Sox, over five separate stints that spanned four decades; and

WHEREAS, Minnie Minoso was the first great Cuban American baseball player; and

WHEREAS, Minnie Minoso is generally considered to be one of the top left fielders in baseball history; and

WHEREAS, Minnie Minoso broke the White Sox color barrier in his professional debut on May 1, 1951 at age 28; and

WHEREAS, Orestes "Minnie" Minoso was voted American League Rookie of the Year by The Sporting News in 1951; and

WHEREAS, Orestes "Minnie" Minoso hit over .300 six times, won three Gold Gloves, batted .300 in seven All-Star game appearances, regularly finished in the League top 10 in most offensive categories, and concluded his career with a .298 batting average, a .391 on base average, almost 2,000 hits, and over 1,000 runs batted in; and

WHEREAS, Minnie Minoso was the heart and soul of the "Go, Go White Sox" in the 1950s; and

WHEREAS, Minnie Minoso was widely known as "Mr. White Sox" and "the Cuban Comet"; and

WHEREAS, Orestes "Minnie" Minoso was named to the White Sox All-Century Team in 2000; and

WHEREAS, Even though he was not part of the pennant-winning 1959 White Sox team, he was given an honorary championship ring; and

WHEREAS, Minnie Minoso's "9" jersey was retired by the White Sox; and

WHEREAS, Orestes "Minnie" Minoso was elected to the Chicago Sports Hall of Fame, the World Baseball Hall of Fame, and to the White Sox All-Century Team; and

WHEREAS, In 1985, Coy Pugh became the Executive Director of the Westside Small Business Development Center (WSBDC), which was a member of the small business development center program designed by the State of Illinois' Department of Commerce and Community Affairs under the Build Illinois Act, put in place by then Governor James Thompson; WSBDC offered technical assistance to small business owners, entrepreneurs, and perspective business owners by designing, developing, and implementing seminars and workshops focusing on the needs of the small businessperson; and

WHEREAS, By 1989, the WSBDC joined forces and Coy Pugh became the Director of a coalition of 40 community based organizations known as Austin United, the project was funded by a large coalition of businesses known as Chicago United; and

WHEREAS, Coy Pugh was appointed to the House of Representatives in 1991; in 1992 after an intensely contested and bitter campaign, he won the Democratic nomination for State Representative in the 10th District with the community's overwhelming support; news of his improbable win spread throughout the country and was featured in national publications such as Ebony and the National Enquirer; and

WHEREAS, Mrs. Byrnes attended Indiana University from 1943 to 1945, where she worked part time at the RCA war plant and became a founder of the first student chapter of NAACP; and

WHEREAS, Mrs. Byrnes received her Divisional M.A. in Social Sciences from the University of Chicago; this was one of the broad spectrum degrees initiated by Robert Hutchins and included, Political

Science, Economics, Sociology, and Education; she worked part-time as secretary for Leo Szilard, the "Father of the Atomic Bomb"; and

WHEREAS, Mrs. Byrnes became active with the civil rights movement in 1964, and participated in marches until the culminating open housing march of 25,000 to City Hall in 1966; she was also a founding member of Breadbasket Teachers, a branch of Operations Breadbasket, the predecessor of Operation PUSH: and

WHEREAS, Mrs. Byrnes taught in the Chicago Public School District for 22 years, teaching primary grades, then educable mentally handicapped classes, and finally a resource room for children of all grades with learning disabilities; she was an active member of Chicago Teachers Union (CTU), serving as school delegate to the House of Delegates for 15 years and as a district supervisor in CTU's first strike; she also worked with the Concerned FTB's (full-time basis substitutes) to help them prove discrimination in the Board's process of examinations for teachers to become certified; this issue was resolved by the first strike, when the Teachers Action Caucus, of which Marian was a leader, prevailed on the CTU House of Delegates to make certification based on three years' satisfactory service a non-negotiable demand in the contract negotiations; and

WHEREAS, After retiring from the public schools in 1984, she worked for two years as an administrative assistant to the executive director of Protection and Advocacy, an agency which must exist in each state in order for the state to receive its federal funding for people with developmental disabilities and/or mental illness; and

WHEREAS, Mrs. Byrnes became a legislative aide to State Representative Clem Balanoff from 1988 to 1991; she was chief organizer for the 32nd District Environmental Task Force, which later became the Southeast Environmental Task Force; and

WHEREAS, After retiring from the State Representative's office, she increased her amount of volunteer work; she founded the committee to Protect the Prairie, saving the Van Vlissingen Prairie from development; she was one of the founders of Citizens United to Reclaim the Environment, working to save wetlands and prevent additional landfills in region; she was one of the originators of the 32nd District Environmental Task Force and its successor group, The Southeast Environmental Task Force, leading the fight which closed the malfunctioning Waste Management toxic incinerators, limited landfills, stopped the transport of, and disposal of, unused napalm in the area, monitored pollution, and established Good Neighbor Dialogues with industry; she helped to reclaim the Calumet area Cluster Sites, Hegewisch Marsh and numerous other local wetlands and openlands for cleanup and restoration; she was founder and co-chair of the Lake Calumet Vision Committee, which continues working to restore the ecological value of the lake and its surroundings and develop a feasible plan for the region; and she continues to work with the Calumet Sustainable Growth Advisory Committee, Chicago Recycling Coalition, Calumet Heritage Partnership, Lake Calumet Ecosystem Partnership and numerous other organizations to better the region; and
