HOUSE RESOLUTION 222

Offered by Representative Flider:

WHEREAS, The State has a number of unique climate types, all of which require energy for both cooling and heating; there are many cost-effective measures that can reduce peak energy use and reduce cooling, heating, and other energy costs in buildings; and

WHEREAS, Improvements in the energy efficiency of institutional buildings will provide long-term operating cost reductions and reduce the overall use of energy in Illinois; and

WHEREAS, Reducing the use of energy promotes the reduction of air pollution from power plants and green house emissions and saves important environmental resources; and

WHEREAS, The American Council for Energy-Efficient Economy projects that if steps are taken in the State to improve energy efficiency, it would reduce overall energy spending and generate a positive cost benefit ratio; and

WHEREAS, The Government Buildings Energy Cost Reduction Act of 1991 is intended to reduce energy consumption and costs by promoting energy conservation in government buildings, including public universities; the Act created an Interagency Energy Conservation Committee, consisting of the Secretary of Human Services, the Directors of Central Management Services and Corrections, the Executive Directors of the Illinois Board of Higher Education and the Capital Development Board, and chaired by the Department of Commerce and Economic Opportunity (formerly Commerce and Community Affairs); and

WHEREAS, The Interagency Energy Conservation Committee publishes an annual assessment of opportunities for energy cost reduction in state-owned and leased buildings and designated facilities, including public universities, and reports to the Governor and General Assembly every 2 years on the status of energy cost reduction in government buildings; and

WHEREAS, The Public University Energy Conservation Act authorizes public universities to enter into guaranteed energy savings contracts or energy performance contracts for preliminary analyses, recommendations of energy conservation measures, implementation of such measures, and monitoring by the contractor of savings; and

WHEREAS, The Department of Commerce and Economic Opportunity provides matching technical assistance grants that are designed to help local schools, colleges, and universities finance comprehensive studies to find opportunities for energy conservation and to implement those measures; the institution and DCEO share the cost equally; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Department of Commerce and Economic Opportunity is directed to assess energy conservation measures taken at each of the State's public universities since 1995, and report its findings to the General Assembly by January 1, 2004; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Director of Commerce and Economic Opportunity and the Executive Director of the Illinois Board of Higher Education.

HOUSE RESOLUTION 224

Offered by Representative Watson:

WHEREAS, Millions of men and women in the Armed Forces volunteer to serve our country, take an oath to defend the Constitution of the United States, and risk making the ultimate sacrifice to defend the freedoms enjoyed by their fellow Americans; and

WHEREAS, A large number of these soldiers live on modest financial means; and

WHEREAS, In 2002, during the 107th Congress, the United States Senate Finance Committee and then the full Senate passed a bill co-authored by U.S. Senator Chuck Grassley (R-Iowa) to improve tax equity for members of the military; and

WHEREAS, The bill underwent changes in the U.S. House of Representatives and never received approval before Congress adjourned for the year; and

WHEREAS, Congress is once again considering tax-equity legislation, and versions of the Armed Forces Tax Fairness Act of 2003 have been approved by both the U.S. House and U.S. Senate; and

WHEREAS, The Armed Forces Tax Fairness Act of 2003 would extend deadlines for filing tax returns or making tax payments for individuals who become involved in military actions, operations, or hostilities against an enemy of the United States; and

WHEREAS, If a member of the Armed Forces dies on active duty, the federal government pays the surviving spouse a death benefit of \$6,000 but only half of this benefit is now excluded from taxable income; and

WHEREAS, The Armed Forces Tax Fairness Act of 2003 would fully exempt death gratuity payments received by families of deceased members of the military from being included in taxable income; and

WHEREAS, Many National Guard members and reservists travel for weekend drills and spend their own money for travel and lodging; and

WHEREAS, These expenses are generally non-deductible for one of two reasons: either the reservist is part of the 75 percent of the population that does not itemize, or the expenses do not exceed two percent of

the reservist's adjusted gross income; and

WHEREAS, The Armed Forces Tax Fairness Act of 2003 would create a tax deduction of up to \$500 for unreimbursed travel expenses by reservists; and

WHEREAS, In 1997, Congress changed the tax code to exclude gains from the sale of a person's home from the capital gains tax, below certain thresholds, and thus, under present law, in order to qualify for an exclusion of capital gains on a home, uniformed service members must have owned and used a home as a principal residence for at least two of five years ending on the date of sale; and

WHEREAS, The Armed Forces Tax Fairness Act of 2003 would suspend this requirement; and

WHEREAS, The Armed Forces Tax Fairness Act of 2003 is especially important as the nation engages in military conflict abroad involving both enlisted members of the military and reservists; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the members of the Illinois House of Representatives respectfully request that the members of the United States House of Representatives and United States Senate work for consensus on the Armed Forces Tax Fairness Act of 2003; and be it further

RESOLVED, That a suitable copy of this resolution be presented to each member of the Illinois Congressional delegation, the Speaker of the United States House of Representatives, the Majority Leader of the United States Senate, and the President of the United States.

WHEREAS, The early indicators of infection are flu-like symptoms and/or an enlarged rash, which may not appear or may be missed, allowing the disease to disseminate and cause serious, permanent and sometimes life threatening damage to the brain, joints, heart, eyes, liver, spleen, blood vessels, and kidneys; and

WHEREAS. The bacterium can cross the placenta and infect a developing fetus; and

WHEREAS, Lyme Disease is difficult to diagnose because it imitates other conditions and there is no reliable test that can prove who is infected or who is bacteria free, which often leads to misdiagnosis; and

WHEREAS, Lyme Disease is most easily treated when diagnosed early and is more difficult to treat if discovered after dissemination occurs, making early detection and treatment more important; and

WHEREAS, The best solution to the threat of Lyme Disease is educating people about the seriousness, prevention, and early detection of all tick borne diseases as well as showing more compassion towards patients and their families; and

WHEREAS, People still need to practice personal protection techniques to prevent other tick transmitted diseases such as Ehrlichiosis, Babesiosis, Tulameria, Rocky Mountain Spotted Fever, Tick Paralysis, Colorado Tick Fever, and Relapsing Fever; and

WHEREAS, Lyme Disease victims, families and friends are demonstrating their support for a cure in the first National "Walk Against Lyme Disease" to be held on May 17, 2003 in New Lenox, Illinois; therefore, be it

The purpose of this Section is to ensure that consumers over the age of 60 residing in facilities licensed or regulated under the Nursing Home Care Act, Skilled Nursing and Intermediate Care Facilities Code, Sheltered Care Facilities Code, and the Illinois Veteran's Homes Code receive high quality long-term care through an effective Illinois Long-Term Care Council.
 - (b) Maintenance and operation of the Illinois Long-Term Care Council.
 - (1) The Department shall develop a fair and impartial process for recruiting and receiving nominations for members for the Illinois Long-Term Care Council from the State Long-Term Care Ombudsman, the area agencies on aging, regional ombudsman programs, provider agencies, and other public agencies, using a nomination form provided by the Department.
 - (2) The Department shall appoint members to the Illinois Long-Term Care Council in a timely manner.
 - (3) The Department shall consider and act in good faith regarding the Illinois Long-Term Care Council's annual report and its recommendations.
 - (4) The Director shall appoint to the Illinois Long-Term Care Council at least 18 but not more than 25 members.
- (c) Responsibilities of the State Long-Term Care Ombudsman, area agencies on aging, regional long-term care ombudsman programs, and provider agencies. The State Long-Term Care Ombudsman and each area agency on aging, regional long-term care ombudsman program, and provider agency shall solicit names and recommend members to the Department for appointment to the Illinois Long-Term Care Council.
 - (d) Powers and duties. The Illinois Long-Term Care Council shall do the following:
 - (1) Make recommendations and comment on issues pertaining to long-term care and the State Long-Term Care Ombudsman Program to the Department.

- (2) Advise the Department on matters pertaining to the quality of life and quality of care in the continuum of long-term care.
- (3) Evaluate, comment on reports regarding, and make recommendations on, the quality of life and quality of care in long-term care facilities and on the duties and responsibilities of the State Long-Term Care Ombudsman Program.
- (4) Prepare and circulate an annual report to the Governor, the General Assembly, and other interested parties concerning the duties and accomplishments of the Illinois Long-Term Care Council and all other related matters pertaining to long-term care and the protection of residents' rights.
 - (5) Provide an opportunity for public input at each scheduled meeting.
- (6) Make recommendations to the Director, upon his or her request, as to individuals who are capable of serving as the State Long-Term Care Ombudsman and who should make appropriate application for that position should it become vacant.
- (e) Composition and operation. The Illinois Long-Term Care Council shall be composed of at least 18 but not more than 25 members concerned about the quality of life in long-term care facilities and protecting the rights of residents, including members from long-term care facilities. The State Long-Term Care Ombudsman shall be a permanent member of the Long-Term Care Council. Members shall be appointed for a 4-year term with initial appointments staggered with 2-year, 3-year, and 4-year terms. A lottery will determine the terms of office for the members of the first term. Members may be reappointed to a term but no member may be reappointed to more than 2 consecutive terms. The Illinois Long-Term Care Council shall meet a minimum of 3 times per calendar year.
- (f) Member requirements. All members shall be individuals who have demonstrated concern about the quality of life in long-term care facilities. A minimum of 3 members must be current or former residents of long-term care facilities or the family member of a current or former resident of a long-term care facility. A minimum of 2 members shall represent current or former long term care facility resident councils or family councils. A minimum of 4 members shall be selected from recommendations by organizations whose members consist of long term care facilities. A representative of long-term care facility employees must also be included as a member. A minimum of 2 members shall be selected from recommendations of membership-based senior advocacy groups or consumer organizations that engage solely in legal representation on behalf of residents and immediate families. There shall be non-voting State agency members on the Long-Term Care Council from the following agencies: (i) the Department of Veterans Affairs; (ii) the Department of Human Services; (iii) the Department of Public Health; (iv) the Department on Aging; (v) the Department of Public Aid; (vi) the Illinois State Police Medicaid Fraud Control Unit; and (vii) others as appropriate.

Section 99. Effective date. This Act takes effect upon becoming law.".

The motion prevailed and the amendment was adopted and ordered printed.

There being no further amendments, the foregoing Amendment No. 5 was ordered engrossed; and the bill, as amended, was advanced to the order of Third Reading.

HOUSE BILL ON THIRD READING

The following bill and any amendments adopted thereto were printed and laid upon the Members' desks. This bill has been examined, any amendments thereto engrossed and any errors corrected. Any amendments pending were tabled pursuant to Rule 40(a).

On motion of Representative Osterman, HOUSE BILL 1240 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 115, Yeas; 0, Nays; 0, Answering Present. (ROLL CALL 2)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

By unanimous consent, on motion of Representative Phelps, SENATE BILL 257 was recalled from the order of Third Reading to the order of Second Reading and held on that order.
