HOUSE RESOLUTION 626

Offered by Representative Franks:

WHEREAS, A recent study by the Parents Television Council indicated a jump in profanity in virtually every network and every time slot, finding that foul language increased during the 8 to 9 p.m. "family hour" by 94.8% between 1998 and 2002 and during the 9 to 10 p.m. hour by 109% in the same period; and

WHEREAS, The Parents Television Council said the television industry needs to get serious about reducing the flood of vulgarity coming into homes via television; and

WHEREAS, According to Syracuse University Professor Robert Thompson:

Once prime-time television decides to absorb something, it becomes a stamp of normalcy. It's no longer controversial. It's no longer a big deal. It makes it a casual, accepted sort of thing; and

WHEREAS, According to P.M. Forni, cofounder of the Civility Project at Johns Hopkins University:

Very often, rudeness and cursing are the beginning of an escalation toward violence. Words,

our words, are like our hands. They can soothe and heal, but they can also strike, which means they can hurt;

therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Federal Communications Commission and major television networks to curb or eliminate the growing amount of profanity on television, especially during the "family hour"; and be it further

RESOLVED, That a copy of this resolution be transmitted to the Federal Communications Commission, to the major television networks, and to each member of the Illinois congressional delegation.

HOUSE RESOLUTION 627

Offered by Representative Franks:

WHEREAS, 138 years ago Brigham Young and more than 20,000 members of the Church of Jesus Christ of Latter-day Saints were expelled from the State of Illinois after the Illinois General Assembly withdrew its charter for the city of Nauvoo, Illinois in Hancock County in 1844; and

WHEREAS, During a period of seven years of Illinois history, from 1839 to 1846, Latter-day Saints built and developed the city of Nauvoo into the largest city in the State of Illinois and the tenth largest city in the nation; and

WHEREAS, The Church of Jesus Christ of Latter-day Saints was established by Joseph Smith in Fayette, New York on April 6, 1830; and

WHEREAS, The Mormon Prophet, Joseph Smith, led the community of Latter-day Saints from Fayette, New York to Kirtland, Ohio in 1831; and from Ohio to Independence, Missouri, in 1837; and

WHEREAS, Joseph Smith, a strong anti-slavery advocate, led his community of some 15,000 Latter-day Saints to the Mississippi River town of Nauvoo, in Illinois, following their expulsion from the slave State of Missouri in 1839; and

WHEREAS, Joseph Smith and the Latter-day Saints exercised enormous industry and effort in the development and growth of the town of Nauvoo, succeeding in creating a prosperous community in which they drained the local swamp lands and transformed them into productive agricultural and residential environments; and

WHEREAS, Joseph Smith and the Latter-day Saints were given an extraordinary charter for the powers of home-rule by the Illinois General Assembly to create and preside over their own court system and also to maintain their own military force, second in size only to the United States Army; and

WHEREAS, Joseph Smith and the community of Latter-day Saints exercised extensive missionary activities which drew new Mormon settlers to the city Nauvoo, reaching a population of some 20,000 citizens by 1844; and

WHEREAS, The prevailing economic conditions of the nation in general, and Illinois in particular, faced a downturn in the early 1840s, with the result that the rapidly growing population of Nauvoo faced drastic levels of unemployment without success in attracting needed industry; and

WHEREAS, During the period of their residency in Nauvoo, Joseph Smith and his community of Latter-day Saints began as political Democrats, transferring their political allegiance to the Whig Party in both the elections of 1838 and 1840, before once again transferring their affiliations back to the Democratic Party in the election of 1842, until the establishment of the Reform Party by Smith in time for the election of 1844, when he began to seriously campaign for the office of President of the United States; and

WHEREAS, The expression of political authority and power within the community of Latter-day Saints was seen by many citizens in Illinois as reasons for caution and concern, seeing the control of local courts by Joseph Smith as autocratic, and interpreting the leverage and influence of the Mormon community's voting strength as an over influential forceful and voting bloc; and

WHEREAS, Local religious customs among the Latter-day Saints began to be viewed with suspicion, bias and misunderstanding; and

WHEREAS, Following the destruction of a local anti-Mormon newspaper known as the Expositor, violence against the Latter-day Saint community increased; and

WHEREAS, The Governor of the State of Illinois, Thomas Ford, called out the Illinois Militia to keep order: and

WHEREAS, Governor Ford had the Prophet Joseph Smith and his brother, Hiram Smith, jailed, on suspicion of complicity in the destruction of the Expositor, in the nearby town jail of Carthage, Illinois; and

WHEREAS, A violent mob stormed the Carthage jail on June 27, 1844, causing the deaths of Joseph and Hiram Smith; and

WHEREAS, Between 1844 and 1845, violent acts against the community of Latter-day Saints increased in volume and intensity, demonstrated in such acts as the burning of crops, the destruction of homes and the threaten extermination of the entire Mormon population; and

WHEREAS, Faced with the extremism against the community of Latter-day Saints, Brigham Young, the new leader of the Nauvoo community made plans to take his people out of Illinois; and

WHEREAS, Beginning on February 4, 1846, Brigham Young began sending the community of Latter-day Saints out of their homeland of Nauvoo, Illinois across the frozen waters of the Mississippi

River, in the largest forced migration in American history; and

WHEREAS, Brigham Young made an exodus from the State of Illinois, leading tens of thousands of men, women and children, together with livestock and wagons that stretched across the expansive winter horizon for miles; and

WHEREAS, In this Mormon exodus, Brigham Young and the community of Latter-day Saints left behind their life in Illinois and the shining city that they had fashioned from both their faith and the hard work of their hands; and

WHEREAS, Brigham Young and the community of Latter-day Saints set off in the midst of winter for Utah, some 1300 miles to the west; and

WHEREAS, The severity of the winter placed on Brigham Young and the community of Latter-day Saints extreme hardships, trudging across the Iowa Plains to the far side of that state where they made a winter camp; and

WHEREAS, In the Spring of 1847, Brigham Young and the community of Latter-day Saints began again their journey to Utah, beyond the Rocky Mountain Range, to the valley of the Great Salt Lake; and

WHEREAS, On July 24, 1847, Brigham Young and the community of Latter-day Saints arrived in that valley following a trek of more than five months, journeying across the heart of the American continent, from the heartbreak of events in Nauvoo, Illinois to a place of far-western refuge; and

WHEREAS, Within 50 years of their arrival in the territory of Utah, the community of Latter-day Saint became the 45th state in the Union on January 4, 1896; and

WHEREAS, The community of Latter-day Saints grew from a population of 250,000 at the end of the 19th century to a population of more than 10 million people in our present day; and

WHEREAS, The goodness, patriotism, high moral conduct, and generosity of the community of Latter-day Saints has enriched the landscape of the United States and the world; and

WHEREAS, The biases and prejudices of a less enlightened age in the history of the State of Illinois caused untolled hardship and trauma for the community of Latter-day Saints by the distrust, violence, and inhospitable actions of a dark time in our past; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we acknowledge the disparity of those past actions and suspicions, regretting the expulsion of the community of Latter-day Saints, a people of faith and hard work; and be it further

RESOLVED, That we asks the pardon and forgiveness of the community of Latter-day Saints for the misguided efforts of our citizens, Chief Executive and the General Assembly in the expulsion of their Mormon ancestors from the gleaming city of Nauvoo and the State of Illinois.

HOUSE RESOLUTION 628

Offered by Representative Flowers:

WHEREAS, The Medicare Prescription Drug, Improvement and Modernization Act of 2003 was signed into law on December 8, 2003; and

WHEREAS, In 2001 the United States spent \$140.6 billion on prescription drugs, with Medicare spending \$2.4 billion on prescription drugs; and

WHEREAS, The high cost of prescription drugs places an extraordinarily heavy burden on elderly persons and persons with disabilities who live on fixed incomes; and

WHEREAS, It remains crucial for Congress and each of the state legislatures to respond to this health care crisis in a timely yet thoughtful manner; and

WHEREAS, The enacted federal Medicare Prescription Drug Bill does not adequately meet the needs of Illinois senior citizens and persons with disabilities; it offers less assistance than our current State prescription drug programs offer; and

WHEREAS, The enacted federal Medicare Prescription Drug Bill includes a complicated drug benefit and fails to lower drug prices; and

WHEREAS, The enacted federal Medicare Prescription Drug Bill will adversely affect elderly persons and persons with disabilities who currently receive prescription drug coverage and other benefits under the Illinois Medicaid Program; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call upon the United States Congress to amend the

federal Medicare Prescription Drug, Improvement and Modernization Act of 2003, and we further urge the United States Congress not to pass any measure that fails to do less for its senior citizens than does the current Illinois drug prescription program; and be it further

RESOLVED, That a copy of this resolution be sent to each member of the Illinois Congressional delegation.

HOUSE RESOLUTION 629

Offered by Representative Flowers:

WHEREAS, The Social Security Fairness Act of 2003 was introduced into the U.S. House of Representatives on February 5, 2003 as H.R. 594 and into the U.S. Senate on February 11, 2003 as S. 439; and

WHEREAS, The Social Security Fairness Act of 2003 amends title II of the Social Security Act to repeal the Government Pension Offset and the Windfall Elimination Provision; and

WHEREAS, The Government Pension Offset was enacted in 1977 and the Windfall Elimination Provision was enacted in 1983; and

WHEREAS, The majority of public employees affected by the Government Pension Offset lost their entire spousal benefit despite the fact that their spouses paid Social Security contributions for many years; and

WHEREAS, An affected public employee loses an average of \$3,000 per year because of the Government Pension Offset; and

WHEREAS, The Windfall Elimination Provision causes public employees to lose up to 60% of the benefits that they earned; and

WHEREAS, According to the Social Security Administration's actuaries, the long-term cost of eliminating both of these provisions is negligible while the loss of income to affected employees caused by these provisions forces some civil servants into poverty; and

WHEREAS, These provisions discriminate against teachers, police, firefighters, social workers, and other civil servants; and

WHEREAS, The State and national shortage of teachers, police officers, and firefighters is exacerbated by these provisions because they discourage people from entering and staying in these professions; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the U.S. Congress to pass the Social Security Fairness Act of 2003 or other legislation that eliminates both the Government Pension Offset and the Windfall Elimination Provision; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President pro tempore of the U.S. Senate, the Speaker of the U.S. House of Representatives, and each member of the Illinois Congressional delegation.

HOUSE RESOLUTION 632

Offered by Representative Granberg:

WHEREAS, On March 30, 1981, President Ronald Reagan was scheduled to speak to a labor conference at 1:45 p.m. at the Washington Hilton Hotel in Washington, D.C.; and

WHEREAS, John Hinckley, Jr. ventured to the Washington Hilton Hotel on March 30, 1981 with the goal of assassinating President Reagan; and

WHEREAS, At 1:30 p.m., Hinckley stepped forward from a crowd of television reporters and fired six shots from a Rohm R6-14 revolver at President Reagan; and

WHEREAS, The bullets from Hinckley's gun struck President Reagan in the left chest, Press Secretary James Brady in the left temple, Washington D.C. police officer Thomas Delahanty in the neck, and Secret Service agent Timothy J. McCarthy in the stomach; and

WHEREAS, Hinckley was immediately arrested, and after seven weeks of testimony and three days of jury deliberation, he was found to have carried out his assassination attempt while under psychotic delusion

and pronounced not guilty by reason of insanity; and

WHEREAS, Immediately after the verdict, Hinckley was committed to St. Elizabeth's Mental Hospital in Washington, D.C. where he underwent a psychiatric evaluation and was classified as a danger to himself, Jodie Foster, and any other third party whom he would consider incidental to his ultimate aims; and

WHEREAS, James "Jim" Brady was born in Centralia and is a former resident of Chicago; he is a graduate of the University of Illinois, where he earned a B.S. degree in communications and political science; and

WHEREAS, Jim suffered permanent brain damage from the gunshot wound inflicted by Hinckley, as his memory and speech are forever impaired; his left leg was left partially paralyzed and his left arm remains completely paralyzed; and

WHEREAS, On December 17, 2003, U.S. District Court Judge Paul L. Friedman ruled that Hinckley no longer poses a serious danger to himself or others and granted Hinckley permission to begin a series of six daytime and two overnight visits with his parents in the Washington, D.C. area; and

WHEREAS, Judge Friedman, who took the case following the 2001 death of Judge June Green, who consistently ruled against Hinckley, rejected the arguments of federal prosecutors, who said that Hinckley has a history of deception and that they believe he is concealing dangerous thoughts and remains a risk; and

WHEREAS, Judge Friedman's decision not only endangers the public and leaves many in outrage, but serves as an affront to Hinckley's victims and their families; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn Judge Paul L. Friedman for his December 17, 2003 ruling allowing attempted presidential assassin, John Hinckley, Jr., unsupervised daytime and overnight visits with his parents; and be it further

RESOLVED, That a copy of this resolution be presented to Judge Paul L. Friedman.

HOUSE RESOLUTION 635

Offered by Representative Soto:

WHEREAS, Pregnancy rates among Hispanic teenagers are alarming; and

WHEREAS, The General Assembly should take action to find appropriate and effective solutions for this problem; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the House Task Force on Hispanic Teen Pregnancy is created to study the rate of pregnancy among Hispanic teenage girls; and be it further

RESOLVED, That the Task Force shall consist of: 3 Representatives and 3 public members appointed by the Speaker of the House of Representatives; and 3 Representatives and 3 public members appointed by the Minority Leader of the House of Representatives; and be it further

RESOLVED, That the public members of the task force shall represent the Hispanic community and providers of health care and other services to teenagers; and be it further

RESOLVED, That the task force shall submit a report of its findings and recommendations, including recommendations for legislation, to the House of Representatives no later than December 31, 2004.

HOUSE RESOLUTION 643

WHEREAS, Give Kids A Smile is a national campaign, sponsored by the American Dental Association, to deliver free oral health education, screening, and treatment services to children who would not otherwise receive dental care; and

HOUSE JOINT RESOLUTIONS CONSTITUTIONAL AMENDMENTS FIRST READING

Representative Cross introduced the following:

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 28

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article V of the Illinois Constitution by changing Sections 1, 3, 7, and 18 and by repealing Section 17 as follows:

ARTICLE V THE EXECUTIVE

SECTION 1. OFFICERS

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller and Treasurer elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office.

(Source: Illinois Constitution.) SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller or Treasurer, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election.

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, Comptroller or Treasurer fails to qualify or if the his office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if the his office becomes vacant, it shall remain vacant until the end of the term.

SECTION 17. COMPTROLLER - DUTIES (REPEALED)

The Comptroller, in accordance with law, shall maintain the State's central fiscal accounts, and order payments into and out of the funds held by the Treasurer.

SECTION 18. TREASURER - DUTIES

The Treasurer, in accordance with law, shall (i) maintain the State's central fiscal accounts, and order payments into and out of the funds held by him or her, (ii) be responsible for the safekeeping and investment of monies and securities deposited with him or her, and for their disbursement upon his or her order, and (iii) have the duties and powers that may be prescribed by law of the Comptroller.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7

of the Illinois Constitutional Amendment Act. This Constitutional Amendment applies upon the conclusion of the terms of the Comptroller and the Treasurer elected in 2002.

The foregoing HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 28 was taken up, read in full a first time, ordered printed and placed in the Committee on Rules.

Representative Cross introduced the following:

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 29

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article V of the Illinois Constitution by changing Sections 1, 2, 3, 6, and 7 and by repealing Sections 4 and 14 as follows:

ARTICLE V THE EXECUTIVE

SECTION 1. OFFICERS

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller and Treasurer elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office.

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, except in the case of the Lieutenant Governor, until their successors are qualified. They shall be elected at the general election in 1978 and every four years thereafter.

(Source: Illinois Constitution.) SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, Comptroller or Treasurer, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his election.

SECTION 4. JOINT ELECTION (REPEALED)

In the general election for Governor and Lieutenant Governor, one vote shall be cast jointly for the candidates nominated by the same political party or petition. The General Assembly may provide by law for the joint nomination of candidates for Governor and Lieutenant Governor.

SECTION 6. GUBERNATORIAL SUCCESSION

- (a) In the event of a vacancy, the order of succession to the office of Governor or to the position of Acting Governor shall be the Lieutenant Governor, the elected Attorney General, the elected Secretary of State, and then as provided by law.
- (b) If the Governor is unable to serve because of death, conviction on impeachment, failure to qualify, resignation or other disability, the office of Governor shall be filled by the officer next in line of succession for the remainder of the term or until the disability is removed.
- (c) Whenever the Governor determines that he may be seriously impeded in the exercise of his powers, he shall so notify the Secretary of State and the officer next in line of succession. The latter shall thereafter become Acting Governor with the duties and powers of Governor. When the Governor is prepared to resume office, he shall do so by notifying the Secretary of State and the Acting Governor.
- (d) The General Assembly by law shall specify by whom and by what procedures the ability of the Governor to serve or to resume office may be questioned and determined. The Supreme Court shall have original and exclusive jurisdiction to review such a law and any such determination and, in the absence of such a law, shall make the determination under such rules as it may adopt.

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, Comptroller or Treasurer fails to qualify or if his office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if his office becomes vacant, it shall remain vacant until the end of the term.

SECTION 14. LIEUTENANT GOVERNOR - DUTIES (REPEALED)

The Lieutenant Governor shall perform the duties and exercise the powers in the Executive Branch that may be delegated to him by the Governor and that may be prescribed by law.

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act and applies upon the conclusion of the term of office of the Lieutenant Governor elected in 2002.

WHEREAS, The members of the House of Representatives of the State of Illinois learned with regret of the death of Dr. Jacob Hudson Carruthers, Jr., of Chicago on Sunday, January 4, 2004; and

WHEREAS, Jacob Hudson Carruthers, Jr., was born February 15, 1930, in Dallas; he excelled academically; following graduation from Phillis Wheatley High School in Houston, Texas, he attended Samuel Houston College in Austin, Texas, where he earned a bachelor's degree; after the Sweatt vs. Painter United States Supreme Court decision in 1950, he along with Heman Marion Sweatt and three other African Americans integrated the University of Texas Law School; jurisprudence, however, was not his calling, and he did not return the following year; in 1951, facing the draft and the Korean War, he volunteered for the United States Air Force; after serving in the Air Force, he enrolled in Texas Southern University where he earned a master's degree in government; and

WHEREAS, His passion for learning and a sense of service led him back to the classroom; from 1961 to 1964, Dr. Carruthers taught at Prairie View College in Texas; after being the first African American to earn a doctorate in political science from the University of Colorado at Boulder, he taught at Kansas State College in Pittsburg, Kansas, for two years; thereafter, his career led him to Chicago, and in 1968, he joined the faculty of the Department of Inner City Studies Education at the Center of Inner City Studies of Northeastern Illinois University, where he taught for 32 years; and

WHEREAS, Dr. Carruthers' leadership pioneered the development of both undergraduate and graduate degrees in Inner City Studies, which influenced the development of hundreds of students who sought careers working in the urban environment of the inner city; he contributed to the development of the Inner City Studies academic discipline in the United States, and he fostered the Chicago School of African Centered Thought that manifested itself in the community based Communiversity; and

WHEREAS, Serving as a consultant on African centered education to the Chicago Public Schools and other school systems throughout the United States, Dr. Carruthers was influential in the African centered education movement; he was a cofounder of the teacher training program, Teaching About Africa; he was also sought after nationally and internationally as a lecturer on African history; and

WHEREAS, Dr. Carruthers established himself through his work with leading African and African-American scholars in the world through his leadership in the development of a plan to rewrite African history under the aegis of the African World History Project of the Association for the Study of Classical African Civilizations (ASCAC); he was a founding member of the Kemetic Institute and ASCAC; and

WHEREAS, Dr. Carruthers authored several important books that paved the way and provided the framework for the African centered approach to the research and study of Classical African history and African civilization; his works include: Intellectual Warfare (1999), Mdw Ntr (1995), Essays in Ancient Egyptian Studies (1984), and The Irritated Genie (1985); other significant works include Science and Oppression (1972) and African or American (1994); he coedited Reconstructing Kemetic Culture (1990), The African Worldview (1986), and The Preliminary Challenge (1997); many of his works challenged the prevailing ideas in the field of Egyptology as well as the role of African people in the development of civilization in the ancient Nile Valley; and

WHEREAS, In 1981, Dr. Carruthers became the High Priest of the Temple of the African Community of Chicago that was established to meet the spiritual needs of those who sought to practice ancient Nile Valley spirituality; in 1995, Dr. Carruthers was initiated into elderhood in a community ritual at which time he took the name Jedi Shemsu Jehewty (the one who speaks is a follower of Jehewty); and

WHEREAS, The passing of Dr. Jacob Hudson Carruthers, Jr., has been deeply felt by many, especially his wife, Linda (Ifé); his sons, Jacob III, Darnell, and Christopher; his daughter, Tawakalitu Jogunosimi; his niece, Margaret Lee (Georges), who he considered a daughter; his grandchildren, Jacqueline and Jacob IV; his great-grandchildren, Lynon and Makala; his sister, Carol Lee (Charles); his brothers, Riley and Andrew (Willie); and his many nieces, nephews, and cousins; therefore, be it

HOUSE BILLS ON SECOND READING

HOUSE BILL 378. Having been printed, was taken up and read by title a second time.

The following amendment was offered in the Committee on Personnel & Pensions, adopted and printed:

AMENDMENT NO. ___1__. Amend House Bill 378 by replacing everything after the enacting clause with the following:

"Section 5. The Illinois Pension Code is amended by changing Section 6-210.1 as follows:

(40 ILCS 5/6-210.1) (from Ch. 108 1/2, par. 6-210.1)

Sec. 6-210.1. Credit for former employment with the fire department.

(a) Any fireman who (1) accumulated service credit in the Article 8 fund for service as an employee of

the Chicago Fire Department and (2) has terminated that Article 8 service credit and received a refund of contributions therefor, may establish service credit in this Fund for all or any part of that period of service under the Article 8 fund by making written application to the Board by January 1, 2005 2000 and paying to this Fund (i) employee contributions based upon the actual salary received and the rates in effect for members of this Fund at the time of such service, plus (ii) interest thereon calculated as follows:

- (1) For applications received by the Board before July 14, 1995, interest shall be calculated on the amount of employee contributions determined under item (i) above, at the rate of 4% per annum, compounded annually, from the date of termination of such service to the date of payment.
- (2) For applications received by the Board on or after July 14, 1995, interest shall be calculated on the amount of employee contributions determined under item (i) above, at the rate of 4% per annum, compounded annually, from the first date of the period for which credit is being established under this subsection (a) to the date of payment.

A fireman who (1) retired on or after January 16, 2004 and on or before the effective date of this amendatory Act of the 93rd General Assembly and (2) files an application to establish service credit under this subsection (a) before January 1, 2005, shall have his or her pension recalculated prospectively to include the service credit established under this subsection (a).

- (b) A fireman who, at any time during the period 1970 through 1983, was an employee of the Chicago Fire Department but did not participate in any pension fund subject to this Code with respect to that employment may establish service credit in this Fund for all or any part of that employment by making written application to the Board by January 1, 2005 and paying to this Fund (i) employee contributions based upon the actual salary received and the rates in effect for members of this Fund at the time of that employment, plus (ii) interest thereon calculated at the rate of 4% per annum, compounded annually, from the first date of the employment for which credit is being established under this subsection (b) to the date of payment.
- (c) A fireman may pay the contributions required for service credit under this Section established on or after July 14, 1995 in the form of payroll deductions, in accordance with such procedures and limitations as may be established by Board rule and any applicable rules or ordinances of the employer.
- (d) Employer contributions shall be transferred as provided in Sections 6-210.2 and 8-172.1. The employer shall not be responsible for making any additional employer contributions for any credit established under this Section.

Section 90. The State Mandates Act is amended by adding Section 8.28 as follows:

(30 ILCS 805/8.28 new)

Sec. 8.28. Exempt mandate. Notwithstanding Sections 6 and 8 of this Act, no reimbursement by the State is required for the implementation of any mandate created by this amendatory Act of the 93rd General Assembly.

Section 99. Effective date. This Act takes effect upon becoming law.".
