WHEREAS, The State of Illinois is facing a budget crisis; and

WHEREAS, New ways to generate revenue for the State and ways to reduce State spending should be explored as a means to deal with this crisis; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that each State agency is urged to discourage the use of directory assistance, out-of-state phone calls, and personal use of employee phones in order to reduce State spending; and be it further

RESOLVED, That a copy of this resolution be transmitted to each State agency.

#### HOUSE RESOLUTION 670

Offered by Representative Bill Mitchell:

WHEREAS, Economic development is a major function of state and local governments nationwide; and

WHEREAS, Job growth and quality of life enhancements are two major objectives of state and local economic development policy; and

WHEREAS, Given the economic and demographic diversity of Illinois, economic development policy may best be crafted at the local and regional levels where local government, labor, and business leaders are most aware of the economic strengths and weaknesses of their own communities and counties; and

WHEREAS, Many Illinois communities and regions depend upon the economic development expertise and capacity of the State for their own business and workforce development needs; and

WHEREAS, When developing statewide economic development policy and objectives, the State should contact local and regional economic leaders to ascertain the business and workforce development needs and objectives of Illinois communities and counties; and

WHEREAS, In conjunction with a renewed initiative to assist the diverse regions and communities in Illinois with economic development strategic planning, the State is entering an opportune time to systematically maintain contact with local and regional economic leaders in order to gauge their workforce and business development concerns and the effectiveness of State policy in support of local economic development policy; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we encourage the Governor and the Department of Commerce and Economic Opportunity to develop a program of systematic contact with local and regional economic development stakeholders and policy makers with the purpose of gauging the effectiveness of State business and workforce development policy at the local and regional levels and with the purpose of



crafting new development policies and objectives that best meet the needs and strategies of local and regional economic leaders; and be it further

RESOLVED, That the Department of Commerce and Economic Opportunity report to the chairmen and spokespersons of the House Commerce and Business Development Committee and the House Labor Committee concerning (i) the Department's current efforts to make systematic contact with local and regional economic stakeholders and policy makers concerning economic development and (ii) the scope of those efforts; and be it further

RESOLVED, That a copy of this resolution be presented to the Director of Commerce and Economic Opportunity.

#### HOUSE RESOLUTION 671

Offered by Representative Meyer:

WHEREAS, the Department of Commerce and Economic Opportunity (DCEO) is the lead State agency for economic development in Illinois; and

WHEREAS, in that capacity, DCEO expended over \$800 million in Fiscal Year 2002 appropriations for community and business development, technology and industrial competitiveness, tourism, coal development and marketing, and Illinois First; and

WHEREAS, Executive Order Number 11 (2003) transferred responsibility for administering the federal Workforce Investment Act of 1998, Title I, the federal Illinois Trade Adjustment Assistance Program, and the federal and State funded Welfare to Work program from the Department of Employment Security to DCEO; and

WHEREAS, Executive Order Number 11 (2003) also vested in DCEO certain duties of the Illinois Community College Board and the Prairie State 2000 Authority and abolished the latter agency; and

WHEREAS, efficient and effective management of the State's economic development programs is critical to the fiscal soundness of the State, local communities, business, and Illinois workers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a management and program audit of the Department of Commerce and Economic Opportunity's administration of its economic development programs; and be it further

RESOLVED, That the audit include, but need not be limited to, the following determinations: (i) whether DCEO's economic development programs are operated in conformity with applicable federal and State requirements; (ii) whether DCEO has established and implemented procedures to periodically review both the efficiency and effectiveness of its economic development programs; (iii) whether DCEO has in place appropriate monitoring and reporting procedures to ensure that it receives timely and accurate information from its grant and loan recipients; (iv) whether DCEO's reported performance measures are periodically reviewed and adequately supported by underlying documentation; and (v) whether DCEO's performance measures indicate that its economic development programs are effective in accomplishing their stated purposes; and be it further

RESOLVED, That the Department of Commerce and Economic Opportunity and its predecessor agencies, recipients of State funds, and any other entity or person that may have information relevant to this audit cooperate fully and promptly with the Auditor General's Office in the conduct of this audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and distribute the report upon completion in accordance with Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That a copy of this resolution be delivered to the Auditor General and to the Director of Commerce and Economic Opportunity.

#### HOUSE RESOLUTION 674

Offered by Representative Krause:

WHEREAS, A study cited by the U.S. Senate Special Committee on Aging indicates that 60% of

individuals who reach the age of 65 will eventually face the need for long term care; and

WHEREAS, A one-year stay in a nursing home can cost anywhere from \$35,000 to \$100,000 and the average length of a stay is about 2.5 years; and

WHEREAS, Medicaid, the federal-state partnership, now pays most nursing home costs for people with limited incomes and assets; and

WHEREAS, In an effort to increase the number of individuals purchasing long term care insurance, the State of Illinois enacted the Long Term Care Partnership Act to provide for asset protection for individuals who purchase private long term care insurance; and

WHEREAS, The purpose of long term care partnership programs is to provide incentives to individuals to purchase long term care insurance and, consequently, to relieve the financial burdens on the State when the State assumes payment for the long term care needs of citizens under the Medicaid program by allowing individuals who exhaust private qualified private long term care policy benefits to protect an equivalent value of assets and still satisfy Medicaid's financial eligibility requirements; and

WHEREAS, The Illinois Long Term Care Partnership Act is similar to programs currently operational in California, Connecticut, Indiana, and New York, but due to federal provisions contained in what is commonly referred to as the "Waxman Amendment" to the Omnibus Budget Reconciliation Act of 1993, the asset protections in Illinois do not extend to the estate of an individual; and

WHEREAS, The "Waxman Amendment" provisions contained in Section 1396p of the Social Security Act (42 U.S.C. 1396p(b)(1)(C)) have effectively removed the major incentive for individuals to participate in the Long Term Care Partnership program in Illinois; and

WHEREAS, The states that have had fully operational partnership plans for almost a decade have experienced significant savings to taxpayers because, out of 66,000 policies in force, only 28 policyholders to date have exhausted their long term care insurance benefits and accessed benefits under the Medicaid program; and

WHEREAS, Legislation is pending in the 108th Congress, in the form of H.R. 1406, that would allow the asset protections currently in place for the Long Term Care Partnership Programs operating in California, Connecticut, Indiana, and New York to be extended to programs in other states; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that that we support and urge efforts by the United States Congress to repeal provisions contained in the Omnibus Budget Reconciliation Act of 1993 that limit the ability of states to operate effective Long Term Care Partnership programs; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to each member of the Illinois Congressional delegation, the Speaker of the United States House of Representatives, and the Majority Leader of the United States Senate.

#### HOUSE RESOLUTION 676

Offered by Representative Franks:

WHEREAS, It is crucial that adults join together to empower young people with the confidence, strength of purpose, and vision needed to succeed in the workplace, and to negotiate the pitfalls that often stand in the way of success; Take Our Children to Work Day encourages cooperation not only from children and their parents, but also employers and schools, and it provides businesses and government with the opportunity to collaborate with schools to develop a strong work force for the State; and

WHEREAS, Such a day reinforces the importance of staying in school and introduces children to career possibilities; the exceptional hands-on experience that children receive from such an event will allow youth to envision a future with limitless possibilities; and

WHEREAS, Children are the future of the State of Illinois, the United States of America, and the world; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that as a valuable tool for the strengthening of society, we encourage parents to celebrate Take Our Children to Work Day by taking their children to work on a day that school is not in session.

#### HOUSE JOINT RESOLUTION 61

Offered by Representative Eddy:

WHEREAS, The State's objective is to establish an efficient system of high quality public educational institutions and services at the elementary and secondary school levels; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created the School Code Review Committee consisting of one member of the House appointed by the Speaker of the House, one member of the House appointed by the Minority Leader of the House, one member of the Senate appointed by the President of the Senate, one member of the Senate appointed by the Minority Leader of the Senate, and one member appointed by the Governor, all of whom shall be appointed within 30 days after adoption of this resolution and shall serve without compensation but shall be reimbursed for their reasonable and necessary expenses from funds available for that purpose; and be it further

RESOLVED, That the committee may meet at the call of the Governor or by a vote of the majority of the members at any time after the appointment of a majority of the members, shall select 2 members as co-chairpersons, who must be from different political parties, at its initial meeting, shall receive the assistance of the State Board of Education, including the provision of staff, subject to appropriation, shall undertake a comprehensive and thorough review of every Article of the School Code and related laws, rules, and regulations impacting Illinois K-12 schools with the intent of eliminating unnecessary and burdensome mandates on school districts, increasing accountability and efficiency in schools, returning control of school districts to locally elected school officials, teachers, administrators, and parents, and improving the educational performance of students, shall solicit testimony from impacted groups, including but not limited to teachers, school administrators, parents, and members of the business community, and shall issue a report detailing specific recommended changes to the School Code to the General Assembly and the Governor on or before April 1, 2006; and that upon issuing its report the committee is dissolved; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Governor.

#### HOUSE JOINT RESOLUTION 63

Offered by Representative Stephens:

WHEREAS, The State of Illinois is facing a budget crisis; and

WHEREAS, New ways to generate revenue for the State should be explored as a means to deal with this crisis; and

WHEREAS, The Governor's office has looked into the possibility of advertising on State-owned property, including the name badges and informational pamphlets produced by the State, as a way to generate additional revenue for the State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that an Illinois State Advertising Task Force be created to thoroughly explore the potential State revenue that could be derived from advertising on State property, explore the best means for selling permanent naming and sponsorship rights, and explore the best means to lease temporary naming and sponsorship rights for fixed periods; and be it further

RESOLVED, That the Task Force shall be composed of a representative of the Governor's office, a representative of the Speaker of the House, a representative of the President of the Senate, a representative of the Minority Leader of the House, a representative of the Minority Leader of the Senate, the Director of Central Management Services, the Secretary of Transportation, and a representative of the Illinois advertising industry to be chosen by the Governor; and be it further

RESOLVED, That the Illinois State Advertising Task Force shall compile a report and shall submit their report and findings to the General Assembly no later than January 1, 2005; and be it further

RESOLVED, That a copy of this resolution be sent to the Office of the Governor, the Director of Central Management Services, and the Secretary of Transportation.

HOUSE JOINT RESOLUTION 64

Offered by Representative Steve Davis:

WHEREAS, Manufacturing jobs, which build and sustain America's middle class, are disappearing; the United States has lost more than 2 million manufacturing jobs since April 1998; and

WHEREAS, Trade agreements, such as GATT, creating the WTO, and NAFTA, were passed with strong bipartisan support, amidst promises from the leadership of both parties that the benefits would far outweigh the negative effects; and

WHEREAS, Studies based on the government's own figures have estimated 3 million actual and potential jobs lost since the signing of the NAFTA in 1994; in Illinois, an estimated 140,900 manufacturing jobs were lost between July 2000 and June 2003, a decline of 16.2%, or one out of every six manufacturing jobs was lost in Illinois; and

WHEREAS, The annual trade deficit has hit a record high of over \$450 billion, growing by more than 600 percent in the past 10 years; and

WHEREAS, Our trade deficit with Canada and Mexico has ballooned to nine times its size before NAFTA; since Congress granted China Permanent Normal Trade (PNTR) status in 2000, the U.S. deficit with China has grown more than 20%, by more than \$14 billion; and

WHEREAS, The current administration is working on a new trade deal, Free Trade Area of the Americas (FTAA), which is expected to be presented to the U.S. Congress in 2005; and

WHEREAS, The tremendous effects of the manufacturing crisis in Illinois are obvious, on the tax base and budgets, on our local, county, and State governments, schools, and public services; and

WHEREAS, It is incumbent upon the Illinois General Assembly to not only do everything it can to save and attract manufacturing jobs in our State, but legislators must also seriously examine the effects of U.S. trade policy on our State and determine our recommendations to our respective party leadership in Congress; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we will convene a study committee to investigate and hold public hearings about the effects of U.S. trade policy on Illinois jobs and farms; the study committee shall consist of the following: two members of the House of Representatives appointed by the Speaker of the House of Representatives, one of whom shall serve as co-chairman; two members of the House of Representatives appointed by the Minority Leader of the House of Representatives; two members of the Senate appointed by the President of the Senate, one of whom shall serve as co-chairman; two members of the Senate appointed by the Minority Leader of the Senate; six individuals appointed by the Governor from unions representing manufacturing workers in the State, which will include representatives from the United Steelworkers of America; six individuals appointed by the Governor from manufacturing companies in the State; two individuals appointed by the Governor from the Illinois AFL-CIO Executive Board; and two individuals appointed by the Governor from the Illinois Chamber of Commerce; and be it further

RESOLVED, That the study committee shall meet at least four times while the General Assembly is in recess, inviting workers, labor unions, employers, academics, and farm and trade experts to testify; the panel shall make recommendations to the Governor and to the U.S. Congressional delegation and the President as to the future direction on trade agreements and what must be done immediately to reverse the continual loss of middle class jobs in our State; and be it further

RESOLVED, That the members of the study committee shall receive no compensation for their services but shall be reimbursed for their necessary expenses incurred while serving as study committee members.

**HOUSE JOINT RESOLUTION  
CONSTITUTIONAL AMENDMENT 32**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article VIII of the Illinois Constitution by changing Section 2 as follows:

ARTICLE VIII  
FINANCE

SECTION 2. STATE FINANCE

(a) The Governor shall prepare and submit to the General Assembly, at a time prescribed by law, a State budget for the ensuing fiscal year. The budget shall set forth the estimated balance of funds available for appropriation at the beginning of the fiscal year, the estimated receipts, and a plan for expenditures and obligations during the fiscal year of every department, authority, public corporation and quasi-public corporation of the State, every State college and university, and every other public agency created by the State, but not of units of local government or school districts. The budget shall also set forth the indebtedness and contingent liabilities of the State and such other information as may be required by law. Proposed expenditures shall not exceed funds estimated to be available for the fiscal year as shown in the budget.

(b) The General Assembly by law shall make appropriations for all expenditures of public funds by the State. Appropriations for a fiscal year shall not exceed funds estimated by the General Assembly to be available during that year.

(c) The total aggregate appropriations for each fiscal year shall not exceed the previous fiscal year's total aggregate appropriations by the greater of 4% of the previous fiscal year's total aggregate appropriations or a percentage representing the sum of the percentage rate of inflation and the percentage rate of the State's population growth since the previous fiscal year. State revenues in excess of a fiscal year's total aggregate appropriations as calculated under this subsection shall be deposited into a rainy day fund within the State treasury established and to be used for purposes provided by law.

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 8.1 to Article IV of the Illinois Constitution as follows:

ARTICLE IV  
THE LEGISLATURE

SECTION 8.1. PASSAGE OF REVENUE BILLS.

(a) A bill that would result in the increase of revenue to the State may become law only with the concurrence of three-fifths of the members elected to each house of the General Assembly.

(b) A house of the General Assembly may not pass a bill that would result in the increase of revenue to the State until:

(1) at least 30 calendar days have elapsed (i) after the introduction of the bill in that house or (ii) after an amendment to the bill has been adopted in that house, whichever is later; and

(2) that house has held at least 2 public hearings on the bill prior to passage by that house. Notice of each hearing must be given to the public at least 6 days before the date of the hearing. At least one of the

hearings held by each house must be held outside the corporate limits of:

(A) the capital city of the State; and

(B) the largest city in Illinois by population as measured by the federal decennial census.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

**HOUSE JOINT RESOLUTION

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 8.5 to Article IV of the Illinois Constitution as follows:

ARTICLE IV  
THE LEGISLATURE

SECTION 8.5. REVENUE BILLS; SUNSET

(a) A bill that contains one or more provisions that would result in the increase of revenue to the State may become law only if each of those provisions is explicitly limited in effect to no more than 5 years after the effective date of the bill.

(b) A sunset date established under subsection (a) may be extended by the General Assembly by law for up to an additional 5 years in each of up to 3 separate bills. If the General Assembly extends the sunset date of a provision 3 additional times, the General Assembly by law may thereafter remove the sunset date as to that provision.

(c) A bill that fails to comply with this Section is void.

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 11 to Article IX of the Illinois Constitution as follows:

ARTICLE IX  
REVENUE

SECTION 11. HIGHWAY FUNDS

(a) No moneys derived from fees, excises, or license taxes relating to registration, titles, operation, or use of vehicles on public highways or relating to fuels used for propelling those vehicles, including bond proceeds, shall be expended for other than (i) costs of administering those laws; (ii) statutory refunds and adjustments provided in those laws; (iii) payment of highway obligations; (iv) costs for construction,

reconstruction, maintenance, repair, and betterment of public highways, roads, streets, and bridges and other statutory highway purposes; (v) the State or local share to match federal aid highway funds; (vi) administrative costs of the Department of Transportation or any successor agency; (vii) expenses of grade separation of public highways and railroad crossings; (viii) protection of at-grade public highways and railroad crossings; (ix) expense of State enforcement of traffic laws; and (x) with respect to local governments, other transportation purposes as authorized by law.

(b) The total amount appropriated in any fiscal year for the sum of the cost of State enforcement of traffic laws plus the cost of collecting and administering fees, excises, and license taxes described in subsection (a) plus the cost of administering laws relating to motor vehicles shall not exceed 2% of the total amount of those fees, excises, and taxes collected by the State of Illinois in the most recent complete fiscal year.

(c) Federal funds may be spent for any purposes authorized by federal law.

#### SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.
