WHEREAS, The members of the House of Representatives of the State of Illinois were saddened to learn of the death of Emmett V. McNamara Sr. of Villa Park on Wednesday, March 3, 2004; and

WHEREAS, Mr. McNamara was born in 1926 in Villa Park; he attended York High School in Elmhurst; he married Jeanne McNamara in 1964; and

WHEREAS, Mr. McNamara was a great patriot and defended his country during World War II in the U.S. Army; he served in the Asiatic-Pacific Theater as a corporal; he was honorably discharged in January of 1947 having earned the Asiatic-Pacific Theater Ribbon, the Victory Medal, the Good Conduct Medal, and the Army of Occupation Medal for Japan; upon his return home, he became an electrician; and

WHEREAS, Mr. McNamara was a devoted union activist for many years; he was a member of the International Brotherhood of Electrical Workers Local 701 from 1967 to 1990 and represented the interests of that union in State government for nearly 40 years; and

WHEREAS, In his work as a lobbyist for the I.B.E.W., Mr. McNamara was a staunch ally of blue collar working families and was instrumental in the passing of much legislation that benefitted all of the hard-working citizens of Illinois; and

WHEREAS, Mr. McNamara was a former acting chairman and member of the DuPage Airport Authority; he was a devoted family man, and he believed that if every person would help his or her neighbor, no person would be without help; to his friends in Springfield, he was known as "Smokey"; and

WHEREAS, The passing of Emmett V. McNamara Sr. has been deeply felt by many, especially his wife, Jeanne McNamara; his children, Emmett Jr., Eugene, Kathleen Bakken, and Edward Sr.; his grandchildren, Michael, Edward Jr., Aidan, and Emily; his siblings, Earl, Kathleen, Rita Sheehan, and Eugene; and his many nieces and nephews; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we mourn the passing of Emmett V. McNamara Sr., and we extend our sincere condolences to his family, friends, and all who knew and loved him; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the family of Emmett V. McNamara Sr. as an expression of our deepest sympathy.

WHEREAS, In his time as chairman, the Committee received the Employer of the Year award from the Department of Human Services for extending an arm of employment to people with disabilities; he is a former member of the Board of Directors for the Randolph-Sheppard Vendors of America, and, in 1999, he was named the National Vendor of the Year by that organization; he currently operates a vending service at Stroger Hospital in Chicago; and

WHEREAS, Current State law provides that State agencies shall give opportunity to blind vendors at State offices; this program enlarges economic opportunities for the blind; and

WHEREAS, In order to bring awareness to this situation and to make the public aware of the plight of blind vendors, Mr. Gordon embarked on a walk from Chicago to Springfield on April 12, 2004; he plans to arrive in Springfield on Tuesday, April 20, 2004, where he will be joined by friends, supporters, and blind business people from around the State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Office of the Governor and all State agencies to give preference, not just opportunity, to blind vendors as the law provides; and be it further

RESOLVED, That we congratulate John Gordon on his quest to make the public aware of the plight of blind vendors that led to his trek from Chicago to Springfield; and be it further

RESOLVED, That a suitable copy of this resolution be presented to John Gordon as an expression of our respect and esteem; and be it further

RESOLVED, That a copy of this resolution be presented to Governor Rod R. Blagojevich.
