To the Honorable Members of the Illinois House of Representatives 94th General Assembly

Pursuant to Article IV, Section 9(b) of the Illinois Constitution of 1970, I hereby veto House Bill 340, entitled "AN ACT concerning criminal law." House Bill 340 eliminates the required waiting period for purchasing a firearm if the purchaser is trading in one gun for another. Waiting periods serve an important purpose; they help prevent certain violent crime. Domestic violence shootings, suicide attempts, and crimes of passion may be averted or reduced if a potential offender is required to wait up to 72 hours before purchasing a weapon. This bill allows current gun owners access to more dangerous weapons and or handguns without any cooling off period. I do not believe this exemption is necessary.

For this reason, I hereby veto and return House Bill 340.

More importantly, trucks operating under such payloads undermine the safety designs of our bridges and culverts. Increasing these limits could compromise the safety of others users of our roadways.

House Bill 1486 allows hunters to use snares to trap animals such as raccoons, foxes and beavers on land. These traps have been banned in Illinois for over 50 years because the trap's wire hoop strangles the animal. Twenty-one states in the nation do not allow the use of snares.

Snares are inhumane and indiscriminate. Not only do they cruelly kill wild animals for their fur, they may also kill domestic pets and even endangered species. Even though the bill requires a mechanism on the snare to reduce the chance of strangulation, the safety provisions are still inadequate and animals would suffer unnecessarily. While I support the hunters and trappers of Illinois, I refuse to support this particularly gruesome hunting method that's been banned in the state for years.

In addition, the Commission enjoys the freedom and discretion to require recommendations and public hearings before a State facility closes. House Bill 2528 removes this discretion and requires the State to submit to certain procedures before closing many of the facilities operated by the Department of Corrections, Department of Human Services and the Department of Veterans' Affairs. As a result, an agency will incur additional administrative costs and many closures that the Commission is not interested

in reviewing will be significantly delayed. The delay in action will only serve to diminish the costs savings in year one. Since the Commission already enjoys the authority to oversee our facility closures; additional mandates only serve to increase spending and frustrate government efficiency.

For this reason, I hereby veto and return House Bill 2528.

However, we should not further restrain the Office of Management and Budget from applying charge backs when appropriate. These charge backs recognize the valuable financial management services that the State provides to these funds. On the contrary, we should provide the Office of Management and Budget more flexibility in determining the value of these services. Therefore, this amendatory veto will allow us to revisit the charge back calculations for fiscal year 2005 in accordance with the statutory formula. HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 21

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend the Illinois Constitution by changing Section 3 of Article IV as follows:

ARTICLE IV

THE LEGISLATURE

SECTION 3. LEGISLATIVE REDISTRICTING

(a) Legislative Districts shall be compact, contiguous and substantially equal in population of citizens.

Representative Districts shall be compact, contiguous, and substantially equal in population of citizens.

(b) In the year following each Federal decennial census year, the General Assembly by law shall redistrict the Legislative Districts and the Representative Districts.

If no redistricting plan becomes effective by June 30 of that year, a Legislative Redistricting Commission shall be constituted not later than July 10. The Commission shall consist of eight members, no more than four of whom shall be members of the same political party.

The Speaker and Minority Leader of the House of Representatives shall each appoint to the Commission one Representative and one person who is not a member of the General Assembly. The President and Minority Leader of the Senate shall each appoint to the Commission one Senator and one person who is not a member of the General Assembly.

The members shall be certified to the Secretary of State by the appointing authorities. A vacancy on the Commission shall be filled within five days by the authority that made the original appointment. A Chairman and Vice Chairman shall be chosen by a majority of all members of the Commission.

Not later than August 10, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.

If the Commission fails to file an approved redistricting plan, the Supreme Court shall submit the names of two persons, not of the same political party, to the Secretary of State not later than September 1.

Not later than September 5, the Secretary of State publicly shall draw by random selection the name of one of the two persons to serve as the ninth member of the Commission.

Not later than October 5, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.

An approved redistricting plan filed with the Secretary of State shall be presumed valid, shall have the force and effect of law and shall be published promptly by the Secretary of State.

The Supreme Court shall have original and exclusive jurisdiction over actions concerning redistricting the House and Senate, which shall be initiated in the name of the People of the State by the Attorney General.
