(20 ILCS 1705/15f new)

Sec. 15f. Individualized behavioral support plan.

(a) As used in this Section:

"Behavioral challenges" means episodes of significant property destruction, self-injurious behavior, assaultive behavior, or any other behavior that prevents a person from successful participation in a Home and Community Based Services Program for Persons with Developmental Disabilities, as determined by the community support team.

"Home and Community Based Services Program for Persons with Developmental Disabilities" means a program that is funded through a waiver authorized under Section 1915(c) of the federal Social Security Act and that is administered by the Department of Human Services' Division of Developmental Disabilities. Services under the Program include Community Integrated Living Arrangements, Community Living Facilities of 16 or fewer individuals, home-based support services, day programs, and therapies. The term also includes newly developed programs and settings that are funded through the Home and Community Based Services Program for Persons with Developmental Disabilities.

(b) Each individual participating in a Home and Community Based Services Program for Persons with Developmental Disabilities, regardless of whether the individual is eligible for federal financial participation for these services, who exhibits behavioral challenges shall have an individualized behavioral

support plan. Each individualized support plan shall: (i) be designed to meet individual needs; (ii) be in the immediate and long-term best interests of the individual; (iii) be non-aversive; (iv) teach the individual new skills; (v) provide alternatives to behavioral challenges; (vi) offer opportunities for choice and social integration; and (vii) allow for environmental modifications. The plan must be based on a functional behavioral assessment conducted by a professional trained in its use. The plan shall be implemented by staff who have been trained in and are qualified to effectively apply positive non-aversive intervention. All behavioral supports required by the plan shall be applied in a humane and caring manner that respects the dignity of the individual and shall be implemented in a positive and socially supportive environment, including the home.

Interventions must not: (1) include electric shock; (2) withhold essential food and drink; (3) cause physical or psychological pain; (4) use drugs as restraints; or (5) produce humiliation or discomfort.

Nothing in this subsection shall preclude, for therapeutic purposes, variant scheduling of food or drink or the application of safe and appropriate time-out procedures.

(c) The Department of Human Services shall be responsible for developing and promulgating rules to implement the provisions of this Section and to carry out the intent of this Section.

(d) To the extent this Section conflicts with Article I of Chapter II of the Mental Health and Developmental Disabilities Code, that Article controls.

Section 99. Effective date. This Act takes effect upon becoming law.".

Each form shall contain a statement that the contributions will reduce the taxpayer's refund or increase the amount of payment to accompany the return. Failure to remit any amount of increased payment shall reduce the contribution accordingly.

(b) If, on October 1 of any year, the total contributions to any one of the funds made under this Section do not equal 100,000 or more, the explanations and spaces for designating contributions to the fund shall be removed from the individual income tax return forms in accordance with subsection (d) for the following and all subsequent years and all subsequent contributions to the fund shall be refunded to the taxpayer.

(c) In any year, the individual income tax return forms may not contain explanations and spaces for more than 18 funds. The funds must be placed on the tax return forms in the chronological order in which they were authorized. The Department must maintain a reserve list of all income tax checkoffs in excess of the 18 that are placed on income tax return forms and, as set forth under subsection (d), of checkoffs removed from the forms. The checkoffs on the reserve list shall be placed on the tax return forms to replace those funds that are removed from the forms under subsection (b) or by law.

<u>Funds must be placed on the reserve list in chronological order, beginning with the first tax checkoff that became law after the effective date of this amendatory Act of the 94th General Assembly. If 2 or more checkoffs became law on the same day, then the checkoff that passed both houses of the General Assembly on the earliest date shall be listed first.</u>

(d) If a tax checkoff is removed from the tax return forms under subsection (b), the the checkoff shall be placed at the bottom of the reserve list. If 2 or more checkoffs are removed from the tax return forms under subsection (b) in the same year, then the funds shall be placed at the bottom of the reserve list in the order, from highest to lowest, of the amount of contributions that the fund received during that year. A fund that was removed from the return forms more than once after the effective date of this amendatory Act of the 94th General Assembly may not be placed on the reserve list.

Sec. 510. Determination of amounts contributed. Perfunctory Session

FRIDAY, MARCH 24, 2006

At the hour of 12:57 o'clock p.m., the House convened perfunctory session.

RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 1053

Offered by Representative Daniels:

WHEREAS, The Illinois State Board of Education has reported that today there are more than twice as many children in Illinois diagnosed with autism as there were only five years ago; and

WHEREAS, It is estimated that fewer than 1 in 10 children with autism receive the level and type of services recommended by the National Research Council; and

WHEREAS, Families of children with autism bear an enormous financial burden of providing needed services and healthcare; and

WHEREAS, Public Act 93-773 was signed into law in 2004 establishing the Autism Task Force, in order to study and assess service needs of persons with autism spectrum disorders ("ASD") in the State of Illinois; and

WHEREAS, Public Act 93-773 additionally required the Department of Human Services (DHS) and the Department of Public Aid to determine the availability of federal financial participation in the cost of developing a family support program, which would include medical assistance coverage for children diagnosed with autism, including services to support persons with autism in their homes and communities that are not provided through local school systems, early intervention programs, or the medical assistance program under the Illinois Public Aid Code; and

WHEREAS, Public Act 93-773 required the departments to determine the feasibility of obtaining federal financial participation and stated that they "may apply for any applicable waiver under Section 1915(c) of the federal Social Security Act"; and

WHEREAS, The Autism Task Force met for over 18 months and, on September 1, 2005, delivered a 30-page report which recommended that the Governor and State Legislature should give "the highest priority" to establishment of a children's Autism Waiver program in Illinois; and

WHEREAS, The Autism Task Force further recommended that, "with the support of the Governor and the Legislature, the Department of Healthcare and Family Services (HFS) and DHS should prepare and submit as soon as possible to the Federal Centers for Medicare and Medicaid Services an application for an Illinois Children's ASD Waiver"; and

WHEREAS, Committees of both houses of the General Assembly convened several subject matter hearings on autism in Fall 2005 in Chicago and Springfield, including hearings by the House Developmental Disabilities/Mental Illness Committee, the Senate Health and Human Services Committee, and the House Human Services Committee; and

WHEREAS, Many dozens of parents of children and adults with autism testified before these committees, attesting to the urgent need for services and financial support for families of children and adults with autism; and

WHEREAS, Illinois has no Medicaid waiver program for children with autism or any developmental disabilities; and

WHEREAS, A children's Medicaid waiver will provide Federal Match to the State through reimbursement by the Federal government for waiver services; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we endorse the goal of supporting families of children with autism directly and providing consumer-directed services for persons with autism; and be it further

RESOLVED, That we support the goal of establishing a Medicaid waiver or waivers to provide supports and services for families of children with autism; and be it further

RESOLVED, That we urge the Department of Healthcare and Family Services and the Department of Human Services to apply for a children's Medicaid waiver that includes a minimum of 2,000 children with autism and provides for these children to receive specialized autism services, including applied behavioral analysis and analogous habilitative methodologies, in addition to other waiver services and supports that will allow parents to keep their children with autism in their homes and with their families; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Director of Healthcare and Family Services and to the Secretary of Human Services.

HOUSE RESOLUTION 1055

Offered by Representative Bellock:

WHEREAS, The Illinois State Board of Education has reported that today there are more than twice as many children in Illinois diagnosed with autism as there were only five years ago; and

WHEREAS, It is estimated that fewer than one in ten children with autism receive the level and type of services recommended by the National Research Council; and

WHEREAS, Families of children with autism bear an enormous financial burden of providing needed services and healthcare; and

WHEREAS, Public entities such as the Illinois Autism Training and Technical Assistance Project and private entities like Giant Steps of Illinois provide educational and therapeutic services to enable children with autism to achieve their maximum potential and strive to improve a child's ability to interact, communicate, and develop academic and daily life skills; these groups work cooperatively with local school districts to reintegrate students with autism into their home school on a full-time or part-time basis based on the individual needs of the student; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we name the month of April 2006 as Autism Awareness Month in the State of Illinois, and we recognize and commend the parents and relatives of children with autism for their sacrifice and dedication in providing for the special needs of children with autism and for absorbing significant financial costs for specialized education and support services; and be it further

RESOLVED, That we support the goals of expanding supports and services for individuals with autism across their lifespan, promoting understanding of the special needs of people with autism, and promoting their inclusion in their communities, increasing federal, State, and private funding for aggressive research to learn the root causes of autism and the best methods of early intervention and treatment; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Autism Society of Illinois, the Illinois Autism Training and Technical Assistance Project, and Giant Steps of Illinois.

HOUSE RESOLUTION 1063

Offered by Representative Sullivan:

WHEREAS, Public Act 94-693 was signed into law to create the Covering ALL KIDS Health Insurance Act to provide access to affordable health insurance coverage for all children residing in the State of Illinois; and

WHEREAS, The Department of Healthcare and Family Services estimates that there are 253,000 uninsured children in Illinois and roughly half of these children are eligible for the KidCare program; and

WHEREAS, The provisions of the new Covering ALL KIDS Health Insurance Program provide that children may be enrolled in the program as long as they are living in Illinois for other than a temporary or transitory purpose and no requirement for previous residency is required; and

WHEREAS, Concerns have arisen that families may move to Illinois from other areas to take advantage of the new Covering ALL KIDS Health Insurance Program, which includes a State subsidy for the medical care provided to enrollees; and

WHEREAS, The Department of Healthcare and Family Services is adding headcount to provide for administration of the Covering ALL KIDS Health Insurance Program and this additional headcount has the

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Department of Healthcare and Family Services to track the recent areas of residence of Covering ALL KIDS Health Insurance Program enrollees for the last 3 years to ensure that the Program is successfully enrolling uninsured children historically residing in Illinois; and be it further

RESOLVED, That information gathered from tracking residency for Covering ALL KIDS Health Insurance Program enrollees should be compiled into a report by the Department of Healthcare and Family Services to be presented to the General Assembly by December 31, 2006; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Director of Healthcare and Family Services.

HOUSE RESOLUTION 1067

Offered by Representative Jakobsson:

WHEREAS, The personal prosperity of Illinois citizens and the economic security of our nation will require uniting our workforce development, education, and economic development strategies in a common effort to provide our citizens with higher skills and supply our businesses with qualified workers; and

WHEREAS, The economic security of Illinois citizens will enhance the quality and productivity of people and businesses and provide effective economic development strategies for the workforce needs of the future; and

WHEREAS, The Illinois Local Workforce System and One-Stop Centers must be able to offer more programs and services to a wider customer base; and

WHEREAS, The Illinois Workforce Development System must continue to recognize the value of local decision making, which is key to the success of the future workforce; and

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, That we recognize the importance of workforce development and designate the week of August 27, 2006, as "Workforce Development Week" in the State of Illinois to showcase the Illinois workforce system.

HOUSE RESOLUTION 1068

Offered by Representative Mulligan:

WHEREAS, Illinois has developed a network of health insurance coverage options for children, working families, and those with preexisting medical conditions, including programs such as KidCare, the Comprehensive Health Insurance Plan, and the new Covering ALL KIDS Health Insurance Program; and

WHEREAS, Studies indicate that a child's access to health care improves not only the child's health, but also improves other outcomes, including education; and

WHEREAS, Estimates indicate that as many as 253,000 children in Illinois lacked health insurance coverage prior to the passage of the Covering ALL KIDS Health Insurance Act, even though half of these children met eligibility requirements for KidCare coverage; and

ASSEMBLY OF THE STATE OF ILLINOIS, that there is hereby created the Children's Health Insurance Task Force, consisting of 3 members appointed by the Speaker of the House of Representatives and 3 members appointed by the Minority Leader of the House of Representatives; and be it further

RESOLVED, That the Task Force shall gather information and make recommendations relating to access to quality, affordable health insurance for children in Illinois and shall examine the cost effectiveness of current programs to assess whether the programs are meeting goals established for the programs; and be it further

RESOLVED, That the Task Force shall submit a report to the General Assembly by December 31, 2006.

HOUSE JOINT RESOLUTION 110

Offered by Representative Stephens:

WHEREAS, Illinois State women have proudly served in defense of our Nation since the Civil War, despite their lack of military standing before the 1900s; and

WHEREAS, They served in all major conflicts in ever-increasing numbers, volunteering to preserve our freedom; and

WHEREAS, They served in expanding positions of responsibility from laundresses and cooks to administrators, from medical and technical personnel to full combatants; and

WHEREAS, Illinois State women contributed to establishing and maintaining our independence, preserving the Union, abolishing slavery, and advancing the cause of freedom and democracy around the world; and

WHEREAS, In times of conflict, State of Illinois women served the military as society permitted or as the situation demanded; and

WHEREAS, Women came forward to replace men as battlefield emergencies demanded and some even disguised their gender in order to serve; others masked their identity, risking their lives as couriers and intelligence agents; and

WHEREAS, The value of their contributions has finally been recognized by their ever-increasing integration and opportunities in the Armed Forces; and

WHEREAS, Women now make up over 15% of the active duty force and about 23% of the reserve force, totaling over 203,000 women soldiers; and

WHEREAS, Today women make up 7% of the United States Veterans population; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the General Assembly authorize the construction of a memorial honoring women in military service on a portion of the State-owned property in Oak Ridge Cemetery in Springfield, Illinois.
