SENATE JOINT RESOLUTION NO. 81

RESOLVED, BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that when the two Houses adjourn on Thursday, February 14, 2008, the Senate stands adjourned until Friday, February 15, 2008, in perfunctory session; and when it adjourns on that day, it stands adjourned until Wednesday, February 20, 2008, at 11:30 o'clock a.m.; and the House of Representatives stands adjourned until Friday, February 15, 2008, at 11:00 o'clock a.m., and when it adjourns on that day, it stands adjourned until Wednesday, February 20, 2008, at 11:30 o'clock a.m.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE JOINT RESOLUTION 98

Offered by Representative Pihos:

WHEREAS, The U.S. Department of Education has indicated through its peer review process that the Illinois Measure of Annual Growth in English (IMAGE) reading test is no longer an acceptable achievement test for English Language Learner (ELL) students; and

WHEREAS, The State Board of Education made a decision to eliminate the use of the IMAGE test; instead, ELL students will have to take the Illinois Standards Achievement Test (ISAT) and the Prairie State Achievement Examination (PSAE); and

WHEREAS, School districts were informed of this decision in November; and

WHEREAS, The impact of this decision will mean that ELL students will be taking tests that are inappropriate to measure their academic performance because the ISAT was never developed for an ELL population; the ISAT was never normed on an ELL population; and, by definition, students receiving English as a Second Language (ESL) services (students who score 3 or lower on the ACCESS test, the State-required English language proficiency assessment) are not able to work at grade-level standards; and

WHEREAS, The Illinois Advisory Council on Bilingual Education has made the following recommendations to the State Board of Education:

(1) to not penalize schools and districts that do not make Adequate Yearly Progress (AYP) in 2008 solely because of the ELL subgroup;

(2) to include ELL students only in participation calculations;

(3) to not include ELL students' scores on the reading and math tests in AYP calculations for up to 2 years from the time the student enters the Illinois school system; and

(4) to exempt ELL students who have a composite score of 3 or less on the ACCESS test from the State content assessments for one year; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we encourage the U.S. Department of Education to approve the request made by the State Board of Education in its letter dated January 8, 2008 with respect to the IMAGE test; and be it further

RESOLVED, That students scoring 3 or lower on the ACCESS test should not be required to take the ISAT and PSAE or participate in the State's testing program until a new and appropriate assessment can be developed by the State Board of Education; and be it further

RESOLVED, That should the U.S. Department of Education not approve the State Board of Education's request, that the State Board of Education still not require testing of students receiving an ACCESS score of 3 or lower; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the U.S. Department of Education, the State Board of Education, and each member of the Illinois congressional delegation.

HOUSE JOINT RESOLUTION 99

Offered by Representative Reis:

WHEREAS, The State Board of Education presently gives out an annual award, the Illinois Teacher of the Year Award, to deserving educators who have proven themselves to be caring and committed to bettering the lives of others through quality education; and

WHEREAS, Willard Carl Widerberg spent more than 30 years of his life in teaching and school administration; he was called to teaching at a very early age and has been credited with building the foundation for numerous co-op, special education, and school administrative programs still in use today; he developed innovative educational and administrative programs working for DeKalb Community Unit School District 428, the United States military, and the National Science Program at Northern Illinois University; and

WHEREAS, Mr. Widerberg became an elementary school principal in 1954; during the following years he served as principal in several schools within DeKalb Community Unit School District 428; during the summer months, he worked with the National Science Program at Northern Illinois University, which teaches new and existing elementary and high school teachers nationwide the foundations of various science disciplines; he also taught an Americanization class at De Kalb High School for more than 10 years, working with immigrants from numerous countries; and

WHEREAS, He retired in 1979 after 32 years in teaching and administrative roles within DeKalb area schools; throughout his career, he volunteered with numerous local and State organizations focused on developing and enriching the educational environment, as well as the community's wellbeing; and

WHEREAS, Mr. Widerberg received the very first Illinois Teacher of the Year Award in 1954; in addition, that same year he was the first Illinois teacher to be recognized as the National Teacher of the Year; and

WHEREAS, Willard Carl Widerberg has proven over the years that his heart is all about education; he has shown his determination to teach, to lead, and to place others on a path that pushes them towards a brighter future; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the State Board of Education to rename the Illinois Teacher of the Year Award the Willard Carl Widerberg Illinois Teacher of the Year Award in honor of Mr. Widerberg's many achievements and dedication to education in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the State Board of Education.

HOUSE JOINT RESOLUTION 100

Offered by Representative Chapa LaVia:

WHEREAS, Several recent economic and academic studies have demonstrated a growing skills gap among workers in the nation; and

WHEREAS, These studies have demonstrated that the greatest disparity in skills exists among the nation's traditionally underrepresented minority populations, specifically African Americans, Latinos, and Native Americans; and

WHEREAS, A logical and efficient manner of addressing this skill gap is through the provision of post-secondary education; and

WHEREAS, Illinois needs to improve college access for all of its citizens in order to address the skill gap, provide a cadre of more qualified and competent workers for Illinois businesses, and improve the State economy; and

WHEREAS, Traditionally underrepresented populations, specifically African Americans, Latinos, and Native Americans, make up an increasingly higher percentage of the State's population, and thus will be called upon to make up an increasingly higher percentage of the State's workforce; and

WHEREAS, Traditionally underrepresented populations, specifically African Americans, Latinos, and Native Americans, make up a disproportionately lower percentage of those students attending colleges and

universities in Illinois as compared to their overall Illinois population; and

WHEREAS, It has been demonstrated that traditionally underrepresented student populations are more successful in their degree attainment when they are taught and supported by faculty and staff that includes those of similar ethnic and cultural backgrounds; and

WHEREAS, Traditionally underrepresented populations, specifically African Americans, Latinos, and Native Americans, make up a disproportionately lower percentage of the faculty and staff at colleges and universities in Illinois as compared to their overall Illinois population; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that a bi-partisan task force on the status of underrepresented minorities in higher education is commissioned to evaluate the status of traditionally underrepresented populations, specifically African Americans, Latinos, and Native Americans, in this State's public and private institutions of higher education; and be it further

RESOLVED, That membership on this task force include 2 Republican and 2 Democrat members of the House of Representatives, appointed by the Speaker of the House; 2 Republican and 2 Democrat members of the Senate, appointed by the President of the Senate; the Chairperson, or his or her designee, of the State Board of Education, the Executive Director, or his or her designee, of the Board of Higher Education, and the Executive Director, or his or her designee, of the Illinois Student Assistance Commission; and the head, or his or her designee, of a group representing independent Illinois colleges and universities, the head, or his or her designee, of a group representing black concerns in higher education in Illinois, the head, or his or her designee, of a group representing Latinos and higher education in Illinois, and the head, or his or her designee, of a group representing the interests of community colleges in Illinois, each appointed jointly by the Speaker of the House and President of the Senate; and be it further

RESOLVED, That this task force assess accessibility of institutions of higher education in Illinois for those in the above-stated Illinois populations who want to enroll as students; and be it further

RESOLVED, That the task force assess the representation of these populations in all job categories, including faculty, staff, and civil service, at institutions of higher education in Illinois; and be it further

RESOLVED, That the task force assess issues of campus climate that might affect the success of students and the retention of faculty and staff at institutions of higher education in Illinois; and be it further

RESOLVED, That the task force pay particular attention during its assessment of those college and university programs that target areas of the most drastic skills disparity, as identified by previously published economic and academic studies; and be it further

RESOLVED, That in order to make these assessments, the task force shall receive assistance from the Board of Higher Education and shall hold a series of regional public hearings on college and university campuses across the State; and be it further

RESOLVED, That this task force shall file a report with the General Assembly, the Office of the Governor, the State Board of Education, and the Board of Higher Education upon completion of its assessments, and that this report shall include any findings and recommendations for further legislative action that are generated as a result of the task force's work; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the the Chairperson of the State Board of Education, the Executive Director of the Board of Higher Education, and the Executive Director of the Illinois Student Assistance Commission.
