WHEREAS, Blagojevich claimed that finding a job for the secretary would, according to a tape of the interview, "keep that guy happy and, you know, then hope that they might work with us on some issues"; and

WHEREAS, The request that Blagojevich hire someone not based on merit or need, but rather to satisfy a legislator, a request that would result in a legislator or legislators then working with the Governor "on some issues", would appear to constitute an attempt at pay to play; and

WHEREAS, State law prohibits public officials from trading official acts for services; and

WHEREAS, The people of the State of Illinois expect their elected officials to follow State law and work to root out corruption; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the House urges the office of the Sangamon County State's Attorney to immediately begin an inquiry or investigation to determine, based on Rod Blagojevich's claims, if any State laws were violated, and if any legislator or legislators, together or alone, sought to trade their services in exchange for Governor Rod Blagojevich hiring a legislator's secretary; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Sangamon County State's Attorney.

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 18**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 2 of Article IV of the Illinois Constitution as follows:

**ARTICLE IV
THE LEGISLATURE**

SECTION 2. LEGISLATIVE COMPOSITION

(a) One Senator shall be elected from each Legislative District. Immediately following each decennial redistricting, the General Assembly by law shall divide the Legislative Districts as equally as possible into three groups. Senators from one group shall be elected for terms of four years, four years and two years; Senators from the second group, for terms of four years, two years and four years; and Senators from the third group, for terms of two years, four years and four years. The Legislative Districts in each group shall be distributed substantially equally over the State.

(b) Each Legislative District shall be divided into two Representative Districts. In 1982 and every two years thereafter one Representative shall be elected from each Representative District for a term of two years.

(c) To be eligible to serve as a member of the General Assembly, a person must be a United States citizen, at least 21 years old, and for the two years preceding his election ~~or appointment~~ a resident of the district which he is to represent. In the general election following a redistricting, a candidate for the General Assembly may be elected from any district which contains a part of the district in which he resided at the time of the redistricting and reelected if a resident of the new district he represents for 18 months prior to reelection.

(d) If a vacancy in the office of Senator or Representative occurs 180 or fewer days before the next general election, the vacancy shall be filled at the next general election. If a vacancy in the office of Senator or Representative occurs more than 180 days before the next general election, the vacancy shall be filled at a special election as provided by law. A person elected to fill a vacancy in office shall serve for the remainder of the term. ~~Within thirty days after a vacancy occurs, it shall be filled by appointment as provided by law. If the vacancy is in a Senatorial office with more than twenty eight months remaining in the term, the appointed Senator shall serve until the next general election, at which time a Senator shall be elected to serve for the remainder of the term. If the vacancy is in a Representative office or in any other Senatorial office, the appointment shall be for the remainder of the term. An appointee to fill a vacancy shall be a member of the same political party as the person he succeeds.~~

(e) No member of the General Assembly shall receive compensation as a public officer or employee from any other governmental entity for time during which he is in attendance as a member of the General Assembly.

No member of the General Assembly during the term for which he was elected ~~or appointed~~ shall be appointed to a public office which shall have been created or the compensation for which shall have been increased by the General Assembly during that term.

WHEREAS, A degree from a particular institution does not automatically qualify an individual to be a trustee, nor should a non-graduate automatically be disqualified from service; nonetheless, a successful trustee ought to have a longstanding relationship with his or her particular university; it stands to reason that the mandatory predicate for any trustee candidate should be an intangible love for the institution of higher education that he or she is being asked to serve; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Governor Quinn to return to the practice of selecting State university trustees from a list provided by and vetted by the alumni association of the State university in question; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Governor Quinn.

HOUSE JOINT RESOLUTION 11

Offered by Representative Ryg:

WHEREAS, In times of economic downturn, states look to reduce spending to stay within the available resources; and

WHEREAS, The State of Illinois currently is at the lowest federal Medicaid matching rate (50%); and

WHEREAS, Community service providers provide Medicaid funded health care, mental health, substance abuse and community based disability services; and

WHEREAS, Community service providers are often in the top five largest employers in their counties; and

WHEREAS, Downturns in the economy often result in an increased need for services provided by community disability, mental health and substance abuse services and supports providers; and

WHEREAS, The Medicaid program is the health care safety net for low-income children, families, the elderly and the disabled; and

WHEREAS, A significant portion of the services and supports provided by community service providers receive federal reimbursement from the Medicaid program; and

WHEREAS, Increases in the Federal Medical Assistance Percentage, also known as FMAP, decrease pressure on states to cut spending and raise taxes; and

WHEREAS, Increases in FMAP reduce the need to cut Medicaid eligibility, benefits and rates; and

WHEREAS, Increases in FMAP reduce the necessity of community providers significantly funded by Medicaid to lay off staff, reduce services and expand waiting lists when reductions in funding are made, thereby providing ongoing economic stimulus by the staff's continued employment and spending being maintained rather than reduced; and

WHEREAS, Increased demand for community disability, mental health, and substance abuse services requires community providers to be fully staffed to safely respond to those demands; and

WHEREAS, An FMAP increase would allow the State of Illinois to increase General Revenue spending to maintain community services and supports, and therefore leverage greater amounts of total dollars; and

WHEREAS, An FMAP increase would help the State of Illinois meet its current commitments to the Medicaid program and also be able to withstand future enrollment increases for current eligibility groups that will occur with the recession; and

WHEREAS, It is critically important that the State of Illinois respond to the pressure of its current fiscal crisis in a responsible way to those who are currently aided by Medicaid spending; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL

ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we do hereby direct the Illinois Department of Healthcare and Family Services to amend its State Medicaid Plan to reflect that with the increased FMAP, current efforts in serving the needs of beneficiaries will be maintained and expanded in proportion to the FMAP generated by these services; and be it further

RESOLVED, That neither the Governor, nor the Governor's Office of Management and Budget, nor the Illinois Department of Healthcare and Family Services will be permitted to allocate increased FMAP funds for other non-Medicaid programs; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Majority Leader and Minority Leader of the United States Senate, the Speaker and Minority Leader of the United States House of Representatives, and to each member of the Illinois Congressional delegation.

HOUSE JOINT RESOLUTION 12

Offered by Representative Riley:

WHEREAS, Fetal Alcohol Spectrum Disorders (FASD) are the leading cause of mental retardation in western civilization, including the United States, and are 100% preventable; and

WHEREAS, The term FASD includes a broader range of conditions and therefore has replaced the term fetal alcohol syndrome as the umbrella term describing the range of effects that can occur in an individual whose mother consumed alcohol during pregnancy; and

WHEREAS, FASD are a major cause of numerous social disorders, including learning disabilities, school failure, juvenile delinquency, homelessness, unemployment, mental illness, and crime; and

WHEREAS, The incidence rate of fetal alcohol syndrome is estimated at one out of 500 live births and the incidence rate of fetal alcohol spectrum disorders is estimated at one out of every 100 live births; in Illinois, it is estimated that there are potentially 9,000 children born with FASD each year; and

WHEREAS, It is estimated that FASD alone can cost between one and 5 million dollars per child, not inclusive of societal costs associated with lost productivity, incarceration, and quality of life; and

WHEREAS, Learning and life skills affected by prenatal alcohol exposure vary among persons, depending on amount, timing, and pattern of exposure and on each person's current and past environments; as a result, services for people with FASD vary according to the parts of the brain that have been affected, the person's age or level of maturation, the health or functioning of the person's family, and the person's overall living environment; given the range of need, services must be individualized; and

WHEREAS, Children diagnosed with FASD consistently have lower IQs, have difficulty with behavior regulation, impulsivity, socialization, and poor judgment; and

WHEREAS, Early identification of the disability and proper school interventions can greatly increase the potential for success in school and in life; and

WHEREAS, Illinois does not currently have a statewide, coordinated response to FASD that includes data collection, educational services, and mental health services; and

WHEREAS, The estimated cost that each individual with fetal alcohol syndrome will cost taxpayers is significant; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the Department of Human Services, in collaboration with the Departments of Children and Family Services, Healthcare and Family Services, Corrections, Financial Institutions and Professional Regulation, the Illinois State Board of Education, and the Illinois Planning Council on Developmental Disabilities to complete an assessment of existing State and federal assistance programs that includes the following: conducting public hearings across the State to gather testimony from parents, educators, healthcare providers, clinicians, mental health providers, FASD service providers, and others regarding what services they feel need to be in place in this State to serve this unique population of children and adults; and be it further

RESOLVED, That the Illinois Department of Human Services shall issue a report highlighting the findings of this Resolution's requirements and recommendations for improving Illinois' services to children, adults, and their families affected by FASD to the Governor and the General Assembly no later than January 2, 2010; and be it further

RESOLVED, That a copy of the report be sent to the Directors of the Departments of Children and

Family Services, Healthcare and Family Services, Financial Institutions and Professional Regulation, and Corrections, the Superintendent of the Illinois State Board of Education, the Illinois Planning Council on Developmental Disabilities, the Illinois General Assembly, the Office of the Governor, and the Governor's Office of Management and Budget.
