HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 152

Offered by Representative Zalewski:

WHEREAS, Although it is relatively uncommon in the United States, accounting for about 1% of total

diagnosed cancers, the incidence of esophageal cancer has been increasing; and

WHEREAS, One factor contributing to this trend is greater prevalence of obesity, which increases the risk of one form of esophageal cancer known as adenocarcinoma; according to the American Cancer Society's estimates, in 2008 there were 16,470 new cases of esophageal cancer causing 14,280 deaths; the five-year relative survival rate for localized stage esophageal cancer is 34%, and the five-year survival rate for all stages combined is only 16%; and

WHEREAS, Symptoms of esophageal cancer generally do not appear until the disease has advanced; this fact illustrates the importance of educating the public about the various risk factors for this disease; early detection and proper diagnosis are also critical in order to treat esophageal cancer effectively; new ways to detect changes in genes may lead to the development of more accurate screening tests to find esophageal cancer at an earlier, more curable stage; and

WHEREAS, It is hoped that understanding these changes will lead to gene therapies for preventing or treating esophageal cancer; avoiding tobacco and excessive alcohol use can substantially reduce the risk of developing esophageal cancer; men have esophageal cancer at rates about three times greater than women do, primarily due to men's greater use of tobacco and alcohol; in addition, the risk of dying from this cancer is increased by approximately 50% in obese men; and

WHEREAS, People between the ages of 70 and 84 have the greatest risk for cancer of the esophagus; nearly 80% of people diagnosed are between the ages of 55 and 85; African Americans are twice as likely as Caucasians to have cancer of the esophagus; people with long-standing reflux or people with Barrett esophagus, a condition associated with long-term reflux of stomach acid into the esophagus, are at sharply increased risk; and

WHEREAS, A diet that is low in fruits, vegetables, and vitamins A, B2, and C increases the risk for esophageal cancer; specific quality-of-life issues associated with esophageal cancer include the inability to eat solid food, guilt associated with a history of tobacco and alcohol use, and end-of-life issues due to the low survival rate; and

WHEREAS, Cancer of the esophagus usually is diagnosed at a late stage and therefore has a poor outlook for survival; this kind of cancer can virtually be prevented by stopping, or never starting, tobacco use and by moderating alcohol use; screening endoscopy for people at high risk for this cancer can also increase early detection rates; typically, the earlier cancer is detected and diagnosed, the more successful the treatment, thus enhancing the survival rate; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we proclaim the month of May of 2009 be designated as Esophageal Cancer Awareness Month in the State of Illinois; and be it further

RESOLVED, That we declare that the Illinois government has a responsibility:

(a) to raise awareness about the importance of screening methods for, and treatment of, esophageal cancer;

(b) to increase research funding that is commensurate with the burden of the disease so that the screening and treatment of esophageal cancer may be improved, and so that the causes of, and a cure for, prostate cancer may be discovered; and

(c) to continue to consider ways for improving access to, and the quality of, health care services for detecting and treating esophageal cancer; and be it further

RESOLVED, That the Governor is requested to issue a proclamation calling upon the public officials and the citizens of Illinois to observe the month with appropriate activities and programs annually; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Governor Pat Quinn.

HOUSE RESOLUTION 154

Offered by Representative Burke:

WHEREAS, Bisphenol A (BPA) is found in many consumer products, such as baby bottles and other reusable containers made from polycarbonate plastic and in the epoxy resin coating used in most food and beverage cans, including canned infant formula; and

WHEREAS, Upon the request of the Commissioner of the United State Food and Drug Administration (FDA), the FDA formed an agency-wide BPA task force to facilitate cross-agency review and evaluation of current research and new information on BPA for all FDA regulated products and to make

recommendations to the Commissioner regarding actions the FDA should take next regarding BPA; and

WHEREAS, As part of its evaluation, the task force has reviewed the concerns presented in the National Toxicology Program Brief published in September 2008 by the National Institutes of Health and the concerns presented in the Canadian risk assessment released in October 2008; and

WHEREAS, The FDA has considered the research and positions of other transnational food safety organizations, including the 2 risk assessments for BPA conducted by the European Food Safety Authority's Scientific Panel on Food Additives, Flavours, Processing Aids and Materials in Contact with Food and the Japanese National Institute of Advanced Industrial Science and Technology; each of these documents considered the question of a possible low-dose effect and concluded that no current health risk exists for BPA at the current exposure level; and

WHEREAS, The FDA has been reviewing the emerging literature on BPA on a continuous basis; and

WHEREAS, In August 2008, the FDA released a draft safety assessment of BPA in food contact products and in October 2008, the FDA Science Board provided recommendations to the FDA to improve the safety assessment; and

WHEREAS, The FDA has reported back to the Science Board on February 24, 2009 on the progress they have made to address the Science Board recommendations; and

WHEREAS, It is altogether fitting and proper and in the public interest for us to urge the United States Food and Drug Administration to expedite their current review of bisphenol A in food containers and baby bottles; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the United States Food and Drug Administration to expedite its current review of the safety of bisphenol A in products that contact food and take appropriate action based on its findings; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Commissioner of the United States Food and Drug Administration and each member of the Illinois congressional delegation.

HOUSE RESOLUTION 156

Offered by Representative Washington:

WHEREAS, 20 million Americans suffer from chronic kidney disease and an additional 20 million are at risk for kidney disease; 600,000 people in Illinois alone suffer from chronic kidney disease and over 15,000 are on dialysis due to kidney failure; and

WHEREAS, The Illinois House of Representatives recognizes that more can be done to prevent and lessen the effects of Chronic Kidney Disease (CKD) and improve the lives of millions of Americans; and

WHEREAS, Early detection is critical to helping those affected by kidney disease; the Illinois House of Representatives recognizes that early detection and treatment in its early stages can delay the onset of end stage kidney failure, which in turn reduces the number of patients that require dialysis and reduces the long-term effects of the disease, including its impact on diabetes and cardiovascular disease; and

WHEREAS, African-Americans and Hispanics currently suffer from chronic kidney disease at a rate that is four times higher than the overall rate of Americans diagnosed with CKD; and

WHEREAS, Targeting specific populations can help maximize the efficiency of catching the disease in its early stages, saving not only money but greatly improving the quality of life of those affected by the disease; and

WHEREAS, We have affirmed our support for early detection and education programs offered through the National Kidney Foundation of Illinois and World Kidney Day; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SIXTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate March 12, 2009 as "World Kidney Day" in the State of Illinois; and be it further

RESOLVED, That we support public policy initiatives in this area and acknowledge the need for education and awareness to support applicable medical treatment specific to the populations at greatest risk in eliminating this health disparity.

HOUSE JOINT RESOLUTION 30

Offered by Representative Biggins:

WHEREAS, Section 14.1 of the Toll Highway Act provides that prior to the issuance of bonds for or the commencement of construction of any new toll highway, that particular toll highway shall be authorized by joint resolution of the General Assembly; and

RESOLVED, That the Illinois State Toll Highway Authority be authorized to expand the Illinois toll highway system to include a Bypass to O'Hare International Airport (commonly known as Western Access) to be constructed generally along the western edge of the O'Hare International Airport between I-90 (Northwest/Jane Addams Tollway) and I-294 (Tri-State Tollway), and with the extension to be constructed in a generally east-west direction between west of I-290 (near Roselle Road) at the west and the Bypass at the east (commonly known as the Elgin-O'Hare Expressway); and be it further

RESOLVED, That construction of the referenced Bypass be completed no later than December 31, 2015; and be it further

RESOLVED, That the completion of said construction by 2015 is necessary to ensure operational stability for vehicular traffic on the west side of the Airport with the completion of the improvements associated with the O'Hare Modernization Program and the creation of approximately 44,000 new jobs created resulting from the referenced improvement; and be it further

RESOLVED, That the referenced completion comports with the timeline required for the many infrastructure improvements required to be in place for the City of Chicago to host the 2016 Olympic Games; and be it further

RESOLVED, That a copy of this preamble and resolution be immediately forwarded to each of the Directors of the Illinois State Toll Highway Authority.
