HOUSE BILLS ON SECOND READING

HOUSE BILL 1154. Having been read by title a second time on February 27, 2013, and held on the order of Second Reading, the same was again taken up.

Representative Nekritz offered Amendment No. 1 and moved its adoption.

And on that motion, a vote was taken resulting as follows:

(ROLL CALL 2)

The motion was lost.

Representative Nekritz offered Amendment No. 2 and moved its adoption.

And on that motion, a vote was taken resulting as follows:

5, Yeas; 62, Nays; 0, Answering Present.

(ROLL CALL 3)

The motion was lost.

There being no further amendments, the bill was ordered held on the order of Second Reading.

HOUSE BILL 1165. Having been reproduced, was taken up and read by title a second time.

Representative Nekritz offered Amendment No. 1 and moved its adoption.

And on that motion, a vote was taken resulting as follows:

1, Yea; 66, Nays; 0, Answering Present.

(ROLL CALL 4)

The motion was lost.

There being no further amendments, the bill was ordered held on the order of Second Reading.

HOUSE BILL 1166. Having been reproduced, was taken up and read by title a second time.

Representative Nekritz offered Amendment No. 1 and moved its adoption.

And on that motion, a vote was taken resulting as follows:

3, Yea; 61, Nays; 0, Answering Present.

(ROLL CALL 5)

The motion was lost.

There being no further amendments, the bill was ordered held on the order of Second Reading.

ACTION ON MOTIONS

Pursuant to Rule 18(g), Representative Bill Mitchell moved for unanimous consent to discharge the Committee on Rules from further consideration of HOUSE BILL 28 and requested a record vote on the motion.

Representative Currie was recognized and announced her opposition to the motion.

The Chair ruled that a record vote was not necessary because the motion was already lost due to the denial of unanimous consent.

Representative Bill Mitchell moved to appeal from the ruling of the Chair regarding the request for a record vote on the Motion to Discharge.

The Chair ruled that the Motion was out of order.

HOUSE BILLS ON THIRD READING

The following bills and any amendments adopted thereto were reproduced. These bills have been examined, any amendments thereto engrossed and any errors corrected. Any amendments still pending upon the passage or defeat of a bill on Third Reading are automatically tabled pursuant to Rule 40(a).

On motion of Representative Zalewski, HOUSE BILL 99 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote:

115, Yeas; 1, Nay; 0, Answering Present.

(ROLL CALL 6)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of Representative Chapa LaVia, HOUSE BILL 105 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote:

70, Yeas; 47, Nays; 0, Answering Present.

(ROLL CALL 7)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of Representative Zalewski, HOUSE BILL 181 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 117, Yeas; 0, Nays; 0, Answering Present.

(ROLL CALL 8)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of Representative Lang, HOUSE BILL 183 was taken up and read by title a third time.

Representative Durkin was recognized for a parliamentary inquiry regarding the applicability of extraordinary vote requirements for certain limitations on home rule units of local government.

The Chair ruled that a vote of a majority of the members elected (60 votes) was required for the passage of the bill.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 102, Yeas; 13, Nays; 1, Answering Present.

(ROLL CALL 9)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of Representative Mayfield, HOUSE BILL 167 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 106, Yeas; 11, Nays; 0, Answering Present.

(ROLL CALL 10)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of Representative Jackson, HOUSE BILL 192 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 80, Yeas; 37, Nays; 0, Answering Present.

(ROLL CALL 11)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of Representative Chapa LaVia, HOUSE BILL 194 was taken up and read by title a third time.

Pending discussion, D'Amico moved the previous question.

And the question being, "Shall the main question be now put?" it was decided in the affirmative.

The question then being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 95, Yeas; 22, Nays; 0, Answering Present.

(ROLL CALL 12)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of Representative Moffitt, HOUSE BILL 956 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 117, Yeas; 0, Nays; 0, Answering Present.

(ROLL CALL 13)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

On motion of McAsey, HOUSE BILL 958 was taken up and read by title a third time.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 117, Yeas; 0, Nays; 0, Answering Present.

(ROLL CALL 14)

This bill, having received the votes of a constitutional majority of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate and ask their concurrence.

SENATE BILLS ON FIRST READING

Having been reproduced, the following bill was taken up, read by title a first time and placed in the Committee on Rules: SENATE BILL 26 (Feigenholtz).

HOUSE JOINT RESOLUTIONS CONSTITUTIONAL AMENDMENTS FIRST READING

Representative Brown introduced the following:

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 31

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article V of the Illinois Constitution by changing Sections 1, 3, 7, and 18 and by repealing Section 17 as follows:

ARTICLE V

THE EXECUTIVE

SECTION 1. OFFICERS

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, and Comptroller of the Treasury ~~Comptroller and Treasurer~~ elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office. (Source: Illinois Constitution.)

SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, or Comptroller of the Treasury ~~Comptroller or Treasurer~~, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election. (Source: Illinois Constitution.)

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, or Comptroller of the Treasury ~~Comptroller or Treasurer~~ fails to qualify or if the ~~his~~ office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if the ~~his~~ office becomes vacant, it shall remain vacant until the end of the term. (Source: Illinois Constitution.)

SECTION 17. COMPTROLLER - DUTIES (REPEALED)

~~The Comptroller, in accordance with law, shall maintain the State's central fiscal accounts, and order payments into and out of the funds held by the Treasurer.~~ (Source: Illinois Constitution.)

SECTION 18. COMPTROLLER OF THE TREASURY ~~TREASURER~~ - DUTIES

The Comptroller of the Treasury ~~Treasurer~~, in accordance with law, shall (i) maintain the State's central fiscal accounts, and order payments into and out of the funds held by him or her, (ii) be responsible for the safekeeping and investment of monies and securities deposited with him or her, and for their disbursement upon his or her order, and (iii) have the duties and powers that may be prescribed by law ~~of the Comptroller~~. (Source: Illinois Constitution.)

SCHEDULE

A Comptroller of the Treasury, but not a Comptroller or Treasurer, shall be elected in 2018 and thereafter. This Constitutional Amendment otherwise takes effect upon the conclusion of the terms of the Comptroller and the Treasurer elected in 2014.

The foregoing HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 31 was taken up, read in full a first time, ordered reproduced and placed in the Committee on Rules.
