HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 214

Offered by Representative Hoffman:

WHEREAS, The Southwestern Illinois Flood Prevention District Council annually expends substantial sums in the purchase of construction goods and services on projects that are part of the regional levee system improvement project, known as the Southwestern Illinois Flood Prevention Project; and

WHEREAS, The Southwestern Illinois Flood Prevention Project is primarily being built using public tax dollars, as authorized by the Illinois General Assembly and the county boards of Madison, St. Clair, and Monroe counties; and

WHEREAS, Those expenditures constitute a major investment in the future of southwestern Illinois, and the Southwestern Illinois Flood Prevention District Council will compete in the private marketplace for these construction goods and services; and

WHEREAS, The Southwestern Illinois Flood Prevention Project is an urgent priority for the region because of the impact on public safety and the area's economy; and

WHEREAS, Because of the urgent nature of the Southwestern Illinois Flood Prevention Project, the Council desires to take all necessary steps to minimize any delay in the construction of the project; and

WHEREAS, Time lost due to labor conflicts and jurisdictional disputes can cause serious delays in the completion of the project and consequently cause an increase in the cost of the construction project; and

WHEREAS, There are trade unions that are recognized by the National Labor Relations Board, and which have as their primary duties the negotiation of wages and hours, no-strike agreements, and other matters on behalf of their members; the unions also have control of the apprenticeship of new members and the continued training of current members; and

WHEREAS, Project Labor Agreements can be of economic benefit to property owners, including states and their political subdivisions, for their major construction projects (including a complex interrelated series of projects), particularly those which extend for a substantial period of time and involve a substantial number of construction contractors and subcontractors or a substantial number of construction trades and specialized craft workers; and

WHEREAS, Project Labor Agreements can facilitate the timely and efficient completion of the regional levee system improvement project by making available a ready and adequate supply of highly trained and skilled craft workers; permitting public and private owners and contractors to more accurately predict project labor costs at the bidding stage; establishing working conditions for all construction crafts for the duration of the project; and providing a legally enforceable means of assuring labor stability and labor peace over the

life of such project, thereby reducing the possibility of interruptions and delays resulting from labor disputes; and

WHEREAS, The generally short-term nature of employment in the construction industry makes post-hire collective bargaining difficult and unrealistic; and

WHEREAS, The Board of Directors of the Southwestern Illinois Flood Prevention District Council has adopted a resolution requiring contractors working on the Project and paid with local tax dollars to enter into Project Labor Agreements; and

WHEREAS, If work is to be done on the Project by the United States Army Corps of Engineers, there is a substantial required local cost-share that will be provided from the proceeds of the local sales tax authorized by the Illinois General Assembly; and

WHEREAS, The President of the United States has issued Executive Order 13502 to "encourage executive agencies to consider requiring the use of project labor agreements in connection with large-scale construction projects in order to promote economy and efficiency in Federal procurement"; and

WHEREAS, The National Labor Relations Act allows for a collective bargaining agreement between a labor organization and an employer in the construction industry relating to the contracting or subcontracting of work to be done at the site of the construction, alteration, painting, or repair of a building, structure, or other work; and

WHEREAS, The courts have upheld the right of states and their subdivisions, as proprietors, to enter into construction contracts, with project managers or general contractors, that contain Project Labor Agreement provisions, and those courts have found that Project Labor Agreement provisions are not preempted by the National Labor Relations Act, the Employee Retirement Income Security Act, or the Sherman Anti-Trust Act, or by the Equal Protection or Due Process Clauses of the 14th Amendment; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge organizations that are entering into construction contracts for work on the Southwestern Illinois Flood Prevention Project, where that work is paid for wholly or partially with public tax dollars, to require contractors to sign and use Project Labor Agreements for those projects; and be it further

RESOLVED, That this resolution is to apply to work done by the United States Army Corps of Engineers on the Southwestern Illinois Flood Prevention Project.

HOUSE RESOLUTION 215

Offered by Representative Flowers:

WHEREAS, The State of Illinois has an interest in encouraging and promoting the development of agriculture, commerce, and industry, for the benefit of all Illinois residents; and

WHEREAS, Access to credit, guided by sound lending policies tailored to Illinois' unique natural resources and infrastructure, and its position within the national and world economies, is essential to the growth of all sectors of the Illinois economy; and

WHEREAS, In addition to the role of private lenders in restoring prosperity to Illinois, there is also a role for government to play in the revitalization of all sectors of the Illinois economy; therefore, be it

Two members of the General Assembly and 2 members of the public knowledgeable about the State's banking sector and economy, appointed by the Minority Leader of the House of Representatives;

The Governor, or his or her designee; the State Treasurer, or his or her designee; the Director of the Department of Commerce and Economic Opportunity, or his or her designee; the Director of the Division of Financial Institutions within the Department of Financial and Professional Regulations, or his or her designee; and the Director of the Department of Revenue, or his or her designee; and be it further

RESOLVED, That the members of the Commission shall serve without compensation, but may be reimbursed for actual expenses from funds appropriated for that purpose; and be it further

RESOLVED, That the chair of the Commission, in his or her discretion, may appoint, as additional non-voting members of the Commission, representatives of units of local government, experts in public finance or the Illinois economy, and other interested parties; and be it further

RESOLVED, That the Commission shall review and evaluate the creation of an Illinois State Bank that would:

- (1) purchase, guarantee, or hold loans made by community banks, credit unions or other financial institutions doing business in Illinois;
- (2) provide a secondary market for residential loans and mortgages, and other loans, made by financial institutions doing business in Illinois;
- (3) make loans in the form of participation loans with Illinois community banks to qualified individuals and businesses residing in or doing business in Illinois when the originator of the loan is a community bank, credit union, or other financial institution;
- (4) serve as a banker's bank for Illinois chartered banks by providing correspondent banking services and other related services in keeping with its mission;
- (5) accept deposits related to such transactions from banks and other financial institutions; and
- (6) be authorized to issue bank stock loans to Illinois chartered banks; and be it further

RESOLVED, That in making its review and evaluation, the Commission shall consider that the mission of an Illinois State Bank would include:

- (1) supporting the economic development of the State by increasing access to capital for agriculture, businesses, and industry within the State in partnership with local financial institutions;
- (2) providing stability to the local financial sector without entering into competition with community banks, credit unions, or other financial institutions;
- (3) reducing the costs paid by the State for basic banking services; and
- (4) returning profits, beyond those necessary to accomplish the mission and sound operations of the Bank, to the General Revenue Fund of the State; and be it further

RESOLVED, That in making its review and evaluation, the Commission shall consider relevant factors to its mission, including, but not limited to:

- (1) the operation and impact of the Bank of North Dakota;
- (2) whether other states have state banks or are currently considering the creation of a state bank;
- (3) the effectiveness and usefulness of existing state banks, with specific attention to the economic impact of having a state bank;
- (4) determine the costs and revenues associated with the Bank of North Dakota and any other existing state banks;
- (5) estimate the short-term operating costs and projected revenues of an Illinois State Bank; and
- (6) examine the long-term impact on the economy, job creation, and state revenue of having a state bank; and be it further

RESOLVED, That the Commission shall make its report to the General Assembly and the Governor on or before December 31, 2013. The report of the Commission shall detail those findings and recommendations supported by a majority of the voting members.
