HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 270

Offered by Representative Bellock:

WHEREAS, Autism spectrum disorders can affect all individuals regardless of racial, ethnic, economic, and social groups; and

WHEREAS, About 1 in 6 children in the United States had a developmental disability in the period of 2006-2008, ranging from mild disabilities such as speech and language impairments to serious developmental disabilities, such as intellectual disabilities, cerebral palsy, and autism; and

WHEREAS, Autism spectrum disorders are more common than pediatric cancer, diabetes, and AIDS combined; and

WHEREAS, Studies in Asia, Europe, and North America have identified individuals with an autism spectrum disorder, with an average prevalence of about 1%; a recent study in South Korea reported a prevalence of 2.6%; and

WHEREAS, About 1 in 88 children has been identified with an autism spectrum disorder, according to estimates from CDC's Autism and Developmental Disabilities Monitoring Network; and

WHEREAS, The cause of autism spectrum disorders is still unknown, but research strongly suggests that it is caused by certain factors that affect brain development; and

WHEREAS, Autism spectrum disorders have increased tenfold in the last decade and now occurs in some form in 1 in 54 boys in the United States; and

WHEREAS, Autism, which is five times more common among boys than girls, usually appears during the first three years of life; and

WHEREAS, Early diagnosis, research, training, education, and therapies are vital to reducing the effects of autism; and

WHEREAS, Current research suspects that there is not a single cause that will ultimately be discovered, but rather a cluster of factors which include genetics, pregnancy/birth complications, viral infections, metabolic disorders, congenital anomaly syndrome (birth defects), and environmental toxins; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the date of April 17, 2013 as Autism Day in the State of Illinois for the purpose of urging both government entities and the citizenry to become aware and educated on the subject of autism spectrum disorders.

HOUSE RESOLUTION 271

Offered by Representative Flowers:

WHEREAS, Alpha Kappa Alpha Sorority, Incorporated, founded on the campus of Howard University in 1908 and incorporated in 1913, has established a mandate for carrying out the vision of a new day of excellence and performance; and

WHEREAS, Alpha Kappa Alpha's mission of "Service to All Mankind" began at its inception; the sorority has remained at the forefront of positive change in American life, particularly in the African-American community, for 105 years; and

WHEREAS, Many prominent women have been or are members of Alpha Kappa Alpha Sorority, Inc., including the late First Lady Eleanor Roosevelt, the late civil rights leaders Coretta Scott King and Rosa Parks, actress Phylicia Rashad, poet Maya Angelou, writer Toni Morrison, singer Alicia Keys, attorney Star Jones, financial expert Mellody Hobson, comedian/actress Wanda Sykes, actress Jada Pinkett-Smith, congresswoman Eddie Bernice Johnson, former U.S. Secretary of Energy Hazel O'Leary, congresswoman Sheila Jackson Lee, Cook County Recorder of Deeds Karen Yarbrough, and CNN reporter Suzanne Malveaux; and

WHEREAS, Many members of the General Assembly and legislative staff are members of Alpha Kappa Alpha Sorority, Inc., including Senator Mattie Hunter, Senator Toi Hutchinson, Representative Monique Davis, India Hammons, and Nia Odeoti-Hassan, who serves as the Illinois State Connection Coordinator in the Central Region under the leadership of Regional Director Dr. Gisele M. Casanova; and

WHEREAS, The 2010-2014 Alpha Kappa Alpha Sorority, Inc., administration, under the leadership of attorney Carolyn House Stewart, continues to fulfill the service imperative of the founders with the theme, "Global Leadership Through Timeless Service", and the "Collaboration, Advocacy, Registration, Education and Stimulation (C.A.R.E.S.) Program Through Global Leadership and Timeless Service"; and

WHEREAS, Alpha Kappa Alpha Sorority Inc.'s signature program, the Emerging Young Leaders (EYL), will impact 10,000 girls in grades 6 through 8 by providing leadership development, civic engagement, enhanced academic preparation, and character building; the program is implemented by all 90 AKA chapters of the Central Region, which consists of Illinois, Indiana, Missouri (St. Louis and Cape Girardeau), Minnesota, Wisconsin, North Dakota, South Dakota, and Kentucky; young women from the Illinois programs will be a part of the day at the Capitol on May 15, 2013; and

WHEREAS, Alpha Kappa Alpha's storied history of proven leadership and extensive involvement in the world community through strategic partnerships evidence the sorority's potential to significantly contribute to the world community; and

WHEREAS, Leadership development is essential to the vitality of the organization, and the sorority's continuing requirements of academic excellence, shared values, and dedication to the mission of Alpha Kappa Alpha ensure a continuous wellspring of quality leaders; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the date of May 15, 2013 as Alpha Kappa Alpha Day in the State of Illinois in honor of Alpha Kappa Alpha Sorority, Incorporated, and its work; and be it further

RESOLVED, That suitable copies of this resolution be provided to the sorority for presentation to attorney Carolyn House Stewart, International President; Dr. Gisele M. Casanova, Central Regional Director; Kiahna Davis, Central Regional Representative to the International Connection Committee; and attorney Leyser Hayes, International Chair of the Connection Committee.

HOUSE RESOLUTION 273

Offered by Representative Meier:

WHEREAS, Governor Pat Quinn has announced his intention to transition care from State Operated Developmental Centers; as part of that initiative, he has proposed the closure of the Warren G. Murray Developmental Center; and

WHEREAS, On April 19 2013, Governor Quinn announced that residents of the Warren G. Murray Developmental Center will begin moving out of the facility; and

WHEREAS, The Warren G. Murray Developmental Center has provided exceptional care to its residents since 1964; and

WHEREAS, The Warren G. Murray Developmental Center serves as the home to more than 275 severely developmentally-disabled individuals, many of whom cannot function on their own or without constant care; and

WHEREAS, The closure of the Warren G. Murray Developmental Center would result in the displacement of 276 residents and directly impacting the lives of 225 families; and

WHEREAS, The State of Illinois does not have viable alternative options of care for the residents upon their displacement; and

WHEREAS, The State has begun a study of the results of the closure of the Jacksonville Developmental Center; and

WHEREAS, The Department of Human Services has not had the time to observe and track the progress of former residents of the Jacksonville Developmental Center; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to stop the closure process of the Warren G. Murray Developmental Center; and be it further

RESOLVED, That we request that the Governor complete and review the study of the closure of the Jacksonville Developmental Center before the process of closing other State Operated Developmental Centers begins; and be it further

RESOLVED, That suitable copies of this resolution is presented to the Governor and to the Secretary of the Department of Human Services.

HOUSE RESOLUTION 275

Offered by Representative Walsh:

WHEREAS, The two bombings that occurred on April 15, 2013 during the running of the 117th Boston Marathon represent a terrible tragedy and horrific act of terrorism against the United States; and

WHEREAS, The people of the State of Illinois mourn those who lost their lives or were wounded during the attacks; and

WHEREAS, Police officers, firefighters, members of the National Guard, emergency medical personnel, and other first responders acted heroically in responding to the attacks, preventing additional loss of life; and

WHEREAS, The residents of Massachusetts are a resilient people and will recover from this tragedy; and

WHEREAS, The people of the United States will always remember the victims of the previous acts of terrorism that have occurred in the United States and will always stand together as one people; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn the senseless attack in Boston, Massachusetts, on April 15, 2013; and be it further

RESOLVED, That we offer our heartfelt sympathy and condolences to the victims' families and wish the best for those who are recovering from their injuries; and be it further

RESOLVED, That we honor the heroic efforts of the medical personnel who are tirelessly providing care for the victims of this horrific act of violence and show our admiration for the courage of the first responders and the many citizen heroes who aided the injured and tended to the community; and be it further

RESOLVED, That we affirm that the citizens of this State stand proud with the City of Boston, the people of Massachusetts, and all Americans as we rise up from this tragedy and stand together as patriots.

HOUSE RESOLUTION 279

Offered by Representative Golar:

WHEREAS, Behavioral healthcare disparities exist across Illinois; these disparities include underserved populations with behavioral healthcare needs as one of their acute or chronic conditions; and

WHEREAS, Behavioral healthcare disparities include racial, ethnic, and rural behavioral health disparities and underserved or professional shortage areas; and

WHEREAS, The mental well-being of young people and their ability to not use alcohol or other drugs is strongly linked to their academic success; helping students stay healthy is a fundamental mission of schools; and

WHEREAS, According to the United States Surgeon General, approximately 50% of children with emotional disturbances and behavioral disturbances drop out of school; and

WHEREAS, According to the Centers for Disease Control, suicides are among the leading cause of death for people 15-54 years of age; and

WHEREAS, County coroners in Illinois report that, in some counties, the suicide rate has doubled since 2002, while, in other counties, the suicide rate has increased in recent years; and

WHEREAS, According to the Department of Defense Annual Suicide Report, suicides in the military started climbing considerably in 2005; this trend has not abated in recent years; and

WHEREAS, Cook County Jail is the largest "mental institution" in the State, due to its active inpatient psychiatric population; there are over 1,700 people on psychotropic medication for treatment of bipolar disorder, clinical depression, and schizoaffective disorder in the jail; and

WHEREAS, In Cook County Jail, 80% of the women there have a chronic mental illness; 80% of the women in that jail are the sole caretakers of their children; and

WHEREAS, Illinois courts, municipal and county jails, and the juvenile justice system have direct contact with many individuals who could be diverted away from these systems if behavioral healthcare services were available to them; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor to seek to empower and engage individuals and communities where behavioral healthcare disparities exist through the use of incentives, education, outreach, technology, and innovation; and be it further

RESOLVED, That we further urge the administration to work with the 98th General Assembly to establish Behavioral Healthcare Enterprise Zones (BHEZs); BHEZs, modeled after economic enterprise zones, should be established in areas with significant behavioral health disparities, poor access to behavioral healthcare, high rates of trauma, or acute or chronic behavioral healthcare illnesses; primary care physicians and behavioral healthcare clinicians should be encouraged to practice in BHEZs through a range of incentives, including loan repayment assistance, tax credits, and assistance in installing health information technology; and be it further

RESOLVED, That we further urge the administration to establish Behavioral Healthcare Loan Repayment Assistance initiatives, in which behavioral healthcare professionals would be encouraged to practice through a range of incentives to include loan repayment assistance; the initiatives should include eligibility requirements, in which clinicians would have to participate in the Medicaid program and meet voluntary standards for community service; community-based organizations should be urged to apply to create the zones and proposals with matching funding should be given priority; and be it further

RESOLVED, That we further encourage the administration to call on the Department of Human Services, in collaboration with the Department of Healthcare and Family Services, to identify a method to establish pilot programs for health homes, systems of care, and essential community behavioral healthcare providers to address the racial, ethnic, and rural behavioral health disparities, underserved populations, and underserved areas or professional shortage designated areas; and be it further

RESOLVED, That we further encourage the administration to include a standardized collection and analysis of data on the impact on racial, ethnic, and rural healthcare disparities, underserved populations, and underserved or professional shortage designated areas in the Department of Human Services data collection process; and be it further

RESOLVED, That we further encourage the administration to create an Illinois Behavioral Health Innovation Prize that would provide public recognition for a new intervention or program that successfully reduces or eliminates behavioral healthcare disparities; the prize should broaden the scope of community participation and discover new solutions that can be duplicated and employed throughout the State; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Pat Quinn and the Secretary of the Department of Human Services.

HOUSE RESOLUTION 280

Offered by Representative Hernandez:

WHEREAS, No resident of Illinois should have to be food-insecure; and

WHEREAS, 1,932,580, or 1 in 7 residents of the State of Illinois are experiencing food insecurity, meaning they lack access to adequate nutritious food for a healthy lifestyle; and

WHEREAS, 684,960, or just over 1 in 5 children in the State of Illinois are experiencing food insecurity; and

WHEREAS, Food insecurity is experienced in every county in the State of Illinois; and

WHEREAS, Hunger increases health care costs, lowers workers' productivity, harms children's development, and diminishes children's educational performance; and

WHEREAS, Fighting hunger is a public-private partnership; in Illinois, a strong private network exists that has provided 1.4 million people in Illinois with more than 127 million pounds of food in 2010; however, private charity cannot do it alone and a strong federal hunger relief safety net is required; and

WHEREAS, The Supplemental Nutrition Assistance Program (SNAP), the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC), The Emergency Food Assistance Program (TEFAP), the Older Adult Congregate Dining and Home Delivered Meals, The Free and Reduced School Breakfast and Lunch Program, the Summer Feeding Supplemental Program (SFSP), the Child and Adult Care Food Program (CACFP), and the Commodity Supplemental Food Program (CSFP) are all important pieces to the federal food and nutrition safety net that require State engagement and support; and

WHEREAS, SNAP is the cornerstone of the nutrition safety net, with 2 million, or 1 in 6, Illinois residents enrolled in the program; just under half of those utilizing the program are children; and

WHEREAS, Any reduction in funding of or change in policy that seeks to exclude individuals from participating in the SNAP Program will increase the number of food-insecure people in Illinois; and

WHEREAS, Threats to the federal food and nutrition safety net, including SNAP, exist in both the reauthorization of the Farm Bill and the annual federal budget process; and

WHEREAS, Attempts to change State policy for federal food and nutrition programs, including SNAP, can have harmful effects on the food insecure; and

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to develop the 2013 Farm Bill with a strong Title IV that protects and strengthens federal food and nutrition programs; and be it further
