HOUSE RESOLUTIONS

HOUSE RESOLUTION 804

Offered by Representative Hatcher:

WHEREAS, Veterans have served valiantly and honorably in defense of the United States and have put their lives on the line in order to defend America's beliefs and freedoms; and

WHEREAS, Veterans' Day is a National holiday held every year on November 11th and honors the people who have served as a part of any branch of the United States Armed Forces in defense of the United States of America, which allows the freedom and liberty we practice every day; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that in order to educate the students of Illinois about the sacrifices made for freedom on behalf of the country and the values on which this country was founded, we encourage each school year during the week in which Veterans' Day occurs, that all students in kindergarten through eighth grade attend an assembly during the school day to honor the history and importance of Veterans' Day; and be it further

RESOLVED, That school districts are encouraged to consult with local veterans' groups on the content of the assembly; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the superintendent of each school district within the State.

HOUSE RESOLUTION 805

Offered by Representative Durkin:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Rules of the House of Representatives of the 98th General Assembly are amended by adding Rule 37.7 as follows:

(House Rule 37.7 new)

37.7. Consideration of Bills On or After Date of General Election.

(a) From the Tuesday following the first Monday of November in even-numbered years until adjournment sine die, no bill may be moved from the order of Second Reading to the order of Third Reading unless a motion to approve such measure for consideration has been adopted by a record vote of 71 members. If such a bill is on the order of concurrence or in the form of a conference committee report, no motion to concur or to adopt that conference committee report is in order unless a motion to approve such measure for consideration has been adopted by a record vote of 71 members. Nothing in this House Rule shall be deemed to alter the vote requirement for final passage of a legislative measure required by the Illinois Constitution.

(b) Any motion made pursuant to subsection (a) to approve a legislative measure for consideration must be in writing. Upon receipt of the written motion, the Clerk shall immediately notify the Speaker and the Minority Leader. The motion shall not be referred to a committee. The motion must be carried on the calendar before it may be taken up by the House and may then be immediately considered and adopted by the House. The motion is renewable and may be reconsidered, provided that once that motion is adopted, it shall not be reconsidered.

(c) Notwithstanding any other provision of these House Rules, any resolution proposing to amend or delete this Rule requires the affirmative vote of 71 members elected for adoption by the House. This Rule may not be suspended except by unanimous consent.

HOUSE RESOLUTION 807

Offered by Representative Senger:

WHEREAS, The federal Patient Protection and Affordable Care Act was signed into law by President Barack Obama on March 23, 2010; and

WHEREAS, The Obama administration has hired thousands of marketers and members of community organizations to educate and assist consumers with the Obamacare enrollment process; and

WHEREAS, These new government employees tasked with helping consumers understand the law and the insurance coverage provisions in the new health insurance marketplace are known as "navigators"; and

WHEREAS, The State of Illinois has given out more than \$36 million in federal taxpayer dollars to dozens of community groups in Illinois to hire temporary workers as navigators; and

WHEREAS, There are over 1,200 navigators in Illinois, many with no background in health insurance and limited training; and

WHEREAS, Since open enrollment began in October of 2013, there have been serious questions raised about the qualifications of navigators and the necessity of the program overall; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Department of Insurance to conduct a thorough review of the navigator program and its performance in enrolling previously uninsured Illinois citizens; and be it further

RESOLVED, That the Department of Insurance report those findings to the General Assembly at the earliest convenience; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Illinois Department of Insurance Director Andrew Boron and Governor Pat Quinn.

HOUSE RESOLUTION 813

Offered by Representative Smith:

WHEREAS, In an effort to crack down on fraud, the General Assembly passed into law regulations restricting which citizens with disabilities may park at meters for free; and

WHEREAS, Some citizens with disabilities that no longer qualify for free parking are having difficulty physically using the meters; many with disabilities do not move very quickly and have a harder time making it back to their vehicles in time to move their car or feed the meter; and

WHEREAS, There are very few spots reserved specifically for disabled drivers in many areas of the State, especially in downtown Chicago; and

WHEREAS, Many citizens with disabilities are on fixed incomes and have difficulties being able to pay for parking, especially with the expensive parking rates in Chicago; and

WHEREAS, The Secretary of State's office currently has a program for reduced license plate fees for citizens with disabilities and the Regional Transit Authority currently has a program that allows passengers with disabilities to ride for free; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Secretary of State's office to review the current policies regarding meter parking for those with disabilities, and we encourage them to work with qualified medical professionals, advocates, and citizens with disabilities to consider various options to make meter parking more affordable and accessible for a greater number of citizens with disabilities, including possibly re-instating free parking or reduced parking for the disabled; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Secretary of State Jesse White.

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 44**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article V of the Illinois Constitution by changing Sections 1, 3, 7, and 18 and by repealing Section 17 as follows:

ARTICLE V
THE EXECUTIVE

SECTION 1. OFFICERS

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, ~~and Comptroller of the Treasury Comptroller and Treasurer~~ elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office. (Source: Illinois Constitution.)

SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, ~~or Comptroller of the Treasury Comptroller or Treasurer~~, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election. (Source: Illinois Constitution.)

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, ~~or Comptroller of the Treasury Comptroller or Treasurer~~ fails to qualify or if ~~the his~~ office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if ~~the his~~ office becomes vacant, it shall remain vacant until the end of the term. (Source: Illinois Constitution.)

SECTION 17. COMPTROLLER - DUTIES (REP)

~~The Comptroller, in accordance with law, shall maintain the State's central fiscal accounts, and order payments into and out of the funds held by the Treasurer.~~ (Source: Illinois Constitution.)

SECTION 18. COMPTROLLER OF THE TREASURY TREASURER - DUTIES

The ~~Comptroller of the Treasury Treasurer~~, in accordance with law, shall (i) maintain the State's central fiscal accounts, and order payments into and out of the funds held by him or her, (ii) be responsible for the safekeeping and investment of monies and securities deposited with him or her, and for their disbursement upon his or her order, and (iii) have the duties and powers that may be prescribed by law of the Comptroller. (Source: Illinois Constitution.)

SCHEDULE

A Comptroller of the Treasury, but not a Comptroller or Treasurer, shall be elected in 2018 and thereafter. This Constitutional Amendment otherwise takes effect upon the conclusion of the terms of the Comptroller and the Treasurer elected in 2014.

The foregoing HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 44 was taken up, read in full a first time, ordered reproduced and placed in the Committee on Rules.
