WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to individuals who gave their lives in the service of the State of Illinois; and

WHEREAS, Edgar County Deputy Sheriff John Dean Landrum gave his life in the line of duty on February 15, 1989 while responding to a domestic disturbance; and

WHEREAS, Deputy Sheriff Landrum was born January 12, 1937 in Centralia to John Paul and Irene B. (nee Wayman) Landrum; he married his loving wife, Kay Hamlin on June 26, 1958; and

WHEREAS, Deputy Sheriff Landrum graduated from Centralia High School in 1955 and from Kaskaskia Community College in 1957, where he earned a degree in drafting; and

WHEREAS, After earning his degree, Deputy Sheriff Landrum worked for the Seiger heating company in Centralia in 1957, for McDonald-Douglas in 1958 as a draftsman, and at TrailMobile in Charleston in the late 1970's; and

WHEREAS, Deputy Sheriff Landrum went to Lincoln Christian College where he earned a bachelor's degree in ministry in 1966; he served as a minister for one year at Keenes Christian Church in Keenes in 1966, as a house parent at Ladoga Children's home in Ladoga, Indiana in 1967-1970, at Edgar County

Children's Home in Paris, Illinois from 1970 until 1975, and as a minister at Pleasant Hill Christian Church in Kansas, Illinois from 1975-1986; and

WHEREAS, Deputy Sheriff Landrum served as an Auxiliary Deputy in the early 1970's for the Edgar County Sheriff's Department, and attended the police academy in Springfield from January 8th - February 15, 1979, graduating from class 258-08 as class president; and

WHEREAS, Deputy Sheriff Landrum served as Chief of police of Kansas, Illinois from 1977-1982; and

WHEREAS, Deputy Sheriff Landrum became a part-time deputy at Edgar County Sheriff's Department in 1982 and began serving full-time in 1987; and

WHEREAS, Deputy Sheriff Landrum's death left behind his wife, Kay (nee Hamlin) Landrum; his daughters, Cheryl Clark and Lisa Weilhammer; his sons, John W. Landrum, Curtis Landrum, and Chad Landrum; his 15 grandchildren; and his 5 great-grandchildren; and

WHEREAS, Deputy Sheriff Landrum courage will be remembered fondly by his loving family, his fellow officers, and all who knew him, and it is therefore fitting that we not forget Deputy Sheriff John Dean Landrum's sacrifice; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the section of US Route 150 from Paris, Illinois to the Indiana border as the "Deputy Sheriff John D. Landrum Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Deputy Sheriff John D. Landrum and the Secretary of the Illinois Department of Transportation, Ann L. Schneider.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 906

Offered by Representative Bellock:

WHEREAS, Someone develops Alzheimer's disease every 68 seconds; that number will increase to every 33 seconds by 2050; and

WHEREAS, Alzheimer's disease is on the rise, with more than 5.2 million Americans of all ages currently living with the disease; and

WHEREAS, Over \$140 billion is spent on Alzheimer's disease every year through Medicare and Medicaid; that number will rise to \$1.2 trillion in 2050; and

WHEREAS, Currently, over 210,000 people in Illinois live with the disease; there will be an estimated 14% increase in the next 11 years; and

WHEREAS, The Alzheimer's Association and the Centers for Disease Prevention's Healthy Aging Program have developed a Road Map to advance cognitive health as a vital, integral component of public health; and

WHEREAS, The Illinois Public Health Association and the Alzheimer's Association issue a call to action for an effective coordinated approach to moving cognitive health into public health practice and developing partnerships and assuring a competent workforce; and

WHEREAS, The impact of Alzheimer's and other dementia on Illinois families, the health care system, and society as a whole is of great importance; the need for home and community-based services for those with Alzheimer's is on the rise and caregiver stress is at an all-time high; and

WHEREAS, Alzheimer's disease is a looming public health crisis and the need to address cognitive health and to meet the needs of caregivers is growing daily; we call upon policymakers to join in the efforts to raise awareness, promote cognitive functioning and help meet the needs of caregivers and to acknowledge the hundreds of thousands of persons with Alzheimer's and other dementia in Illinois, their families, and caregivers; and

WHEREAS, On April 2, 2014, Alzheimer's and public health advocates will speak up for the needs and rights of persons with cognitive impairment; these advocates ask the Illinois General Assembly to make Alzheimer's disease a priority public health issue in the State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the date of April 2, 2014 as Annual Alzheimer's Association and Illinois Public Health Association Advocacy Day in the State of Illinois.

HOUSE RESOLUTION 916

Offered by Representative Bellock:

WHEREAS, Autism spectrum disorders can affect all individuals regardless of racial, ethnic, economic, and social groups; and

WHEREAS, About 1 in 6 children in the United States had a developmental disability in the period of 2006-2008, ranging from mild disabilities such as speech and language impairments to serious developmental disabilities, such as intellectual disabilities, cerebral palsy, and autism; and

WHEREAS, Autism spectrum disorders are more common than pediatric cancer, diabetes, and AIDS combined; and

WHEREAS, Studies in Asia, Europe, and North America have identified individuals with an autism spectrum disorder, with an average prevalence of about 1%; a recent study in South Korea reported a prevalence of 2.6%; and

WHEREAS, About 1 in 88 children has been identified with an autism spectrum disorder, according to estimates from CDC's Autism and Developmental Disabilities Monitoring Network; and

WHEREAS, The cause of autism spectrum disorders is still unknown, but research strongly suggests that it is caused by certain factors that affect brain development; and

WHEREAS, Autism spectrum disorders have increased tenfold in the last decade and now occurs in some form in 1 in 54 boys in the United States; and

WHEREAS, Autism, which is five times more common among boys than girls, usually appears during the first three years of life; and

WHEREAS, Early diagnosis, research, training, education, and therapies are vital to reducing the effects of autism; and

WHEREAS, Current research suspects that there is not a single cause that will ultimately be discovered, but rather a cluster of factors which include genetics, pregnancy/birth complications, viral infections, metabolic disorders, congenital anomaly syndrome (birth defects), and environmental toxins; therefore, be it
RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the date of April 17, 2014 as Autism Day in the State of Illinois for the purpose of urging both government entities and the citizenry to become aware and educated on the subject of autism spectrum disorders.

HOUSE RESOLUTION 917

Offered by Representative Bellock:

WHEREAS, Heroin is an illegal and highly addictive drug that is both the most abused and the most rapidly acting of the opiates; and

WHEREAS, Heroin was first synthesized in 1874 from morphine, a naturally occurring substance extracted from the seed pods of certain varieties of poppy plants; and

WHEREAS, Heroin is typically sold as a white or brownish powder or as the black sticky substance known as "black tar heroin"; and

WHEREAS, Although purer heroin is becoming more common, most heroin is "cut" with other drugs or with substances such as sugar, starch, and powdered milk, as well as strychnine or other poisons; and

WHEREAS, Because heroin abusers do not know the actual strength of the drug or its true contents, they are at risk of overdose and death; and

WHEREAS, Heroin also poses special problems because of transmission of HIV and other diseases that can occur from sharing needles or other injection equipment, and because of the medical and social consequences of abuse, including fetal effects, crime, violence, and disruptions to the family, workplace, and educational environments; and

WHEREAS, According to "Heroin Use in Illinois: A Ten-Year Multiple Indicator Analysis, 1998 to 2008", the Chicago metropolitan area ranked among the worst nationally for heroin-related problems, including ranking first in the number of individuals admitted to the emergency room for heroin abuse and first in the percentage of arrestees testing positive for heroin; and

WHEREAS, The study also found a large increase in deaths from heroin overdoses in the collar counties, including a 130% increase in Lake County from 2000 to 2009, a 150% increase in McHenry County in just a three-year period, a doubling of heroin-related deaths in Will County in a period of just two years, and a total of 78 heroin-related deaths in DuPage County over a three-year period, indicating that heroin remains a continuing problem in DuPage County; and

WHEREAS, The study also found the increase in suburban heroin abuse has resulted from increased heroin use among teens, including a 27% increase in suburban Cook County and a 46% increase in the collar counties; in 2008, over 100 individuals in the Chicago Metropolitan Area under the age of 35 died from heroin overdose; and

WHEREAS, Despite efforts to combat the use of heroin, DuPage County saw a record 45 confirmed heroin-related deaths in 2013; and

WHEREAS, Heroin has become the second most common drug after alcohol and the most common illegal substance for which individuals enter treatment in Illinois, compared to the fourth most common reason Illinoisans entered publicly-funded treatment in 1998; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-EIGHTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the citizens of the State of Illinois, especially the parents of Illinois youth, to become aware of the dangers associated with the use of heroin and the escalating number of accidental deaths due to heroin overdoses; and be it further

RESOLVED, That we find that comprehensive drug education programs, including the Drug Abuse Resistance Education (DARE) program, serve as valuable tools in presenting the facts and dangers related to heroin use to Illinois youth; and be it further

RESOLVED, That we designate the date of November 4, 2014 as Heroin Abuse Awareness Day in the State of Illinois.
