HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 195

Offered by Representative William Davis:

WHEREAS, Relations between the Republic of China (Taiwan) and the United States, in particular the State of Illinois, which shares sister-city and sister-state relationships, are marked by strong bilateral trade, educational and cultural exchanges, and tourism; and

WHEREAS, Taiwan, which is the world's 19th-largest economy, shares with the United States and the State of Illinois the common values of freedom, democracy, human rights, and a commitment to the rule of law; and

WHEREAS, As of 2014, Taiwan is the United States' 10th-largest trading partner in the world, with bilateral trade worth US \$67.4 billion, and is the United States' 14th-largest export market, with total U.S. exports worth US \$26.8 billion, and its 12th-largest source of imports; and

WHEREAS, Taiwan and the State of Illinois have enjoyed a long and mutually beneficial relationship and anticipate continuing growth, as Illinois in 2014 continued to rank 5th among all U.S. states in the value of overall exports to Taiwan, worth US \$940.13 billion, a 2% increase in value over its 2013 exports to

Taiwan; Taiwan ranks as Illinois' 15th-largest export market, its 6th-largest market in Asia, and its 9th-largest source of imports; and

WHEREAS, Taiwan has consistently imported between US \$2.5 billion and US \$3 billion of U.S. farm products annually and is the world's 2nd largest consumer per-capita of U.S. agricultural goods in 2013; the Illinois economy has greatly benefited from Taiwan's reliably large imports of Illinois farm products, which in 2014 were worth US \$578.4 million for agricultural products (US \$532.4 million) and food manufactures (US \$46 million) combined, together comprising 61.5% of Illinois' total exports to Taiwan that year; and

WHEREAS, Taiwan, in order to contribute to greater regional integration in the Asia-Pacific region and to further promote bilateral investment and trade relations with the United States, Taiwan's 2nd-largest trading partner, seeks to join the Trans-Pacific Partnership (TPP), the proposed 21st century trade agreement between the United States and currently 11 other Asia-Pacific Rim countries; the United States has announced its intention that membership in the TPP expand in the future to include other friendly countries, such as Taiwan; and

WHEREAS, Taiwan is the 19th-largest economy, the 20th-largest exporter, and the 18th-largest importer in the world, according to the 2013 World Trade Organization report; Taiwan also should be included in regional economic integration due to its status as an important economic power, a dynamic market economy, and leading supplier of high-tech products; and

WHEREAS, Taiwan ranks as the world's 14th-freest economy and the 8th freest in the Asian Pacific, according to the 2015 Index of Economic Freedom; Taiwan also ranks as the 13th-most competitive economy worldwide and the 6th most competitive in the Asian Pacific, according to the Swiss-based International Institute for Management Development's 2014 report; and

WHEREAS, Taiwan's admission to the U.S. Visa Waiver Program in November of 2012 has, as predicted, led to increased tourist and business travel from Taiwan, increasing more than 29% in the 8 months after Taiwan joined the Visa Waiver Program, according to the April 2014 testimony of U.S. State Department Assistant Secretary for East Asian and Pacific Affairs Daniel R. Russel, who acknowledged the Department's pleasure with the result as "foreign visitors to the United States generate stateside jobs"; moreover, travel by Taiwanese visitors to the United States remains higher than in prior years, having increased 33% in 2013 and 7% in the first half of 2014; and

WHEREAS, Negotiations for a bilateral investment agreement between Taiwan and the United States are an important step toward further strengthening bilateral trade and paving the way for entering into a free trade agreement between our 2 countries, thereby increasing Illinois's exports to Taiwan and creating bilateral investment and technical collaboration through tariff reduction and other trade facilitation measures; and

WHEREAS, Taiwan, as a full-fledged democracy that shares the same values of freedom, democracy, human rights, the rule of law, peace, and prosperity with the United States and the State of Illinois, should be allowed to participate appropriately in international organizations, such as the United Nations Framework Convention on Climate Change, so as to advance the welfare of the 23 million people of Taiwan and further contribute to the international community; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we reaffirm our commitment to the strong and deepening sister-city and sister-state relationships between Taiwan and the State of Illinois; and be it further

RESOLVED, That we reaffirm our continued support for Taiwan's efforts to secure entry to the Trans-Pacific Partnership to contribute to greater regional integration; and be it further

RESOLVED, That we reaffirm our continued endorsement of the signing of a bilateral investment agreement between Taiwan and the United States to promote Taiwan's bilateral investment and trade relations with the United States and facilitate its economic and other ties with Illinois and the individual states; and be it further

RESOLVED, That we reaffirm our support for Taiwan's participation in international organizations, such as the United Nations Framework Convention on Climate Change, that impact the health, safety, and well-being of Taiwan; and be it further

RESOLVED, That suitable copies of this resolution be presented to United States Secretary of State John F. Kerry, United Nations Framework Convention on Climate Change Executive Secretary Christiana Figueres, and the Taipei Economic and Cultural Office in Chicago.

Offered by Representative Hurley:

WHEREAS, Approximately 6.5 million people in the United States and 1% of the global population have an intellectual disability; and

WHEREAS, In the 1950s and early 1960s, Eunice Kennedy Shriver saw how unjustly and unfairly people with intellectual disabilities were treated and saw that many children with intellectual disabilities didn't even have a place to play; deciding to take action, she held a summer day camp for young people with intellectual disabilities in her backyard in order to learn what these children could do in sports and other activities and not dwell on what they could not do; and

WHEREAS, Throughout the 1960s, Eunice Kennedy Shriver continued her pioneering work, both as the driving force behind President John F. Kennedy's White House panel on people with intellectual disabilities and as the director of the Joseph P. Kennedy, Jr. Foundation; her vision and drive for justice eventually grew into the Special Olympics movement; and

WHEREAS, The Special Olympics strives to create a better world by fostering the acceptance and inclusion of all people; through the power of sports, people with intellectual disabilities discover new strengths and abilities, skills, and success and find joy, confidence and fulfillment on the playing field and in life; and

WHEREAS, The Special Olympics hosts a wide range of training sessions, competitions, health screenings, and fund-raising events for those with intellectual disabilities; the organization also creates opportunities for families, community members, local leaders, businesses, law enforcement, celebrities, dignitaries, and others to band together to change attitudes and support athletes; and

WHEREAS, Anne McGlone Burke, then a Chicago Park District instructor at West Pullman Park, received support from Mayor Richard J. Daley to pursue her vision to organize an event showcasing the abilities of her athletes; and

WHEREAS, On July 19-20, 1968, the first International Special Olympics Summer Games were held at Soldier Field in Chicago; a thousand people with intellectual disabilities from 26 U.S. states and Canada competed in track and field and swimming; and

WHEREAS, The Special Olympics mission of empowering those with intellectual disabilities through sport remains as vital today as it did when the movement was founded; the athletes, administration, and countless volunteers of the Special Olympics are worthy of the greatest respect; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate July of 2015 as Special Olympics Month in the State of Illinois in honor of this great organization and its goals; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Special Olympics as a symbol of our esteem and respect.

HOUSE RESOLUTION 199

Offered by Representative Moeller:

WHEREAS, On July 16, 2014, Jesse Vega, also known as Jesse Ortiz, escaped from Elgin Mental Health Center custody while being transported to a court hearing concerning criminal charges pending against him; and

WHEREAS, Vega was charged with aggravated domestic battery, aggravated battery causing great bodily harm, aggravated battery in a public place, obstructing justice, and aggravated driving under the influence with a suspended or revoked license; and

WHEREAS, Vega remained at large for 8 hours, placing the community in harm's way for an extended period of time; and

WHEREAS, At the time of the escape, Vega was accompanied by 3 security officers; he fled from the vehicle as it was stopped at a gas station in a residential neighborhood; and

WHEREAS, The safety of individuals residing, working, or traveling in our neighborhoods is of paramount concern; the public requires a full understanding of how this escape occurred so officials may take the necessary steps to help prevent any future escape; and

WHEREAS, This escape constitutes a breakdown in either the design or execution of the procedures governing the transportation of prisoners at the Elgin Mental Health Center; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we direct the Office of the Auditor General to conduct an investigation to examine the circumstances surrounding Vega's escape and evaluate whether prisoner transport procedures need to be improved at Elgin Mental Health Center or other State facilities; and be it further

RESOLVED, That we urge the administration of the Elgin Mental Health Center and all other institutions involved with this inquiry to make available all information to the Office of the Auditor General that may be necessary to their investigation; and be it further

RESOLVED, That the Office of the Auditor General shall present a report to the Illinois House of Representatives detailing the findings of its investigation and any recommendations for procedural reform, should they result from the investigation, not more than one year after the passage of this resolution; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, the Director of the Department of Human Services, the Director of the Department of Corrections, and the members of the Illinois congressional delegation.

HOUSE RESOLUTION 201

Offered by Representative Currie:

WHEREAS, The future of our nation's productivity and competitiveness in the global marketplace depends on the success of all men and women; and

WHEREAS, Women have been discriminated against in education, the workplace, and society as a whole; and

WHEREAS, Women continue to earn no more than 78 cents on the dollar compared to men; and

WHEREAS, The pay gap has been shown to start as soon as one year after college; this inequality affects not only women, but their families and society as a whole; and

WHEREAS, The pay gap between women and men has long-term effects on women's economic security; such a gap affects women's Social Security earnings, their ability to save for retirement, and their children's education; and

WHEREAS, Pay equity is closely linked to the eradication of poverty and is essential to having a highly-motivated workforce; and

WHEREAS, Equal Pay Day was originated by the National Committee on Pay Equity in 1996 as a public awareness event to illustrate the gap between men's and women's wages; the day, observed in April, symbolizes how far into the year a woman must work, on average, to earn as much as a man earned the previous year, with Tuesday being the day in which women's wages catch up to men's wages from the previous week; because women earn less on average than men, they must work longer for the same amount of pay; this wage gap is even greater for most women of color; and

WHEREAS, Equal pay is a priority for all women and for our society at large; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate April 14, 2015 as Pay Equity Day in the State of Illinois in order to raise awareness about this endemic inequity.

HOUSE RESOLUTION 203

Offered by Representative Cassidy:

WHEREAS, The nationally-recognized Alternative Schools Network runs many programs that assist at-risk youth, including the Youth Skills, Scholars, and Service and Project New Futures Programs; and

WHEREAS, The Youth Skills, Scholars, and Service Program educates and graduates over 300 Department of Children and Family Services high school dropouts annually; the program provides educational support and various services to these youth in order to provide a quality education and helps to prevent and reduce violence in Department of Children and Family Services wards; and

WHEREAS, The Project New Futures Program supported 130 older Department of Children and Family Services youth to successfully enter adulthood by providing the personal, consistent, and intense support they needed as they prepared to emancipate from Department of Children and Family Services; and

WHEREAS, The Department of Children and Family Services has recently cut \$1 million from the Alternative Schools Network's Youth Skills, Scholars, and Service Program by denying the organization the sub-contract that was needed to expand services for older Department of Children and Family Services youth; this funding cut also resulted in the elimination of the Project New Futures Program; and

WHEREAS, The Department of Children and Family Services is contractually obligated to refer youth that are appropriate for the Alternative Schools Network's Youth Skills, Scholars, and Service Program by their level of credits, skills, age, and motivation; and

WHEREAS, The Department of Children and Family Services has notified the Alternative Schools Network that the Youth Skills, Scholars, and Service Program should change from the grant-based program it has been in previous years into a fee-for-service program, a move that would undoubtedly affect many of the at-risk youth these programs seek to help; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Department of Children and Family Services to reinstate the funding for the Alternative Schools Network's Youth Skills, Scholars, and Service and Project New Futures Programs and to maintain the grant-based nature of the programs so that at-risk youth can receive the education and skills they need to be responsible and productive adults; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Director of the Department of Children and Family Services.

HOUSE RESOLUTION 204

Offered by Representative Kelly Burke:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a program audit of appropriations from the General Professions Dedicated Fund for Fiscal Years 2012, 2013, and 2014 for costs associated with the development, support, or administration of pharmacy practice education and training at Chicago State University, the University of Illinois, and Southern Illinois University; and be it further

RESOLVED, That the audit include, but not be limited to, the following determinations:

(1) the purposes for which the appropriations were used; and

(2) whether each university has performed any study or analysis of the need for pharmacists in the labor market and, in particular, in rural areas and whether that study or analysis demonstrates how the university's program meets any identified need; and be it further

RESOLVED, That Chicago State University, Southern Illinois University, the University of Illinois, the Board of Higher Education, and any other entity having information relevant to this audit cooperate fully and promptly with the Auditor General's office in the conduct of this audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and report his findings and recommendations upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Auditor General, the Board of Higher Education, and the Board of Trustees of Chicago State University, the University of Illinois, and Southern Illinois University.

HOUSE RESOLUTION 205

Offered by Representative Morrison:

WHEREAS, On May 13, 2013, a jury in a Philadelphia Court of Common Pleas convicted abortion provider Kermit Gosnell of 3 counts of first-degree murder in the deaths of infants born alive following attempted abortions and one count of involuntary manslaughter in the death of Karnamaya Mongar, a patient

who sought an abortion at Kermit Gosnell's abortion clinic, the Women's Medical Society in West Philadelphia; and

WHEREAS, On May 13, 2013, a jury in a Philadelphia Court of Common Pleas also convicted Kermit Gosnell of 21 counts of performing illegal late-term abortions and 210 counts of violating Pennsylvania's Abortion Control Act which, among other requirements, mandates a 24-hour reflection period before an abortion may be performed; and

WHEREAS, The report of the Grand Jury in the Court of Common Pleas, First Judicial District of Pennsylvania, Criminal Trial Division, certified on January 14, 2011, begins, "This case is about a doctor who killed babies and endangered women. What we mean is that he regularly and illegally delivered live, viable babies in the third trimester of pregnancy-and then murdered these newborns by severing their spinal cords with scissors. The medical practice by which he carried out this business was a filthy fraud in which he overdosed his patients with dangerous drugs, spread venereal disease among them with infected instruments, perforated their wombs and bowels-and, on at least two occasions, caused their deaths."; and

WHEREAS, The report of the Grand Jury detailed findings of dangerous and unsanitary conditions in the Women's Medical Society: "The clinic reeked of animal urine, courtesy of the cats that were allowed to roam (and defecate) freely. Furniture and blankets were stained with blood. Instruments were not properly sterilized. Disposable medical supplies were not disposed of; they were reused, over and over again. Medical equipment-such as the defibrillator, the EKG, the pulse oximeter, the blood pressure cuff-was generally broken; even when it worked, it wasn't used. The emergency exit was padlocked shut. And scattered throughout, in cabinets, in the basement, in a freezer, in jars and bags and plastic jugs, were fetal remains. It was a baby charnel house."; and

WHEREAS, The report of the Grand Jury described an "inexcusable" and "complete regulatory collapse" by the Pennsylvania Department of Health in inspecting, investigating, and appropriately sanctioning Kermit Gosnell and the Women's Medical Society; specifically, officials with the Pennsylvania Department of Health failed to perform routine inspections of the Women's Medical Society, refusing to inspect the clinic for years and even decades at a time, and failed to investigate specific and credible complaints against Kermit Gosnell and the Women's Medical Society; and

WHEREAS, The report of the Grand Jury detailed repeated complaints to the Pennsylvania Department of Health involving Kermit Gosnell and the Women's Medical Society: "Several different attorneys, representing women injured by Gosnell, contacted the Department. A doctor from Children's Hospital of Philadelphia hand-delivered a complaint, advising the Department that numerous patients he had referred for abortions came back from Gosnell with the same venereal disease. The medical examiner of Delaware County informed the Department that Gosnell had performed an illegal abortion on a 14-year-old girl carrying a 30-week-old baby. And the Department received official notice that a woman named Karnamaya Mongar had died at Gosnell's hands. Yet not one of these alarm bells-not even Mrs. Mongar's death-prompted the Department to look at Gosnell or the Women's Medical Society"; and

WHEREAS, The problem of dangerous and substandard conditions and practices at abortion clinics is not confined to Pennsylvania but extends to other states around the nation including Illinois; and

WHEREAS, In January 2012, the Associated Press and the Chicago Tribune reported that "(a)n increased scrutiny of Illinois abortion clinics in the wake of revelations about a 'house of horrors' in Philadelphia revealed that some facilities had gone up to 15 years without inspections, and two now have closed after regulators found health and safety violations. The renewed oversight by state regulators led to the permanent closure of a clinic in Rockford (in January 2012), following the closing of a clinic in suburban Chicago (in October 2011), according to documents obtained by The Associated Press through a Freedom of Information Act request"; and

WHEREAS, In 2011, The Women's Aid Clinic in Lincolnwood was inspected by the Illinois Department of Public Health; the clinic failed inspection and was fined \$36,000 for a multitude of violations by the State; the most egregious violation was for the clinic to fail in performing CPR on a patient who died following a procedure, the owner of the Women's Aid Clinic refused to pay the \$36,000 fine to the State and instead forfeited its license; and

WHEREAS, The abortion clinic in Lincolnwood is not the only clinic to have a major violation upon a Department of Public Health inspection; and

WHEREAS, In 2012, the Northern Illinois Women's Center in Rockford was inspected by the Illinois Department of Public Health which found numerous health and safety violations; these violation include, 3 of 3 operation rooms failed to ensure a sanitary environment, failure to prevent contamination of clean surgical equipment, gynecological cannulas were stained with a brown substance, shoes stored inside an open box of surgical gloves, autoclave equipment used to sterilize medical instruments failed biological testing on

at least 2 occasions, and failure to meet legal requirement for a qualified registered nurse to be present in the operation room during procedures; and

WHEREAS, The violations at the Northern Illinois Women's Center in Rockford were so severe the clinic announced it was closing its doors and would not be re-opening, this clinic had been in operation for over 40 years; and

WHEREAS, On July 20, 2012, Tonya Reaves, a 24-year-old mother of a one-year old son, entered an abortion clinic at 18 S. Michigan Avenue in Chicago; she was 16-weeks pregnant and, at 11 am that that morning, she underwent a dilation and evacuation ("D&E") abortion, an abortion procedure often performed in the second trimester which involves significantly more risk to the woman than earlier term abortions; while in recovery, Ms. Reaves suffered significant bleeding and, more than 5 hours after her abortion, she was finally rushed by ambulance to Northwestern Memorial Hospital; at Northwestern, doctors performed an ultrasound and discovered an incomplete abortion; in response, they performed a second ("D&E") procedure; however, Ms. Reaves continued to suffer pain and other complications; a second ultrasound was then performed and doctors learned that Ms. Reaves had suffered a "perforation"; she was taken into surgery where "an uncontrollable bleed" was discovered; an emergency hysterectomy was performed, but Ms. Reaves died at 11:20 pm; and

WHEREAS, An autopsy report released in early September 2012 confirmed that Ms. Reaves suffered from an incomplete abortion and that pieces of placenta were still attached to the inside of her uterus even after the second D&E procedure was performed at Northwestern; had a 3/16 inch perforation in her uterus near impression marks that appeared to have been made by forceps, instruments typically used during a D&E abortion; suffered an "extensive" perforation of her broad uterine ligament with the possible severing of her left uterine artery; and had one to one-and-a-half liters of blood and blood clots inside her abdominal cavity indicating that Ms. Reaves had bled about 30 percent of her total volume of blood into her abdomen following her abortion at the Michigan Avenue abortion clinic; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Illinois House of Representatives extends its condolences to the families of the victims of Kermit Gosnell and to the family of Tonya Reaves; and be it further

RESOLVED, That the Illinois House of Representatives condemns the criminal actions of Kermit Gosnell, the dangerous and substandard conditions at the Women's Medical Society in West Philadelphia, and the inexcusable dereliction of duty by the Pennsylvania Department of Health and other state officials in failing to properly inspect, investigate, and sanction Kermit Gosnell and the Women's Medical Society and to appropriately inspect other abortion clinics in the State of Pennsylvania; and be it further

RESOLVED, That the Illinois House of Representatives urges the Illinois Department of Public Health to pursue a regime of regular inspections of Illinois "pregnancy termination specialty centers" (abortion clinics) to ensure compliance with Illinois law governing those centers or clinics, specifically 77 Ill. Adm. Code 205.710, to ensure that centers or clinics failing to meet legally required and medically appropriate standards for patient care are either closed or comply, within an agreed upon time, with an approved plan to correct deficiencies, and to properly respond to and investigate complaints and other credible allegations it receives concerning conditions and conduct at these centers or clinics; and be it further

RESOLVED, That the Illinois House of Representatives urges the Illinois Department of Public Health to ensure that the provisions and intent of 1 U.S.C. 8 and Illinois' complementary statute, 5 ILCS 70/1.36, are properly enforced and respected and that "pregnancy termination specialty centers" (abortion clinics) are complying with these laws.

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 30**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Sections 4, 5, and 6 of Article IV and Section 2 of Article V of the Illinois Constitution as follows:

ARTICLE IV
THE LEGISLATURE

SECTION 4. ELECTION

(a) Members of the General Assembly shall be elected at the general election in even-numbered years.

(b) The proclamation of results of each election of members of the General Assembly must take place as soon as practical after the general election, but in no case later than seven days prior to the date the General Assembly first convenes under subsection (b) of Section 6 of this Article.

SECTION 5. SESSIONS

(a) The General Assembly shall convene each year on the second Wednesday of ~~December~~ January.

The General Assembly shall be a continuous body during the term for which members of the House of Representatives are elected.

(b) The Governor may convene the General Assembly or the Senate alone in special session by a proclamation stating the purpose of the session; and only business encompassed by such purpose, together with any impeachments or confirmation of appointments shall be transacted. Special sessions of the General Assembly may also be convened by joint proclamation of the presiding officers of both houses, issued as provided by law.

(c) Sessions of each house of the General Assembly and meetings of committees, joint committees and legislative commissions shall be open to the public. Sessions and committee meetings of a house may be closed to the public if two-thirds of the members elected to that house determine that the public interest so requires; and meetings of joint committees and legislative commissions may be so closed if two-thirds of the members elected to each house so determine.

(d) Notwithstanding any other provision of this Section, the General Assembly may not be in session in any general election year from the date of the general election until the second Wednesday of December, except upon a joint proclamation stating the purpose of the session signed by the Speaker and the Minority Leader of the House of Representatives, the President and the Minority Leader of the Senate, and the Governor; and only business encompassed by such purpose shall be transacted.

SECTION 6. ORGANIZATION

(a) A majority of the members elected to each house constitutes a quorum.

(b) On the second Wednesday first day of December following a general election ~~the January session of the General Assembly in odd numbered years~~, the Secretary of State shall convene the House of Representatives to elect from its membership a Speaker of the House of Representatives as presiding officer, and the Governor shall convene the Senate to elect from its membership a President of the Senate as presiding officer.

(c) For purposes of powers of appointment conferred by this Constitution, the Minority Leader of either house is a member of the numerically strongest political party other than the party to which the Speaker or the President belongs, as the case may be.

(d) Each house shall determine the rules of its proceedings, judge the elections, returns and qualifications of its members and choose its officers. No member shall be expelled by either house, except by a vote of two-thirds of the members elected to that house. A member may be expelled only once for the same offense. Each house may punish by imprisonment any person, not a member, guilty of disrespect to the house by disorderly or contemptuous behavior in its presence. Imprisonment shall not extend beyond twenty-four hours at one time unless the person persists in disorderly or contemptuous behavior.

SECTION 2. TERMS

(a) ~~The Attorney General, the Secretary of State, the Comptroller, and the Treasurer~~ These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, ~~except in the case of the Lieutenant Governor~~, until their successors are qualified. The Governor shall hold office for four years beginning on the second Wednesday of December after his or her election and until his or her successor is qualified. The Lieutenant Governor shall hold office for four years beginning on the second Wednesday of December after his or her election.

All of the elected officers of the executive branch ~~They~~ shall be elected at the general election in 1978 and every four years thereafter.

(b) The proclamation of results of each election of the Governor and Lieutenant Governor must take place as soon as practical after the general election, but in no case later than seven days prior to the date the General Assembly first convenes under subsection (b) of Section 6 of Article IV.

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 31

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 3 of Article IV of the Illinois Constitution as follows:

ARTICLE IV THE LEGISLATURE

SECTION 3. LEGISLATIVE REDISTRICTING

(a) The Independent Redistricting Commission, comprised of eleven Commissioners, shall adopt and file with the Secretary of State a district plan for Legislative Districts and Representative Districts by June 30 of the year following each federal decennial census.

Legislative Districts shall be ~~compact~~, contiguous and substantially equal in population. Representative Districts shall be ~~compact~~, contiguous, and substantially equal in population. The district plan shall comply with federal law. Subject to the foregoing, the Commission shall apply the following criteria: (1) the district

plan shall not dilute or diminish the ability of a racial or language minority community to elect the candidates of its choice, including when voting in concert with other persons; (2) districts shall respect the geographic integrity of units of local government; (3) districts shall respect the geographic integrity of communities sharing common social and economic interests, which do not include relationships with political parties or candidates for office; and (4) the district plan shall not either purposefully or significantly discriminate against or favor any political party or group. In designing the district plan, the Commission shall consider party registration and voting history data only to assess compliance with the foregoing criteria, and shall not consider the residence of any person.

The Commission shall hold at least one public hearing in each Judicial District before, and at least one public hearing in each Judicial District after, releasing the initial proposed district plan. The Commission may not adopt a final district plan unless the plan is to be adopted without further amendment, and public notice of a report explaining its compliance with this Constitution and the criteria applied has been given at least seven days before the final vote on such plan. Upon adoption, a district plan shall have the force and effect of law and shall be published promptly by the Secretary of State.

The State Board of Elections shall provide the Commission and the public with complete and accurate census information and technology sufficient to propose district plans. The Commission shall adopt rules governing its procedures and the implementation of matters under this Section.

(b) The Commission shall act in public meetings by an affirmative vote of six Commissioners, except that approval of any district plan shall require the affirmative vote of at least seven Commissioners, which shall include (1) at least two Commissioners from each political party whose candidate for Governor received the most and second-most votes cast in the last general election for Governor, and (2) at least two Commissioners not affiliated with either such political party. The Commission shall elect its chairperson and vice chairperson, who shall not be affiliated with the same political party. Six Commissioners shall constitute a quorum. All meetings of the Commission attended by a majority of its quorum, except for meetings qualified under attorney-client privilege during pending litigation, shall be open to the public and public notice shall be given at least two days prior to any meeting. All records of the Commission, including communications between Commissioners regarding the Commission's work, shall be open for public inspection, except for records qualified under attorney-client privilege during pending litigation. The Commission may retain assistance from counsel, technical staff, and other persons with relevant skills, and shall be provided with adequate resources by the General Assembly to complete its work.

(c) For the purpose of conducting the Commissioner selection process, an Applicant Review Panel comprising three Reviewers shall be chosen in the following manner in the year in which each federal decennial census occurs. Beginning not later than January 1 and ending not later than March 1 of the year in which the census occurs, the Auditor General shall request and accept applications to serve as Reviewers. By March 31, the Auditor General shall appoint a Panel of three Reviewers, selected by random draw from eligible applicants.

The Panel shall act in public meetings by an affirmative vote of two Reviewers. All meetings of the Panel shall be open to the public and public notice shall be given at least two days prior to any meeting. All records of the Panel, including applications to serve on the Panel or the Commission, shall be open for public inspection, except private information about applicants for which there is no compelling public interest in disclosure. The Panel may retain assistance from counsel, technical staff, and other persons with relevant skills, and shall be provided with adequate resources by the General Assembly to complete its work.

(d) A Commission shall be chosen in the manner set forth in this subsection (d) in the year in which each federal decennial census occurs.

Beginning not later than January 1 and ending not later than March 1 of the year in which the census occurs, the Auditor General shall request and accept applications to serve as Commissioners.

By May 31, the Applicant Review Panel shall select one hundred eligible applicants based on their relevant analytical skills, impartiality, and ability to contribute to a fair redistricting process, and shall ensure that such applicants reflect the demographic and geographic diversity of the State. The Speaker and Minority Leader of the House of Representatives and the President and Minority Leader of the Senate each may remove up to five of the applicants selected by the Panel.

By June 30, the Panel shall publicly select seven Commissioners by random draw from the remaining applicants; of those seven Commissioners, including any replacements, (1) the seven Commissioners shall reside among the Judicial Districts in the same proportion as the number of Judges elected therefrom under Section 3 of Article VI of this Constitution, (2) two Commissioners shall be affiliated with the political party whose candidate for Governor received the most votes cast in the last general election for Governor, two Commissioners shall be affiliated with the political party whose candidate for Governor received the second-

most votes cast in such election, and the remaining three Commissioners shall not be affiliated with either such political party, and (3) no more than two Commissioners may be affiliated with the same political party. The Speaker and Minority Leader of the House of Representatives and the President and Minority Leader of the Senate each shall appoint one Commissioner from among the remaining applicants on the basis of the applicant's contribution to the demographic and geographic diversity of the Commission.

(e) To be eligible to serve as a Reviewer, a person must have education and experience in the examination and assessment of personnel, records, systems, or procedures for ten years preceding his or her application, must have demonstrated understanding of and adherence to standards of ethical conduct, and must not have been affiliated with any political party within the three years preceding appointment. To be eligible to serve as a Commissioner, Special Commissioner, or Reviewer, a person (1) must be a resident and registered voter of the State for the four years preceding appointment, (2) within the three years preceding appointment, must not have been the holder of, or a candidate for, any public office in the State, an employee or officer of the State or a unit of local government or a political party, registered as a lobbyist anywhere in the United States, or party to a contract to provide goods or services to the State or a principal, officer, or executive employee of such a contractor, and (3) within the three years preceding appointment, must not have resided with any person described in clause (2) of this subsection.

(f) If the Commission fails to adopt and file a district plan with the Secretary of State by June 30 of the year following a federal decennial census, the Chief Justice of the Supreme Court and the most senior Judge of the Supreme Court who is not affiliated with the same political party as the Chief Justice shall jointly appoint a Special Commissioner for Redistricting by July 31. The Special Commissioner shall design and file with the Secretary of State by August 31 a district plan satisfying the requirements and criteria set forth in subsection (a) and a report explaining its compliance with this Constitution and the criteria applied. The Special Commissioner shall hold at least one public hearing in the State before releasing his or her initial proposed district plan and at least one public hearing in a different location in the State after releasing his or her initial proposed district plan and before filing the final district plan with the Secretary of State. Upon its filing, the final district plan filed by the Special Commissioner shall have the force and effect of law and shall be published promptly by the Secretary of State.

~~In the year following each Federal decennial census year, the General Assembly by law shall redistrict the Legislative Districts and the Representative Districts.~~

~~If no redistricting plan becomes effective by June 30 of that year, a Legislative Redistricting Commission shall be constituted not later than July 10. The Commission shall consist of eight members, no more than four of whom shall be members of the same political party.~~

~~The Speaker and Minority Leader of the House of Representatives shall each appoint to the Commission one Representative and one person who is not a member of the General Assembly. The President and Minority Leader of the Senate shall each appoint to the Commission one Senator and one person who is not a member of the General Assembly.~~

~~The members shall be certified to the Secretary of State by the appointing authorities. A vacancy on the Commission shall be filled within five days by the authority that made the original appointment. A Chairman and Vice Chairman shall be chosen by a majority of all members of the Commission.~~

~~Not later than August 10, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.~~

~~If the Commission fails to file an approved redistricting plan, the Supreme Court shall submit the names of two persons, not of the same political party, to the Secretary of State not later than September 1.~~

~~Not later than September 5, the Secretary of State publicly shall draw by random selection the name of one of the two persons to serve as the ninth member of the Commission.~~

~~Not later than October 5, the Commission shall file with the Secretary of State a redistricting plan approved by at least five members.~~

~~An approved redistricting plan filed with the Secretary of State shall be presumed valid, shall have the force and effect of law and shall be published promptly by the Secretary of State.~~

(g) The Supreme Court shall have original and exclusive jurisdiction in cases relating to matters under this Section. The Commission shall have exclusive authority, and shall be provided adequate resources by the General Assembly, to defend any district plan adopted and filed by the Commission, over actions concerning redistricting the House and Senate, which shall be initiated in the name of the People of the State by the Attorney General.
