42ND LEGISLATIVE DAY

Perfunctory Session

TUESDAY, MAY 5, 2015

At the hour of 7:49 o'clock p.m., the House convened perfunctory session.

INTRODUCTION AND FIRST READING OF BILLS

The following bills were introduced, read by title a first time, ordered reproduced and placed in the Committee on Rules:

HOUSE BILL 4209. Introduced by Representative Thapedi, AN ACT concerning racial profiling.

HOUSE BILL 4210. Introduced by Representative Madigan, AN ACT concerning appropriations.

HOUSE BILL 4211. Introduced by Representative Ford, AN ACT concerning education.

HOUSE BILL 4212. Introduced by Representative Ford, AN ACT concerning criminal law.

SENATE BILLS ON FIRST READING

Having been reproduced, the following bills were taken up, read by title a first time and placed in the Committee on Rules: SENATE BILLS 377 (Rita), 438 (Dunkin), 691 (Dunkin), 1470 (Nekritz) and 1529 (Currie).

SENATE RESOLUTION

The following Senate Joint Resolution, received from the Senate, was read by the Clerk and referred to the Committee on Rules: SENATE JOINT RESOLUTION 13 (Nekritz).

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 439

Offered by Representative Mussman:

WHEREAS, A McKinsey and Company study entitled "Women Matter" showed that companies where women are most strongly represented at board or top-management levels are also the companies that perform the best; companies with 3 or more women in senior management functions score more highly, on average, on the organizational performance profile than companies with no women at the top, and performance increases significantly once a certain critical mass is attained -- specifically, when there are at least 3 women on management committees with an average membership of 10 people; and

WHEREAS, An Oklahoma State University study found that board diversity, including diversity with respect to gender and ethnicity, is associated with improved financial value; the study also found a significant positive relationship between the fraction of women or minorities on the board and firm value; and

WHEREAS, A report entitled "Women Directors on Corporate Boards" found that gender diversity on corporate boards contributes to more effective corporate governance and to positive governance outcomes through a variety of board processes as well as through individual interactions; that women directors

contribute to important firm-level outcomes as they play direct roles as leaders and mentors, as well as indirect roles as symbols of opportunity for other women, and inspire those women to achieve and stay with their firms; and that more recognition is needed for the valuable contribution of women directors to firm value; and

WHEREAS, Credit Suisse conducted a 6-year global research study, commencing in 2006, of more than 2,000 companies worldwide that showed that women on boards improve business performance by key metrics, including stock performance, as demonstrated by the fact that companies with a market capitalization of more than \$10 billion, whose boards have women, outperformed shares of comparable businesses with all-male boards by 26%; and

WHEREAS, The Credit Suisse report included the following findings: (1) there has been a greater correlation between stock performance and the presence of women on a board since the financial crisis in 2008; (2) companies with women on their boards significantly outperformed others when the recession occurred; (3) companies with women on their boards tend to be somewhat risk-averse and carry less debt, on average; and (4) net income growth for companies with women on their boards averaged 14% over a 6-year period, compared with 10% for those with no women directors; and

WHEREAS, According to the study entitled "Women Directors on Corporate Boards: From Tokenism to Critical Mass" and a report entitled, "Critical Mass on Corporate Boards: Why Three or More Women Enhance Governance", attaining critical mass, going from one or 2 women directors to at least 3 women directors, creates an environment where women are no longer seen as outsiders and are able to influence the content and process of board discussions more substantially, and boards of directors need to have at least 3 women to enable them to interact and exercise an influence on the working style, processes, and tasks of the board, in turn positively affecting the level of organizational innovation within the firm; and

WHEREAS, The State of Illinois has seen a slight uptick in the percentage of women on corporate boards; in 2013, 17.5% of the corporate boards in the State included women, and in 2014, that percentage rose to 17.7; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we acknowledge that the body of evidence to date concludes that companies perform better when their boards of directors and executive leadership include women and that the State of Illinois has a significant stake in protecting the shareholders of publicly held companies as well as in setting policies that enable such companies to perform better; and be it further

RESOLVED, That we encourage equitable and diverse gender representation on corporate boards of directors and urge that, within the next 3 years: (1) every publicly held corporation in Illinois with 9 or more seats on its board of directors have a minimum of 3 women on its board; (2) every publicly held corporation in Illinois with at least 5 but fewer than 9 seats on its board of directors have a minimum of 2 women on its board; and (3) every publicly held corporation in Illinois with fewer than 5 seats on its board of directors have a minimum of one woman on its board; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Judi Spaletto, Ph.D., Chicago Chapter Chair of WOB2020.

HOUSE RESOLUTION 440

Offered by Representative Monique Davis:

WHEREAS, Illinois State Representative Monique Davis and the members of the Illinois House of Representatives recognize that Mother's Day is celebrated nationally on May 10, 2015; and

WHEREAS, Every mother wants her child to succeed; and

WHEREAS, A child's parents are the foremost authority in the needs of the child; and

WHEREAS, Every day, mothers and grandmothers stand up for the rights of their children and advocate for their needs; and

WHEREAS, Many of these parents and grandparents come to Springfield to advocate on behalf of legislation that supports their children's rights; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate May 6, 2015 as "Moms on a Mission Day" in the State of Illinois to honor mothers, grandmothers, fathers, and their families who stand up for children's rights; and be it further

RESOLVED, That we welcome the mothers and grandmothers present at the Illinois State Capitol on May 6, 2015, particularly those who are here for the first time, to join us in our efforts.

HOUSE RESOLUTION 442

Offered by Representative McSweeney:

WHEREAS, The Equal Pay Act of 1963, as amended, guarantees wage parity to all Americans and mandates that employers provide equal pay to men and women for equal work; and

WHEREAS, The courts have spoken out on the Equal Pay Act of 1963 and have issued decisions that have created a large quantity of case law that enables employers, workers, and practitioners of employment law to comprehend and interpret the Act; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we strongly support workplace equity and equality under the law covering pay and benefits for employees as established by the Equal Pay Act of 1963, the Constitution, statutory law, and case law; and be it further

RESOLVED, That we support the Equal Pay Act of 1963 and consistent statutory and case law in support of workplace fairness and equity, including rights that are clearly defined and understood by all employers, all employees, and all contractors; and be it further

RESOLVED, That we support consistent application of the Equal Pay Act of 1963, other federal statutory law, and federal and State case law to issues of workplace pay in the belief that these laws will help Illinois continue to move forward towards equality under the law; and be it further

RESOLVED, That we support the continued efforts of the Illinois Human Rights Commission to monitor and advocate for implementation of equality under the law, including issues of workplace compensation and pay; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Rose Mary Bombela-Tobias, Chairman of the Illinois Human Rights Commission.
