(7) two members of the Illinois House of Representatives chosen by the Speaker of the

(8) two members of the Illinois House of Representatives chosen by the Minority Leader of the Illinois House of Representatives;

(9) the President of the Student Government Association at Rock Valley College;

(10) the Director of Corrections or his or her designee, who must:

(A) be from the Division of Parole;

(B) be an active field agent; and

(C) possess at least a master's degree in criminal justice or criminology;

(11) a faculty member of the Criminal Justice program at Rock Valley College appointed by the President of Rock Valley College; and

(12) a representative of an organization representing Rockford-area businesses

appointed by the Speaker of the Illinois House of Representatives; and be it further

RESOLVED, That all appointments shall be made no later than 45 days following the adoption of this resolution; and be it further

RESOLVED, That the Task Force shall study and determine the causes of violent crime in Rockford and nearby affected communities; and be it further

RESOLVED, That the Task Force shall study and determine the feasibility of deploying the Illinois State Police to Rockford and nearby affected communities and neighborhoods; and be it further

RESOLVED, That the Task Force shall develop a comprehensive long-term solution to the effect of violent crime in Rockford and nearby affected communities; and be it further

RESOLVED, That the Task Force shall recommend a plan of action to substantially reduce the incidents of violent crime in Rockford and nearby affected communities; and be it further

RESOLVED, That the Task Force shall draft any necessary legislation and make any necessary recommendations for appropriations for the General Assembly to pass and the Governor to sign to place the plan of action into immediate effect; and be it further

RESOLVED, That the Task Force shall report its findings and recommendations and submit any and all proposed legislation to the Governor and General Assembly on or before December 31, 2015; and be it further

RESOLVED, That the members of the Task Force shall serve without compensation, but shall be reimbursed for their reasonable and necessary expenses from the funds appropriated for that purpose from the Illinois State Lottery; and be it further

HOUSE RESOLUTION 495

Offered by Representative Lilly:

WHEREAS, Article X, Section 1 of the Illinois Constitution provides that "A fundamental goal of the People of the State is the educational development of all persons to the limits of their capacities."; the Section also provides that "The State shall provide for an efficient system of high quality public educational institutions and services." and that "The State has the primary responsibility for financing the system of public education."; and

WHEREAS, The economic competitiveness of the United States and Illinois in the global economy requires a well-educated workforce; and

WHEREAS, In 2015, education is more important than ever because it is an essential step to entering and remaining in the middle class; and

WHEREAS, High school dropouts are more than twice as likely to be unemployed and 3 times as likely to receive welfare assistance; nationally, this costs billions of dollars to government-funded assistance programs annually; and

WHEREAS, The United States Census Bureau estimates that a person with a high school diploma will earn \$9,634 more per year than someone without a high school diploma; and

WHEREAS, In 2014, people without a high school diploma had a 9% unemployment rate, compared to a 6% rate for those with a high school diploma; and

WHEREAS, A well-educated citizenry improves the business climate by providing highly skilled workers that employers need; and

WHEREAS, According to a Georgetown University study, the United States economy will face a shortage of 5 million workers with the necessary education and training by 2020; and

WHEREAS, The majority of jobs that will be created will require some sort of education and training after high school; and

WHEREAS, Males with a college education live an average of 8 years longer than those without a high school diploma, while females with a college education lived an average of 6 years longer; males with a college education are also 55% more likely to vote than those without a high school diploma, and females with a college education are 40% more likely to vote than those without a high school diploma; a one-year increase in median education level is associated with a more than 13% increase in political primary turnouts; and

WHEREAS, Between 1987 and 2007, the United States has increased spending on incarceration by 127%, compared with a 21% increase in funding for education during the same time period; and

WHEREAS, Forty-one percent of all prisoners have not completed high school, compared to 18% of the general adult population; and

WHEREAS, The annual cost of incarcerating an individual is roughly \$32,000, while the annual cost of educating a student is about \$11,000; a 5% increase in male graduation rates nationally would save an estimated \$5 billion annually in crime-related expenses; and

WHEREAS, Investment in education is shown to prevent violence by providing opportunities and knowledge that create a higher quality life; and

WHEREAS, The average annual public health cost is an estimated \$2,700 per high school dropout, \$1,000 per high school graduate, and \$170 per college graduate; it is estimated that if every high school dropout graduated, the national savings in public health costs would exceed \$40 billion annually; and

WHEREAS, The foundation level is the statutorily set minimum per-pupil funding necessary to adequately educate public K-12 students in Illinois through a combination of State and local resources; the foundation level has remained at \$6,119 since the 2009-2010 school year, despite rising costs of education; and

WHEREAS, The Education Funding Advisory Board recommended that the foundation level be changed to \$8,899 for Fiscal Year 2016 to adequately fund the educational needs of students; and

WHEREAS, The State of Illinois has not fully funded K-12 education since Fiscal Year 2009; and

WHEREAS, For Fiscal Year 2015, General State Aid to schools was prorated at 87.1% and the State's share of K-12 education funding was underfunded by nearly \$650 million; Illinois currently ranks last in state share of P-12 education funding; and

WHEREAS, Improved education and more stable employment greatly increase tax revenue, such as a return of at least 7 dollars for every dollar invested in pre-kindergarten education; and

WHEREAS, A high quality education system should be the identity and legacy that we establish for Illinois and the United States; in addition, education should be the number one budget priority for the State of Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we acknowledge the importance of having a high quality education system and all of the societal benefits that go along with it; and be it further

RESOLVED, That we encourage the General Assembly to make education a priority in the Fiscal Year 2016 budget and to fully fund elementary and secondary education; and be it further

RESOLVED, That we encourage the business community to advocate for a high quality education system in Illinois, which will benefit the business climate as well as the citizens of Illinois; and be it further

RESOLVED, That we encourage the General Assembly to continue to strive to create an adequately funded and high quality education system for the benefit of all citizens.

HOUSE RESOLUTION 497

Offered by Representative Ford:

WHEREAS, In response to fast-growing defense industries during World War II, Congress passed the Defense Housing and Communities Facilities and Services Act of October 1940, 54 Stat. 1125 (commonly known as the Lanham Act), to fund various national defense public works projects; and

WHEREAS, One of the public works projects funded under the Lanham Act concerned the construction and maintenance of child care facilities nationwide in communities that lacked sufficient child care services to meet the growing demand for women to enter the workforce and contribute to the nation's war production effort; and WHEREAS, The child care program implemented under the Lanham Act operated from 1943 to 1946 and provided funding not only for the construction of child care facilities, but also to help cover the costs associated with teacher training activities, teacher salaries, and meal services provided at child care facilities; and

WHEREAS, Although the child care program implemented under the Lanham Act was viewed as a temporary practical solution to the economic and social demands placed on families, specifically mothers with children, during World War II, many child care advocates consider the Lanham Act a turning point in this country's long-standing policy on child care because it created the first, and only, federally subsidized child care program for children regardless of family income; and

WHEREAS, Many child care advocates have studied the social and economic implications of the child care policy established under the Lanham Act and have argued that it increased maternal employment as well as children's educational attainment, labor force participation, and earnings as adults; and

WHEREAS, In light of these positive outcomes, child care advocates have called for a return to the child care policy established in the Lanham Act and for a permanent commitment by the federal government to make affordable and high-quality child care services accessible for all working families; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we respectfully urge Congress to pass legislation in support of universal child care services for working families and to provide sufficient and sustainable funding for a permanent child care program similar to the federally administered program created and implemented under the Lanham Act of 1940; and be it further

RESOLVED, That after adoption, suitable copies of this resolution be delivered to the Speaker and Minority Leader of the United States House of Representatives, the Majority and Minority Leaders of the United States Senate, and the members of the Illinois congressional delegation.

HOUSE RESOLUTION 498

Offered by Representative Flowers:

WHEREAS, Illinois citizens who have been convicted of Class X felonies and other felony offenses are unfairly denied opportunities to obtain jobs even after complying with all sentencing and post-sentencing requirements; and

WHEREAS, African-American men are disproportionately affected by policies because too many of them are disqualified from job opportunities and other opportunities; and

WHEREAS, Under the current system, being a formerly incarcerated person essentially amounts to a life sentence of being a second class citizen; and

WHEREAS, Formerly incarcerated citizens depend on the benevolence of school administrators, employers, landlords, and more individuals in order to properly participate in society; and

WHEREAS, There is no current means to rid oneself of the stigma associated with being an ex-felon; and WHEREAS, Formerly incarcerated citizens should be empowered to determine their own destinies; and

WHEREAS, Formerly incarcerated citizens should be given the same opportunities as other Illinois Citizens to choose where they live, work, and attend school; and

WHEREAS, Formerly incarcerated citizens should be provided with the incentive to conform their behavior to society's standard, which will increase public safety; and

WHEREAS, A person should not have to continue to pay for something he or she may have done years ago after complying with all sentencing requirements; and

WHEREAS, Having job opportunities and having one's record sealed will reduce recidivism; and

WHEREAS, Innocent individuals are also hurt by current policies because sometimes the innocent get convicted or plead guilty to felonies; and

WHEREAS, Discriminatory policies created by administrators, employers, and legislators amount to postincarceration sentencing equating to double jeopardy; and

WHEREAS, If a person is no longer incarcerated, he or she is not serving a de jure life sentence, so it is immoral to be serving a de facto life sentence (void of sufficient job opportunities); and

WHEREAS, The lack of sufficient criminal sealing protections entails the creation of a permanently dependent class of individuals; and

WHEREAS, Many of those individuals cannot earn a living and are forced to prey upon those who do or to earn a living by obtaining entitlements or sponging off law-abiding citizens; therefore, be it RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor's Commission on Criminal Justice and Sentencing Reform (Executive Order 15-14) to study issues and permit, to the extent that such a determination is appropriate, the mentioned members of the vulnerable population to have a chance to relieve themselves of the stigma of being convicted felons and to have a chance to obtain jobs by having their records sealed (and through any other means) so long as they comply with the following steps:

1) Complete parole/probation;

2) Complete any required drug treatment program, anger management program, psychological testing, and anything else required;

3) Obtain a G.E.D., high school diploma, or something equivalent to the mentioned;

4) Employed, actively seeking employment, enrolled in vocational training, or enrolled in a college program;

5) Does not have any felony conviction for a period of time commensurate with the severity of their convictions (e.g., for 1, 3, 5, or 7 years, etc.)

6) So long as a formerly incarcerated Illinois citizen successfully complies with the above steps, unless he or she is a registered sex offender, then his or her record must forever be sealed unless he or she commits another felony; and

7) A person who is a registered sex offender must have his or her situation reviewed by a

review board to determine whether the person may have his or her record sealed; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Governor's Commission on Criminal Justice and Sentencing Reform.
