RESOLVED, That suitable copies of this resolution should be delivered to the Governor of Illinois, the Speaker of the Illinois House of Representatives, and the President of the Illinois Senate.

#### HOUSE JOINT RESOLUTIONS CONSTITUTIONAL AMENDMENTS FIRST READING

# HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 62

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 8.5 to Article IV of the Illinois Constitution as follows:

ARTICLE IV

#### THE LEGISLATURE

#### SECTION 8.5. PASSAGE OF REVENUE BILLS

A bill passed on or after the date of a general election but on or before the second Wednesday of January following the general election that would result in the increase of revenue to the State by an increase of a tax on or measured by income or the selling price of any item of tangible personal property or any service may become law only with the concurrence of three-fifths of the members elected to each house of the General Assembly.

#### **SCHEDULE**

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

The foregoing HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 62 was taken up, read in full a first time, ordered reproduced and placed in the Committee on Rules.
