And would also remove language from the Pharmacy Practice Act which requires citizenship before people can receive those licenses. That's currently not the practice in IDFPR, they allow DACA recipients to receive these licenses anyway. So, it's just cleaning up that legacy language and codifying existing practice in the statute."

Guzzardi: "Thank you, Representative."
