Today, up in the Speaker's Gallery, if he would please stand, we have Mayor Paul Antrim, the mayor of Stewardson, Illinois. Stewardson, again, is a rural farming community with just over 700 people. Let me read from the Resolution briefly. The town was named after William Stewardson Jr., who was born in

Westmoreland County, England in February 24 of 1828, and he came to Shelby County in 1845. Stewardson was incorporated in September 30 of 1874. In Stewardson's 150-year history, a number of important events have happened: the establishment of a newspaper, the building of an opera hall in 1893, the consolidation of the Stewardson-Strasburg schools, and the opening of a new high school along the Route 32 in 1951, the opening of new convenience stores and gas stations, and get this, the opening of a Dollar General in 2022, thus eliminating the Dollar General desert in our neighborhood. Today, Stewardson is now home to over 20 businesses, 3 churches, the Stewardson Fire and Ambulance District, and the new Stewardson Community Center and a new American Legion Hall. Stewardson will celebrate its 150th anniversary from June 27 to the June 30 of this year. In closing, Ladies and Gentlemen, our rural... rural, small communities have been, and will continue to be, an important part of the fabric throughout the State of Illinois. Please join with me in welcoming and congratulating Stewardson Mayor Paul Antrim, that's with us today, on the 150th anniversary of the success of their community."

Halbrook: "Thank you, Mr. Speaker. Yesterday, Ladies and Gentlemen, we were invited to EV Day at the Governor's Mansion. Hopefully, you were able to be there. There on display was the latest and the greatest in electrical vehicle manufacturing: Ford, GM, Lions, and Rivian, and some other manufacturers. What is most interesting about this early afternoon event was just a few hours later, Rivian's quarterly earnings call would be out. This leads us to today's number. Today's number is \$38,784. That's right, every Rivian vehicle on display that had been manufactured recently had been losing \$38,784. This is on the heel of the Governor's announcement late last week of cash and tax incentives to Rivian to the tune of just over \$800 million. When you do the math on that, that's over a million and a half dollars per every job that's to be created. Of course, this is on the announcement after last fall's \$125 million cash infusion into Gotion battery, one of America's foreign adversaries, which hasn't produced a single product yet. So, why is this important? It's important because it impacts your neighbors and mine. They elect us and pay the freight for us to be here every day to be good stewards of their dollars. The Governor needs almost a billion dollars of additional new revenue to make the Fiscal Year '25 budget truly balanced. This will more than likely come up from a series of proposed revenue enhancements that will drive up the cost of living in Illinois. The experts agree more revenue is needed or spending will need to be cut. The question I have is, where is the money going to come from? Did the construction workers dig up buried treasure in the front lawn of the Capitol Complex recently? The Governor

continues to spend well over a billion dollars a year on a population of people that are in this country illegally. Now, he is spending a billion dollars on electric vehicle and manufacturing subsidies. He continues to grow the size of government through new and expanding programs. Let me ask you, how many government subsidies did it take to make that phone that's in your pocket or lying on your desk the top of the market? That's right, zero dollars. And as if the subsidies aren't enough, the Governor has proposed hundreds of millions of dollars in sales of these electrical vehicle companies by forcing the state to purchase 10 thousand electric vehicles by the year 2030 for the state fleet. The numbers speak for themselves. If people want EVs, they will buy them. If they don't want the EV, they won't buy them. No amount of taxpayer funded subsidies will ever change that. Ladies and Gentlemen, in closing, it's past time to reign in the out-of-control spending and let's do right by the people of the State of Illinois. Thank you."

The Illinois Department of Natural Resources is proud to announce the recent graduation of 21 new recruits. These completed a comprehensive 30-week training program. recruits spent 16 weeks at the Illinois State Police Academy, they received full-time certification where as enforcement officers. Then they completed a 14... 14 weeks at the IDNR Conservation Police Academy, focusing conservation-related topics, such as wildlife enforcement, fisheries enforcement, and watercraft safety. The graduates are currently participating in a field training program where they are transiting from what they learned in the academy to performing law enforcement patrol duties competently in the field with experienced Conservation Police officers. Upon completion of the field training program, these recruits will be certified Conservation Police officers where they will be assigned to various counties across the state, including Cook, LaSalle, Lake, Will, Putnam, Christian, Livingston, Crawford, Warren, White, and Winnebago. Once they receive

their counties of assignment, their primary enforcement mission is to protect Illinois' natural resources and promote recreational safety. Some of these duties include enforcing criminal laws, vehicle laws, and drug laws within state parks, conducting patrols of lakes and rivers to ensure compliance with boating safety equipment and watercraft registration, responding to boating accidents and providing assistance as needed, enforcing fish and wildlife laws, including checking hunters, trappers, and sport commercial fishermen for licenses and permits, enforcing federal fish and wildlife laws, enforcing timber buyers, enforce transportation laws, enforcing endangered species enforcing snowmobile registration operation laws, assisting other law enforcement agencies to providing support in emergency and rescue situations. In addition to their enforcement duties, CPOs also participate in nonenforcement activities, including providing public education and outreach at sport or hunt clubs, civic organizations, school classrooms and other events, staffing information booths at major outdoor sporting events, travel and expositions, assisting with hunting, boating, and snowmobile and safety and education programs, and providing instruction to other law enforcement agencies on conservation-type laws and related enforcement procedures. Overall, the Conservation Police is proud to have produced a new group of highly-trained and skilled officers who are dedicated to protecting Illinois' natural resources and promoting recreational safety for decades to come. Kifowit: "Thank you, Mr. Speaker, Member of the General Assembly. This Resolution and the following Resolutions were brought before me by Rolling Thunder. They're in the Speaker's Gallery. Rolling Thunder is dedicated to supporting U.S. military active duty, veterans, prisoners of war, and personnel missing in action from past wars. They were established in 1995 as a nonprofit organization and today have over 90 chartered chapters across the United States and abroad. Many members are veterans and motorcycle enthusiasts, but they all share a common goal, and that is to ensure full accountability for prisoners of war and those missing in action from all conflicts. Their mission is to educate the public about the issue, advocate for the return of living POWs, and the repatriation of remains, and support American veterans from all wars. The organization traces its roots back to the fall of 1987 when two Vietnam veterans, Artie Muller and Ray Manzo, initiated discussions about the neglect of POW/MIA issues. And this led to the inaugural Rolling Thunder demonstration in 1988, where thousands of motorcycles descended upon Washington, D.C. demanding a full accounting of all POW/MIAs. And since then, Rolling Thunder, Inc. has remained steadfast in its commitment to honoring advocating for those who have served our country. With us in the Speaker's Gallery are members of Rolling Thunder, and specifically Gold Star parents Robert Patterson and his wife, Mary, who proudly served in the United States Navy. They are from North Aurora, and... and Robert has dedicated his life to ensuring that the sacrifices of fallen heroes, like his son, Specialist... Army Specialist Christopher Patterson, are never

forgotten. Christopher, a graduate of West Aurora High School, tragically lost his life along with three other... three other military individuals at the age of 20 in Afghanistan in 2012. Motivated by his own personal loss and the plight of thousands of families who still await closure for their missing loved ones, Patterson was taken a proactive approach to honoring these local heroes. He currently spearheads a project with Rolling Thunder, Illinois Chapter 1, aimed at naming parts of local roads in honor of our fallen service members. And his involvement in his project, along with his active participation in various veteran organizations, reflects his unwavering dedication to honoring the memory and sacrifice of those who have served our country. So, with that, Ladies and Gentlemen of ... of the House, it is my honor to present the current Resolution, which is House Joint Resolution 53. House Joint Resolution 53 is... pays honor and respect to those who have served our country and also that made the ultimate sacrifice for our nation. House Joint Resolution 53 recognizes Sergeant First Class Ogden Neil Thompson of Aurora, who served with the U.S. Army as a member of Company G, 2nd Battalion, 8th Cavalry Regiment, 1st Cavalry Division. And Specialist Thompson was listed as missing in action while fighting the enemy near Unsan, North Korea in November 1, 1950. Specialist Thompson was presumed dead in December 31, 1953. Thereby, it's resolved that the House of Representatives for the 103rd General Assembly in the State of Illinois designate Route 25 in Aurora from Sullivan Road to Ashland Avenue as the 'Specialist Ogden North Thompson

Kifowit: "Thank you, Mr. Speaker and Members of the General Assembly. This is continuing our honor to those that gave the ultimate sacrifice in the State of Illinois. This Resolution, House Joint Resolution 54, is for Private First Class Wayne Hall (sic-Hill) Jr. He served in the United States Army as a member of Company K, 3rd Battalion, 34th Infantry Regiment, 24th Infantry Division. And PFC Hall (sic-Hill) was taken prisoner of war while fighting the enemy near Taejon, South Korea on July 20, 1950. PFC Hall died... Hill died while a POW on October 20, 1950, and his remains are still not recovered. PFC Hill received the Purple Heart, the Combat Infantry Badge, the Korean Service Medal, the United Nations Service Medal,

the National Defense Service Medal, the Korean Presidential Unit Citation, and the Republic of Korea War Service Medal. Therefore, the House of Representatives of the 103rd General Assembly of the State of Illinois shall designate Route 31 in Aurora from Sullivan Road to Ashland Avenue as the 'PFC Wayne W. Hill Jr. Memorial Highway'. And I ask that all Members be added to this Resolution, Sir."

Speaker Evans: "Seeing no further discussion, Representative Kifowit moves for the adoption of House Resolution 54... House Joint Resolution 54. All those in favor vote 'aye'; all those opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On this question, there are 113 voting 'yes', 0 voting 'no', 0 voting 'present'. And this Resolution, having reached the Constitutional Majority, is hereby declared adopted. Continuing down page 17 of the Calendar. Under Order of Resolutions, we have House Joint Resolution 55, Representative Kifowit."

Kifowit: "Thank you, Mr. Speaker and Members of the General Assembly. Continuing on the initiative from Rolling Thunder is House Joint Resolution 55 that are recognizing those that made the ultimate sacrifice for our nation. In this Resolution, we recognize Staff Sergeant Robert Dale Herreid. He served as a Specialist 5 in the U.S. Army with Detachment A-402P, Company D, 5th Special Forces Group and was an advisor operating with a mobile strike force company. On October 10, 1968, Staff Sergeant Herreid company was ambushed by a large enemy force in the Co To Mountain area, Chau Doc Province, South Vietnam. The company was forced to fall back after

suffering casualties, and the area was then subjected to heavy artillery bombardment in subsequent battles. Staff Sergeant Herreid was hit and killed during the ensuing fire fight, and his unit could not evacuate his body as they fell back. Later searches of the battle area failed to locate his remains. Following the incident, the Army promoted Staff Sergeant Herreid to the rank of Staff Sergeant. He was memorialized on the Courts of the Missing in the National Memorial Cemetery of the Pacific. His name is also inscribed along all of his fallen comrades on the Vietnam Veteran Memorial Wall in Washington, D.C. He was awarded the Purple Heart, the National Defense Service Medal, the Vietnam Campaign Medal, the Vietnam Service Medal, the Army Presidential Unit Citation, the Vietnam Gallantry Cross, and the Army Good Conduct Medal. Therefore, it be resolved that the House of Representatives of the 103rd General Assembly State of Illinois designate Route 31 in Batavia from Main Street south to Mooseheart Road as the 'Staff Sergeant Robert Herreid Memorial Highway'. And I ask that all Members be added to this Resolution, Sir."

I am honored to present House Joint Resolution 56, the final initiative of the Rolling Thunder project in which we are making sure and honoring those who have made the ultimate sacrifice for our nation. Sergeant First Class Theodore Katsoolias served in the U.S. Army as a member of the 1st Battalion, 38th Infantry Regiment, 2nd Infantry Division. And on November 25, 1950, approximately thousand Chinese Communist forces launched a counteroffensive against U.N. forces after crossing the Yalu River. SFC Katsoolias was... unit was positioned near the Chongchon River and soon came under intense attack. Unable to halt the enemy advance and in danger of being surrounded, his unit pulled back and was forced to fight against enemy pursuit while also attempting to break through well-defended roadblocks. The withdrawal was not complete until early December inflicted extremely heavy casualties in his unit. He went missing at some point during the withdrawal. He was never reported as a prisoner of war, and his remains have not been recovered. He is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific. And therefore, by the House of Representatives of the 103rd General Assembly, we shall designate Route 59 in West Chicago from Route 38 to Route 64 as the 'SFC Theodore A.
