- W. Robert Blair: "Gentleman from ah.. Cook, Mr. Mann."
- R. E. Mann: "Mr. Speaker and Members of the House, ah.. I would ask that the Clerk read the Resolution."
- W. Robert Blair: "Alright, ah.. the Gentleman's requested that the Clerk ah.. read ah.. Resolu.. H.. House Resolution 26. Alright, question's been raised ah.. that ah.. the Resolution is on every members desk and there's not a necessity to ah...



- have a Resolution read in full, but ah.. if you desire to have the Clerk read it, why I'll ask him to."
- R. E. Mann: "Mr. Speaker, in order to conserve time, ah.. I will agree not to have it read."
- W. Robert Blair: "Alright, ah. you want to proceed then."
- R. E. Mann: "Well, Mr. Speaker and Members of the House, I move to suspend Rule 41 A, with respect to House Resolution 26, to allow the immediate conclusion of of that Resolution.. consideration of that Resolution on the Floor. Mr. Speaker, this Resolution would authorize the expenditure or the loaning of funds necessary to pail out the beleaquered Chicago Transit Authority. This Resolution memorializes the Exec.. the Executive to expend this money immediately, today, to meet the crisis in Chicago in Mass Transportation. This can be done by the Chief Executive by issuing a Warrant transferring the funds in the Federal Financial Fiscal Fund from the State Treasury where they now repose to the General Revenue Fund. And having done that, simultaneously, to expend the sum of \$28,000,000, or any sum less than \$88,000,000. that being the sum which now reposes in the Federal Fiscal Financial Trust. Now, that Trust is commonly known as the General.. as the Federal Revenue Sharing Monies and it comes to ah.. Illinois without earmarks, without strings, without attachments, and therefore may be spent immediately for any purpose, including bailing out the beleaguered C.T.A. Now, Mr. Speaker, I indicated that that money can be loaned as well as spent. We have precedent for that, Mr. Speaker, the State Treasu.. the State Treasurer, Stevenson, loaned General



Revenue Funds to Ghetto banks for the purpose of ah.. meetind the needs of the Inner Cities. He can do the same thing with the General Revenue Funds that are now available to him after he issues the Warrant. The.. the Treasurer has just done this by issuing monies to farmers for the purpose of ah.. granaries, so that there's no question about the precedent. Now, if we do not spend this money, we make a mockery of the State's responsibility to the urban area of Chicago and the County of Cook. The Mayor of the City of Chicago, as the Chief Executive of that great city, has asked that funds be made available to the C.T.A. in a ratio of two to one. The State is to expend ah.. twice as much money as the City and the County of Cook. Therefore, the Mayor having indicated that \$10,000,000 of City funds are available and \$5,000,000 of County of Cook funds are available, that \$30,000,000 should be expended first by the State in order to help the C.T.A. Now, as you know, there are many bills which the C.T.A. has to pay. It owes \$400,000 to Commonwealth Edison. There is a strike which is threatening to paralize mass transportation in the Cook County area. Mr. Speaker, and Members of the House, last Fall Governor Olgilvie wrote a letter in which he indicated that two people within the Executive Branch were authorized to issue this Warrant; the Governor and the Director of the Bureau of the Budget. This action which I seek today, action which would appropriate funds without legislative action, is clearly authorized under the 1970 State Constitution. And, Mr. Speaker, I would ask that this matter be immediately considered and I would urge

the membership of this House to immediately approve the Resolution with the necessary votes thereof and Mr. Speaker, with that I respectfully ask for the support of the Members of this House."

- W. Robert Blair: "The Gentleman from Cook, Mr. William Walsh."
- W. D. Walsh: "Well, Mr. Speaker and Ladies and Gentlemen of the House, needless to say I object to the Gentleman's motion to suspend the Rule and I object on ah.. for a variety of reasons and it's very difficult where.. to know where to begin. I call your attention to the fourth Whereas in the gentleman's Resolution which says 'Whereas the issuance of a Warrant is all that is needed to remove these monies from the Federal Financial Assistance Trust Fund to the General Revenue Fund'. I have difficulty relating that, Mr. Speaker, to Article VIII, Section 1-B, of the State Constitution which says that 'The General Assembly, by law, shall make appropriations for all expenditures of public funds by the State. Appropriations for a fiscal year shall not exceed funds estimated by the General Assembly to be available during that year. \* Now, Mr. Speaker, Federal Revenue Sharing Funds just as Federal Grants of every nature that flow to the State are public funds. There's never been any question that this was true. Now, I would like to say secondly that if the gentleman were right, if it were possible to do this by authority of the Governor without benefit of the Legislature, then what is the point in ah.. introducing a Resolution that has no force or effect at all, and I'm sure the gentleman will agree



me on that. He ought to take his case directly to Governor Walker and let Governor Walker listen to it and try to do what he is attempting to do. I am not sure that he's going to have much success because in the Governor's news conference of February 2nd, ah.. last week, he ah.. said 'I don't have the legal power to write checks on those funds. That money has to be appropriated by the General Assembly just like any other money.' And I certainly agree with the Governor's statement with regard to this. Ah.. further objections to the Resolution are that it.. they don't seem to be based at all on the immediate needs of the Chicago Transit Authority for bailing out. The House Appropriations Committee staff has done considerable work in this matter, ah.. has gone to Chicago and gone over the books of the C.T.A. and found that their immediate needs can be answered by a considerably less amount of money. So, I reiterate, Mr. Speaker and Ladies and Gentlemen of the House, that I object very strongly to the gentleman's motion and I would urge you to vote No thereon."

- W. Robert Blair: "Gentleman from Union, Mr. Choate."
- C. L. Choate: "Well, Mr. Speaker, Ladies and Gentlemen of the House, as I understand it, the immediate question that's confronting the House at the present time is whether the Resolution shall bypass committee or not. I want to be quite frank in my extremely brief remarks. Not only is the City of Chicago, but there's other areas Downstate, that is confronted with a problem as far as mass transit systems are concerned. I appreciate the Gentleman from Cook's attention



to attempt to bring about an expenditure of money that will help alleviate some of the problems that does confront the Chicago Transit Authority at the present time. I'm not saying to this House that this might not be a workable idea. I don't know yet. But I am only saying this, that I don't think that the Resolution should bypass committee. I think that it should go to committee to the extent that we do have a through study of it and the possibilities of it being a remedy as far as the Chicago Transit Authority is concerned and I ah.. would not support, though, Mr. Speaker, the idea of bypassing committee with it. I think we have time to go to committee and to give it the due consideration which I'm sure the committee would do."

- W. Robert Blair: "Gentleman from ah.. DuPage, Mr. Hoffman."
- G. L. Hoffman: "Mr. Speaker, Ladies and Gentlemen of the House, on this non-debatable motion, I move the previous question."
- W. Robert Blair: "Right, ah.. as a matter of procedure ah.. so as we move along in informing ah.. especially our new members about ah.. the situation, the question of suspension of the Rules is not debatable, but as a practical matter we've ah.. we've.. we have allowed, when the sponsor himself ah.. takes the time to explain his position as to why he wants it, ah.. a couple of ah.. ah.. comments from ah.. the members which only seems fair. So, now, the gentleman's motion is in order ah.. and ah.. all those in favor of the motion to move the previous question say Aye."

- W. Robert Blair: "Opposed No. The Ayes have it. Now we're back to the Gentleman from Cook, Mr. Mann, to close."
- R. E. Mann: "Well, Mr. Speaker and Members of the House, ah.. I feel compelled out of respect and a sense of duty to reply to the distinguished Majority Leader's arguments which ah.. as always are well taken and well put and sincerely held. First of all, ah.. a Resolution ah.. has as its purpose to memorialize a certain body or to urge a certain action. Ah.. I've been asked to take my case directly to Governor Walker. I'm taking my case directly to Governor Walker. And all he has to do is indicate by a nod of the head or a wink of the eye that he desires to bail out the beleaguered C.T.A. ah.. immediately. Ah.. with regard to the constitutional authority for this action, may I remind the distinguished Majority Leader that if you can spend money you can loan it. And it has been already demonstrated that monies can be loaned ah.. out of the General Revenue Fund for a specific purpose, to wit. ah. Secre.. ah.. Treasurer Stevenson would loan money to Ghetto banks for the purpose of improving the quality of life in the Inner City. Ah.. just recently, the Treasurer loaned money ah.. to farmers for purpose of improving life in our agricultural ah.. areas. We're dealing now ah.. with the immediate needs ah.., Mr. Majority Leader, ah.. of the State of Illinois. Ah.. and ah.. the Mayor has indicated that he needs \$30,000,000 immediately. Now, the distinguished Minority Leader has said that there are Downstate needs. Well, I would say that I'm taking my case to



Governor Walker with regard to Downstate mass transportation needs, too. There is \$60,000,000 left ah.. strike that, \$58,000,000 would be left in the General Revenue Fund for the purpose of meeting the ah.. financial, fiscal needs of ah.. Downstate mass transit. Having said this, Mr. Speaker, ah.. and appreciating very much ah.. the manner with which you have implemented the Rules today, I would ask for a favorable vote from the membership in this House. All I'm asking you to do is ask Governor Walker to do what he has promised to do and what he has said he can do. He said he is interested in bailing out mass transit in Chicago. Ah.. we agree with him. The Mayor agrees with him. The President of the County Board, George Dunne, agrees with him. Ah.. the people of the City of Chicago, who do not want a fare hike, who do not want a paralizing strike, agree with him. Let's get that money up by Pony Express, today, and let's end the debate on the C.T.A. and move on to other important matters

Fredric B. Selcke: "House Resolution 31. Choate et al. Whereas it is with deepest regret that this House notes the untimely passing of Steven J. Lamb of Great Chicago, and a truly fine human being, and whereas he has passed on in Augusta Hospital, February 5, 1973, at the age of 52, and whereas a prominent figure in the Illinois Labor Movement and Democratic politics, periennial chairman of the Chicago St. Patrick's Day Parade and long-time personal friend of Mayor Richard J. Daly of Chicago and House Democratic Leader, Clyde L. Choate of Anna, Steven Lamb became a remarkable successful career in 1937 as an apprentice plumber and whereas the good hard worker and trusted colleague, he was elevated to the Examining Board of the Plumbers Union in 1948 and the position of Recording Secretary only four years later in 1952, and whereas continuing his rise as a trusted person, he officially became Business Manager of the Chicago Journeyman's Plumbers Union, Local Number 130 in 1966, succeeding the late Steven M. Bailey, who had held the position for 22 years, and whereas four years ago, he was named international vice-president of the 255,000 member United Association of Journeymen and Apprentices of the Plumbers and Pipe Fitters Unions of the United States and Canada, and whereas he was also first vice-president of the Chicago



Federation of Labor and a delegate to the Regional AFLCIO Conventions and a member of the Plumbers Union Training Fund Board and Apprentice Program in the establishment of which he was instrumental and which had been adopted in locals throughout the United States, and whereas, speaking of his death, William A. Lee, President of the Chicago Federation of Labor, AFLCIO, said \* Chicago has lost a far too young vigorous community and labor leader. He was one of the Nation's most knowledgable trade leaders in the field of apprenticeship training and his ideas have been adopted throughout the Country. He was a quiet and effective leader and strong supporter of broad variety of charitable and civic needs', and whereas Thomas J. Nader, President of the Chicago Building Trades Council, speaking of Steven Lamb, said, 'Mr. Lamb's death is a shocking loss to the members of the plumbers union and all building tradesmen in the Labor Movement in the community', and whereas he is survived by his widow, Lucille, and two daughters, Mary Ann and Susan; Therefore, be it resolved by the House of Representatives of the 78th General Assembly, State of Illinois, that the Chicago community and the Illinois Labor Movement has lost a exemplary civic leader and we have all been enriched by his strong presence and that our deepest sympathy lies with with family, and be it further resolved, that a copy of this preamble and Resolution be presented to his widow and family and to Local 130 of the Chicago Journeyman's Plumbers Union."
