- Hon. W. Robert Blair: "Alright, well.... ah.... in order to ah.... suspend the provisions of Rule 41A, 107 votes are required. Gentleman from Lawerence, Mr. Cunningham."
- R. D. Cunningham: "Can we postpone the taking of the vote until next Tuesday, when the machine is in order, so we won't have to go down the line, or is it working now?



Can we have leave to postpone the rollcall until next

Tuesday. If Toby isn't willing to make the gracious gesture

of making our Resolution timely, the birthday will have

passed and this opportunity will not come again."

Hon. W. Robert Blair: "Gentleman from Bureau, Mr. Barry."

Tobias Barry: "I would like to respond. May I, Sir?"

Hon. W. Robert Blair: "It's a little out of order, but you certainly may."

Tobias Barry: "I objected to the Resolution on the Agreed Calendar for the reason that the resolution contained a blank as to a Bill, when presented for adoption with agreed resolutions. I see now that it has a Bill number. I further object to this substance of the Resolution because it in fact declares a Holiday for a State Employee for one day because it's their birthday. Now I love Nancy like he loves Nancy, but I think it's a poor policy for us to start in this House. For that reason, I suggest the Bill go to Committee at least."

Hon. W. Robert Blair: "Gentleman from Lawerence, Mr. Cunningham."

R. D. Cunningham: "Well, I respectfully urge, Toby, you missed the point. The day is already a legal holiday and that's why we sites you to the House Bill that shows that next Monday is a legal holiday. We gave her nothing. I am as determined as you that the taxpayer's interest be safe-quarded."

Hon. W. Robert Blair: "Gentleman from Bureau, Mr. Barry."



Tobias Barry: "Obviously, we don't need the Resolution, if it is a legal holiday."

Hon. W. Robert Blair: "Alright, ah.... we do have a motion, before the House. Does the gentleman desire to ask leave to withdraw the motion? Gentleman from...."

R. D. Cunningham: "Mr. Speaker, I suggested a moment ago
that the calling of the roll was an aggression against the
membership. Might we postpone the roll call until next
Tuesday and then if we are all in the mind that this particular individual should be wished a Happy Birthday, we can do
so. Is that permissible?"

Hon. W. Robert Blair: "Well, technically, you have a motion before the House, which takes the leave of the House for withdrawel. Now, what I would suggest as a procedure, ah.... might be that that matter be held on the Speaker's Table ah.... until next Tuesday rather than be assigned by the Speaker to the Committee on Assignment of Bills, and if you would care to renew your efforts on Tuesday, ah... I would assume you could do so at that time."

R. D. Cunningham: "Splendid suggestion. I accept it and asked that it be held on the Speaker's Table until next Tuesday, at which time I shall renew."

Hon. W. Robert Blair: "Alright, does the gentleman have consent to withdraw his motion? Hearing none, then that particular Resolution indicate that so that the Committee on Assignment realizes that it still remains on the Speaker's Table until next Tuesday, so they won't assign it some place. Your ahead so far. The gentleman from Lawrence, Mr. Cunningham



for what purpose do you rise?"

R. D. Cunningham: "May we hear a Resolution 20? May it be read please?"

Fredric B. Selcke: "House Resolution 20. Cunningham. Whereas it is in the interest of efficient state government that there be wholesale turnover of state employees as the result of the vicissitudes of political fortune and whereas state employees should not be religated to the status of second class citizens which enjoy the same rights as other citizens to participate in the political processes, Therefore be it resolved by the House of Representatives of the 78th General Assembly, the State of Illinois, that it is the consensus of the House that no state employee regardless of whether subject to the personnel code should be dismissed because of political party affiliations or off-duty political activity."

- W. Robert Blair: "The Gentleman from Lawrence, Mr. Cunningham."
- R. D. Cunningham: "Mr. Speaker and Members of the House.

  If you'll give me your attention for just a few minutes

  I want to talk to you about a matter of great interest to
  all of us called patronage."
- W. Robert Blair: "All right. The Gentleman from ah.. Cook, Mr. Shea. For what purpose do you rise?"
- J. Shea: "Ah, my understanding is the Gentleman has a resolution he is seeking to by-pass committee with."
- W. Robert Blair: "Yes. The Gentleman's point is well-taken and ah.. I ah.. was frankly expecting the Gentleman from



Lawrence to ah.. be just about at the point where he was asking for.. just a moment.. where he was going to put the motion to suspend the provisions of 41 a. Is that correct ah..?"

- R. D. Cunningham: "Indeed it was, Mr. Speaker."
- W. Robert Blair: "All right. The Gentleman ah.. has now moved to ah.. suspend the provisions of Rule 41 a with respect to House Resolution 20 and in the normal course of business we have allowed even though that non-debatable item the mover of it to give us a few minutes of why he thinks it ought to be suspended and I'll give you a chance to reply. And any other point of order you want to raise right now, I'll be happy to entertain."
- J. Shea: "Well, I'm goin' to.. I just want to inform the Chair that I will object to unanimous consent and I think the resolution ought to go to committee ah.. as he knows it's a subject matter of three or four lawsuits pending throughout the State of Illinois now and I think to embroil us in any court battles and that is exactly what this resolution would do, would be foolhardy at this time and I think the man's a good enough lawyer to know that."
- W. Robert Blair: "All right the Gentleman from Lawrence, Mr. Cunningham."
- R. D. Cunningham: "I agree on the recommendation and I would like to say just a few words now that we've got such controversial matters as Birthday Resolutions out of the way. In the olden days..."



- W. Robert Blair: "Now. ah. wait. wait a minute. Ah yer.. your motion to suspend 41 a is before the House and your're speaking to that motion. Is that right?"
- R. D. Cunningham: "Precisely. The same way it was done yesterday by Representative Mann and by everyone else."
- W. Robert Blair: "No.. I just wanted to make sure. I thought you said something about things being disposed of. That is the matter before the floor and you're addressing yourself to that question, sir, so proceed."
- R. D. Cunningham: "Thank you for your assistance."
- W. Robert Blair: "All right. Wait just a moment. What.. for what purpose does the Gentleman from ah.. Cook, Mr. Lechowicz rise?"
- T. Lechowicz: "Point of order, Mr. Speaker. I thought that the motion was to ah.. have the floor address this matter. There was an objection raised and I think that for having him to speak on this would be out of order."
- W. Robert Blair: "Well. What the Gentleman from Lawrence has done is to move to suspend the provisions of Rule 41 a for the immediate consideration and adoption of ah.. House Resolution 20 and we have in the past accorded the maker of such a motion the opportunity to explain why he feels that motion should carry and then we've allowed a very limited rebuttal position even though suspension of the rules is not a debatable subject. And your point is quite well taken. I assume you want to handle the matter as we have in the past and allow a few minutes ah.. comments. So



proceeding on that basis.. The Gentleman from Lawrence, Mr. Cunningham."

- R. D. Cunningham: "Mr. Speaker and Members of the House. In the olden days, each new administration engaged in the wholesale dismissal of experienced employees and a new crop of political creditors were brought in on the scene. But this system, this time-worn spoil system, was too wateful of human resources to be tolerated by an enlightened public. So we have the merit system in Illinois, and I think that it was long overdue. It's a system of government that can serve well all the people if there is patience and dedication and a resolute adhering to it by all of us. Unhappily the problem is somewhat complicated in our State just now because last November, a partisan judge issued an order enjoined in the Secretary of State for certifying thousands of.. of proven employees who were entitled to the protection of the personnel code. I don't interupt when you folks talk, let me be heard a little while."
- W. Robert Blair: "Now, now. Hold on. hold on. The Genlteman from Union, Mr. Choate. What purpose do you rise?"
- C. Choate: "Well, inasmuch as the Gentleman is ah.. taking the attitude that he is taking, I am going to raise a point of order. I'm not sure that I am right because I don't have a.. a copy of the printed ah.. ah.. daily order of business in my hand. But it seems to me that I remember when we was discussing the rules, at this stage of business of discussing agreed or passing of agreed resolutions and I was thinking



- that the unagreed resolutions come at the ah.. latter stage of business as far as the House was concerned."
- W. Robert Blair: "Ah.. we are on order of business number 21 which is general resolutions. We passed the agreed resolutions and then went to the constitutional resolutions amendment resolutions. And now we are factually on the general.."
- C. Choate: "I didn't realize that we was on the subject of 21 which ah.. then is in order in doing what he's doing. But I would ask, Mr. Speaker, that the Gentleman ah.. keep his remarks germane to the resolution and cut out the frivilous things that he's doing."
- W. Robert Blair: "All right. This is a limited privilege situation which ah.. you.. you only have the floor until somebody actually wants to get up and object to your explanation since debate is not permissable on suspension. So, I would assume that you would want to confine your remarks to a.. just your motion. Now, the Gentleman from Cook, Mr. Shea. Are you seeking recognition?"
- J. Shea: "Mr. Speaker. I don't mind Mr. Cunningham making political speeches on the floor. We all do it. But I do object to using this point to more or less castigate the Secretary of State. So, I would wish that he would hold his remarks to suspending the Rules of the House. Not to try to take apart the Secretary of State."
- W. Robert Blair: "All right. The Gentleman from Lawrence will bring his arguments to a close now."



- R. D. Cunningham: "Mr. Speaker, it would seem simple justice to allow me as much time as the objectors. I can live with any precedence they establish but heretofore, we have permitted the argument. And if it's not going to be allowed in the future, fine. But we will remind the Chair of the ruling. In this particular situation that we're confronted with in Illinois, because of that decision last fall by a partisan judge, there are thousands of dedicated employees who have the .. "
  - W. Robert Blair: "All right. We're back in trouble again. Okay. For what purpose does the Gentleman from Moultrie Mr. Stone rise?"
  - Moultrie: "Mr. Speaker, I object to the Gentleman proceeding in this fashion and I ask that debate be closed as the rules provide."
  - W. Robert Blair: "All right. The Gentleman's objection is in order. For what purpose does the Gentleman from Lawrence Mr. Cunningham rise?"
  - R. D. Cunningham: "May I close by saying it's the truth that stings in this world. And we have the responsibility of following the courageous leadership of a man named 'Shockman' who took a course to the federal case.. who took a case to the federal courts and showed that we no longer believe in the spoil system in Illinois and the people on the other side of the aisle must accept the legal reality to which they're confronted."
    - W. Robert Blair: "Now, wait a minute. The Gentleman's point

from Moultrie is quite well-taken. Ah.. that ah.. you no longer ah.. debate the matter and I assume that you were closing then, right?"

- R. D. Cunningham: "I want to make the motion."
- W. Robert Blair: "OH, you renew your motion. The Gentleman is renewing.. you're renewing your motion now. For what purpose does the Gentleman from Lawrence, Mr. Cunningham rise?"
- R. D. Cunningham: "Mr. Speaker, at this time I wanted to move that my motion lie on the Speakers Table to be called next Tuesday so we can have a printed record of how every member wishes to vote in the interest of saving the time of all the members of this House.. and ask consent.
- W. Robert Blair: "All right now. There.. there are some complications with regard to the situation. There is a motion before the body. The Gentleman's attempting to ah.. move to ah.. place that matter on the table. The table he's talking about is the Speaker's Table and you cannot move to table something to the Speaker's Table. So, that motion would not be in order. For what purpose does the Gentleman from Cook, Mr. Shea rise?"
- J. Shea: "Well, I that.. I'm confused at what he wants to do.

  If he wants to table his resolution, I'll give him leave to do
  that. If he wants to by-pass the committee, I want a roll
  call vote on it."
- W. Robert Blair: "Well, I think what he intended to do was to ah.. have the same thing happen ah.. to this resolution



that happened to his 35 which was to ask leave to withdraw his motion to suspend the provisions of 41 a and ask the Speaker if he would hold that matter on the Speaker's Table without assignment to the Committee on Assignments until at least next Tuesday."

- J. Shea: "I'll object to that."
- W. Robert Blair: "You'll object to his withdrawing ah.. the motion? Ah.. to suspend? Just be at ease for a minute while we resolve this question. I'm interested in. There's a number of votes required. All right. Under Rule 62, Motions, generally, 'c' provides that once a motion has been stated by the Speaker or read aloud by the Clerk, it may be withdrawn only by leave of the House. Now, the Gentleman asked for that leave ah.. objection was made, so we're now with the motion still before us. Gentleman from Lake Mr. Murphy."
- W. Murphy: "Ah.. parliamentary inquiry, Mr. Speaker. Would a motion to postpone to a date certain ah.. allow Representative Cunningham to postpone his bills to Tuesday as he requested, or a later date or a certain date?"
- W. Robert Blair: "All right the Chair would rule that the ah.. Gentleman's point is well taken. A motion to postpone to a day certain such as next Tuesday, would be in order under the provisions under the Rule 63 and ah.. for what purpose does the Gentleman from Cook, Mr. Shea rise?"
- J. Shea: "Ah, I think ah.. if Representative Murphy would like me to withdraw my objection I'd be very happy to do



- him. If he would just keep his member from making his Fourth of July speeches all the time."
- W. Robert Blair: "There's a conditional proposal, Mr. Murphy, and.. The Gentleman from Lake, Mr. Murphy."
- W. J. Murphy: "Ah.. Mr. Speaker, I'd like to tell the distinguished leader over there that while I sometimes cause a lot of my own problems I've never considered that I could possibly keep Representative Cunningham from making the Fourth of July speech. So, I couldn't really make any firm promise."
- W. Robert Blair: "Alright, then I take it that ah.. Gentleman from Cook, ah.. Mr. Ewell."
- R. W. Ewell: "Just a point of order. Ah.. I personally have no objections, but would Mr. Cunningham be bound by Rule 57 which says that no member shall speak more than twice to the same subject. I feel that a large number of us would be.. would be greatly relieved if we found that this rule would apply and would not have any further objection. If he could speak no further, I'm sure all of us would agree to postpone it."
- W. Robert Blair: "Ah.. I think the Gentleman's point is well taken ah.. under the provisions of Rule 57-G, if the question remains pending when the House adjourns on a day and is revived on a succeeding day, no member who has spoken on the preceding day may speak again on the question without leave.

- W. Robert Blair: "Yes."
- R. W. Ewell: "Did we ah.. get leave of the House or do we.."
- W. Robert Blair: "No, I proceeded under Rule 10-A, which provides that any Order of Business may be changed any time by the Speaker."
- R. W. Ewell: "Without Leave. I just wanted.."
- W. Robert Blair: "Yeh, no, we.. we made that very clear ah.. this time, if you look at 10-A. We discussed that at.. quite at length ah.. in the Rules Committee. - W. Robert Blair: "Alright, ah.. we're going to try to have matters like this confined to a particular Order of Business rather than just one. I guess another good example, for example, I was.. I'm on Introductions, First Reading, I will bring myself down now to 22, which is Announcements, and ah.. I think that's the category, so under.. Oh, it's a Motion, alright. Down to the Order of Business of Motions, so that ah.. you can put your Motion which is asking leave of the House to have Representative McMasters added as a Co-Sponsor on Bill.."
- R. O. Hart: "House Bill 128."
- W. Robert Blair: "Alright, is there ah. Leave. Alright, ah. hearing no objections that will be done. Ah. for what



- purpose does the Gentleman from ah.. Lake, Mr. Pierce, rise.
- D. M. Pierce: "Mr. Speaker, on the same Order of Business, I would like permission to add Representatives Berman and Jaffee as Co-Sponsors of House Bill 174."
- W. Robert Blair: "Alright, does the Gentleman have Leave. Hearing no objection that will be done. Gentleman from ah.. Cook, Mr. William Walsh."
- W. D. the ah. Minority Leader and I ah. discuss that before we
leave here this eve.. what we might do on Tuesday, to accomodate ah. the situation on Wednesday. I. I.."

- T. S. Lechowicz: "Well, Mr. Speaker, I'd just like to also point out that the date that was established ah.. was cleared with Senator Harris and in turn Senator Partee and it was their understanding that the House would come back on the 15th. That's why they chose the 14th date."
- W. Robert Blair: "Well, there are certainly matters of grave importance before this House and its committees and ah.. I determined that ah.. ah.. there are certainly matters of mutual interest and I determined that it would be in the best interest of this Body to stay in session this week and next week to accomplish the people's business. Senators Harris and Partee decided another course of action and that was their judgement. Gentleman from Cook, Mr. Lechowicz."
- T. S. Lechowicz: "Well, would it be permissible then, Mr. Speaker, to show for the record that we are officially excused because of this reason."
- W. Robert Blair: "Well, there's no such provision ah.. in the Rules, ah.. for an official excuse. That isn't until



Wednesday, is it. And we're coming back in on Tuesday.

And what I'm suggesting is that if we can ascertain the facts about what's going to be on on that day the Minority Leader and I can sit down and figure out ah.. when we can have the House in Session on Wednesday. ah.. and uh.. - J. R. Washburn: "Ah.. Mr. Speaker and Ladies and Gentlemen of the House, I just wished to announce that the Appropriations Committee will meet at 2:00 this afternoon in 212 rather than in A-1 as originally scheduled. It will be in 212 at 2:00."
- W. Robert Blair: "Alright, are there any ah.. further announcements. Alright, the Gentleman from Cook, Mr. William Walsh."
- W. D. Walsh: "Now, Mr. Speaker, I move that the House adjourn.
