Clerk Selcke: "All those not entitled to the Floor, please retire to the Gallery."

Speaker Blair: "Is this turned on? All right, the House will be in Order. The House will be in Order. You can't hear me? All right, the House will be in Order. All right, the House will be in Order. The invocation will be by Doctor Johnson."

Doctor Johnson: "We pray. Eternal God, our Maker and Redeemer, the Lord and Giver of life, we confess that You are not bound in temples and buildings which mens hands have made. You dwell in the hearts of those who love mercy, do justice and walk humbly with You, their God. Nonetheless, we ask You now to bestow your presence and Your benediction upon this renovated Chamber and all who work in this Chamber of government. Let Your devine presence sustain us especially, as we enter into this spring session. Let the intentions of our hearts, the words of our mouths and the work of our hands be found acceptable in Your sight. Under Your devine governess, grant that what we think, say and do hear may reknown to the welfare to the People of this State, who have established this branch of government, to enact those ordinances under which all may live in justice, liberty and the pursuit of happiness. And now we here dedicate ourselves and this our legislative home to Your honor and the well-being of our citizens, oh Lord, our strength, our E edeemer. Amen."

Speaker Blair: "Roll Call for Attendance. All right, your switches should be open now and you can vote 'present' if you're here.

Well we..... Fred's going to, the Clerk's going to explain, if you'll give us your attention, please. Now obviously, it's going to take some periods of time, in which to learn this new System and the Clerk has graciously consented to give us a short instruction period."

Clerk Selcke: "If I can have all your attention, I'll try to explain this system to you. If you'll look on your desk, you'll notice you have the 'yes', 'no' and 'present'. Now when we take the



Roll Call, we'd like you to mark the 'present', push the 'present' button, which will show up on the board in a yellow light. Now one thing about voting on this machine, once you've made up your mind to vote, you can change your vote from a 'yes' to a 'no' or a 'no' to a 'yes' or a 'yes' to a present and so forth, but once you push the button and you decide you don't want to be recorded at all, you can't get off. You're on. Forever. So, there is one way we can get you off, but if we take you off, we have to take everybody else off, too, so before you make that momentus decision, I wish you'd think about it, because we don't want you running up here and asking us to dump the vote so you can start all over. Can't hear me? O'kay. John says to give you the announcement again about the changing the votes, so you don't make mistakes. Now, some of you say you can't hear? Can't hear anything, huh? Huh? Well, if you've noticed, we've got a hum in this system, so we've turned the volume, the power down a little bit, and as soon as we get the hum out, we'll give you a full blast. Ah.... there it comes now. Hear it? We've got ah the firm that's been putting this in, has been working night and day, trying to get the bugs out of it. Everything is not in operational order yet, but it is working sufficiently, so we can proceed and you can cast your votes, so I see except for Weber and Bluthardt and Barnes and Choate, oh I better quit counting. There's more coming on. We'd like to have everybody vote 'present' if you would. Any questions? 0'kay."

Speaker Blair: "Fred."

Clerk Selcke: "Another thing, will the individual that is voting for an individual that is not here, please refrain from this, because you're going to get them in trouble with the Comptroller and everybody else and I'm sure you're all full of Internal Revenue business, so please don't pull a guy's switch when a guy's not here, cause if the Roll Call shows he's here, he's going to get a check and that's going to screw up the whole works, so please, please don't pull anybody's switch that's



not here and I'm particularly referring to Toby Barry's switch now. All right, now let's do it all over again and only pull your own switch."

Speaker Blair: "Roll Call for attendance. Open it up on your desk.
O'kay. Mr. William Walsh."

Clerk Selcke: "Both Parties will go to Conferences now and we'll be back here at 2:00 O'Clock sharp. 212. Democrats M-5."

Speaker Blair: "Mr. Cunningham."

Cunningham: "There comes a time in the tide in the affairs of men where a vicious regard for excellence requires each of us to pause and pay tribute to that priceless commodity and such a moment has come here today to this House and I can think of no finer way to celebrate our entry into this handsomely remodeled Peoples Chamber and I salute the Speaker for his perserverence and determination in that regard, and then to present to you the #1 high school basketball team in the State of Illinois, bar none. LaFleur: "Yes, well these are all Retirement Bills, these are all Retirement Bills, 638 came from the Senate and it allowed qualification of Pension for people who had served under I.M.R.S. Legislative Pensions. Amendment #2 allowed for the qualification of Legislative Pensions who served in Municipalities that had qualified for I.M.R.F. but had never paid into I.M.R.F. Amendment #3...Amendment #2."

Shea: "Is there any objection to taking this out of the record until we can find out what's going on with it? You know Mr. Speaker, we have no copies of the Bills, we have no copy of the Amendment."

Speaker Blair: "What's the pleasure of the Gentleman from DuPage?

Take it out of the record?"

LaFleur: "Fine."

Speaker Blair: "All right, so he indicates that we'll take it out of the record. Ah...Have...have you each listened to whether or not your speakers at your individual desks are actually working? Ah...they're not actually working? Just a few of them? I'm not on? They're not on? Are they trying to fix this thing now Fred? Are they working on it now or what?
