Ebbesen: "Mr. Chairman, and Ladies and Gentlemen of the House. House Bill 1797, as amended, amends the Illinois Governmental Ethics Act. Now the Illinois Constitution provides that the General Assembly by law shall prescribe a reasonable time for the filing of the statements of economic interests and quoting, 'the failure to file a statement within the statement prescribed shall result in ineligibility for or forfeiture of office.' Now basically, House Bill 1797 especially now after having been amended twice, once in committee and once this morning in the House Floor, does amend the Ethics Act and spells out the constitutional penalty for the failure to file a statement of economic interests. It also amends the Act to include certain position of public employees...employment to comply with a 1972 opinion of the Attorney General and makes it clear that both public officials and certain employees who fail to comply are ineligible for or must forfeit that particular office or position of employment whichever the case may be.

I would encourage everybody's support for House Bill 1797." Telcser: "The gentleman from Cook, Representative Lundy." Lundy: "Thank you Mr. Speaker, Ladies and Gentlemen of the House.

I'm alittle distressed that the membership doesn't seem to be listening. It seems to me that this is a Bill of really extrodinary importance to the Members of the House and others as well. If the sponsor would yield for a question, I'd

like to try to clarify something with him."

Telcser: "He indicates he will."

Lundy: "Joe, am I correct that this Bill rather than imposing very drastic penalties, in fact, provides by law for penalties which in some cases would be less drastic than those required under the constitution?"

Ebbesen: "It's the same as the constitution."

Lundy: "Well, then the purpose of the Bill is simply to specify the procedures to be followed in imposing the constitutionally required penalties."

Telcser: "The gentleman from Cook, Representative Shea." Shea: "Will the sponsor yield for a question or two?" Telcser: "Indicates he will."

Shea: "Since we've talked about this last, I've had occasion to try and find out some information. I talked to John Hoppercamp in the Secretary of State's office and he tells me that there are 675 people who filed their ethics statement on May 1st or after. I see by this mornings paper that the State's Attorney in Will County filed lawsuits against 74 people on a selective basis. Now, I didn't quite understand that selective basis maybe one of the gentlemen from Will can explain that to me."

Ebbesen: "Well...uh...that was the first time, relative to the implementation of this particular section of the Ethics Act and also the constitution and the purpose of this is spelled out very clearly for the future and we also did pass a Bill out of the House within the past month at which time in the future when we file, anyone files for public office, they will receive notice that they are to file a statement of economic interest."

Shea: "Yes, I understand that. What about this Bill, I think, we would have a very dire effect on 675 people in State government, it would have on at least, if I'm to believe the information in this mornings paper, 74 people in Will County and Lord knows how many other people throughout this State that, you know, are employees and don't even know their supposed to file these things."
Ebbesen: "Well, Jerry,...uh...I don't think this Bill is retro-

Ebbesen: "Well, Jerry,...uh...I don't think this Bill is retroactive, I don't think it goes back at the time this was done



was the initial inception of this particular procedure. I think this Bill is something that looks into the future as opposed to going retroactive in its effect."

Shea: "Well, I still have problem with it, I want you to understand that."

Ebbesen: "And I appreciate that...uh..."

Telcser: "The gentleman from Bureau, Representative Barry." Barry: "Joe, now as I understand the dialogue, this suggests that the people who are employed and earn more than \$20,000 live by the same rules that we who are elected are demanded to live by as suggested by the new constitution, is that simply what it is?"

Ebbesen: "Yes very simply, that's exactly what it is." Telcser: Is there further discussion? Does the gentleman wish

to close the debate?"

Ebbesen: "I would just...uh...in the interest of time, encourage a yes vote on House Bill 1797."

Telcser: "Question is shall House Bill 1797 pass? All those in favor signify by voting aye, the opposed by voting no. Record Representative Shea as voting present. Lauer aye. Alright, there's a number of people who want to be recorded as voting present yet. Kosinski present. Laurino present. Kozubowski present. Brandt, Thompson, Leon, Houlihan, Do. Matijevich: "Mr. Speaker and Members of the House, this is a Bill which we thoroughly discussed some time ago relating to the provision involvement in dispensing of drugs. I want all of you to pay close attention because when this Bill was called on Third Reading I mentioned that I would, because some asked me, amend it to be a prohibition of fee splitting on drugs only. However, some have talked to me and also I think House Bill 979 which has been sent to the Senate can do that job. So those of you who) think that I am now going to amend it to be a prohibition of fee splitting only, I want you to know that this is a more stringent Bill than I had originally which eliminates the dispensing of drugs by the medical practioner as outlined in the Act and I would solicit your favorable support on House Bill 979."

Telcser: "Is there any discussion? The question is, the Gentleman from Cook, Representative Huskey."

Huskey: "Mr. Speaker, can I ask the Sponsor a question? Did I understand correctly that you say that all the Bill

relates to now is fee splitting?"

Matijevich: "No, I wanted to be clear with you, Representative Huskey, because I think you are one of them that I said I would probably amend it to be a prohibition of fee! splitting only. But I would rather go up and down, up or down on the more stringent Bill. There are enough pay cards for the rural physicians, etc. and I think to be a real viable Bill in relation to getting the physicians out of the drug dispensing business I would rather go up or down on this Bill as it is."

Huskey: "Well, then I would like to speak on the Bill. Actually we have a Bill here that is going to affect every medical center in the State of Illinois that dispenses drugs because in most cases the doctors pool their money together to build these medical centers that would not normally be built and in most cases they put a drug dispensing



unit in these medical centers. Now, doesn't this make sense that if you go to a doctor in a medical center that you buy your medicine or drugs on your way out to go home that you didn't have to go to some distant drug store or pharmacy to get your prescription filled? And this is going to hurt thousands and thousands of people. It's also going to put a lot of people out of jobs and in most cases, when I rise to oppose a Bill it's only a Bill that is going to put a lot of people out of a job. So I hope that you people oppose this Bill also." Telcser: "The Gentleman from Cook, Representative Douglas." Douglas: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, it's not easy since most of my medical colleagues who have spoken to me tend to be opposed to this Bill to stand up and to tell you that I think it's. very important that we vote for it and I would like to explain why for those of you who have may have any doubts at this point. First of all, it does not prevent doctors in any way from dispensing drugs to their patients. What it does it prevents doctors from being in a business that they are not prepared to be in and that is selling drugs to their patients and I can say from enough experience that there is good reason why doctors should not sell drugs. If they wish to give drugs to their patients in line with the treatment that they are administering I can tell you from enough experience that they can do it without losing one penny. Doctors get drugs from pharmeceutical houses in abundance. If a doctor wants to give a drug to a patient in line with treatment which he feels in any part of Illinois is in the patient's best interest he doesn't have to be in the drug business or in the pharmeceutical supply business. I urge you to vote for this Bill for another very important reason. There is enough research to justify the conclusion that doctors who profit from selling drugs tend to over-prescribe and tend to over-



dispense and without any undue criticism of my fellow practioners I will say that this Bill will help doctors to do the job they are trained for and that they should do. It will separate the two professions of medicine and pharmacy. I think that the Bill is designed for the best interest of the patient and I think that the fears that have been expressed by those who say doctors in rural areas where there are drug stores not available will not be able to do their business is unjustified. They can give away drugs, they can get drugs in other ways and I understand from Representative Matijevich that there are protective parts in this Bill and anyhow and I think this is a good Bill and you should vote for it."

Telcser: "The Gentleman from Lakeside, Representative Miller."

Miller: "Well, Mr. Speaker and Ladies and Gentlemen of the House, according to the Calendar this Bill has not been amended since we discussed it the other day and my, I am also what this Bill is trying to do except, except Ladies and Gentlemen, we have enough trouble now getting doctors in our small villages and cities downstate This is going to magnify our problem. I would like to be very specific. I have a small village in my district where there is a family doctor. There is a small country drug store. That's all within 20 miles. This doctor has no choice other than to carry his own supply of drugs of those which the druggist refuses or is unable to maintain. What is going to happen if this Bill passes in that area? This Bill, as I understand it, does not provide for the doctor to furnish drugs in those cases where the druggist does not have the necessary drugs available. That is the problem, Ladies and Gentlemen. I know another village in my area in which there is no drug store. In that instance I understand that this Bill does solve the problem because then the

doctor can dispense drugs. But what about the case where adequate drugs, the one he needs to prescribe are not available? Do you expect every patient to drive 20 miles to buy drugs at the nearest drug store where he can buy the particular drug that is prescribed by the doctor? Let's don't jeopardize the health of the people in the small areas of Illinois. Let's vote this Bill down."

Telcser: "Is there further discussion? If not, the Gentleman from Cook, Representative Williams."

Williams: "Thank you, Mr., thank you, Mr. Speaker. I would

like to answer that Gentleman on that question. This Bill will not at all prevent that doctor in the small town there for dispensing the necessary medication to his patient. I see what this Bill will do is in areas where there are pharmaceutical services, it says the doctor cannot dispense these as long as there are adequate pharmaceutical services. Not to eliminate the small town doctor who wants to provide that service for his patients. What this Bill is it will prevent the, let's say the exploitation or the possible violation of anti-trust that could exist in other areas and I urge an 'aye' vote on this Bill. Thank you,"

Telcser: "The Gentleman from Marion, Representative Stedelin.' Stedelin: "Mr. Speaker and Ladies and Gentlemen of the

House, it seems funny to me that a doctor don't know what in the heck he is prescribing. To me this is another thing in the world for a Bill that protects the druggist. That's all it is. For instance, I happen to be on a certain medication. I go to a drug store. I pay 12¢ for the same particular medication that I get from the doctor in this community that that prescribes these pills for 9¢. I think this Bill is nothing in the world but a Bill to help one particular class and I have relatives in both class so you can't say it's a conflict of interest. Thank you."



Telcser: "The Gentleman from Lake, Representative Matijevich to close."

Matijevich: "I will only close by saying that the Bill has the protection for the rural physicians and they can dispense where there are emergency situations, etc. and also when you talk about the physician possibly selling some drug for 9¢ remember, he might not even dispense that drug for 9¢ if he didn't know he is getting a profit on it. There are many, many people having drugs prescribed to them for the simple reason that a physician is getting a profit off of that drug and I think we ought to eliminate that. This Bill does it. I solicit your support for House Bill 978."

Telcser: "The question is, shall House Bill 978 pass. All those in favor signify by voting 'aye', the opposed by voting 'no'. Have all voted who wish? Take the record. On this question there are 60 'ayes', 49 'nays', and this Bill having failed to receive a, Tuerk 'no', having failed to receive a, Peters 'aye', Ryan wishes to be recorded as voting 'present' and this Bill having failed to receive a Constitutional Majority is hereby declared lost. Now, the Gentleman from Cook, Representative William Walsh with respect to one motion and then we will go right back to considerations postponed."

Walsh: "Mr. Speaker, in order that Members who have Senate Bills may set them for Committee next week, I move to suspend the provisions of Rule 18 and that is the 6'1/2 day posting rule for next week only so that Bills may be posted today and heard in the Tuesday, Wednesday or Thursday Committees next week. So if we are successful, if this motion prevails and I have every reason to think it will and you have Senate Bills, try to get them posted for next week so that we can dispose of them and I so move, Mr. Speaker."

Walsh: "No, I don't believe so. No, I think we can hear them the week after next also but..."

Wall: "Yeah, but our Committee clerks were told that next week would be the last week..."

Walsh: "I heard that rumor John. I don't think they are correct."

Telcser: "The Gentleman has moved to suspend our provisions for Rule 18 for the purpose of having Senate Bills posted for hearing next week. All in favor of the Gentleman's motion signify by voting 'aye', the opposed by voting 'no'. 107 votes. Have all voted who wish? Take the record. Lemke 'aye'. On this question 135 'ayes', no 'nays' and the Gentleman's motion prevails. On the order of consideration postponed, Geo-Karis 'aye', on the order of consideration postponed appears House Bill 1714 for which purpose the Gentleman from Cook, Representative Phil Collins is recognized."

Collins: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 1714 is a Bill which amends the Chicago Firemen's Annuity Fund which would provide for an increase in the minimum benefits for widows of firemen in the city of Chicago. This Bill received either 84 or 85 votes last week and fell a little short of passage because some questions were raised as to the cost of the program. Thanks to Representative Terzich who presented me with some figures it now is indicated that the cost would be minimal spread over the three year period in addition to the fact that the fund did have a substantial reserve in 1973 which would provide ample funds for the payment for this increase out of current revenue and I would ask for the favorable consideration of the House."

Telcser: "Is there any discussion? The question is shall



House Bill 1714 pass. All those in favor signify by voting 'aye', the opposed by voting 'no'. Have all voted who wish? Have all voted who wish? Take the record. Telcser 'aye'. On this question there are 105 'ayes', 3 'nays' and this Bill having received the Constitutional Majority is hereby declared passed. Record Representative Martin as voting 'aye'. Taylor 'aye'. On the order of consideration postponed appears House Bill 1108 for which purpose the Gentleman from Randolph, Representative Springer is recognized."

Springer: "Mr. Speaker and Ladies and Gentlemen of the House, House Bill 1108 repeals an Act relating to acquisitions, possession and transfer of firearms and firearms ammunition. This Act has been in force for five years. The Act has not reduced crime or homicide. The Act has not increased the efficiency of the Department of Law Enforcement. The Act has penalized over one million Illinois residents by compelling them to register as a gun owner for \$5.00 fees. Since this Act has had a trial run for five years it has not really accomplished anything. I therefore ask you for your affirmative vote for the repeal of this Act."

Telcser: "Is there any discussion? The Gentleman from Cook, Representative Jaffe."

Jaffe: "Mr. Speaker and Ladies and Gentlemen of the House, this Bill was substantially beat back the last time it was up. This repeals the Gun Registration Act. It seems to me that we have worked for years to get a gun registration act in the State of Illinois. We have finally got it and now this Bill tries to eliminate it. I think that this would be a step backwards for the State of Illinois and would be disastrous. If you take a look at the Committee it was assigned to it was assigned to the Committee on Agricultural Natural Resources and I think that it's rather strange that this type of Bill got sent to that Committee and I think that



the reason that it was sent to that Committee was only because of the fact that that was the only Committee that would pass out a Bill of this type. I would therefore urge the defeat of this Bill."

Telcser: "The Gentleman from Macoupin, Representative Boyle."

Boyle: "Mr. Speaker, that's the second time that the distinguished Gentleman from Cook county talked about the Agriculture and the Conservation Committee of the House. Now the first time he talked about it I didn't say anything. But this time I am and there has been some implications throughout the session that our Committee hasn't given Bills a fair hearing. I would like to point out to the distinguished Gentleman that his Bills haven't done too bad in that Committee this session but I would suggest that if he keeps talking that way his batting average may go down."

Telcser: "The Gentleman, Representative Jaffe, for what purpose..."

Jaffe: "On a point of personal privilege. I would like to tell my good friend from Macoupin that I only got one Bill out of that Committee. I only had one Bill before that Committee and the way I got it out was to discharge the Committee."

Telcser: "The Gentleman from Madison, Representative Kennedy." Kennedy: "Mr. Speaker and Ladies and Gentlemen of the

House, I rise to support House Bill 1108 and with my distinguished seatmate directly to my left in the front, to remind him of the list of Sponsors on that Bill.
There is quite a number of bi-partisian support for this Bill and Firearm Registration Act has been very ineffective and I urge your support of this Bill."
Telcser: "The Gentleman from Marion, Representative Stedelin."
Stedelin: "Mr. Speaker and Ladies and Gentlemen of the House, I happened to have been on the Conservation Committee which is the same as we have now on the original

Bill that we have gun registrations. It was heard in that Committee and I want you to know that the Committee passed this particular Bill out. I am sorry that they did but they did. So it's not the Committee that was to fault for it."

Telcser: "The Gentleman from St. Clair, Representative Flinn."

Flinn: "Well, Mr. Speaker, maybe I should ask you first, is the rule still in that, you are going to have only two proponents and two opponents today?" Telcser: "Yes, we would like to if we can." Flinn: "Well, all right, then I will sit down." Telcser: "Go ahead, I called on you, Representative."

Flinn: "All right, I rise, I rise in support of this

Bill. It doesn't do a thing except cost the gun owners a \$5.00 bill. That's what it costs. It should have never passed to start with and it should be done away at this time."

Telcser: "The Gentleman from Cook, Representative Ike Sims." Sims: "Representative Springer, do your Bill affect home

rule units? Do your Bill affect home rule units?" Springer: "No."

Telcser: "The Gentleman from Kankakee, Representative Beaupre."

Beaupre: "Mr. Speaker, I would like to ask the Sponsor a question. When this Bill appeared on the floor the last time and again today we have heard assertions by the Sponsor and those who are for the Bill that the gun registration has not accomplished its purpose. That may very well be true but I would like to have some sort of response as to stastics or some argument in that respect rather than just drawing those conclusions and I haven't heard any. Neither the last time it was discussed or this time."

Telcser: "The Gentleman from Randolph, Representative Springer to close."



Springer: "Mr. Speaker, did the Gentleman ask a question?" Telcser: "Who asked the question? Oh, I'm sorry, the Gentleman from Randolph, do you wish to respond to his question?"

Springer: "Some of the statistics, an informal telephone survey of Illinois counties other than Cook indicates that the counties have generally experienced six or fewer prosecutions for violations of a Firearms Owner Identification Act since 1968. The officers of the State's Attorney in these sample counties reported the prosecutions for violations of the Act are usually in connection with another charge such as hunting without a license, assault, robbery and so forth. Precise statistics on the number of prosecutions for violations of the Act are difficult to obtain because the records of the prosecution are filed in the Circuit Clerk's office in chronological order without regard to this type of offense. Obtaining precise information would require searching every prosecution file since '68 and checking every charge on each file. The impressions of the State's Attorneys and Circuit Clerks in the counties sampled, however, would seem to indicate that the prosecutions for violations of the Act occur at about the rate of two per year in each county, mostly in connection with other criminal charges."

Telcser: "Representative Beaupre."

Beaupre: "Well, I think that answers the question as to how many prosecutions there are and points up the activity towards the enforcement of this law but as I understand it the gun registration law was passed for the purpose of keeping track of weapons and the experience in the prosecution of the law I don't think really addresses itself to the real matter and that is, whether or not we're going to have some sort of record as to who possesses and owns weapons."

Telcser: "The Gentleman from Randolph, Representative Springer



Springer: "To close?" Telcser: "To close."

Springer: "Mr. Speaker and Ladies and Gentlemen of the House, when this Bill was heard in Committee it was posted as according to the rules. There was no one from the Department of Law Enforcement, no one to testify as an opponent. Therefore, I think, actually the Department of Law Enforcement is not really interested in it and I urge your affirmative vote. Thank you very much." I feel that this has been a bad piece of legislation when it was passed by this House, therefore, I will go back to the old saying, wise men change their minds, fools never do and I hope we don't have a bunch of fools. Thank you."

Telcser: "O.K., Representative Harold Washington. O.K.,

It's of no value to know and an expensive ridiculous situation to just regulate and put down on paper the names of those that are honest and keep their guns registered, or rather not the guns but themselves. The thing to do is to forget it. It's the unregistered gun that is doing the killing and they are not about to register themselves. All you've got to do is go look at the record. I have it at home. The decrease that is claimed in crime is actually from traffic violations, not major crimes. That has increased all over this State including suburban areas and country areas."

verified so there is no way you can get on it, sir. The Gentleman has offered to move the adoption of Amendment #1 to House Bill 1362. All in favor of adoption signify by saying 'aye', the opposed 'no'. The Amendment is adopted. Are there further Amendments? Third Reading. The Bill has been read a Third time. The Gentleman from Logan, Representative Lauer."

"As you heard from my discussion of the Amendment, Lauer: the purpose of the Bill is to speed up the disposition of cases in the courts and to shorten up the time between the finding of guilt and the passing of sentence. The major purpose of the Bill, as you know, is to attempt to speed up the process in our over logged courts. We have taken care of those to assure that the convicted felon does not have the post-trial motions prejudiced in any way because we have made it impossible by law for the court to find out ahead of the disposition of these post-trial motions what the finding of the presentence investigation was. It had nothing to do with the waiver of pre-sentence investigation and these rights are still available. Ladies and Gentlemen of the House, I would appreciate a favorable vote."

Telcser: "Is there any discussion? The question is, shall House Bill 1362 pass. All those in favor signify by voting 'aye', the opposed by voting 'no'. Have all voted who wish? The Gentleman from Cook, Representative Getty."

Getty: "Mr. Speaker, Ladies and Gentlemen of the House, in explaining my 'aye' vote I want to point out that when this Bill was previously called I voted against it and I opposed it. With the Amendment I believe that now it is an instrument for speedier justice and it does not infringe upon the rights of the defendant. I therefore would urge your green lights." Telcser: "The Gentleman from Cook, Representative Kosinski." Kosinski: "Mr. Speaker and Ladies and Gentlemen of the House,



one of our problems, one of our major problems in the courts is lack of transition in cases. Speedy justice will end in good law enforcement and I urge a green light on this Bill."

- Telcser: "Have all voted who wish? Take the record. On this question 105 'ayes', LaFleur 'aye', 5 'nays'. This Bill having received the Constitutional Majority is hereby declared passed. House Bill, on the order of consideration postponed appears House Bill 1818 for which purpose the Gentleman from McHenry, Representative Skinner is recognized."
- "Mr. Speaker, the first time this Bill was up the Skinner: question was asked how much would it cost. I prepared a fiscal note which indicates that the 39 county nursing homes for which this Bill proposes reimbursement for that portion, that percentage of the caseload in the nursing home which is on public aid would run approximately \$1.1 million per year for the next 40 years. The question, the basic question however seems to be should not be the cost question but should be the equity question. Is it fair to reimburse private nursing homes for the total cost of caring for a patient but to not do the same for county nursing homes. At the present time the cost of construction is excluded and it seems to me this is a completely unjust procedure. In fact, the Department of Public Aid claims they do not discriminate against public nursing homes but all you have to do is compare the rates of reimbursement between county nursing homes and surrounding private nursing homes in any county, at least in my county and you will find out there is a rather large differential. This Bill attempts to negate that differential." "Are there any questions? The Gentleman from Telcser:

St. Clair, Representative Flinn."
Flinn: "Well, Mr. Speaker and Ladies and Gentlemen of
the House, I had asked the Sponsor originally when this



Bill came up the first time and was defeated what the opinion of the Public Aid Department was and he said they were opposed to it and obviously they are opposed to it because there is a whole new plan by the Public Aid Department to take care of matters like this and all this would do would interfere with the Department's plans and I am going to have to oppose the Bill." Telcser: "The Gentleman from Macoupin, Representative Boyle."

Boyle: "Thank you, Mr. Speaker. I rise to support this Bill.

I think it's a good Bill. I don't believe that we should discriminate against county nursing homes, against public facilities. These facilities most of the time are subject to more careful scrutiny by the public and by public agencies more so than the private homes. In Macoupin county we have been attempting to build a nursing home for many years down there. It's very difficult under the existing law to provide financing to build a public, county nursing homes. This Bill would provide a vehicle to do so. I believe in public nursing homes and as a Member of the Visitations Committee it has been our experience that these homes have been better kept than some of the private homes and I would urge support of the membership to support this Bill. I think it's a good Bill and it deserves your favorable vote. Thank you."

Telcser: "Is there further discussion? The Sponsor, the Gentleman from McHenry, Representative Skinner to close." Skinner: "Mr. Speaker, I would like to second Representative Boyle's comments about the regulations, the strict regulations of county nursing homes. You don't see county nursing homes burning down like the ones in Springfield did and yet if you compare the reimbursement rates between a county nursing home and the ones that have been burned down or have been closed because they haven't been properly supervised in Cook County, you

will find county nursing homes are getting paid less. What we are trying to do is increase the number of high quality care, we are trying to keep the number of high quality care nursing homes in existence. At the present time when a nursing home becomes substandard, a county nursing home, the temptation becomes extremely large to say to equit it. Why run a county nursing home at all. And if that's, with this Bill this doesn't, this does not provide all the money to build county nursing homes. A county nursing homes is still going to, the county is still going to have to put up the front money and they are only going to be reimbursed for that share of the county nursing home that is occupied by public aid patients. It seems to me it's time the public aid, the public welfare patients carried their own load and for that reason I would ask for a fair, for a 'yes' vote."

Telcser: "The question is, shall House Bill 1818 pass. All those in favor signify by voting 'aye', the opposed by voting 'no'. Have all voted who wish? The Gentleman from McHenry, Representative Skinner to explain his vote."

Skinner: "Mr. Speaker, in explaining my vote I would like to respond to what Representative Flinn said about the Public Aid Department having some grandiose plan to do with county nursing homes. They have yet to come to me with that plan and quite frankly, the Public Aid Department is not one that is known for implementing plans in a rapid fashion. Now it seems to me that if we want to get them off their rear end and get them to treat county government fairly that we are going to have to tell them that they are going to have to do it. And that is what this Bill does."

Telcser: "The Gentleman from Macoupin, Representative Boyle." Boyle: "Thank you, Mr. Speaker. I would sure appreciate it if we could get a few more green lights up on the board



from this side of the aisle. I feel that this is a
good Bill. I don't think we should discriminate against
public nursing homes. I think it's about time that we
allow the county to go into this business and this is....
one way that they can go into business and this is one...
way that they can go into business. This Bill merely
allows the State to pay the public nursing homes the
same as they pay the private nursing homes and I
sincerely hope we get a few more green lights up there."
Telcser: "The Gentleman from Stephenson, Representative
Rigney."

Rigney: "Mr. Speaker and Ladies and Gentlemen, I certainly do hope that this fine Bill does pass. You will find that many of our counties are building these type of facilities. They are financing a two or three million dollar construction project out of their local real estate taxes and if you want to give some relief to the real estate taxpayer and I think all of us have said this time and time again, this is an excellent opportunity for the State of Illinois to assume it's fair share of the cost of this type of institution and to give some relief to the real estate taxpayer." Telcser: "Have all voted who wish? Take the record. On this question 104 'ayes', 5 'nays' and this Bill having received the Constitutional Majority is hereby declared passed. On the order of postponed consideration appears House Bill 1299 and for which purpose the Gentleman from Cook, Representative Mann is recognized. Is Representative Mann on the floor? All right, take that out of the record. On the order of postponed consideration appears House Bill 1764 for which purpose the Gentleman from Lawrence, Representative Cunningham is recognized."

Cunningham: "Mr. Speaker and Members of the House, when this Bill was presented two or three days ago the explanation was inadequate. I apologize to you for that inadequacy. It's a good Bill. It makes Amendments in

the Motor Vehicles Act...and I respectfully submit your 'aye' vote for this Bill."

Telcser: "The Gentleman from Cook, Representative Fleck." Fleck: "Well, here we go again....ah...Mr. Speaker and Ladies

and Gentlemen of the House, once again we get a minor Amendment to the Motor Vehicle Code and we're not told what it is. We're right back where we were a few days ago, so what we're doing...we're doubling the right of a man to say to say 'no' if he has to take a breathalizer, we're kicking up the penalities for a man to refuse to take a breath analysis. I think the Bill that we passed last Session should be given a chance to work and we shouldn't use this pernicious means to get involved with peoples Constitutional rights to say no if they so desire by this backdoor method and I would urge every Member to defeat this Bill."

Telcser: "All right. The Gentleman from Winnebago, Representative Giorgi."

- Giorgi: "The only thing missing from the Sponsor of this Bill is he's not waiving the American Flag as he goes down the aisle. This is one of the worst Bills, and I've seen this Bill by evalutioncome....become a 'worser' Bill. This is the Bill where if you're....if you've been stopped on the suspicion of a DWI....and refuse to take a breathalizer test, then you go to a fine attorney like the guy that Sponsored the Billyou might plead a charge with the States Attorney for a thousand dollars to get it set aside. This is an atrocious Bill....and I would wonder if maybe some of the attorneys that vote for it don't have a conflict of interest. You ought to be waiving the American Flag on this one....Cunningham."
- Telcser: "Is there further discussion?Representative Cunningham, the Clerk informs me that you....ah..... requested that this Billah....be put on an Interim Study Commission and the Clerk's Office inadvertently put it back on the Calendar.....Representative Cunningham, for what



purpose do you rise?"

Cunningham: "I had previously cleared with the Clerk that it was properly on today's Calendar. I acknowledge that I discussed the matter yesterday evening with Speaker Murphy, the Bill is too important to let it be permitted to rest dormant on the Interim Study Committee. I would appreciate the opportunity to reply to the statements that have been made....that we might have a Roll Call vote on this particular issue. It is on the Calendar."

Telcser: "The Gentleman from Lake, Representative Murphy." Murphy: "Well, Mr. Speaker, I expect Representative Cunningham has the right to change his mind, but I just wanted to remind him that if this goes up on a Roll Call vote ...and is defeated why then it is dead."

Telcser: "Okay, the Gentleman from Lawrence, Representative Cunningham, to close the....."

Cunningham: "Now, Speaker Murphy if it's defeated the blame will not be on my hands or on your hands. Two years ago this State embarked upon a noble experiment to make the highways more safe for all of the users including the Members of this General Assembly. A Bill that has bad the things said about itmaliciously and inaccurately as strongly as this Bill can't be all bad. You're either for safety on the highways or you /against safety on the highways. The people of the State of Illinois believe in the breathalizer as the means of safeguarding their lives and the lives of their loved ones. It is unhappily true that as the Bill is presently written and stands on the books it is not as ... effective as it needs to be. It is your responsibility and my responsibility to give this Bill an opportunity to work its magic for the benefit of all of us. Specifically the issue is this....the penalty that is presently provided by the Statutes that is the 90 day suspension....for a drunk... to refuse to take the test is inadequate...that test...that penalty needs to be expanded. That's all this Bill does

it expands the penalty from 90 days to 6 months. It also requires that the machine be tested once a month. It isthere are no.....I...I defy any of you to disprove this statement....there are no Bills that have come before this House this year that have a greater capacity for good for all of the people of the State of Illinois than House Bill 1764. You can't have it both ways. You cannot be for drunks on the highway and at the same time be a.....for this Bill. You cannot be against public safety and vote against....this.....you cannot be for public safety and vote against this Bill. This is one of those splendid moments in which this House offers us so many....that we come to the 'Y' in the road and we make our choice as to where we stand. I invite each of you who stand for public safety and stand for safety on the highways to cast an 'aye' vote and make the breathalizer test the force for good for which it was planned and for the capacity that it has to serve as each. Vote 'aye'."

Telcser: "Shall House Bill 1764 pass? All those in favor signify by voting 'aye', the opposed by voting 'no'. The Gentleman from Winnebago, Representative Giorgi."

Giorgi: "Mr. Speaker, I know I am speaking for the record so I want to be as gentle as I can. But I say that the last speaker represented a drunken driver last year, and the court record will bear it out, I think he was State's Attorney there, I think I'd like for my own personal I think I'd like a copy of his court records on these Bills. I say this is in conflict of interest for some of these people that know better on these breathalizer tests and on these measuring of thesethe deci....the alcoholic decimals and some of the other things that are occuring on this Bill. We were promised when this Bill was passed that in the event that a person wasn't....wasn't guilty of ten hundredths....he'd be allowed to go free. Now we find they are giving them other charges, I think that this is in



conflict of interest to some of the people voting on this Bill."

Telcser: "The Gentleman from Cook, Representative Duff." Duff: "Mr. Speaker, I think that last speaker was so far out

of order that he ought to come over to the Sponsor of the Bill and ask him where the Bill came from. The Bill came from the State's Attorneys Association and I personally asked the Sponsor however reluctant he was to take it on, there is no conflict here. Now, I have never represented the drunken driver and I represent a lot of people. The simple fact of the matter is the implied consent struggle is over with. Now this Bill can use improvement. We have done things in this Legislature this year...like allow alcoholism to longer.....to no longer be a public crime .. we have done things in this Legislaturelike allowing teenagers to drink....and this Bill makes it possible for us to improve the process of the Implied Consent Bill." Telcser: "Now, Representative Giorgi, for what purpose do you

rise, Sir?"

Girogi: "Point of Order, Mr. Speaker." Telcser: "Yes, Sir."

Girogi: "I don't know if Duff belongs to an association or corporation of lawyers, but as he said that he never represented a drunken driver, would he tell the House if his Firm has ever represented a drunken driver?"

Duff: "Noooop." Telcser: "The Gentleman from Cook, Representative Fleck.

Representative Duff, for what purpose do you rise?" Duff: "Personal Privilege, Mr. Speaker." Telcser: "State your point, Sir." Duff: "The fact of the matter is, my Firm has never represented

a drunken driver, but the fact is that this Gentleman is trying to take the merit of this Bill and put it into a complex situation that doesn't exist."

Telcser: "The Gentleman from Cook, Representative Fleck."

Fleck: "I'd like to disagree with the previous speaker. There is no merit to this Bill. If this Bill passes out of this House it will be the most pernicious and insidious piece of Legislation that God would ever suffer to call out of this Chamber. Now let's....this Bill not only doubles the right of refusal to take the breath analysis but there is a little sneaker in here that includes a person who drives or is in physical control of a motor vehicle. Now, that simply means that if you are sitting in a car and the engine isn't going and if you happen to have the automobile keys to that car....you are in actual physical control and you're not even driving it you might be sleeping it off. This man shouldn't be punished....and he shouldn't be forced to take the breathalizer because he's not harming nor harassing or endangering anyone on the highways. I think if we're going to pass Legislation we got to be a little more truthful about the Bills we're presenting to the Chamber. I think it's a terrible Bill and any Member who votes for it should read the Bill and realize what they're voting for."

Telcser: "Have all voted who wish? Representative Cunningham, for what purpose do you rise, Sir?"

Cunningham: "Mr. Speaker, I wanted to explain my 'aye' vote and I wanted to say that this Bill is not sponsored entirely by the States Attorneys Association, the Illinois State Police are for it, they came and appeared and testifyed in its behalf. Those of you who are voting red up there are not voting against me or the sponsorship of this Bill. You're voting for drunken drivers on the highway....and I trust that you'll be glad to see your Roll Call in your local newspapers. Now, in answer to the question,....I'm not through....in answer to the question as to whether or not I defend drunken drivers, the answer is.....I do not.....but if the Representative from Rockford ever needs counsel, I'd be willing to make



exception. I urge each of you to reconsider. This is notthis is not a question of personalities, this is a question of where you stand on every possible....reasonable basis to make our highways more safe. I'm not going to say it will save 5,000 lives in Illinois, but if it saves one it is our responsibility. Give the breathalizer testgive implied consent a chance to work for you and for me.....PLEASE."

Telcser: "Have all voted who wish? Take the record. Representative Geo-Karis, for what purpose do you rise?"

Geo-Karis: "Ah.....Mr. Speaker, Ladies and Gentlemen of the House...ah....I rise a Point of Personal Privilege because I do not condone drunken drivers and I do not like to be ascribed as condoning them....simply because I do not agree with the Bill. I don't think the Bill is a good Bill and I rise to vote 'no'."

Telcser: "This question there is 32 'ayes', 81 'nays', and this Bill having failed to receive a Constitutional Majority is hereby declared lost. House Bill 1299. What did you say, Representative Mann?"

Mann: "Kepresentative Martin has an Amendment and she is off of the Floor."

Telcser: "All right, take it out of the record. House Bill 797. ...On the order of Postponed Consideration appears House Bill 797....for which purpose the Gentleman from Cook, Representative Schlickman is recognized."

Schlickman: "Mr. Speaker, I would ask for the leave of the House to take 797 back to the order of Second Reading for the purpose of an Amendment to be offered by Representative Tuerk."

Telcser: "All right, are there any objections? Hearing none, 797 will appear on the order of Second Reading. Will the Clerk please read the Amendment."

Jack O'Brien: "Amendment #5, Tuerk, amends House Bill 797.... amends....."



Telcser: "The Gentleman from Peoria, Representative Tuerk." Tuerk: "Mr. Speaker and Members of the House, Amendment #5 to

House Bill 797, really limits the jurisdiction of this Act to the Northeastern Illinois Counties area, as that area is defined in the Northeastern Illinois Planning Act.... Ah....We have precedent for this, we've established the Northeastern Illinois Planning Act, we have it for planning purposes... for land use.?..we're now considering mass transit and I think the Sponsor of this Bill.....ah...... would be in much better shape with this Bill if this Amendment were adopted and I move for its adoption." Telcser: "Is there any discussion? The Gentleman from Cook,

Representative Schlickman."

Schlickman: "Mr. Speaker and Members of the House, I should like to thank the Gentleman from Peoria for this Amendment. Generally I'm opposed to classification but as Members of the House know frequently we do classify on the basis of population or for other reasons. It seems to me Mr. Speaker and Members of the House ...ah...we must recognize that there are problems in part of the State where problems don't exist in other parts of the State and by this classification that we have in the Bill now restricting its application to the six Northeastern Illinois Counties area we are simply doing for the State what the builders do themselves. They have one association for the Chicago Metropolitan Area because of its unique character, they have another association for the remainder of the State....So I concur with the Amendment and urge its adoption."

Telcser: "The Gentleman from Kankakee, Representative Beaupre." Beaupre: "Mr. Speaker and Ladies and Gentlemen of the House... I supported Representative Schlickman's Bill all the way through...ah...ah... while it was in Committee and ...ah. ...also on the House Floor last time. I would like to urge you to vote against this Amendment primarily because



I believe that the potential homebuyers throughout the State of Illinois needs protection....That this is not necessarily an area problem and I would like to ask you to vote 'no'."

Telcser: "The Gentleman from Lake, Representative Pierce." Pierce: "Ah....Mr. Speaker, I believe that this is clearly

an Unconstitutional classification in this Bill. Theah...Mr. Schlickman said it had something to do with population...it has nothing to do with population. Mc-Henry County which would be included in the Bill under this Amendment has less people than Madison County, it has less people than St. Clair County, it has less people than other downstate counties. McHenry County is only about a hundred thousand people and there are many counties that big.....downstate...Winnebago County is not included in the Bill if this Amendment is adopted and yet it's a bigger county in population and has bigger cities than does McHenry County. The biggest city in McHenry County is only about fifteen thousand people. The biggest city in Winnebago County is 150 thousand people. Winnebago County has over 200 thousand people. McHenry County a hundred thousand people and yet McHenry is being put under this Bill and Winnebago and Peoria and East St. Louis, St. Clair and so on are being excluded even though they have urban problems. I think this is a very bad precedent and I ask that you oppose the Amendment."

Telcser: "The Gentleman from McHenry, Representative Skinner." Skinner: "Mr. Speaker, it seems to me....."

Telcser: "One moment....please....Representative Schlickman has indicated he wishes to take this out of the record... Take it out of the recordmomentarily. House Bill 1299.....The Gentleman....on the Order of Postponed Consideration appears House Bill 1299, for which purpose the Gentleman from Cook, Representative Mann is recognized." Mann: "Well, Mr. Speaker, I would like leave of the House to

....ah...bring this bad Bill back to the order of Second Reading for the purpose of an Amendment to be offered by Representative Martin. Are there any objections? Hearing none, the Bill appears on the order of Second Reading. Will the Clerk please read the Amendment?"

Jack O'Brien: "Amendment #1, Martin, amends House Bill 1299... Telcser: "The Lady form Cook, Representative Martin." Martin: "Mr. Speaker, Ladies and Gentlemen, on the day that

this Bill was originally heard ...I asked Mr. Mann if he would have this Bill placed on Postponed Consideration for the purpose of an Amendment which would thenah... make this Bill so that the Public Aid Department ...ah... then could be in complete or total support of this Bill. What we have done here on line 3 page 2....ah...was delete 2 persons for 2 years....that is public aid recipients... and 2 for 1 year each. And on page 2 line 18...deleting 4 and 2. With this new Amendment I'm.....there are no further objections to this Bill and I ask leave that you will accept the Amendment #1."

Telcser: "The Gentleman from Will, Representative Kempiners." Kempiners: "Will the Sponsor of the Amendment yield for a

question?"

Telcser: "She indicates she will."

Martin: "Yes."

Kempiners: "Peggy, is this basically taking out the time requirements so that if somebody goes off of Public Aid that ...ah...the Public Aid recipient can be put on in their place?....Is that basically what the Amendment does?" Martin: "Yes, it does. What it does is it says that there should be 4 recipients but 2 of them will be appointed for 2 years and 2 will be appointed for one year ...each and that if any recipient becomes ineligible in any form offor any for of Public Aid while serving that they shall be replaced within 60 days from a list that is available. A person who said that they would like to serve."

Telcser: "The Gentleman from Cook, Representative William Walsh."

Walsh: "Well, I'd just like to point out, Mr. Speaker that this Amendment does nothing to remove objections that many of us had to this Bill. The Amendment really doesn't do anything at all. The purpose of the Amendment as I understand it is to provide for the situation where because the average stay on Public Aid assistance is two years the Amendment addresses itself to a term on the Advisory Board of no more than two years, but ...ah...I'd like to point out the Sponsor of the Amendment, the Sponsor of the Bill, who seems to think this Amendment is such a good idea that we're dealing in the one hand with av...averages, and on the other hand with absolute....and you simply cannot bring them together. So the Amendment isis ridiculous....ah....if not worthless."

Telcser: "The Gentleman from Cook, Representative Davis." Davis: "Mr. Speaker and Ladies and Gentlemen of the House,

all this Bill does is to say that on this Commission 4 members......4 recipients of aid...will be appointed to the Commission now what is the purpose of the Commission? The Commission renders a report to the Governor at his request. It's advisory in capacity and there's no report rendered unless, His Excellency, the Governor requests one. I'd like to know, number one;let me....let me tell you exactly what the Legislature says and has said that the Members of the Board shall have knowledge bearing on dependency, maladjustment, waist, human resources and the routine tax burden. I think that recipients of Public Aid I think it's a good idea to have them on that Commission because certainly a recipient knows more about it than anybody else.....and they will be able to tell and not only tell, they will be able to



have first hand information themselves as to how much money is being put here. It certainly can't harm anything and I say to you as a Member of the Advisory Committee with power given to that Committee from this Legislationa good thing. I'd rather have them on there as to have them coming down to Springfield week after week..... every time we meet...trying to find out what's going on. If you put 4 Members on the Committee they will know what's going on....they'll know how much money it's costing us. They'll know all these things that they want to come down here to hear and want to come down here to be heard on. They'll know just what it's costing. It's not going to hurt one thing. In think it's a good Bill.....and I believe that we ought to support the Lady's Bill. I plead with you to give it a vote." 1

46.

Telcser: "The Gentleman from DuPage, Representative Hudson. Hudson: "Well, Mr. Speaker and Ladies and Gentlemen of the House, I think we have ah ... come almost full circle in this area. I rise in opposition to this Amendment and to the Bill. With all due respect to the proponents, I know that they're sincerely motivated and feel that this would help. I feel that it would have an adverse effect and an adverse reaction. If we were to argue that we have on this Board.....representatives of peop...... representatives those who have been on Public Aid and those who have found their ways out of Public Aid and off of Public Aid it might make a little more sense to me. But I fail to see why the Board cannot receive the information it needs and the input it needs without actually putting members who are on Public Aid and on Welfare on the Board. I don't think it will do the job, I think it will encourage those who are on Public Aid in many cases to remain on Public Aid....and I suggest and I urge a 'no' vote on the Amendment and a 'no' vote on the Bill."



Telcser: "The Gentleman from Lake, Representative Murphy." Murphy: "I move the Previous Question, Mr. Speaker." Telcser: "The Gentleman has moved the Previous Question. All

in favor signify by saying 'aye', the opposed 'no'. Representative Martin to close."

Martin: "Mr. Speaker, Ladies and Gentlemen, I have before me here a copy of the Code of Federal Regulation, page 37, 220.4, paragraph 2, that says; 'included Representatives of other State Agencies concern with service representation of professional civic or other public or private organizations ... private citizens and those who are connected with service programs as well as three.....1/3 of the Membership should be Public Aid recipients.' I see no reason why that persons on Public Aid would not know what their own destiny is. You talk about persons remaining on Public Aid....that's what happened here yesterday ah. you want to keep people on Public Welfare, yesterday you defeated a Bill that would have permitted women to go to work who make under \$10,000 a year and now you don't even want them to have a voice in their own destiny. Mr. Speaker, Ladies and Gentlemen, I move for the acception of the adoption of Amendment #1."

Telcser: "The Lady has asked to move for the adoption of ` Amendment #1, to House Bill 1299. Representative Borchers do you seek recognition, Sir?"

Borchers: "The only remark I wish to make is...!it's always well to put the rats in charge of the cheese'...."

Telcser: "All in favor of the Ladies ..motion...er...Ladies Amendment signify by saying 'aye', the opposed 'no'. The Amendment is adopted. Are there further Amendments? Third Reading, the Bill has been read a third time. Now, the Gentleman from Cook, Representative Mann, with reference to House Bill 1299."

Mann: "Well, first of all....ah...Mr. Speaker and Members of the Committee, the Amendment merely conforms the Bill to



the objections of the Department of Public Aid, which wanted the terms staggered so that in the event a person came off of the rolls a replacement could be made. Now, Representative Martin, remarks in her presentation of the Amendment that the Federal Regulations in order for Illinois to continue to get matching funds require an Advisory Board composed of 1/3 poor people. Now, we're constantly haranguing .. and criticizing the poor for not being involved in government, by not caring about their lot. Now, there isn't a Board or Commission in the State of Illinois you can go down them....teachers that don't have teachers on them....doctors that don't have doctors on them. dentists that don't have dentists on them All we're doing here is giving the poor an opportunity to participate on an Advisory Board. That's all. Let's see what the poor can do. Let's invite them into Government. It's no big deal....and Representative Borcher's remark about rats and cheese....was highly insulting to people who are on public assistance. They're not rats. I would urge your positive vote for a Bill which merely involves participation by poor people on an Advisory Board that requires consent and approval by the Senate of the State of Illinois. Let's give the poor a chance to get involved in their own Government. This is no radical revolutionary Bill it is a Bill that matches every other partic.....participatory commission and board that we have in the State of Illinois. The other day we passed a Board allowing beauticians ... a Bill allowing beauticians to be appointed. Examine every board and every commission and you'll find consumers and people who know something to be on the board. Who knows more about being poor than poor people? Let's give this an 'aye' vote. The Members have to be confirmed by the Senate."

Telcser: "The Gentleman from Cook, Representative William Walsh."



"Well, Mr. Speaker and Ladies and Gentlemen of the House, Walsh: I.....while I...agree that the Sponsor of this Bill is very concerned and interested in the problems of the Public Aid recipients I don't think his approach is correct in this instance. Now, let me point out to you that the Boards that he talks about ... the various examining Boards and we learned recently that there are some 181 licensed professions in this State and they all have Boards. None of these Boards dictate that Members of that profession shall be on these Boards. I agree with them that in many cases there are Members of the various professions on the professional Boards but the Legislation does not dictate be that they must/and the Governor may appoint whomever he pleases. Now I suggest to you that in the Public Aid Advisory Board the Governor may, if he wishes, appoint all Public Aid recipients to that Board. All or one or two or whatever he wishes. Now, I suggest to you that there is no reason why in this one instance we should dictate to the Governor that he shall appoint a certain number of a certain profession any more than we dictate to him any of the other boards gualifications for Membership on them. This is the reason that I do not approve of this Bill and I don't think that it should pass. The Governor may now appoint 4 members on public assistance to this Board if he wishes....and I suggest to you that this Bill should be defeated." Telcser: "Is there further discussion? If not, the Gentleman

from Cook, Representative Mann to close."

Mann: "Well, Mr. Speaker, first of all the distinguished

Majority Leader is absolutely wrong when he says that none of the advisory boards in this State require the appointment of people from certain professions and...ah..consumers on consumer boardsit's absolutely untrue. Secondly I am telling you that you are jeopardizing federal matching funds by not passing this Bill when it says under the federal law that you must have one-third recipients on this



advisory board which must be approved by the Senate. If you want to take the responsibility of jeopardizing hundreds of millions of dollars for a mere advisory board you take that upon your shoulders, but the Federal Statutes require 1/3 participation by the poor and what's wrong with allowing the poor to participate in an advisory board on poverty and I urge your 'aye' vote."

Telcser: "The question is, shall house Bill 1299 pass? All those in favor signify by voting 'aye', the opposed by voting 'no'. The Gentleman from Cook, Representative Fleck to explain his vote."

Fleck: "Mr. Speaker and Ladies and Gentlemen of the House, if anyone would read the Bill and also read the Federal Statutes I'm no great fan or friend of welfares as this House knows, but this Bill is really a sheep in wolf's clothing. It's....it'slot.....harmless...as.... I'll explain why. It'sIt looks worse than it really is. First of all the Board is an advisory Board. Now what you have you got a Federal Statute and I'm holding it in my hands.....it mandates....and I really mean it...when I say mandates...it's the State plan and they are referring to the advisory boards...must show that they have welfare recipients on it. Now it seems to me that...ah...ah.....Representative Mann is correct when he says that we might be jeopardizing the matching funds in the welfare area unless we take a real close look at this. Now if the Governor for maybe some political reasons is derelict and does not appoint welfare recipients to these boards we're going to have trouble...and a lot of trouble in financing the welfare schemes in the State, we're going bankrupt as it is already and I would urge the Members to really cast a green vote on this one because it is a very important Bill and I think we're going to loose a lot of Federal money unless we mandate the Governor to do this."



Telcser: "The Gentleman from Winnebago, Representative Giorgi. Giorgi: "Mr. Speaker....this Bill provides that the Senate

has to confirm the appointees of the Governor so we've watched the operations of the Senate and we're....we know they are very selective. The second thing is....the Congress recognized this problem many years ago when it allowed communities to form Community Action Committees and insisted that the poor be represented and provided the election guidelines in poor districts. This is not a radical thought ... I think it's like some of the ... the more Biblical Members of this House that say that the poor will always be with you. Let's invite them in the halls of the Mighty. Let's get an input from them. You are always talking about the welfare recipients steals away with the money, well I want to tell this House again today that almost 50 cents out of every dollar of the welfare pot goes into the hands of the doctors, the dentists, the pharmacists, the child care centers and the medical centers and so on. . And the second thing I'd like to say is....the farmers in this House don't do too bad with soil bank moneys and they're represented in the halls of the mighty so I'd like to see a vote for the poor once."

Telcser: "The Gentleman from Will, Representative Kempiners." Kempiners: "Thank you Mr. Speaker, I'd like to explain my

'yes' vote. There are two Bills that Representative Mann brought into the Human Resources Committee. This was the second of the two. The first one I voted against because I thought it was unnecessary. This one I voted for because of what Representative Mann said about the Federal Funds and the danger that we may be in of loosing those Federal funds. But there is something else that...ah...I voted for it for and that is the representation that poor peoples would have on that board. In a discussion with a representative of the Joliet-Will County Community Action Agency

I learned that people in Joliet who could be out throwing bricks through windows, burning down buildings...aren't doing it because there is a voice...er...a place they can go to be heard when they've got frustrations....and that is the Joliet-Will County Community Action Agency....And this is how I would see this Board....with Public Aid recipients they have an outlet for their frustrations.... and I think that if we look at history we'll find that governments have thawed because there haven't been communications between the people and the people who govern them.....and I do not see anything wrong in adding these 4 Public Aid recipients to this Board."

Telcser: "Let me remind the Members, we cannot roll the machinery.....something is broken on it. The Gentleman from Cook, Representative Davis."

Davis: "Mr. Speaker, Ladies and Gentlemen of the House....by the remark that has been made I'm reminded of the story of the little boy who was in a foreigh country...they said to him....Son, what forms of punishment do you have in your country? He said, 'in my country many people are put to death by elocution'.....you know I am always put to sleep or put to death by the distinguished Gentleman's elocution."

Telcser: "Have all voted.....the Gentleman from Vermilion, Representative Campbell."

Campbell: "Now, Mr. Speaker and Ladies and Gentlemen of the House, I agree wholeheartedly with Bob Mann and Charlie Fleck in regard to this concept and toreally if we don't pass this Bill we may very well be jeopardizing the funds of Public Aid in the State of Illinois. And basically what is wrong with the idea....this is an advisory board in the first place and none of us have ever come up with any of the real sound conclusions on what we can do in regard to help this business of the Public Aid debt going up and up and up and up. So let's bring some of these

people in and maybe they can give us some ideas and let everybody have an input into this thing and try to get the job done. So I would urge all of the Members to switch those red votes to 'aye' votes....because thisthis concept is not really as bad as you think it is.."

Telcser: "Have all voted who wish? Take the record. On this there are 96 'ayes', 32 'nays', and this Bill having received the Constitutional Majority is hereby declared passed. On the order of Postponed Consideration appearsRepresentative Martin, for what purpose do you rise?" Martin: "Mr. Speaker, just to say a word to one of the Speakers. I have too much intelligence and too much respect for myself to answer on the rats and cheese matter. Thank you."

Telcser: "On the order of Consideration Postponed appears..... House Bill 921. For which the purpose the Gentleman from Cook, Representative Shea is recognized."

Shea: "Mr. Speaker, Ladies and Gentlemen of the House, House Bill 921 is Representative Arrigo's Bill and with leave of the House I'd like to handle it for him...ah...he's in the hospital."

Telcser: "All right, proceed Representative Shea." Shea: "Mr. Speaker, Ladies and Gentlemen of the House, House

Bill 921 is a Bill that would allow the ...ah..Trustees of the U. of I. ...the Trustees of S. I. U., the Board of Regions and Board of Governors...ah...to furnish secretarial services to the Board Members...I think there was some question about this raise...ah...by President Corbely, in his office at one time....we've tried to get in touch with him. I can't see any reason why that the trustees cannot be furnished a secretary....and I'd appreciate the support of the House."

Telcser: "Is there any discussion? The Gentleman from Cook, Representative Richard Walsh."

Walsh: "Well, Mr. Speaker, and Ladies and Gentlemen of the

House, this Bill was heard in the ah ... Committee on Higher Education and we had considerable debate on it on the floor of the House. As a matter of fact ... ah ... under the existing law the ... ah ... trustees of the ... ah ... University of Illinois and all the others for that matter, can be furnished ... ah... secretarial services. They are entitled to be reimbursed as we are for any secretarial services which are needed. This Bill would give statutory authority to them to hire private secretaries. Now, I don't believe ... at this particular time that it's appropriate for us to, in a sense, dictate to these boards that the Members have private secretaries. Now, the Gentleman who testified in the Higher Education Committee even indicated himself that his secretary only worked 1/3 or 25% of her time on University business and that, I believe was probably one of the high ones.In this Bill we're providing that all of these people be entitled to private secretaries....and I think for once maybe we ought to give the taxpayer a chance to vote 'no' on this Bill." Telcser: "Is there any further discussion? If not, the Gentleman from Cook, Representative Shea to close."

Shea: "Well, Mr. Speaker, Ladies and Gentlemen of the House I frankly don't understand the opposition and.....from the Member....all this says is that Board Members that serve without compensation can have secretarial help. Now, I know of one trustee, Earl Neal, who lives in the Northern part of the State, all he wants to do to do a good job is to be able to have a secretary. I talked to two or three of the trustees and all they want is the opportunity to do the job that they've been elected to door appointed to do and I'd appreciate the support of the House."
Telcser: "The question is, shall House Bill 921 pass? All those in favor signify by voting 'aye', the opposed by voting 'no'. The Gentleman from Cook, Representative



Richard Walsh."

Walsh: "Well, once again, Mr. Speaker, so we understand the Bill we're voting on, the Gentleman did not explain it properly. These people can now be reimbursed for secretarial services which are incurred by them. Any expense in connection therewith. This Bill specifically provides in Section 2 thereof that any governoring board may furnishand I think we could probably put shall in there because.....we sure know that if we're going to enact this Legislation that they will.....may furnish to each of its board members secretarial services or a private secretary and provide compensation therefore. Now, we all know that some of those private secretaries in State Government are paid a pretty penny. I don't think the taxpayers want any more of it and I urge a 'no' vote."

Telcser: "The Gentleman from Moultrie, Representative Stone." Stone: "Mr. Speaker, Ladies and Gentlemen....I .. I think that this is a good Bill...I have served as...as....you know on ...ah..at least two or three of the boards that are involved here. Under the present law it's nearly impossible to ... to charge secretarial services to the ... ah ... board. There's no way that you can adequately account for how many hours that is actually worked... how much of the secretaries time is spent and ...ah....therefore it's practically impossible to make a charge. Now under this Bill it clarifies how the charges are to be made and ... ah. it would make it moreah...plausible for the board Members to file a claim. For example the ... Mr. Hahn, thea Trustee of the University of Illinois Board of Trustees, that lives in Springfield testified before the Committee and he explained that....thatah....he had visited with his secretary about the ...ah..immense amount of time that she spent for him on board work and that he had not submitted claims for this because of the nature of the ...ah...present understanding....This Bill would only make it quite clear that they were entitled to actual

"Ah...Mr. Speaker, Ladies and Gentlemen...ah..House Caldwell: Bill 1848 was heard last week. Many of the Members werehad gone...and I would....briefly...ah...like to describe...ah...what ...ah...House Bill 1848 does. Ah... it's a Bill that simply provides funding for early childhood education for children whose educational progress would be handicapped without it. Ah....This Bill ... ah ... would...would ...ah....enable school districts throughout the State of Illinois to offer early educational envolvement to disadvantaged children in the school districts or in special cases children in pilot programs approved by the Office of the Superintendent of Public Instruction. Now, currently in Chicago seven centers are operated that enroll children at the age of three with the full cost of the program being borne by Model Cities Funds. It is anticipated that Federal Funds will be curtailed This would cause considerable regression....in the educational system in the cities and I want to remind you that it it is applicable Statewide. Ah ... research has indicated that less than a million dollars will be involved although it could increase over a period of years if local funds can be generated to provide for participation up to 2% of the...ah...areas in which it would close. Finally, I want to point out that numerous researchers in the field of cognitive development have established that between birth and four years of age the child develops 50% of his cognitive potential and an additional 50% level of intelligence is developed by age 8. Ah...Mr. Speaker, Ladies and Gentlemen I think this is a much needed ...ah...piece of Legislation...ah...the...the....Superintendent of Public Instruction's Office ...ah...advocates it...and I think that we could save the State a lot of money by encouraging this type of a program throughout the State and I would

Would this program, if implemented throughout the State tie in in any way with the ...ah...plans that the ...the....ah...Department of Health Education and Welfareah...out of Washington has in mind. I know some time back they had a ...ah...Conference on Youth or something...ah...I think ...a year or so ago and...out of that came suggestions. Is,what you have in mind herein line with those suggestions out of HEW2" Caldwell: "Ah...Mr....ah...Speaker...could I yield to Rep-

resentative Chapman to answer that question?" Telcser: "The Lady from Cook, Representative Chapman." Chapman: "The answer, Representative Hudson.....is 'yes'.

The Illinois reports...ah...the White House CommissionConference....pardon me....on Children and Youth, pointed to this deficiency which presently exists in Illinois Statutes...in regard to helping school districts offer programs of early childhood education....So not only is Representative Caldwell's Billan embodiment of the recommendations of the Illinois Report of the White House Commission on Children and Youth, it is included in the Superintendent of Public Instructions action goal and it is strongly recommended by the Illinois Commission on Children."

Hudson: "Ah...would Representative Chapman....yield....ah.. Representative Caldwell.... to another question?"

Telcser: "She indicates she will."

Hudson: "I understood ...going back to that HEW Report that what they envisionedeventually is a system here throughout not only Illinois but presumably other States in this Country, that would drastically alter our



....ah...traditional educational system by adding ...ah ...this educational service down to age 3 or 2 or whatever it may be but the hooker in it being that the evidence of need....now....ah...wouldn't necessarily be the factor. This would be...ah....an educational system down to that age regardless of whether or not a need existed. Is this your understanding?"

Chapman: "Ah...the proposal...ah...of Representative Caldwell, is for children who need compensatory education. The proposal in the White House Report was that there be raised for local school districts where the local school districts saw the need....to offer programs of early childhood education. It was not a....a blanket kind of program but one which ...ah....had a local option."

Hudson: "Thank you. May I speak to the Bill....er....only on the Amendment....Mr. Speaker?"

Telcser: "Only on the Bill.....We're on Third Reading of the Bill."

"Well, Mr. Speaker and Ladies and Gentlemen of the Hudson: House.....I'm going to speak in opposition to this measure and in so doing I want to say that this is done only with a great deal of respect for Representative Caldwell because I think what he is talking aboutah...is a need and ah....in a particular area and I can understand this and I'm sympathetic to it. But what I think the real thrust of the Legislation would be if passed would be to open the door for an extension of educational service at the ... ah. taxpayers expense that we can ill afford and for that and I'm going to suggest which in the long run may not be to the long range benefit of the people footing these tax Bills. I think that if we began to set up a taxpayers expense....educational system and classroom facilities down to age 2 and age 3 the net result is is going to be to encourage children to move out of the home and into ...ah...schools ...where they become subject to whatever.

it may be....the learning process. I'm still old-fashioned enough to believe that insofar as possible our young peopleour children....should be nurtured...taken care of ... tended at the home level by their parents. I see in this the possibility of a disruption of a home unit. I look upon it with some fear. I look upon it with..ah...some apprehension because of the HEW Report and I know that there is desire on some to get our young people and get them at an early age and begin to introduce them to ideas that have nothing to do perhaps with ideas that their parents might favor. This can happen.. And I'm wondering I think perhaps we ought to think about this... I think we ought to take a look a good hard look at what we're doing here or maybe opening the door to do. I think I think that insofar as we can possibly do it...our children should remain under parental influence at least to age 5 or 6that's early enough. Let those formative years be under the guidance of their parents. Under the guidance of their churches, under the guidance of all of those influences that we've traditionally known in this country and let the formal schooling come later."

Telcser: "The Gentleman from Cook, Representative Robert Dunne."
Dunne: "Mr. Speaker and Members of the House. I want to echo a little bit of what Mr. Hudson....Representative Hudson has just said. He really has described this Bill for what I think it is...ah...Sure there is a problem, but this is really a babysitter Bill. And the Representative should know that the estimated cost of this Bill ...to the taxpayers of Illinois is almost \$24,000,000. And we've got to stand here today and I think start to recognize the taxpayer. This is a bad Bill and I urge its defeat."
Telcser: "The Gentleman from Cook, Representative Schneider."

Telcser: "I'm sorry....the Gentleman's from DuPage....I didn't mean to hurt your feelings."



Schneider: "Thanks a lot Art. It takes a more than that. Ah....the Bill itself...is, I think essentially sound. We've looked at some of the questions that relate to probably the probable cost, but in reference to my colleague, Representative Hudson, I think when we talk about value systems we talk about 'em in terms of multiple value systems. But, you don't isolate the school from the family nor the church but in effect they are a kind of a comprehensive system that none of us can avoid. Now, I would suggest that the attitudes and the values that are spoken in the classroom at an early age are the values of ones attitude toward schools. There is no ... proselytizing in church issues, there are no proselytizings...nature in terms of Constitutional questions but rather when you're talking about educational opportunity and when you're talking about giving children a fair chance...and a fair shake....about learning to their greatest capacity...you can do a number of things of value in early education. One is....the awareness of ones world around him with the children learning how to socialize. We don't live in a world that ... isolates ourselves from one another. So, just in that case it is always worthwhile to have children learning how to relate to one another in a multiple situation. I might also suggest that you can ... begin to identify educational problems earlier than 3 years old but certainly at least at 3, 4, 5 and 6. We talk about visually handicapped children, perceptionally handicapped children, children who have come from a bad home and have no interest in education. They come from homes that child-talk and monosyllabic language rather than continual sentence structure. They come from homes that are promoted by visual aids such as television, they never get a chance to really discuss, to experience and to talk. I think it's a good Bill, it's one that I believe deserves a high vote. I think it's essential to

good education and I hope we can support it."

Telcser: "The Gentleman from Cook, Representative Brandt.....The Gentleman has moved the Previous Question..... Those in favor signify by saying 'aye', the opposed 'no'. Representative Caldwell to close."

Caldwell: "Thank you Mr. Speaker and Ladies and Gentlemen, ..ah in reponse to some of the ... ah ... two Gentlemen who ... ah .. have expressed some opposition to this Bill, I would simply like to say that...ah..I'm not surprised. Also, that one of the Gentlemen said he was old-fashioned enough to believe in the old system. I think one of the criteria of being 'revelant' to today's society is to keep abreast of what's happening in whatever field that we express some knowledge about. Ah...Research has indicated that regardless of ... of the communities in which children come, that they can gain knowledge more rapidly if they are given the advantage of pre-kindergarten training. Ah...One Gentleman said that the Bill would cost some \$24,000,000, I'm inclined to go along with the estimate from the Superintendent of Public Instruction's Office and it said that as far as this Bill was concerned it would ... it would be initiated for less than a million dollars. We have a lot of fiscal experts. I think that we all can't be expert in every field and I think that we ought to be guided by the agencies for which the tax payers are paying them to do....certain assigned jobs. One of the things that I would like to emphasize and I think that even the most naive of us can understand that. A great portion of the seven billion dollar budget of this State is spent in maintaining prisons....maintaining mental institutions and maintaining a.....public aid rolls where we have denied the opportunity that in early life for people to get a chance. So I think that we would be remiss in our duties in not...ah...ah... supporting this Bill and I would urge all of us to give it a green light up there and let's move on and be responsible

Telcser: "The question is, shall House Bill 1848 pass? All those in favor signify by voting 'aye', the opposed by voting 'no'. The Gentleman from Madison, Representative Walters to explain his vote."

Walters: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, this Bill was heard in our Committee and I think before you vote green on this Bill you may consider a little bit. I think I may have a conflict of interest here because I am a family man and I believe in the family as the number one unit in society. This is another step by the State of Illinois and the Legislature to take over the responsibility for our children and to get them out of the home a little bit faster and I think it is a very dangerous precedent. I would like to tell you a story of a Bill that was similar to this which we had...it had to do with breakfast in public schools and I asked a witness from Chicago if he thought at any time about the possibility of serving dinner to the school children also? And I would like to tell you that he hesitated for a moment before he answered.and then he finally said, well we haven't thought about that. I think this is the direction we're going, this is a very dangerous precedent, this is a bad Bill...the whold idea of taking the children away from the family at an earlier age is just unbelieveable to me and I please urge you to vote 'no'."

Telcser: "Have all voted who wish? The Gentleman from McHenry Representative Skinner."

Skinner: "Mr. Speaker, it seems to me that we had a much more reasonable Bill before us previously this week and that was Susan Catania's Bill. It would have cost \$500,000 for ...ah...as deductions from the income tax to pay for 'day care'....In effect this is a day care Bill but I just think \$24,000,000 is far in excess of what it deserves at this point and I must vote 'no'."



Telcser: "The Gentleman from Cook, Representative Lechowicz." Lechowicz: "Very briefly, Mr. Speaker and Ladies and Gentlemen

of the House, what we're trying to do here is to provide a worthwhile program so when a child reaches the early schooling age that he is made adaptable for the proper type of instructions. You know we sit and think many times here as far as how we can cut the budget in very many different ways. And one of the highest budget bills we have in State Government Public Aid. If you want to reduce that budget in the coming years these types of Bills are going to have to pass this floor of this House. More investing in children so they can be taught properly. Talk about dropout rates and the failures in our schools. Why? Because Legislation like this has not been passed before. We talk about failing responsibility and I agree with that but more important is that the student has the adaptability to learn. If this Bill pass and I hope it does, this will be ... help these students and these families. / I encourage an 'aye' vote."

Telcser: "The Lady from Cook, Representative Chapman." Chapman: "In explaining my 'aye' vote, perhaps I can clarify

one of the problems that seems to ...ah...come up this morning. This is not a baby-sitting Bill. Ah...A number of people seem to think of baby-sitting in the same..... ah...at the same time that they think of early childhood education. Research shows that it is in these early years that children learn the fastest and the best, retain the best ...ah...you only need to look at what 'Sesame Street' and 'The Electric Company'.....these two television educational television ...ah...programs have done to ...ah... learning in our country to know how important it is to provide educational opportunities particularly for children from backgrounds which are underprivileged. I hope you will approve this good education Bill."

Telcser: "Have all voted who wish, take the record. On this



question there are 78 'ayes', 45 'nays', and this Bill having failed to receive the Constitutional Majority is hereby declared lost. Representative Mann, for what purpose do you rise, Sir?On the Order of Postponed Consideration appears....is Representative Philip on the floor?....Okay. ...On the Order of Postponed Consideration appears House Bill 1477, for which the Gentleman from Cook Representative J. M. Houlihan is recognized."

Houlihan, J.M.: "Mr. Speaker....I'd like permission....er..... leave of the House to bring this back to Second Reading for the purpose of an Amendment...."

Telcser: "Are there any objections? Hearing none, 1477 is on the Order of Second Reading...Will the Clerk please read the Amendment?"

Jack O'Brien: "Amendment #5, Houlihan, amends House Bill 1477 as amended by inserting before the last paragraph, Section 34-2.1, the following, and so forth."

Telcser: "The Gentleman from Cook, Representative Houlihan." Houlihan: "Mr. Speaker and Ladies and Gentlemen of the House,

this Amendment arises from the discussion that we had on Second Reading concerning this Bill and what it does is it allows the Mayor to have the right to reject the first panel of recommendations from the Nominating Commission. He could do this within 15 days and request 3 additional namesanother panel. It was my feeling that a valid point was raised. That if the Mayor is to be responsible and to have theah...accountability in his office he ought to have the ability to ...ah....select....and I think this gives him greater freedom and greater ...ah..ability ...ah...to select a proper name...one that he finds that is ...ah...fit and worthy of the appointment...And I don't think that we have a situation where the panel would recommend ...ah...6 names where he could not find one qualified individual for serving on the school board.....And I'd move for the adoption of this Amendment."

Houlihan: "Mr.....Mr. Speaker and Ladies and Gentlemen of

the House, this Bill was debated on in Second Reading and also debated on Third Reading....ah...I put it on Postponed Consideration to see if I could work out some ...ah..more agreeable way to put the Bill ...ah...in the form it is now. I would ask for a favorable consideration because I believe that we should keep in the City of Chicago the appointed school system. Even though I think some of the people in the neighborhoods have raised serious questions about how they can be involved in those appointments and even though some people have suggested the school boards ...'elete' it because it is not elected, I think this Bill allows us to maintain an appointed school board and still involve people from the neighborhood and make it much more representative and I'd ask for a favorable Roll Call."

Telcser: "The Gentleman from Cook, Representative Berman." Berman: "Thank you,...ah...Mr. Speaker and Ladies and Gentlemen of the House, I rise in opposition to House Bill 1477. We're on Third Reading, I rise in opposition to the Bill. I think that the Sponsor has made some changes ...from the way the Bill was originally introduced, I think those changes have improved the Bill....except in one area.... that I have suggested by way of an Amendment, which the Sponsor refused to accept and which he opposed on the floor of this House....and the whole essence of that Amendment and the thing that I think is fatal to this Bill is that we are mandating that the Mayor choose some people suggested to him, people who have no responsibility and no accountability to the people of the City of Chicago.



That's the fatal defect as I view it in this Bill. The Mayor runs for election, he is responsive and accountable to the people of the City of Chicago. If you look at this Bill, although the idea is a good one, we seek to broaden the input as to suggestions, these are not suggestions... these are mandates.....by faithless, nameless, unaccountable people within the City of Chicago. To me that concept is fatal because I don't know who's going to be making these recommendations, I don't know who's going to be suggesting these people, and we are mandating that the Mayor must choose from the people suggested by these faithless, nameless people. Regardless of how well meaning they are, they are not accountable to me....and I don' know who they are accountable to. The Mayor is accountable to the people of the City of Chicagoat least through a ballot box and every other method of free speech and free assembly and I suggest that in order to keep the Mayor accountable, the Mayor responsible and the Mayor responsive to the needs of the City of Chicago, that House Bill 1477 be rejected and I urge a 'no' vote." "The Gentleman from Cook, Representative Kosinski." Telcser: "Will the Sponsor yield to a question?" Kosinski: Telcser: "He indicates he will."

Kosinski: "Jim, does this permit the Mayor to have the right of veto?

Houlihan: "Excuse me, Representative."
Kosinski: "Does ...this...give...the Mayor the right of veto?"
Houlihan: "Not directly, Representative, what this does is it gives the Mayor a listing from which he can select his choice. The listing he is given is...are three recommendations from which he in fact should select one. Now, he has stated a number of times, I believe in 1955 when he was addressing the Citizens Schools Committee, that he thought this was a good process and he was going to work to legalize this....Ah....but it does....it does not give



him a veto in the sense that he's not vetoing all three of those names...he's not ...ah...the Commission is not recommending one name for one position, it's recommending a number of names three names for one position. Now, he can veto that first slate if he does not feel it meets his requirements, he can then go back to the Commission and recommend they come up with additional names and in that sense he does have a veto."

"But does this give him the right of veto with Kosinski: the other names added to the list, Jim?"

Houlihan: "No, it's my feeling that the Commission...ah....in its second slate is given two opportunitiessix names. will come up with one name that the Mayor can find fitting

...ah...for appointment."

"Jim, in supporting.....ah...may I address the Bill, Kosinski: Sir?"

Houlihan: "Please, Sir."

"In supporting the Right of Veto for the President Kosinski:

of the United States, for the Governor of the State of Illinois and for the Mayor in Municipalities, I will not be able to vote for this Bill."

Telcser: "Any further discussion? The Gentleman from Cook,

Representative the Gentleman from Champaign, Representative Hirschfeld."

Hirschfeld: "Ah....Mr. Speaker, I wonder if the distinguished Minority Leader, who happens to be on our side of the aisle could tell me whether this is one of Representative Houlihan's personal Bills or is this an Administration Bill?"

Telcser: "Any further discussion? If not, the Gentleman from Cook, Representative Houlihan to close.....I'm sorry, did you want to respond, Representative Choate....in Richard Walsh's ...ah...ah..."

Choate: "Ah....I'd like to tell 'Butch'...ah..that..ah..my voice is about gone ... I haven't consulted Representative Houlihan about this..ah...he's not normally in the position



of acting as a shill, but...ah...is this an administration Bill, Jim?"

Houlihan: "On this side of the aisle we have so many administrations that I....I think it is safe to say it is someones administration Bill."

Telcser: "The Gentleman from Cook, Representative Houlihan to close."

Houlihan: "Mr. Speaker and Ladies and Gentlemen of the General Assembly, I believe that this is a very serious matter. Yesterday we passed out a Bill from Executive Committee calling for an elected school board. I don't think that we should only have one Bill to improve the school board system, I think that we ought to have a Bill which tries to implement some of the recommondations on the elected school board but keeps us with the nominating proceedure and the appointment procedure of the Mayor of Chicago. In responding to Representative Kosinski's question, ..ah. we're not actually talking about veto power....we're talk-'ing about recommendations and if you will recall that in the Missouri Merit Selection of Judges, they recommend and require that there is an appointment from those recommendations. This has been tried before and I don't think it is apt to apply veto power to this selection. I don't think that these people can be termed nameless or faceless, they are people who are responsible and who have been involved with community and school affairs and I would ask for a favorable Roll Call on this account to improve the nominating procedure of the Chicago School Board." Telcser: "The question is, shall House Bill 1477 pass? All those in favor signify by voting 'aye', the opposed by voting 'no'. The Gentleman from Cook, Representative Douglas to explain his vote."

Douglas: "Mr. Speaker and Ladies and Gentlemen of the House, I can't resist the temptation in light of the rather facies....ah...question asked of Representative.....



Houlihan to say ... that ... let's let's face up to what the administration of the City of Chicago is. Chicago has traditionally run by a monolithic dictatorship....and that's what's coming from this side of the aisle ... and because of the fact that Chicago is monolithically dictated to by one person and a few people around him, those few of us who care about opening up the democratic process in the City of Chicago want Bills like this to pass and we ask for the support of those of you who recognize that we cannot change that dictatorial policy without the assistance of those in this General Assembly who sympathize with us as we try to gather more power to be able to fight back. The Mayor of the City of Chicago traditionally appoints, to everything, his relatives, his friends and a lot of other people, he doesn't care what his advisory commission say we're asking you to give us a little bit of help in passing a Bill which will let him know that he has got to be more accountable. And all the other things stated by Representative Berman and others are just are just poised .. to avoid the basic issue and we need your help. Thank you very much."

Telcser: "The Gentleman from Cook, Representative J. M. Houlihan to explain his vote."

Houlihan: "Mr. Speaker and Ladies and Gentlemen, in explaining my vote, let me point out that this is not an anti-Mayor of Chicago Bill, that this Bill is not an attempt to take a swing or a swipe at the Mayor of the City of Chicago. This is a pro-education Bill. This is a Bill trying to deal with the problems of education in our cities, very serious problems. In no way is this trying to address the fact of the Mayor of Chicago in terms of his power, his control over the City. This is merely an education Bill, an attempt to address the problem of appointments and how they are arrived at and how we get community envolvement in those appointments. In no way



directed at the City of Chicago, or the Mayor of that City, it's merely an education Bill and a Bill in favor of those children envolving those people in the neighborhoods and not selection process."

Telcser: "The Gentleman from Madison, Representative Kennedy." Kennedy: "Mr. Speaker, Ladies and Gentlemen of the House, I

was voting 'aye', on this Bill until Representative Bruce Douglas accused Mayor Daley of being a dictator. I don't know that and I don't agree with that so you vote me 'present'."

Telcser: "The Gentleman from Cook, Representative Yourell." Yourell: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, Ithe Sponsor of this Legislation....er....of this Bill had convinced me as to the merits of the Bill and you can see that I am voting 'aye'....on this Bill until Representative Douglas got up and convinced me it was a Bill I ought to be voting 'no' on."

Telcser: "Have all voted who wish? The Gentleman from Cook, Representative Thompson."

Telcser: "Have all voted who wish? Take the record. On this question there are 44 'ayes', 64 'nays' and this Bill having failed to receive the Constitutional Majority is hereby declared lost. On the Order of Postponed Consideration appears House Bill 452, for which purpose the Gentleman from Cook, Representative Bluthardt is recognized."

Bluthardt: "Well, Mr. Speaker, and Members of the House, House



Bill 452 has been up twice. I dubbed that ball twice but maybe the third time I can hit one. It's the vacant..... Legislative Vacancy Bill. I think it's a good Bill. There was some quesitons asked of me since the last time it was up....why aren't the vacancies filled by elections...by special elections...simply because the Constitution says that it shall be by appointment. I ...I would certainly hope that we can get enough Bills....er....votes this time to pass this urgent Bill." 1

These jury commissioners are appointed by law by the circuit court judges....they really

In fact, I would point out to you that the Gentlemen that Cosponsored this Bill with me, Representative Porter, Katz, Duff, McCourt, and Lundy....ah....We view this Bill in the same respect that many of us have listened to Bills in other past Sessions of...ah...of Legislature. This is to a great extent...the....the Creek and Dam Bill submitted to this Session of the Legislature by these six Members. I think it has aa...a laudatory educational purpose and I would solicit your vote for House Bill 1431." Telcser: "Is there any discussion? The Gentleman from Cook,

Representative Juckett."

Juckett: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. This Bill is just as discriminatory today as it was the day that we defeated it before. It's nothing but special Legislation for the one or one district initially and then they scraped and then they found out that there might be some other districts that would benefit from it. If we're going to correct the situation we should correct it for all districts and...ah...if size is a factor that should be it....but I can see no reason at all for this type of a Bill other than it will help his own little high school district....and I think there are many...many....excellent high school districts that need as much help....or more than these that are being proposed and there is no rhyme or reason for this type of a Bill or for the reasoning behind it and I urge a no vote and let's permanently bury it."

Telcser: "The Gentleman from Cook, Representative McCourt." McCourt: "Mr....Mr. Speaker and Ladies and Gentlemen, the purpose of this Bill is not discriminatory....it's to

give some equity where equity does not exist at the present time. Now, just because we are a duel district, our elementary school has approximately ...ah...the elementary district has ...ah.. approximately 55,00 children, the high school district has approximately 7,000, but because we are a duel district we are not able to qualify for the density factor. I...I very much respect Representative Juckett but as everyone, on occasion may make mistakes and I would earnestly solicit your support for this measure.....Thank you."

Telcser: "The Gentleman from McHenry, Representative Skinner." Skinner: "Mr. Speaker, the Sponsor of this measure was certain

ly correct when he said this is a creek and dam Bill.... except he probably spelled dam wrong....This Bill helped New Trier Township High School get more State aid to education. Now, if they get it, every other school district in the State is deprived of a certain amount of money.... the amount of money they get from being put into the general pot to be distributed throughout the State. Now, it would seem to me if any ...if any school district in the entire State didn't need more money it's New Trier High School. I would suggest that the density factoris also a....

Telcser: "Representative Pierce, for what purpose.....one moment please.....Representative Pierce, for what purpose do you rise?"

Pierce: "Mr. Speaker, as a graduate of New Trier I want to tell you this helps Evanston High School, it does not help New Trier High School by one cent. It is not a coterminous district and I resent my alma mater being insulted on this floor by the Gentleman from McHenry."

Telcser: "Representative Skinner, would you proceed, Sir."



Skinner: "I would proceed to apologize, I....I....had been informed by one of the Gentlemen from the area that I should be referring to Evanston High School and if we can perhaps strike that....every time I said New Trier Township we can strike that word and add Evanston, I think the argument is....ah...censorship right!....I would suggest the argument is as valid as it was in the first place. The ... ah ... the remark was made that this will allow this school district to...ah....to...ah....qualify for the density factor. As if the density factor was something that was great and sacrosanct. Well the density factor was put in there about three or four years ago as a way to get more money for the Chicago School System and certain other limited.....certain limited number of other large school districts in the State. It has nothing to do with density ... it has to do with the number of students per district. ... If the Legislature want to benefit ... wants to give extra aid to the larger districts I would suggest they put a number of students in the formula and then allow every school district to apply. Regardless of whether it's a unit or duel...district. This Bill does not do this. This is a Bill for one or two or three or four districts throughout the State and everybody else is going to loose. I would urge a negative vote." Telcser: "Is there further discussion? The Gentleman from

Cook, Representative Berman to close."

Berman: ".....In response to the previous speaker I would point out that although we call it density and that's the name that we use to describe what we're talking about we are talking about a bonus which is given to the larger school districts....and both units and duels qualify now, so that the argument that you used really is not an argument against ...ah...against this Bill. What this Bill does do is try to encourage some reorganization to encourage larger districts to be formed....and as I indicated
