

Choate: "I couldn't hear you, Mr. Speaker."

Speaker Blair: "He started.... he read the Amendment by title and we're... I said, rather than go on ahead and read it all you could explain it once you got your file....

What we're waiting on is, Mr. Choate file, so he can explain his Amendment so you all know what the delay is...

All right, Mr. Choate."

Choate: "Now, Mr. Speaker, I have my file and I believe I could have went and got it myself a little quicker than staff

delivered it. Actually House Amendment 19, you might

say is really the guts of the DOT appropriation. The

largest appropriation for any Department in this Session of the General Assembly. Amendment 19, restores the operations budget to its original form by placing line items by Departments rather than highway districts. Now, why do we want to restore this to the Department rather than by highway districts? One of the principal reasons and I should say the principal reason is simply because I think it is an undisputable fact by anyone here or anyone aware of the operation of this Department that no one can look into the future and see which district in the State of Illinois will be faced with national natural disaster in the forth coming twelve months. Now, recently we know by practical experience of the floodings in the northern part of the State, we know of the flooding in the southern part of the State and we know that those areas deserve and rightfully so because of natural disaster... more of the money to take care of these disasters than some of the districts in the central part of the State, eastern and western part of the State as given times. But by not having it placed in the Departments hands it was physically impossible to transfer, the money to where it was so desparately needed. We don't know as an example which districts will be snow bound, or which will be ice bound next winter and in the coming spring especially. You can remember many years ago that many districts was snow bound and ice bound to the extent that back in the days when administration came and it was the policy of the Department, then of highways, to just automatically go in and replace all maintenance personnel with people of that particular party, the Legislature in its wisdom... placed a law on the statute book to the extent that the maintenance personnel could not be replaced until after the springs snows and ice storms. This was so that you would have experienced personnel to take care of this natural disaster. This is



the reason that we want this Amendment so that the Department in its own rights can take care of these disasters. Mr. Speaker and Ladies and Gentlemen of the House, I would encourage the Members to vote 'aye' on Amendment... House Amendment 19."

Speaker Blair: "Mr. Totten."

Totten: "Thank you, Mr. Speaker and Members of the House. rise in opposition to Amendment #19. Amendment #19, and the ensuing Amendments up through 27, tends to destroy what the Members of this Legislature and the time that they put in, in the Committees... in this General Assembly. If you can remember Amendments 1 through 18, some were Committee Amendments and some were Members Amendments on the floor, were all defeated in the prior hearing on Second Reading on this Bill. What the Sponsor is trying to do now, is to put this Bill back in the form in which it was originally introduced by the Administration and run it into a Conference Committee. There was over three days of Committee hearings in the Senate and over two days of Committee hearings in the House which, if we adopt... and Amendmnet 19, or anyone of the next ones, will be destroyed and all the hours that not only the Members put in but also the staff put in... analyzing these Bills will be destroyed. I think there is more to it than just rushing this Bill into a Conference Committee by adopting Amendments, restoring it to its original shape and there is a sanctity of the time that we have put in on this Bill. There appears to be an unnecessary zeal to rush this two billion dollars into Conference Committee where it can be tapped up with none of the Members participating really in the way that we have participated not only on the floor but in Committee on this Bill. I think the whole process of Legislator input and the Members time is being destroyed by the intent of Amendment #19 and the Amendments that



follow and I would ask that the Members seriously take a look at what's being tried here because in effect,

the appropriation Bill has been introduced by the Administration and in effect would be rushed to a Second Conference Committee without any Member input and I think that's a shame, I think we should attempt the defeat of Amendments 19, and the ensuing ones also."

Speaker Blair: "Is there any discussion? Mr. Ryan." Ryan: "Will the Sponsor yield?"

Speaker Blair: "He indicates he will."

Ryan: "Representative Choate, Amendment 19, as I understand from what Representative Totten just said, puts the Transportation Bill back into the form that it was introduced in by the Department of Transportation, is

Ryan: "I would like to address myself to the Amendment." Speaker Blair: "All right, proceed."

Ryan: "If we allow this to happen, Ladies and Gentlemen there

really isn't any need for us to come to Springfield. As Representative Totten has pointed out, we've all spent many hours on this Bill to get it into the shape that it should be in for the Members. There would be no need for us to come down here if we disallow the Departments to introduce there Bills in a form that they want them in. So, I would encourage everyone here... we're talking about the biggest part of the State budget that we have to deal with down here, over two billion dollars and I certainly think we ought to give some great consideration to your vote here and oppose Amendment #19, and all the rest of the Amendments. Thank you." Speaker Blair: "Is there further.... Mr. Choate."

Choate: "Let me close briefy, Mr. Speaker by telling the Members of this House of Representatives and I wish you would listen for just one second. I want you to consider



with me... what has happened this past year. On June 10th, the following counties were declared disaster areas because of flooding. On June 13th, Alexander, Calhoun, Henderson, Jersey, Monroe and Randolph counties were added to the list, on June 18th, sixteen more counties, DeKalb, Fulton, Mason, Ogle, Schuyler and Cass. On June 25th, fourteen more counties made the disaster list, on June 28th, the Civil Defense Agency ask that Woodford county be added to the disaster list. I want anyone of you... and most of you represent these counties, you have them in your district some place, I want you to go back to those counties and ask the people of affected by these disasters if they want the Department to be handstrung by the amount of money that they can spend in that district when the disaster occurs. Now, basically there is not a great deal of difference between this Amendment and Representative Totten's Amendment #1, the only thing that is different... this gives the Department more flexibility to take care of natural disasters. Now, I can't help but remember when Representative Totten says that it is getting late to consider a Bill of this magnitude and the Amendments that I suggested to this House last week, that I had suggested that I had heard that people were so called, cutting deals and that some people were afraid of a Conference Committee... I stood on the floor of this House and suggested that we have an open Conference, I even asked to have Room 212, Room 400, or the floor of the House and invite each and every Member of this Legislature from the House and the Senate to attend and help work out these differences. Now if that's being dilatory, then I don't know what

dilatory is. I say to you, Mr. Speaker, I would hope that a majority of the Members present and voting would join with me in adopting this Amendment."

Speaker Blair: "All right, the question is, shall Amendment #19, to House Bill 1345 be adopted. All those in favor

will vote 'aye' and the opposed 'no'. Mr. Totten."

Totten: "Thank you, Mr. Speaker and Members of the House. I

would just like to remind the Members of the House. I would just like to remind the Members of the House that when we considered Amendments #1 and 2, that were so summarily defeated here, we did provide that flexibility in the Departments budget to allow them to take care of natural disasters and those Amendments were defeated... were short lived so that we could get to where we are today. We did provide that conscientiously that flexibility that the Department requested and to get this Bill in

the shape that we're trying to get it now, is really a disaster to the Members of this House and all the work that's been put into the appropriations and the discussions on the floor and I would again respectfully request to take a serious look at what we're doing and vote 'no'.'

Speaker Blair: "Mrs. Kent."

Kent: "Thank you, Mr. Speaker. I too am voting 'no' on this Amendment and as you know I am for highways all the way down the road... but, what guarantees does this give to those counties that are in the disaster areas, it gives none. They should at least have their appropriated funds ready for each county we agreed in Committee that we were willing to have flexibility of maybe 15%, so that there could be some the.... rearranging of the budget but goodness, do we want to give a blank check. This to me is what we would be doing if we vote 'yes' on this Amendment. I urge you to vote 'no'."

Speaker Blair: "Have all voted who wished? Mr. Lauer."

Lauer: "Mr. Speaker, Members of the House. I find it ironic that Representative Choate makes reference to natural



disasters because it is the feeling of many of us, if we continue with the present administration perhaps we will continue to visited by the wrath of God. However it is the case that... I think Amendment #1 and 2, did give a certain flexibility while assure also to Members of the General Assembly that there would be, at least a certain attention to a balance over the entire State. I don't think that this is too much of an assurance to ask. One of those Amendments that was very blithely slipped out was an Amendment that had a strong effect on my district and quite frankly, Ladies and Gentlemen of the House, I have a tendency to pay attention to the Representatives of the different districts when it comes to these various Amendments. Now, conceivably they could be called pork barrel, I have heard it called as such in the media, but it is a case, Ladies and Gentlemen that these Amendments represent projects that are very important to the individual districts. In one stretch of road that in Amendment #7, I proposed to have widen and resurface... there were 47 accidents last year in One short stretch of road. Now, if that was in your district I think you would also be screaming against any idea of taking an Amendment that would fix this out. It's also a case, Ladies and Gentlemen that I think we better pay attention that maybe the Representatives in the district do know better what is needed in those district than some bureaucrat from the Department of Transportation. He can come out from Springfield or come out from the Regional office and say, well it doesn' look too bad to me now... but conditions do change. It seem to me, Ladies and Gentlemen that in ignoring the input of the Appropriations Committee and I notice that that there are some from the other, side that are voting for this Amendment that you are ignoring the fact that... Amendments that are agreed to in Committee should give a

proper cognizance of the input that went in that Committee and that they should not have been stripped off and this Amendment should be defeated."

Speaker Blair: "Mr. Dunn.... Ralph Dunn.... Have all voted who wished? As I indicated, Mr. William Walsh... as I have indicated before it is difficult to see the switching lights when I've got these T.V. on upstairs so, if somebody wants to be recognized and I'm not recognizing would they stand up and yell, don't scream just yell."

Walsh: "Well, Mr. Speaker and Ladies and Gentlemen of the House. I think the opponents of this Amendment have done an excellent job in pointing out why we should oppose it. The fact is that Amendments 1 and 2, would have solved the problem that the Gentleman referred to and no one fought those Amendments any stronger than the Gentleman from Union. Now, I suggest to you, Mr. Speaker that there is sufficient flexibility here for the disasters that he is fond of pointing out, they can be taken care of very adequately and there's just no reason at all as Representative Ryan pointed out for us to come down here and appropriate a lump sum in the amount of very nearly two billion dollars so that this Department or any Department can do with it as they will. We should have some input in this because really we are the people who are closes to the people that we represent. So, I suggest to you that if we are going to be meaningful at all in this Legislation, we should defeat this Amendment... which in affect give the Department of Transportation a blank check to do with as they will, this is simply poor government and we should have more input than that and I urge you to put up some more red lights and take off some greens."

Speaker Blair: "Have all voted who wished? Mr. Neff."

Neff: "Thank you, Mr. Speaker. In explaining my vote, I

think that it is a must almost to defeat this Amendment



because we've had the experience most of us and particular folks that live in Forgotonia... hoping to get some roads there and we haven't seen any sign of them, if this Amendment is put back on we have no indication but we'll be sitting there the next year with still no roads. We thought that there was money in the budget to do some road work in that area and we found last year that we haven't had it done and I think the only way we can get at the.... leave this budget in a line item and therefore, I would hope that we could get some more red lights and defeat this Amendment which is going to hurt the people from downstate."

Speaker Blair: "Mr. Ralph Dunn."

Dunn: "Thank you, Mr. Speaker. I would like to call attention to the Member of the fact that the appropriations have really worked hard... we worked several days, our staff worked hard in trying to straighten out the Department of Transportation budget in appropriation and the Director of the Department of Transportation, his secretary said that our Amendments put on in the House Appropriations Committee were good and he appreciated Amendment #1 and 2, particuarly. We each had some Amendments on there that we were particularly proud of and if you remember here about a week ago or about ten days ago, Representative Choate got up and sliced all of our Amendments off, including some Amendments for appropriations in my district and some... little bit in his district, not very much granted but, we ought to get some red votes... we ought to defeat this, if we don't I wonder what would be use of serving on the Appropriations Committee and I can't understand the Democrat Members of the Appropriations Committee voting for this Amendment now when they voted to do a better job in the Appropriation Committee. I too urge that we have some: more red lights and some of your turn off your



off your green lights. Let's show some appreciation to the people in Appropriation Committee and for the Committee process. I would urge some more red votes and I'm voting red. Thank you."

Speaker Blair: "Have all voted... Mr. Duff."

Duff: "Well, Mr. Speaker and Ladies and Gentlemen of the House. I'm a little distressed, I recall a couple of weeks ago when we were all trying to finish up the work and get out of here and we had to go through 18 separate Amendments in a kind of charade... or the elimination one at a time of the efforts of a large number of our membership on both sides of the aisle. I would recall to those Members who worked so hard to go not only on the Appropriation Committee, which worked three days on this Bill but also to the Members who went to these Appropriation Committee with Amendment which were important to their own districts. To those that have been taken off... and now we have an Amendment which is going to give as the respected Sponsor of the Amendment suggests broader flexibility. It seems to me that in the last two or three weeks we've seen a very strong argument to why this legislature and this General Assembly should assert its own responsbility as respect to the Executive Branch. If we give unfettered responsibility to one Department, whether it be the Department of Transportation or any other... and we don't apply Legislative concern then we might as well not do the work, we might as well just simply set on an amount of money and drop it off. Here we have a Conference Committee inevitable anyway... we all know that and it seems to me that now... to disregard all of the work of that Committee while.... we know that the Conference Committee is going to be interest ed in the opinion of the House, that we should see some more red lights up there. I would hope that a number of other Members would feel as strongly as they did when

they... for example took the time to go before the.....
to address themselves to it. Thank you."

Speaker Blair: "Have all voted who wished? The Clerk will take the record. All right, Mr. Totten."

Totten: "Mr. Speaker, at the appropriate time I would like to request a verification."

Speaker Blair: "All righty. At this point there are 79 'ayes' and 72 'nays' and the Gentlemen from Union, Mr. Choate, for what purpose do you rise?"

Choate: "I would assume that request would include a poll of
the absentees... a call of the absentees as well as a
verification of both the affirmative and negative."

Speaker Blair: "We have always accorded that to any Member of the House."

Choate: "Thank you."

Speaker Blair: "Mr. Choate, as you well know. Molloy, says

I've been in the Legislature. DOT'S allocation incidentally, is based upon the formula set out in the statutes as for as the statutes are concerned."

Speaker Telcser: "Is there further discussion? Representative..."

Skinner: "Excuse me, I've got two Bills one a 91 and ones

a 92, and I had them mixed up. This is House Bill 2792...

Choate: "Now, that you have found the right Bill."

Skinner: "Right...."

Choate: "House Bill 2792, has been passed by the House and by the Senate, it's on the Governor's desk. The Amendment the Senate Amendment to this Bill is based upon the formula in that Bill and to be quite frank with you, I don't see why in as much as that Bill has already passed that we need that particular language in this Bill. The Bill is already on the Governor's desk 2792."

Skinner: "This Amendment attempts to reinforce that Bill and make sure that the money does go to the townships and cities and to the counties."

Choate: "Well, it shows that a portion goes to the townships and municipalities etc., I'm not sure whether it's the same formula that was included in 2792 or whether it wasn't."

Skinner: "Mr. Speaker, if I may speak to the Amendment... I'm reliably informed by our staff that this Amendment will take away the money that we have allocated to cities for use in non arterial streets, in larger cities it will take away the money that is going to townships road districts, it will also take away the money that is to...."

Speaker Telcser: "Representative Choate, for what purpose do rise, Sir?"

Skinner: "... counties."

Choate: "I tell you, Mr. Speaker... many Members on my side

Amendment, I'm Tabling it."

Speaker Telcser: "The Gentleman moves to Table Amendment #21 of Senate Bill 1345. All in favor 'aye', opposed 'no'. The Amendment is Tabled. Is there further Amendments."

Attorney Generals statement today... that he has no
further inclination to have his Attorneys in this department, so I would move for the adoption of this

Speaker Teleser: "Any discussion? Is there any discussion?

The Gentleman moves the adoption of Amendment #22, to

Senate Bill 1345. All in favor of the adoption signify

Clerk Selcke: "Amendment #23, Choate. Amends Senate Bill 1345 as amended and so forth."

Speaker Telcser: "The Centleman from Union, Representative Choate."

Choate: "Yes, Mr. Speaker, House Bill.... House Amendment 23, restores the supplemental freeway appropriation to the requested three hundred five million dollars. The Department of Transportation three hundred and five million dollar appropriation request is based upon the reappropriation need of fifty-five-million and two hundred and fifty million for programs in fiscal '75. The



31. road program calls for a hundred and ninety-four point five million for supplemental freeways an additional forty million for the City of Chicago road projects and fifteen point five million for preliminary engineering. Now, the department strongly and I concur with them, support the lump sum appropriation simply because two or three things as far as the freeways are concerned that none of us have any control of. We cannot control... the amount of time that it takes for acquisition of right ofaway. We cannot control the amount of time that it takes for engineering studies, feasibility studies, planning studies and all of these things that are required especially

by the federal government... all of things that are required especially by the federal government to get our freeway program going, so consequently if we earmark

a lump sum amount for this particular freeway and we've seen it happen in the past, and a preliminary study the enginerring, design and all things are not completed by the end of the construction year then that money is just left...where it could feasibly be used in other areas of road building throughout the State of Illinois. Not only building a road that is desparetly needed but yes, gainfully employing people that need a job. I would say that this Amendment, Mr. Speaker, is in the interest of not only... building freeways throughout the great State of Illinois not only at hearing through the criteria set forth sometimes arbitrary set forth by the federal government but yes, in the interest of keeping Illinoians employed. I would move for the adoption of House Amendment 24."

Speaker Telcser: "The Gentleman from Cook, Representative Totten."

Totten: "Thank you, Mr. Speaker and Members of the House.

I wonder if I could ask the Sponsor a question?" Speaker Telcser: "He indicates that he will yield."



Totten: "I can under.... Representative Choate, I can under-

stand your position on Amendment 23, but from what you said and looking a little further ahead here... Amendment #28, line items several additional freeways and are you going to have a change in position when you get to 28, than that you have on 23?"

Speaker Telcser: "Turn on, Representative Choate."

Choate: "If 23, is adopted I'm going to Table 28."

Totten: "I just wanted to be sure."

Amendments?"

Speaker Telcser: "Further discussion? The Gentleman moves
to adopt 23, to Senate Bill 1345. All in favor vote
'aye', opposed 'no', the Amendment is adopted. Further

Clerk Selcke: "Amendment 24, Choate. Amends Senate Bill 1345, and so forth."

Speaker Telcser: "The Gentleman from Union, Representative
Choate."

Choate: "House Amendment 24, restores the inter-city rail

program appropriation to that originally requested by the department. I feel personally that the department has the expertise needed in this area to determine, Mr. Speaker, which routes are needed and thus which routes should be funded. I could give you a breakdown if you desire, such as the Chicago, Galesburg, Quincy... DOT recommends five hundred thousand dollars. The Senate Amendment recommended five hundred thousand dollars, Chicago, Peoria, Rock Island, DOT recommended a million

dollars, the Senate recommended a million. Chicago to
Springfield, DOT recommends seven hundred thousand dollars,
the Senate recommened eight hundred thousand dollars.
These are minor changes... a hundred thousand there,

two hundred thousand in the Chicago, Rockford area which
the DOT recommends that the Senate didn't recommend
any money in that area. Chicago, LaSalle, Fulton, I think

that the Department has the expertise to know whether



these rails commuter service lines need the money or whether they don't... much more so than the Senate. I would move for the adoption of 24... House Amendment 24."

Speaker Telcser: "Any further discussion? The Gentleman from DeKalb, Representative Ebbesen."

Ebbesen: "Mr. Speaker, would the Sponsor yield for a question?'

Speaker Telcser: "He indicates that he will."

Ebbesen: "You didn't.... it was four hundred and twenty-four thousand dollar I believe on that Chicago to Clinton, does that remain in with this Amendment?"

Choate: "Chicago to where?"
