Speaker Bradley: "The Gentleman from DuPage, the Speaker

Could we give the Gentleman some attention, please?" William Redmond: "Mr. Speaker and Ladies and Gentlemen of the House. It is with the utmost gratitude that I acknowledge that splendid Resolution. I hope that everything that's said in there is true. I certainly won't dispute it. There hasn't been a moment that I have served that I haven't enjoyed. I don't believe that there is any finer group of men and women anyplace in the state or anyplace in the nation than those that are in the General Assembly. And who've been honored, as I was, to be selected as I was to be selected as Speaker of the House, is a realization of an ambition that I'm sure in every heart and every breast of all of the Members serving here. I've tried my best to do the best that I can and I would have to say that it would have been impossible if I've had any small measure of success; it would have been impossible if it hadn't been for the governance and the patience of my wife, who's sitting up there in the Gallery, Mrs. Redmond. distinguished career of one of the most illustrious sons of Illinois and one of the outstanding civic and political leaders of America; and Whereas, Mayor Daley was a former Member of both Houses of the Illinois General. Assembly, having been elected to the House of Representatives in 1936 and to the Senate in 1938 and 1942, and he was Minority Leader of the Senate in the 63rd and 64th General Assemblies; and Whereas, after

serving with honor and distinction as Director of
Revenue under Governor Adlai Stevenson and as County
Clerk of Cook County, he was elected Mayor of Chicago
in 1955 and was re-elected in 1959, 1963, 1967, 1971 and
1975; and Whereas, under his dynamic and progressive
leadership Chicago became more than ever the 'city

with the big shoulders', and during a period when many urban areas were undergoing a process of stagnation and decay and experts questioned whether cities could be

Swerned, the Caty of Chicago, under the inspired and



and inspiring leadership of Mayor Daley, enjoyed an era of unprecedented progress and development; and Whereas, a man who could 'walk with kings - and not lose the common touch', Richard J. Daley derived strength and sustenance from roots which were firmly planted in his family, his church and his neighborhood; and Whereas, a paraphrase of the celebrated epitaph of another master-builder may justly be applied to Richard J. Daley -- if you seek his monument, look around you -- not only at the burgeoning skyline of his beloved city but in the hearts and minds of countless of his fellow citizens who loved him not only for the deeds he did but for the man he was; therefore, be it Resolved, by the House of Representatives of the Seventy-Ninth General Assembly of the State of Illinois, that we express our profound sense of loss at the death of the Honorable Richard J. Daley; that we express our deep appreciation for the services he rendered throughout his long and distinguished career which benefited not only the City of Chicago but the entire State of Illinois; and that toshis bereaved family we extend our heartfelt sympathy; and be it further Resolved, that suitable copies of this Resolution be present to Mrs. Richard J. Daley and to his sons, daughters and grandchildren; and be it further Resolved, that this Preamble and Resolution be journalized and made a permanent record of the House; and be it further Resolved, that as a sign of our respect this House stand adjourned Sine Die."

Speaker Redmond: "Representative Shea."

Shea: "Mr. Speaker, Ladies and Gentlemen of the House, I just wonder if the greatest thing we could say about this man if we bow our heads and just say a prayer for his family. Now, Mr. Speaker, I'd ask that all Members names be joind with Mr. Tashburn and mine on the
