Resolved by the House of Representatives of the 79th General Assembly of the State of Illinois, the Senate concurring herein, that there shall be submitted to the electors of this State for adoption or rejection at the next election of the Members of the General Assembly in the State of Illinois occurring at least six months after the legislative approval of this proposition in the manner provided by law, a proposition to amend Section 9, paragraph (e) of Section IV of the Constitution to read as follows: Section IV, the Legislature. Section... that's article 4 of the Legislature. Section IX, the veto procedure. The Governor may return a Bill together with specific recommendations for the correction of technical errors, the matters of form to the House in which it originated. The Bill shall be considered in the same manner as a veto Bill, if however, a specific recommendation are accepted by the record... by Record vote the majority of the Member's elected to each House, the Bill shall again be presented to the Governor and if he certifies that the acceptance conforms to a specific recommendation the Bill shall become law, if he does not so certify the Governor shall return it as a veto Bill to the House in which it originated.
