Speaker Redmond: "Representative Washburn, for what purpose do you rise?"

Mudd: "Yes, Mr. Speaker this is a ah... supplemental app-



ropriation to take care of a problem that existed because of the cuts ah... last... last year, it has been amended to reduce the amount to twenty-three thousand, five-hundred dollars, this is all Federal Funds, there is no State money involved. This is money who... which is channeled through the Department of Local Government for a ah... overall fire fighting and safety study for the State of Illinois and ah... they have expended some funds out of there ah... contractual services in the amount of ten-thousand, five-hundred dollars and it places that back and also appropriates money for phase out.... out of Federal Funds ah... from local government affairs some fifteenthousand dollars if... they can't come into the State of Illinois on a grant. It's just an appropriation to this Commission for an expenditure for ah... overall ah... study. I would ask that ah... at this time that it receive a favorable vote."

Speaker Redmond: "Any discussion? Representative Cunning-ham."

Cunningham: "Well... well.... will the Sponsor yield to a question?"

Speaker Redmond: "He indicates he will."

Cunningham: "Representative Mudd, what if anything does this particular group have to do with the proposed location of a National Fire Fighters Academy ah... in the State of Illinois."

Mudd: "I ah... Representative Cunningham, I won't have any knowledge of that, I would imagine that this Commission is involved in ah... statewide study for all ah... our problems of ah... fire fighting and as far as safety in the State of Illinois, sso but, what they would do would be the selection that I ah... I wouldn't have any knowledge..."



Mudd: "No sir,"

Cunningham: "Thank you."

Speaker Redmond: "Any further discussion? Representative Schlickman."

Schlickman: "Would the Sponsor yield for a question?"

Speaker Redmond: "He indicates that he will."

Schlickman: "I understand that the cause for this Bill was an original appropriation of thirty-one thousand to the Department of Local Government Affairs but the Comptroller has taken the position that the money can not go to the Fire Protection Commission from the Department of Local Government Affairs, is that correct? Now, where are we taking that thirty-one thousand from the Department of Local Government

Mudd: "Representative Schlickman it's my understanding that these funds come from a ah... National or Federal level to be expended ah... specifically in the area's of ah... studying more effective ways to fight fires and public safety in that area, but they are channeled through our ah... Department of Local Government and the only way that they appropriated to to the ah... responsible authority is by appropriation from us, this is what the Comptroller addresses himself to that they have to be appropriated to a specific area. Does that answer your question?"

Schlickman: "Yes, I'm satisfied thank you."

Mudd: "Thank you."

Affairs?"

Speaker Redmond: "Any further discussion? Ready for the question, the question is shall this Bill pass. Those in favor will vote 'aye', opposed vote 'no'. Have all voted who wished? Representative Bradley, I....

Clerk O'Brien: "House Bill 3273, A Bill for an Act making appropriation to the Board of Governor's State

Speaker Redmond: "Representative Catania."

Catania: "Thank you, Mr. Speaker and Members of the House.

House Bill 3273 appropriates one-hundred, twenty-five thousand dollars to make back wage payments to female faculty members at Chicago State University. The ah... history of this legislation is that in the summer and fall of 1974 people from the wage and hour division of the United States Department of Labor came into Chicago State University at the request of faculty members and conducted an investigation. They came orginially saying that as a result of their pre-campus investigation they felt that seven-hundred thousand dollars which was due in back wages, to the female faculty members. President Alexander, the new President of Chicago State University, opened his books to the Department of Labor and also to the people from Health and Education Welfare who came in, they sat down and talked with the female faculty members and they have arrived at ah... a total appropriation of one-hundred, twenty-four thousand, nine-hundred nintyone dollars as a satifactory settlement to everyone involved. That is, the United State Department of Labor, ATW, the female faculty members and the Administration of Chicago State University incorporation with the Board of Governors. The problem right now is that the Administration at Chicago State University says that they can not take a hundred, twenty-five



thousand dollars from this years operating expense budget without seriously effecting courses and programs for their students, Chicago State University, as you know, is the school which serve black students on the Southside of Chicago so, they're coming to the General Assembly asking for this money, this one-hundred twenty-five thousand dollars so that they will not have to take it away from these students courses and programs. If we are unable to appropriate this money the Department of Labor will take them to court... there have already been pre-trail motions and I'm afraid that probably we will end up spending a great deal more of the taxpayers money in court cost and Attorney's fees. I hope that you will approve this Bill today... I will be happy to answer any questions that you might have."

Speaker Redmond: "Representative Byers."

Byers: "Thank you, Mr. Speaker will the Sponsor yield for a question?"

Speaker Redmond: "She indicates she will."

Byers: "Ah... Representative, is it true that the money for this goes back to 1972 that we're giving back wages?"

Catania: "That's correct, Representative Byers. This money is for the academic years 72-73, 73-74, 74-75. President Alexander has made the equity payment for the academic years when he has been President and there are no current ah... problems this is back wages due, equal pay for equal work since 1972 up to ah... end of the academic year 74-75."

Byers: "Is it that there is some ah... deal that we might be ah... obligating ourselves the State of Illinois to all the other Universities in the State if we go back beyond this fiscal year and pay this bill, Rep-



resentative Catania?"

Catania: "Well... what this Bill does, is to appropriate this money for Chicago State University, Representative Byers ah... as you know the wage and hour division of the U.S. Department of Labor has been around for many, many years and there are...."

Speaker Redmond: "Representative Houlihan, for what purpose do you rise?"

issue and there is ah... question on the floor....

could we have some order in the House... so the people

could hear the answer of Representative Byers question."

Houlihan: "Ah... Mr. Speaker, I think this is an important

Speaker Redmond: "Please come to order."

Catania: "The answer to the question is that all of these complaints have to be dealt with separately by the U.S.

Department of Labor, what we are talking about here is the problem at Chicago State University."

Byers: "Thank you, I would like to talk ah... against the

Bill ah... while this is not a very large appropriation,

I think it's one-hundred and twenty-four thousand dollars ah... this morning in our ah... Appropriations

Committee pass an appropriation for Public Aid and ah...

I do think the proper thing to do is to give the

University the authority to pass this and pay this obligation but I'm afraid we're going to open the doors of the ah... entire State if we pay this bill and be obligated for others and I would recommend a 'no' vote on this ah... appropriation that we do not have the money for."

Speaker Redmond: "Representative Leinenweber."

Leinenweber: "I have a question for the Sponsor."

Speaker Redmond: "Proceed."

Leinenweber: "Ah... Mrs. Catania as I understand your rat-.

ional for ah... this appropriation is that if we don't



appropriate this money the University will have to pay this sum or a larger sum out of their existing appropriation which would take from ah... their...

appropriation which would take from ah... their...

what they have to spend in education, is that correct?"

Catania: "That's certainly correct, they are not now authorized to do that ah... under the current statute. The Appropriations Committee objected to an Amendment to say that they could transfer funds. The way it is right now, they could not find a hundred, twenty-five thousand dollars, however, I would like to point out if they do have any left of their funds, it would be under this fiscal year, it will return to the General Revenue Fund which is where we are getting this money."

Leinenweber: "Well... wouldn't it be true though that if
Chicago State University had not allegedly violated:
the ah... Fair Labor Standards Act that they would
have had to paid these sums of money to the employees
out of their appropriations in prior years."

Catania: "That's correct, but, of course, the appropriations are no longer standing for the fiscal year under question."

Leinenweber: "Well... except they probably had more money
to spend in the prior years because of the fact that
they in effect saved money to ah... by not paying the
employees:what they allegedly had coming to them, wouldn't
that be true."

Catania: "Unfortunately, it's this current Administration that has to deal with the problem and, as I said, since

Dr. Alexander became President of Chicago State University he has dealt with the problem. What he must now face is this legacy of his ah... previous administration.

Leinenweber: "Is there a statute of limitations involving the ah... these claims."

Catania: "The U.S. Department of Labor goes back only two



years ah... before the date of its investigation so it came in in 74, therefore, this goes back to the academic year 72-73."

Leinenweber: "So ah..."

members."

Catania: "Presumably there was also discrimination in earlier years but goes back only two years."

Leinenweber: "All right, thank you."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Thank you. Mr. Speaker will the Spo

Lechowicz: "Thank you, Mr. Speaker will the Sponsor yield to a question?"

Speaker Redmond: "She will."

Lechowicz: "Ah... Mrs. Catania, I'd like to know the dollar:

amount that is asked in the Bill a hundred, twenty-four thousand. You've stated that it goes back for a period of three years, now this is for Chicago State University.

That is the dollar amount for the rest of the Universities?

If any."

Catania: "The only place that has come in asking for this is the Chicago State University, I have no figures

from the other schools. The U.S. Department of Labor investigated there as a result from the faculty

Lechowicz: "I agree with the concept as far as equal pay for equal work but I think it's, we're establishing is very grey area and the possibility of each University now going through with the establishment this Bill in

stating well, let's see.... what do we owe the ladies
who taught Universities from 1973, 4 and 5 and then
all we have to do is get a Member of the General Assem-

bly to introduce it and we will get an additional back pay because of a problem that should have been corrected

right then and there. Is that true?"

Catania: "Well, Representative Lechowicz what is true is,

people have had the right to file these complaints



for several years, as you know investigations take some time, we are very fond of saying that the statutes are guaranteed to pay for equal work and the question is, are we going to provide the equal pay when it is demonstrated that people are really entitled to it. The only precedence that I think, except here, is the precedence of openness on the part of the University Administration. President Alexander said, all right, say that we have a problem here, let's all sit down together and look at the record and work it out, he did not automatically assume that the people claiming discrimination were wrong, he did not immediately hire attorneys at great expense to the taxpayers and start fighting -- it has unfortunately been the case at some other schools. I think that it is a very good precedence that he sat down and worked it out. As I said, they originally asked for seven-hundred thousand dollars. This is what they have been able to come down to. This is an individual case where a very open and laudable procedure has been followed."

Lechowicz: "Could you tell me what the dollar amount that they just laid in your lap in personnel services?"

Catania: "As of March 29, our staff told me that, not just in personnel services, but in their entire appropriation for fiscal '76, they had 31% of the total left ah...President Alexander said that he could not predict the precise percentage that would be lapsed at the end of the year ah...he thought that it was good administration to have a 31% remainder on March 29. As I pointed out earlier, if there is any money left it will return to General Services."

Lechowicz: "Well, my point is that I would rather have various universities, instead of coming in with the respect of supple.....ah..special Bill to assure their own



economy at that level, transfer the funds in the elapsed of personal services or contractual services equipment telecommunications are unexpended obligated sources and in turn ratify the situation in that way.

And, you're stating to me that you've got approximately 31% left as of March, I think they can do it that way."

Catania: "Well, Representative Lechowicz as I point out, they don't have the authority to do that in the Appropriation II Committee did not amend the Bill to give them that authority ah... they did point out though that if money lapses it will revert to General Services and what we're talking about here is taking it from General Services. I think that with their kind of good management they may well have some money lasping at

Lechowicz: "Thank you."

Speaker Redmond: "Representative Dunn."

the end of the fiscal year."

Dunn: "Thank you, Mr. Speaker ah... ah... I would like to speak ah... in ah... right opposition to this Bill just briefly. This Bill was passed through Appropriation II Committee of which I am a member and during the Committee hearing on the Bill it was ah... represented that ah... the problem that this Bill attempts to solve was common not only to Chicago State University but to another of Universities around the State of Illinois, a number of them and each of the other Universities have picked up the tab within the resources available to it and has not come to the General Assembly for additional appropriations to cover this expense. If we pass this Bill and make this appropriation on behalf of Chicago State University, I think we are at least morally obligated to do the same for everyone similarly effected. We don't have any money this year and I think that if the other schools found a



way to pickup the tab themselves, Chicago State University can do the same. So I would respectfully request a 'no' vote on this Bill."

Speaker Redmond: "Representative Duester."

Duester: "Would the ah... Sponsor yield for a question?"

Speaker Redmond: "Indicates she will."

Duester: "Ah... I just completed ah... a ah... a review of the recent report of the Commission on the status of women and found it quiet interesting because I thought it suggested that this situation of disparity in ah... wages was true in virtually every State of Illinois University and Coilege and Institution of higher education, is that ah... generally so?"

Catania: "Representative Duester, we certainly did find that there was such discrimination in the Universities when I pointed out earlier in my presentation was that Chicago State University, the one that we are considering here has chosen to act in a very open and direct way in dealing with the Department of Labor and ah... APW. They have open their books to them instead of hiring attorneys to fight the women, they have sat down with them and negotiated and they have all agreed that this is a fair settlement. This is a unique approach of the Illinois University System."

Duester: "Ah... is it true that the other Universities are not being open and that they are ah... contesting these ah... wage claims with the United State Department of Labor."

Catania: "Well, Representative Duester I believe you said
that you had just finished reading the report of the
Illinois Commission on the Status of women, that report in its Education Committee Section does point out
that a great deal of time and the taxpayers money is
being spent ah... by Lawyers who are fighting these



claims in those Universities, yes."

Duester: "I thank you."

Catania: "Anytime."

Speaker Redmond: "Any further questions? Representative

Mann."

Mann: "Mr. Speaker and Ladies and Gentlemen of the House.

Thank you, Mr. Speaker.... I don't have any questions but I certainly do want to indicate ah... my support for this legislation and it's no secret that many of the Institutions of higher learning at the community college level and at: the college level are suffering this year so much so, that in Chicago ah... the Board of Community Colleges voted an increase in tuition from four to eleven dollars yesterday. Now, if we do not ah... pass this Bill the people that will suffer will be the students and ah... the programs which were guaranteed to be presented to them. This is no new appeal... we've constantly had appeals where emergency action was required by the House to solve a very pressing problem in need. All we're being asked here to do is pass a Bill appropriating some hundred and twenty-five thousand dollars so that an important Institution which serves the urban needs of your constituents and mind can continue to keep its word with regard to the programs offered to the students and as a Representative of those students it seems to me that we can do no less but support this legislation. If you see a deterioration of urban education ah ... if you want to see ah... fewer people ah... gainfully employed, if you want to see the moral of ah... minority students destroyed perhaps you would oppose the Bill. But, I don't think that anybody in the House wants to do this and I would urge your support."

Speaker Redmond: "Representative Madison."



Madison: "Thank you very much, Mr. Speaker would the Sponsor yield for a question?"

Speaker Redmond: "She will."

Madison: "Representative Catania... if I understand this
Bill it's to ah... make ah... ah... back wage payments to certain female employees ah... based on
hearings and conclusions by the U.S. Department of
Labor. Can you tell me what would be the effect of
the U.S. Department of Labors ruling if we do not
pass this Bill."

Catania: "Yes, Representative Madison. Ah... the Department of Labor representatives are awaiting the action
of this General Assembly to proceed with their activities
in court. As I said earlier, there have already been
pre-trial activities, we will be in court very soon
with this if the General Assemby does not appropriate
this money. The U.S. Department of Labor is waiting
only because this Bill has been introduced in this
General Assembly."

Madison: "I see, thank you very much."

Speaker Redmond: "Representative Peters."

Peters: "Mr. Speaker, I move the previous question."

Speaker Redmond: "The gentlemen has moved the previous question. The question is, shall the main question be put. All in favor indicate by saying 'aye', the opposed 'no', the 'ayes' have it. Representative Catania to close."

Catania: "Thank you Mr..... thank you, Mr. Speaker and

Members of the House. I would like to point out that

contrary to what an earlier speaker said, other Universities have not found money internally to pay these
kinds of claims as a general policy, other schools
have instead hired attorneys with the taxpayers money
to fight these kinds of claims. I think that the



approach that has been taken by the Chicago State University is one that merits our support. They have taken the approach that if they are wrong they will make amends they have said that they are interested in their teaching in achieving excellence they have said that with dealing with their faculty and their staff they are interested in achieving fairness in equality. We all say that we are in favor of equal pay for equal work, this is our chance to demonstrate that that just isn't lip service, that we really mean that when the chips are down we are in favor of equal pay for equal work. These women have been waiting since 1972 and 1973 for justice to be done as you know with spiraling inflation the money that they have been waiting for decreases in value every day that they wait. How long must they wait for this kind of justice how much they wait for their money. I think that equal .pay for equal work, equal justice is what we're talking about here and I ask for your support of this Bill."

Speaker Redmond: "The question is, shall this Bill pass.

The settled Department of Labor has come in and said that, you can't do that there are such things as fair labor standards, there are such things as Federal laws against discrimination and you have got to make amends to these people who are having refused to upgrade them and pay them on a scale equal to the male employee. We are the culprits because we haven't bird dog adequately these agencies. This ah... is an increase in the Local Governments distributive fund in the amount of eight-million dollars ah... this is used to reimburse the local communities ah.... for the... their share of the income tax revenue.

Speaker Chapman: "The Chair recognizes the gentleman from McHenry, Mr. Skinner."

Skinner: "Yes, I wonder if the Sponsor could tell us why



this Bill is necessary."

Shea: "Because the tax collections where larger than the Department had anticipated and in order to refund to the units of local government, their respective shares, we must appropriate it and they have all ready expended almost everything in there and without this additional appropriation no community will get their money."

is a question of priority that we're facing here in the General Assembly. Last year all the municipalities and the counties made up their budgets based on what was in the budget book, I assume. I have to assume that... and yet income tax receipts were under-estimated by approximately 6% and because of that the amount of monies that the cities and counties are supposed to receive ah... was under estimated by 6%. During that same time frame special education got cut 10% from it expected under law, the State Aid Education Formula got cut approximately 10% from what it was entitled to receive under law and the Junior Colleges got slashed by 17 to 20% under what they were promised by State law, now what we're saying here today if this Bill passes, besides the fact that we as Members of. the General Assembly are much more responsive to the Illinois Municipal League and the Illinois Association of County Government ... whatever that's called. Is that we think that.... Municipal and County Government is more important than Education and Community Colleges, at least that's what I will be saying, I'll be saying the reverse of that when I vote 'no' on this Bill."

He did indicate that this was a heavier year than normal because of some Amendments that we passed to the law last year ah ... whereby, we let people use two years... their property tax, their current or latest property tax bill rather than the actual tax bill in this allowed, in some instances, people to file claims for two years in one period of time and it's just this one time that it's a catch up procedure and ' I will be happy to answer any of Mr. Schlickman's

Shea: "No, I know... I ah... can't look in the mind of the Director of the Department and tell you.... or I

can't look in the ah... mind of the Bureau of the Budget and determine why they felt that it was necessary to have a deficiency pro... ah... budget in



this program and not in education. There are other Bills put in to fully fund education in this Session. I supported that position last October when I thought that we were going to have the money ah... I want to look at it again this time and see ah... if we have the money to support those programs ah... what concerns me ah... was when Director Schaeffer and the Bureau of the Budget spoke to the Appropriations Committee yesterday, the fact that in the last nine or ten months we have been expending revenue at the rate of about thirty to forty million dollars a month greater than we'd been taking it in."

Schlickman: "Madam Speaker, may I address myself to the Bill."

Speaker Chapman: "Mr. Schlickman."

Schlickman: "Madam Speaker and Members of the House. detect in the Sponsor of this Bill a lack of enthusiasm for it and I'm sure that that lack of enthusiasm.... however, I can do one thing that he apparently can't do, I can vote against it and that's exactly what I'm going to do and I encourage others to do likewise. It seems to me that if the majority of this House is determined, as it has not, to fully fund certain formula's because to do otherwise would validate the Constitutional requirement that we do balance expenditures and revenue and to be physically responsible, we just can't on a piece meal bases drive ourselves to a state of bankruptcy or to the point where an increase in taxes ah... becomes absolutely necessary and while I sympathize with plightof odds of the person would be the benificary of this Bill, we've got to draw the line. we gotta be consistent, we can't treat anybody ah... differently from how we treat others and it's on that bases ah... that I encourage a 'no' vote on this



proposition."

Speaker Chapman: "The Chair recognizes the gentleman from Kankakee, Representative Beaupre."

Beaupre: "Mr. Speaker and Ladies and Gentlemen of the
House. I lodge the necessity for this supplemental
appropriation is the result of action on part of this
General Assembly. Ah..."

Speaker Chapman: "Excuse me sir, Mr. Shea."

Shea: "Would you get some order in the Chamber, I think that this debate... will be very important to our actions the rest of this fiscal period and how we do it, and I think every Member because of the crisis nature of where we find ourselves in this State is entitled to be heard on this floor."

Speaker Chapman: "Ah... the gentleman request order, will there please be some order in the Chamber please.

Would you proceed Representative Beaupre."

Beaupre: "Mr. Speaker and Ladies and Gentlemen of the

House. By and large the necessity for this supplemental appropriation, arises that the result of the actions taken by this General Assembly in the last year, if you will recall our posture approximately a year ago was that we were in the process of addressing ourselves to giving Senior Citizens further tax relief purportedly as a refund on the sales tax. There was a good deal of controversy over that, there was a good deal of of... publicity in the Press in regard to Senior Citizens and their plight and what the General Assembly was going to do for them. Indeed we did pass those very fine measures to deal with those problems of our Seniors in this State, n addition, there were other measures that were passed by this General Assembly to benefit Senior Citizens, I for example and I think that Rep- . resentative Shea has called your attention to the fact



that instead of using tax bills ah... for the current year.... or instead of waiting for tax bills to come out for the current year in the next year ah... in April that we pass an Amendment to allow Senior Citizens who are about to reach age 65, to use the tax bill for that current year in order to get their tax relief under the circuit breaker program. That being the case, there are a number of Senior Citizens who, attention through publicity and so forth has been called to the opportunity to... to get tax relief through the State. These are programs that we overwhelmingly supported a year ago, we would be reneging on our promise, Mr. Schlickman, when you talk about six-million dollars compared to what we were talking about in regard to the schools, we're talking about a very insufficient amount, I would urge all of you to vote for the Senior Citizens

Speaker Chapman: "The Chair recognizes the gentleman from $$\operatorname{\textsc{DeKalb}}$$, Representative Ebbesen."

Ebbesen: "Ah... would the Sponsor yield."

Speaker Chapman: "He indicate, he will."

and get this Bill passed."

Ebbesen: "Yes ah... Representative Shea ah... since this six-million dollars represents ah... ah... advance payment so to speak because of the fact they could use the ah... latest ah... tax bill they have, can we expect, assuming the same number of people making application for this relief, can we expect a corresponding decrease in the next fiscal year of six-million dollars and this really looks like an advance pay-

Shea: "I don't think this is an advance payment but I think that we can expect that in the next fiscal year that the dollar amount for this grant item will be reduced."

Ebbesen: "Thank you."



ment."

Speaker Chapman: "The Chair ah... recognizes the gentleman from Peoria, Representative Dunn."

Dunn: "Thank you ah... Madam Speaker. I just want to say that this is an important Bill to the people of the State of Illinois this is the Bill ah... this is appropriation for some money to a Bill that we passed. It was vetoed by the Governor, we passed it again and at that time it was signed into law. We passed this Bill to give Senior Citizens an additional tax grant. I would like to call it in my district a sales tax refund to people over 65 and... and then we also, as they said, we moved up the.... so you could use the previous yearstax bill. I think that this is an important Bill to pass, I wish it was a bigger deficiency appropriation which would mean... that more people, more people over 65 who have low income are taking advantage of the Senior Citizens tax relief grant. I find in my district only about one half of the people are taking advantage of the grant and I imagine you'll find that in your's... to put this six-million dollars in so that we can pay off obligations of the State of Illinois that we ah... enact legislation to say that we will give you a tax grant then to come along now and changed our minds would be ah ... I think unthinkable and I certainly urge an 'aye' vote on this. Thank you."

Speaker Chapman: "The Chair recognizes the gentleman from Cook, Representative Lechowicz."

Lechowicz: "Madam Speaker, I move the previous question."

Speaker Chapman: "The previous question has been ah... moved oh... I did it again... ah... all in ah... favor of the ah... question 'aye', opposed 'no' the motion is

carried. Ah... the gentlemen to close."

Shea: "Madam Speaker, Ladies and Gentlemen of the House.



I'm sure that every Member on the floor knows exactly what we're voting on and I would request my colleagues to join me in an 'aye' vote."

Speaker Chapman: "The question is, shall House Bill 3359

pass. All in favor vote 'aye', opposed 'no'. The

gentleman from McHenry, Representative Skinner."

Skinner: "Speaking for myself ah... to the gentleman that

opposed this measure on the floor, keeping Senior
Citizens from getting tax out of their homes is more
important to me than giving cities an extra 8.7 million
dollars that they didn't expect."

Speaker Chapman: "The gentleman from Sangamon, Representative Londrigan.... Have all voted who wished? Have all voted who wished? The Clerk will please take the Record. On this question there are 150 'ayes', 3 'nos' and 4 voting 'present'.

This Bill having received the Constitutional Majority is declared passed. On the Calendar on the Order of Third Reading is House Bill 3360."

Clerk Selcke: "House Bill 3360. An Act to amend an Act
making appropriation to the Illinois Veterans' Commission. Third Reading of the Bill."

Speaker Chapman: "The Chair recognizes the gentleman from Cook, Representative Shea."

Shea: "Madam Speaker and Ladies and Gentlemen of the
House. This increases the appropriation to the
Veterans' Commission for scholarship payment by fourmillion eight-hundred thousand dollars and this is
needed to make and keep the committments to the
Veterans' of this State that were promised scholarship
help and I would appreciate an 'aye' vote on the Bill."

Speaker Chapman: "Any discussion? The gentleman from Cook,

Representative Epton."

Epton: "Madam Speaker and Ladies and Gentlemen of the



House. Ordinarily I wouldn't... I hope that Representative DiPrima will listen to this... Ordinarily I would certainly vote for this Bill but I know how close Representative DiPrima is to the situation and he ah... informed me that it was a bad Bill, now if that's mistake on his part I'll be glad to change my mind. I just don't know why Lawrence DiPrima would accuse Representative Shea of having such a rotten Bill, would you clarify that for me please."

Speaker Chapman: "The ah... lady from Adam, Representative Kent.

Kent: "Thank you. I'm just asking a question... shouldn't this be listed as Illinois Veterans' Department as I understand there is no Illinois Veterans' Commission anymore."

Shea: "I think the appropriation went to the Veterans'

Commission last time and I'll tell you very frankly

ah... I know you're right and I don't know if this

Bill ah... is in that form or not but I think we could

either vote it out now or hold it and correct it here,

it doesn't...."

Kent: "I just wondered if there should be an Amendment to it."

Shea: "If there is I will have it looked after in the $$\operatorname{Senate."}$$

Kent: "Thank you."

Speaker Chapman: "Ah... Representative DiPrima, did I see
your light on, did you wished to recognized sir?"

DiPrima: "I don't know what Bernie said but, ah... you know
ah... its for the Veterans', I'm for it period, Bernie."

I think that Jerry is going to run for counselor at large or something and he wanted to handle a Veterans'

Bill so..."

Speaker Chapman: "The ah... gentleman from Cook, Mr. Walsh."



Walsh: "Mr. Speaker and Ladies and Gentlemen of the House. This deficiency... Madam Speaker, I beg your pardon. This deficiency appropriation increases the total appropriation for this purpose by about 50%... it's an appropriation for scholarships for Veterans' that is based only on the fact that they have been Veterans' and not on the fact that they need a scholarship in order to attend college. Now, I suggest to you in these times of fiscal strife that we ought to start cutting somewhere and this would be a perfect place to start. These people who can not attend college who are Veterans' because of a financial need can go to the Scholarship Commission, those who do not have financial need should, like everyone else, pay for their college education, so I urge a 'no' vote."

Speaker Chapman: "The gentleman from Cook, Representative Madison."

Madison: "Thank you Madam Speaker, would the Sponsor yield for question?"

Speaker Chapman: "He indicates, he will."

Madison: "Representative Shea, I seem to recall in the last years Session ah... a Bill and I assume it's this Bill, that would transfer funds from the Illinois State Scholarship Commission and set them up within the Veterans' Commission, is this that money."

Shea: "Yes sir."

Madison: "Ah... now we just had a Bill that Representative

Madigan introduced that would increase the Illinois

State Scholarship Commission ah... appropriation by

some three-million dollars, I think it was and this

is an additional four... have we had that many request

for these many scholarships?"

Shea: "Absolutely sir, and as you know what's happen... is because of the down turn in the economy in this State



many young men and women, boys and girls that formally whose parents where in a position probably to give them some financial aid found themselves in a position where they couldn't get that kind of help from home and that they have now been found eligible under the guide lines of the Scholarship Commission to receive financial assistance."

Madison: "Is the situation such that... persons who are veterans' are precluded from receiving scholarship; aid from ISSC, because of this program?"

Shea: "I can't answer that, sir."

Madison: "Is there anybody here that can answer? Is Representative Houlihan on the floor? I mean former Representative Houlihan... I don't mean.... I mean the head of the Vet... not a prediction dear... the point that I'm getting at Representative Shea is that it appears to me that individuals who... who need scholarships, who are not Veterans' are precluded from receiving these funds and yet individuals who are Veterans' have the option of going either to the Veterans' Commission or to the Illinois State Scholarship Commission and I... there is something fragrantly wrong with that system and I'm wondering what we can do to correct it."

Shea: "We would have to correct the appropriate legislative changes or to make legislative changes. As I understand your question is, that a young man or women who's not a Veteran would be required to go to the Scholarship Commission and a young man or women who is a Veteran would take their choice of which one they wanted to go to."

Madison: "As a matter of fact if they went to the Illinois

State Scholarship Commission and were turned down they .

could very well go to the Veterans' Commission and



receive the same scholarship."

Shea: "Probably do a little bit better."

Madison: "Absolutely and I still say that there is something flagrantly about that situation, it ought to be corrected and this would be a perfect vehicle to correct it, Mr. ah... Shea."

Shea: "Well, I think all that it would do is if we fail
to pass this money as it... those people that were
granted scholarship would have their scholarship reduced on a prorata dollar per dollar amount."

Madison: "That is exactly what's happening with the Scholarship Commission now, as a matter of fact ah... if
Representative Madigan's Bill had not passed, individuals
were going to receive a reduction and they had already
been sent out, people had been notified. Has the same
notification sent to Veterans' under this program?"

Shea: "I don't know sir."

Madison: "Thank you, very much."

Speaker Chapman: "The gentleman from DuPage, Representative Hoffman."

Hoffman: "Mr. Speaker, Ladies and Gentlemen of the House.

I think that the questions that have been raised ah...
ought to put questions in ah... a number of peoples
mind. One, if there is a need, they can go to the
Scholarship Commission now and age is not a factor.

I might also point out that Veterans' qualify for the
G.I. Bill... a Veteran can get the G.I. Bill and also
go to the Illinois Veterans' Commission and get his
twition paid so that none of the resources that he has
received from the Federal Government ah... are used
ah... to pay tuition and then in fact the Veterans'
Scholarship becomes a tuition waver. Seems to me
that this is unfair to those for whatever the reason
ah... haven't been in the service also the G.I. Bill



in the Armed Forces is a national responsibility and not one that we can take on as a citizen of the State of Illinois. And, therefore, it seems to me... reasonable that if this amounts to a reduction of prorata reduction in what their ah... scholarships support would be, it would be very easy for them worke this difference up out of the G.I. Bill money which they are now not using at all for tuition purposes and, therefore, I would ah... urge ah... a negative response to this Bill."

Speaker Chapman: "The gentleman from Kane, Representative Grotberg."

Grotberg: "Thank you... Madam Speaker, Ladies and Gentlemen of the House. I would like to address the Bill for just a brief moment and ah... Mr. DiPrima and Mr. Houlihan if you're listening I'm sure that you would concur with me that nobody joined the service for the fringe benefits. So, Tthat I would assume that the Memberships of all the ah... exmilitary personnel in the State of Illinois would have some understanding about the finances of the State of Illinois and for that reason alone they will be understanding of an instance that I heard of this morning.... I had no position one way or another on this Bill until I found out that a gentleman of a fellow legislators constituency who earn some twenty-thousand dollars a year ah ... on a regular job and he has ah ... several benefits coming from his Veterans' relationship... enrolled in a local college in a lightweight course and his whole obligation go to the library and read a couple of newspapers every day and write a monthly report for which the taxpayers of Illinois get nicked some four-hundred and forty dollars. And, ah... it



would be because that effort... not the legitimate need that I would hold abeyance my vote on this subject matter and I think if we have a deadline on the 19th of April for substantive legislation, Mr. Shea, Mr. DiPrima and everybody... I just wonder... if there is a State crisis it would be in some of the more liberal aspects of the Veterans' Scholarship fund, I would be glad to Co-Sponsor and go to work on that as fast as we could and get this geared down to where it can be within real terms of the need ah... rather than the availibility of the fringe and I'm therefore going to vote 'no' on this issue."

Speaker Chapman: The gentleman from Lake, Representative Greisheimer."

Greisheimer: "Thank you, Madam Speaker will the Sponsor yield?"

Speaker Chapman: "He indicates, he will."

Greisheimer: "Will the Sponsor standup... Would you...

would you indicate, Mr. Shea whether this Bill ah... covers the appropriation that we made ah... last term or at the beginning of this term for ah... scholarships for the National Guard."

Shea: "No..."

Greisheimer: "That's it, thank you."

Speaker Chapman: "The gentleman from Cook, Representative Miller."

Miller: "Thank you, Mr. Speaker will the ah... Sponsor yield?"

Speaker Chapman: "He indicates, he will."

Miller: "What amount did we appropriate at the beginning of this fiscal year for scholarship for Veterans' in this fund?"

Miller: "Yes."



Shea: "About seven-million."

Miller: "And this would call then for about a 65% increase. If we do not approve this Bill will everybody ah... will all the Veterans' a prorata, or will
they all be cut back at a prorata bases."

Shea: "It is my understanding that they would be."

Miller: "Well, I think that would be fair on the part of the Illinois General Assembly, Mr. Speaker and Members of the House for us to vote 'no' on this Bill. I don't think that we are over looking the needs of ah... those Veterans' who qualify for this help ah... we are cutting them back but we're finding we're cutting back many other areas in State Government that I don't think that it is hurting the Veterans' by doing it in this case too."

Speaker Chapman: "The lady from St. Clair, Representative Stiehl."

Stiehl: "Thank you, Madam Chairman would the Sponsor yield a for a question?"

Speaker Chapman: "He indicates, he will."

Shea: "Yes."

Stiehl: "Representative Shea, if this supplemental deficiency...

has this money already been spent. The tuition wavers

have all ready been granted by the Junior Community

Colleges."

Shea: "It is my understanding that it has and I would imagine what would happen, would be these people would be called on to make the payments themselves now."

Stiehl: "So then, in other words this reimbursement would go to the Community Colleges and the Universities."

Shea: "I can't answer that question. I can find out for you in about one second, I have the Director on the phone."

Stiehl: "Thank you."



Speaker Chapman: "The gentleman from Cook, Representative Duff."

Duff: "Ah... Mr. Speaker ah... Madam Speaker ah... the

Speaker Chapman: "Ah... the gentleman has moved the previous question. All in favor say 'aye', opposed 'no' the motion ah... carries does the gentleman desire to close?"

Shea: "Madam Speaker, Ladies and Gentlemen of the House.

We have made the commitment to the people that we've given these scholarships to ah... if we want to say; that we can not continue with the program I think the appropriate place and time to do it would be in the next Session when this Bill came up... take the money out if you don't think it belongs there but let us keep our commitment to those people that we have all ready given it to. Please vote 'aye'."

Speaker Chapman: "The question is, shall House Bill 3360 pass, all in favor vote 'aye' opposed 'no'. The Chair recognizes the gentleman from Cook, Palmer to explain his vote."

Palmer: "Maybe the Sponsor can... and the explanation of his vote ah... state ah... the ah... or reconcile the ah... Bill itself being 3360 in the Bill Book and saying it is a grant for the Senior Citizens Disabled Property Tax Relief Act and the ah... ah... reconcile that with the:.. todays Calendar which indicates that it is an appropriation of the Illinois Veterans' Commission. Speaker Chapman: "Representative Shea."

Shea: "Perhaps I missed spoke but I handle the other Bill

Speaker Chapman: "Ah... may I remind the Members that if

Speaker Chapman: "Thank you, sir. Ah... Representative ah... the gentleman from Marion, Representative Friedrich."

Friedrich: "I wanted to ask the Sponsor a question rather than precluded from it, I just wanted ah... really wanted to know and I hope that he would explain these votes. Are we tied into this program for ever or is there a cut-off date or is there a service date in which were ah... obligated and so on, that's all I wanted to know and it would help if he would explain."

Shea: "As I explained and from the discussion that our former colleague, John Houlihan who now has this Department stated that the commitment to these Veterans' was made at the beginning of the school year in September and in January. Speaker Chapman: "Well, I... I understand that that is the rule sir."

Madison: "All right, does that rule apply when ah... during the time of debate you only ask a question of the Sponsor and then not speak to the Bill?"

Speaker Chapman: "Ah... my understanding of the rule... Mr.

Parliamentarian are you listening. My understanding

of the rule is that if you spoke during debate you

are... are not given an opportunity to explain your

vote unless you are the Sponsor and I so rule."

Madison: "Madam Speaker, I raised questions during the debate, I did not speak to the Bill. My question is does it apply when you did not speak to the Bill."

Speaker Chapman: "Ah... my understanding is that it does and that is my ruling. Have all voted who wished?

Okay, Representative Beatty."

Beatty: "Madam Speaker, Ladies and Gentlemen of the House.

- Walsh: "Ah... Madam Speaker, I refer you and the Parliamentarian to Article IV, Section 8 (b)... (d) rather, A
 Bill shall be read by title on three different days
 in each House, a Bill on each Amendment thereto shall
 be produced and placed on the desk of each Member
 before final passage. I suggest to you that this
 was not complied with."
- Speaker Chapman: "Ah... the... the remedy of... Representative Walsh ah... would be to file the motion to reconsider if ah... you voted on the prevailing side or if there is some Member...."
- Walsh: "Oh, I didn't vote on the prevailing side obviously.

 That shouldn't be the remedy, Madam Speaker we were considering a different Bill."
- Speaker Chapman: "The ah... objection is not timely, Mr. Walsh."
- Walsh: "There's a Constitutional defect, Madam Speaker in the passage of that Bill. It can not have passed.

 Talk to Jerry... you're talking to the Sponsor,

 Parliamentarian..."
- Walsh: "Madam Speaker will you notify the permanent Speaker as to this defect so as to prevent his signature on that Bill."
- Speaker Chapman: "Ah... I'm sure that... that it is in the

 Record and the Speaker will be ah... aware of this,

 sir. On the Order of Third Reading appears House

 Bill 3364."
- Clerk O'Brien: "House Bill 3364. A Bill for an Act making
 a supplemental appropriation to the State Board of
 Education. Third Reading of the Bill."



Speaker Chapman: "The Chair recognizes the gentleman from

Cook, Representative Shea."

Shea: "Madam Speaker and Ladies and Gentlemen of the House.

This is an appropriation of a hundred thousand dollars to the State Board of Education ah... for the purpose of purchasing books for the blind, braille books. The reason for it there was a lady that testified, a Mrs. Richmond, that unless this money is appropriated that and the books produced and they go to the method of producing them now that there will be... the blind children will not have the books when they return to school in September. So I would ask for a favorable

Speaker Chapman: "The Chair recognizes the gentleman from Madison, Representative Byers."

Byers: "Ah..."

vote."

Speaker Chapman: "Representative Bvers."

Byers: "Madam Chairman, will the Sponsor yield please."

Speaker Chapman: "He indicates he will."

Byers: "Ah... Representative Shea, can you tell us how this

Bill came to be introduced? '

Shea: "I introduced it, on the request of Mrs. Richmond."

Byers: "I was wondering where you see her."

Shea: "Where did I see her..."

Byers: "Yes."

Shea: "I met her in her husbands law office."

Byers: "Okay. Ah... Representative Shea, how much money
is left in this fund and how much did we appropriate

last year."

Shea: "I understand that the fund is almost exhausted and

I believe we appropriated two-hundred thousand dollars."

Byers: "Isn't there ah... about sixty-five thousand dollars

left in that fund according to the reports from the

Appropriation Committee Staff."



Shea: "There's that much on expended but it's incumbered."

Byers: "And doesn't it take awhile to spend that money...

won't it be next to impossible to get that hundred thousand dollars spent before June 30."

Shea: "I don't know if the funds can be spent before June 30, but they can't be incumbered and spent in the last period unless they are available."

Byers: "And how many books do we have for the blind people in the State of Illinois, now... in dollar value."

Shea: "I would assume that we've got about three and a half million dollars worth, but for those students that are going to be going into the school in the fall need additional books and need additional material.

Now, you and I are very fortunate, we have our sight but there are some within the State that are less fortunate than we and I think that we should appropriate this money... that's why I'm sponsoring the Bill."

Byers: "Thank you, Representative Shea. Ah... I would like to speak against this Bill, we ah..."

Speaker Chapman: "Proceed."

on this Bill."

Byers: "We do have money appropriated, we have appropriated two-hundred thousand dollars in the last few years and I think the Sponsor of the Bill indicated that ah... he did meet this lady in her husbands law office and was more or less accommodating ah... for extra money..

We will be appropriating more money for this come July 1, and it would appear to me that this is a hundred thousand dollars that we can save and ah... do not need to spend. So, I would recommend a 'no' vote

Speaker Chapman: "The Chair recognizes the gentleman from DePage, Representative Hoffman."

Hoffman: "Will the Sponsor yield for a question?"

Speaker Chapman: "He indicates, he will."



Hoffman: "Am I to understand this was not introduced at the request of the Illinois Office of Education."

Shea: "No sir, that is in the thirty-three and a half million dollar Bill that Representative Hanahan has introduced, but because of the special nature of this problem, Mrs. Richmond and another member of the Board got a hold of me and I introduced the Bill.

Mrs. Richmond, at her own expense flew to Springfield and testified before the Appropriations Committee and explained the need, she has spent, so that Representative Byers understands this... she has spent some 14 or 15 years doing charity work with blind students."

Hoffman: "All right, now you said that she is a member of a ah... the Board, what..."

Shea: "She's a member of... as I understand it Gene, and I can not give you the exact name... but there are a group of people that do charity work with the blind students."

Hoffman: "Okay... okay then she..."

Shea: "She is not officially connected with any Department of State Government."

Hoffman: "Okay, she not a member of the State Board of Education."

Shea: "No sir."

Hoffman: "There will be no confussion about.... about..."

Shea: "No sir."

Hoffman: "About that and this is a personal request ah...
from her and her group, I assume."

Shea: "It was a request.... I would like to give you a little background that this hundred thousand dollars was in the Bill that was line item vetoed and reduced in the last Session. These people came to me with this particular problem and I agreed to help them, this isn't a hundred thousand dollar figure that I pulled out of



the air, this was in the original appropriation Bill that had been reduced in the last Session."

Shea: "It is my understanding that it is, sir. It's the figure that's right out of 3315."

Hoffman: "Fine, thank you very much."

Speaker Chapman: "The Chair recognizes the gentleman from Winnebago, Representative Stubblefield."

Stubblefield: "Will the Sponsor yield for a question?"

Speaker Chapman: "He indicates, he will."

Stubblefield: "Representative Shea, I have a communication ah... that indicated there were some duplication between ah... this Bill 3364 and a line item of House Bill 3315 now if this Bill is passed will there be some adjustment in the ah... Bill, House Bill 3315 or are we by-passing both of these then duplicating one item. Could you address that point, please."

Shea: "Yes sir, my commitment to the people on the Appropriations Committee is, if this Bill passed the House I would make the appropriate amendment to House Bill 3315 to remove that and Representative Hanahan is holding that Bill on Second Reading."

Stubblefield: "Thank you."

Speaker Chapman: "Is there further discussion? Ah... does the gentleman desire to close?"

Shea: "I think everybody knows what's in the Bill."

Speaker Chapman: "The question is, shall House Bill 3364

pass. All in favor vote 'aye', opposed 'no'. May I

ah... remind Zeke... oh, point of order Representative

Byers, would you proceed."

Byers: "Ah... Madam Chairman, I see people pushing other peoples buttons and I'm going to have to verify the Roll Call."



Speaker Chapman: "Ah... may I... I ah... request that you not press the buttons of another Member, please...

The explaination of votes, have all voted who wished?

Have all voted who wished? Ah... were you requesting recognition Representative Geo-Karis, the lady from Lake."

Geo-Karis: "Ah... Mrs. ah... Madam Speaker and Ladies and
Gentlemen of the House. The Majority Leader made
his word commitment that the hundred thousand dollar
item would be removed from the other Bill, I certainly
think that when people are blind they do need some
help, far more help than we have... maybe we need
more and I would urge a favorable vote."

Speaker Chapman: "Have all voted who wished? Have all voted who wished? Have all voted who wished? The Clerk will please take the Record... Ah... we have a request for a verification, will the Clerk proceed to call the affirmative vote... Oh, Mr. Shea, does the Sponsor request a poll of the absentees?"

Shea: "Might I please, I'm sorry to take up the time of the House and I appreciate it."

Speaker Chapman: "Will the Clerk proceed to poll the absentees.

Ah... as soon as the Roll Call out of the machine."

Clerk O'Brien: "Anderson, Campbell, Carroll, DiPrima,

Duff, Friedrich..."

Speaker Chapman: "Ah... Friedrich, 'aye'."

Clerk O'Brien: "Giglio, Hill, Hirschfeld, J.M. Houlihan,

Kane, LaFleur, Madison, McAuliffe, Meyer, Nardulli,

Peters, Pierce, Rose, Schneider, Schoeberlein..."

Speaker Chapman: "Representative Garmisa, votes 'aye'."

Clerk O'Brien: "Sevcik, Simms, Stearney, Tipsword, VanDuyne,

White, Younge, Mr. Speaker."

Speaker Chapman: "Ah... Representative Pierce."

Pierce: "Ah... Madam Speaker, you called me on the absentees



which was correct but now I'm here and want to vote

Speaker Chapman: "Representative Pierce is voting 'aye'.

Ah... Representative Giglio."

Giglio: "How am I recorded Madam Speaker?"

Speaker Chapman: "How is Representative Giglio recorded, please."

Clerk O'Brien: "The gentleman is recorded as 'no' voting."

Giglio: "Will you please vote me 'aye'."

Speaker Chapman: "Representative Giglio votes 'aye'. Rep-

resentative Kane."

Kane: "How am I recorded?"

Clerk O'Brien: "The gentleman is recorded as not voting."

Kane: "Vote me 'aye' please."

Spekaer Chapman: "Ah... Does... does the gentleman ah...

continue with his request for verification? Do you pursue your request. Representative Hill."

Hill: "I would appreciate being recorded 'aye'."

Speaker Chapman: "Ah... 'aye', Representative Brinkmeier."

Brinkmeier: "Please record me as voting 'aye', please."

Speaker Chapman: "Brinkmeier, 'aye'. Duff... Representative

Duff, votes 'aye'. Representative Arnell, 'aye'.

Ah... Mr. Clerk, how many 'ayes' votes are Recorded?"

Clerk O'Brien: "Ah... 122 'ayes'."

Speaker Chapman: "122 'ayes'. The gentleman withdraws his request for a verification. On this question... Mr.

Clerk do you have the final tally? On this question there are 122 'ayes', 21 'nays' and 11 voting 'present',

Clerk O'Brien: "House Bill 3365, A Bill for an Act to amend an Act to provide for the ordinary and contingent expenses of the Department of Public Health. Third Reading of

the Bill."



Speaker Chapman: "The gentleman from Cook, Mr. Shea."

Shea: "Madam Speaker, Representative Kempiners has asked me some questions about this Bill and I'm wondering if he answers from the Department. This increases ah... the amount of grant money to the Department for various programs, particularly the maternal and child health fund and I would appreciate an 'aye' vote."

Speaker Chapman: "The gentleman from Cook, Representative Schlickman."

Schlickman: "Would the Sponsor yield for one question?"

Shea: "Just one Gene."

Schlickman: "Yap."

Shea: "Okay."

Schlickman: "I think it's a good one too. Do I understand that there is no appropriation from the General Revenue Fund in this Bill... in other words we're talking about an appropriation of Federal Funds and a transfer of General Revenue Funds."

Shea: "I... I believe that's what we're doing but I want to check and make sure. My colleague Mr. Ryan tells me that's what we're doing."

Schlickman: "Thank you."

Shea: "No G.I. Reps."

Speaker Chapman: "There being no further discussion, does the gentleman desire to close. The question is, shall House Bill 3365 pass. All in favor please vote 'aye', opposing 'nay'. Have all voted who wished? Have all voted who wished? Have all voted who wished? The Clerk will please take the Record. On this question there are 128 'ayes', 13 'nays' and 3 voting 'present'. This Bill having received the Constitutional Majority is declared passed. Senate Bills, First Reading."

Clerk O'Brien: "Senate Bill 1542, Kane. A Bill for an Act.

to amend Sections 3 of an Act to provide for the ordinary and contingent expenses of the Office of the



State Treasurer. First Reading of the Bill."

Speaker Chapman: "On the order of motion, the gentleman from Sangamon, Representative Kane."

Kane: "Mr. Speaker, Ladies and Gentlemen of the House.

Senate Bill 1542 is a supplemental appropriation of one-million dollars to the State Treasurer to increase refunds under the State Inheritance Tax Act. What the refunds are for is ah... the States file deposits with the State ah... and then when the tax liability is ah... determined if there... if the deposit is greater than the tax liability the amount is refunded and that amount of money has to be refunded subject to appropriation to the... by the State Treasurer. At present the appropriation is two-million dollars ah... one-million nine-hundred thousand odd has been already put out. Speaker Chapman: "The gentleman moves.... ah... he asks for unanimous consent to take up the motion to advance

Senate Bill 1542 to the Order of Second Reading without reference to Committee. Is there leave? There is an objection sir... Ah... the... the gentleman ah... has the opportunity to file a motion ah... when the motion is on the Calendar on Monday we could proceed,

Mr. Kane."

Kane: "Madam Speaker, I will withdraw the question at this



time and file a written motion to advance to Second without reference."

Speaker Chapman: "And thank you for calling me Madam Speaker."

Speaker Chapman: "On the Order of motions ah... Mr. Von-

Boeckman did you desire to proceed? Out of the Record. On the Order of Resolutions appears ah... S.J.R.

69... 68, I beg your pardon. Does Representative

Shea desire to proceed? Mike please for Mr. Shea."

Shea: "Madam Speaker and Ladies and Gentlemen of the House.

This is a Amendment to the temporary Joint Rules that

would provide cut-off dates for ... ah ... the introduction of Bills and getting Bills out of the House in the last days for hearings and I have had a request from the Republican side of the aisle, the Assistant Minority Leader that he wants more time to look at it so that ah... bearing in mind that this was an agreement as I understand it that he helped draft, I have no objections of taking it out of the Record and calling it on Monday but I would ask that my colleagues take a look at it because it setup some stringent dates for moving Bills along and as I remember it, all the Bills will have to be heard in Committee by the 14th of May, that they would have to be considered by the 28th day of May in their House of origin and that they would have to be out of the Second House sometime late or mid June. So, I will not call that today but I will call it on Monday and I would like all Members to have an opportunity to look it over and be cognizant into the fact that it will be called on Monday."

Speaker Chapman: "The gentleman from Lake, Representative Matijevich."

Matijevich: "Mr. Speaker, as long as the Majority Leader...."

Speaker Chapman: "The gentleman is out of order."

Matijevich: "Okay, we know that ah... but..."

Giorgi: "Madam Speaker, House Resolution 701 marks the 75th

702 honors Father Dunn who became a Monsignor. House
Resolution 705 honors Ulys Cowsert of Rosiclare upon
the occasion of their 50th wedding anniversary. House
