Mr. Speaker, in requesting a Fiscal Note on 437, I'm going to rely upon the conclusion of the Legislative Reference Bureau which indicates on page 592 of the Digest, dated April 25, 1975. Speaker Redmond: "Does he have leave... The Bill is tabled. Representative Griesheimer."

Griesheimer: "Mr. Speaker, I'm just inquiring, I noticed we just finished House Bill 1090 on Third Reading. According to the priority Calendar that ah... about ah... 2/3 of the way down the priority Calendar, I wondered what happen to all the Bills on Third Reading prior to House Bill 1090."

Speaker Redmond: "The gentleman ask leave and he was granted leave by the House. It was an urgency on this one. Representative Porter... Porter."

Porter: "Ah... Mr. Speaker, I ask leave of the House to table the following Bills; 1726, 1962, 1701 and 1702. I am the chief sponsor of those Bills."

Speaker Redmond: "Leave, any objections... Leave.... House Bill 1726, 1962, 1701 and 1702 are tabled. Representative Schneider."

Schneider: "Mr. Speaker, I guess I have to make a motion ah... Bill 1098 was ah... assigned to Education Committee and it appropriately belongs in Municipalities, we re-referred it by message to the floor and then it never made it to the ah... proper Committee. So, Representative Shea has assigned 1098 to appropriate Committee and I would like to wave the rule to have heard at the ah... in which every Committee he placed it. And, also 1505 was inadvertently left off our Calendar, so if I could have leave of the House to

post 1098 and 1505, I would ask that."

Speaker Redmond: "Representative Shea."

- Shea: "Mr. Speaker, with regards to 1098, they want to.... they want to hear this Bill in Elementary and Secondary and decided that it more properly should have been in Cities and Villages, but it never got transfered so I think the gentleman.... I'd support the gentleman's motion to hear the Bill."
- Schneider: "House Bill including 1505 was just left off the Calendar and I would like to have leave of the Members to post that for today also."
- Speaker Redmond: "The gentleman has asked leave to post, two Bills mentioned... the motion is for the suspendion of the rules, all in favor vote 'aye', opposed vote 'no'. Have all voted who wished. Take the record. On this question 115 'aye', 1 'no'. The rules are suspended."

Speaker Redmond: "Representative McLendon."

McLendon: "Mr. Speaker, Ladies and Gentlemen of the House. I'm asking leave to hear House Bill 2582 and Pensions and Personel Committee. This ah... Bill was originally assigned to Higher Education Committee and was re-assigned to Pens... ah... Personel and Pension, it was not posted... Representative Hirschfeld is the sponsor of the Bill."

Speaker Redmond: "Gentleman has asked leave to hear House Bill 2582 in ah... Personel ..."

McLendon: "Personel and Pension, tomorrow morning at 9:30." Speaker Redmond: "Any objections. You have to suspend the rules on

that, the motion is to suspension of the rules to permit House Bill 2582 to be heard tomorrow morning in Personel and Pensions Committee. All in favor vote 'aye', opposed vote 'no'. It takes 107 votes. Representative Calvo, for what purpose do you arise."

Calvo: "Well, after we're finished with this matter I would like to be recognized to table a Bill, Mr. Speaker, it probably wouldn't be too big of a problem."

Speaker Redmond: "Have all voted who wished, we need 107 votes. The gentleman needs a 107 votes. Have all voted who wished. Take the

record. On this question there is 120 'yes', no 'nay', the motion carries and the rules are suspended. Caldwell, 'aye'.... Lechowicz Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I would like leave of the House to suspend the Appropriate Rules to hear House Bill of the following numbers; House Bill 236, 237, 338, 414, 1503. These Bills are posted in your Appropriations Committee, they are substantive Commission Bills and in turn they were assigned to a Sub-Committee. The Sub-Committee ah... Chairman I haven't seen for the past couple of days, so... and because they are governed by the May 2nd deadline, I'm asking that we have the proper number of votes to suspend the rules and have these Bills

re-posted for Appropriation Committee Number 1, meeting tomorrow." Speaker Redmond: "Representative Totten."

Totten: "Representative Lechowicz, I wonder if you would read those numbers again."

Lechowicz: "236, 237, 338, 414, 1503."

Totten: "Ah... 2119 is a substantive Commission Bill, that it one..." Lechowicz: "Well amended, 2119."

Speaker Redmond: "Ready for the question. The question is, on the suspension of the rules to permit House Bill 236, 237, 338, 415,

1503, 2119 to be heard in the Appropriations.... Committee, to-

morrow. All those in favor vote 'aye', opposed vote 'no'." Speaker Redmond: "Representative Houlihan... Representative Peters." Peters: "Ah... if I might ask, Representative Lechowicz a question.

Representative Lechowicz, did I hear 2119..."

Lechowicz: "Yes."

Peters: "For suspension of the rules."

Lechowicz: "Yes, at the request of Representative Totten, that's his Bill, I believe."

Peters: "It's 2119, the Bill that abolishes all Commission." Lechowicz: "I ah... believe it is."

Speaker Redmond: "Representative Yourell."

Yourell: "As a chief sponsor of House Bill 1413 and 1425, I ask leave to table these two Bills."

Speaker Redmond: "Any objections. Leave. Have all voted who wished on the motion on 23... Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker. I think if you'd check the ah... posting, 2119 is already posted Don, for Wednesday at 2 o'clock, so it doesn't have to be included in this suspension. I'll take out 2119 on the suspendion of rules."

Speaker Redmond: "2119 is taken out of the motion. Have all voted who wished. Clerk, take the record. On this question the 'ayes' have 116, 'nos' 1. The motion is carried. Mann, 'aye'. Representative Caldwell."

Caldwell: "Ah... Thank you, Mr. Speaker. Mr. Speaker, I have ah... House Resolution 228 ah... at the Speaker's desk, I talked with ah... the Leadership on both sides of the aisle, I think that this subject matter is ah... sufficient import, that I'm asking..." Speaker Redmond: "Would you hold that for a moment, Representative

Caldwell until he reads it. Representative Barnes."

Barnes: "Thank you, very much Mr. Speaker. Ah... Mr. Speaker, Members of the House. Ah... being the chief sponsor of House Bill 2321 I

would ask leave of the House to table ah... House Bill 2321." Speaker Redmond: "Any objections. Leave granted, the Bill is tabled.

Representative Calvo."

Calvo: "Mr. Speaker, being the chief sponsor of House Bill 1530, I would ask leave of the House to table that Bill."

Speaker Redmond: "Leave granted? Leave. Representative Madigan.... Madigan."

Madigan: "Agreed Resolutions."

Speaker Redmond: "Not quite yet, Representative Houlihan."

Houlihan: "Thank you, Mr. Speaker. As principal sponsor of House Bill

2330, I ask leave to table the Bill."

Speaker Redmond: "Leave."

Speaker Redmond: "Representative Deavers."

Deavers: "Mr. Speaker, as principal sponsor of House Bill 2201, I

would like leave of the House to table."

Speaker Redmond: "Any objections. Leave, granted. Representative Daniels. What was that number again, Representative Deavers."

Deavers: "2201."

Speaker Redmond: "Representative Daniels."

Daniels: "Mr. Speaker, as chief sponsor of House Bill 1511, I ask leave to table that Bill."

Speaker Redmond: "Any objections. Leave. Representative Houlihan, Dan Dan Houlihan... Representative Katz."

Katz: "Ah... two things. Mr. Speaker, as the chief sponsors... sponsor of House Bill 1869 and 1873, I would like leave to table those Bills, please."

Speaker Redmond: "Any objections. Leave. Representative Daniels, do
you desire recognition."

Daniels: "Yes, Mr. Speaker...."

Speaker Redmond: "Daniels."

Daniels: "House Resolution 186, I'm the only listed sponsor on that,

I have checked to see who might be the sponsor on that Resolution, and I would ask leave to have that Resolution tabled. House Resolution 186..."

Speaker Redmond: "Any objection."

Daniels: "Also, Mr. Speaker to show that I was not to have been the sponsor on that Resolution."

Speaker Redmond: "Any objection. Resolution tabled. Representative Katz."

Katz: "Ah... Mr. Speaker, there is another Bill, I'm sorry sir that it wasn't brought to my attention, but I would also like leave to table House Bill 799 of which I'm the principal sponsor." Speaker Redmond: "Any further announcements. Representative Katz."

Katz: "Ah... Mr. Speaker, Ladies and Gentlemen of the House. Judiciary II, will be sitting all afternoon and this evening hearing Bills that have been scheduled for Judiciary II. We expect sponsors to come around and have their Bills called, because time is getting very short and if they are very seriously interested ah... in advancing their Bills or having them considered, we would like very much for them to come to Room 114, this afternoon or tonight." Speaker Redmond: "Resolutions.... Representative Madi.... or ah... House Bill 799, Representative Katz's asked leave to table that Bill,



the Journal will so show. Represen.... 799... Representative Madigan."

O'Brien: "House Resolution 226, Capparelli."

Capparelli: "House Resolution 226, commends Mr. Henry Wlodyga upon being named the Governor of the Portage Park Moose Lodge No. 220 in

Chicago. I move the adoption of House Resolution 226." Speaker Redmond: "The gentleman has moved the adoption of House Res-

olution 226. All in favor say 'aye', opposed 'no'. The 'ayes' have it, the Reolution is adopted. Further Resolutions."

O'Brien: "House Resolution 227, Mann. House Resolution 229, Holewin-

ski. House Resolution 230, Kelly."

Speaker Redmond: "Representative Caldwell on 228."

Caldwell: "Ah... Mr. Speaker, Ladies and Gentlemen of the House. Ah... House Resolution 228 is a Resolution requesting the Legislative ah... Investigating Committee to immediately investigate the situation that occured at Pontiac ah... Correction Center, recentenly ah... where one member ah... was killed and ah... I guess certain ah... the riot was set down but ah... I think that the Legislative investigating Committee Commission ought to look into this matter immediately. I believe that it's of sufficient import to ah... for the House to allow me to by-pass Committee and the Resolution ah... heard and passed immediately. I would appreciate if ah... if we'll do that."

Resolution 228, by-pass Committee and go to the order of Second Reading without reference to Committee. Any discussion....The gentleman.... pardon me, the gentleman has moved that... that ah... House Resolution 228 be adopted immediately. How many... it takes 107 votes. All those in favor vote 'aye', opposed vote 'no'. Representative Walsh."

Walsh: "Mr. Speaker and Ladies and Gentlemen of the House. The gentleman asked that the rules be suspended for the immediately consideration and adoption of this House Resolution, and I think the gentleman is absolutely right in doing so. This is a Resolution that calls for the Legislative Investigating Commission to investigate the unfortunate death of Herbert Catlett at Joliet State Peni-

32.

tentiary last week during the riot. Herbert Catlett, was a young man of 29 years old, who was a prisoner, had been a street gang member and was showing excellent signs of being on the road to recovery. He died, it seems to me, because there was someone who wasn't doing their job, or maybe a group of people who won't be doing their job and I'm afraid that if we don't take some action ... some action like asking the Illinois Lesiglative Investigating Committee Commission to look into his death, then his death will be forgotten and he too will be forgotten. I suggest to you that the care of prisoners is our direct responsibility, no one elses. We are the ones who ought to look into whether this ah... what happen to this gentleman and I urge you to vote 'yes' on the motion, I'm not one generally for suspending the rules, but in this case the Legislative Investigating Commission, if we order them to do this, is going to have to act fast. They are going to act before many of the people involved in that Riot, are transferred, before some of the people are guards and other prison officials retire or also transfered. I suggest to you that a 'yes' is the only vote that you can give on this matter in good conscious."

Speaker Redmond: "Representative Simms."

Simms: "Well, Mr.... Mr. Speaker ah... I would rise in support to this motion also. I think it's of ah... proper import that the Legislative Investigating Commission do look into this type of situation. Ah.... this is in accordance with a House Bill, which we passed in the last couple of weeks that limits investigations to areas of ah... whether there's been a crime committed or something of criminal nature. I agree with the distinguished Assistant Minority Leader, that in this type of case it's expeditious that the Commission do go in on investigation as soon as possible ah.... while there are still people that are available that ah... will communicate as to what happen in that circumstances and before prison personnel have been transfered. There was a young man's life that was losted.... I commend Representative Caldwell for his action... ah... prompt action in this case and as a Member of the Legislative Investigating Commission, I would certainly feel this is of proper magnitude for

our Commission to undertake this investigation. For these reasons I would urge a 'yes' vote."

Speaker Redmond: "Representative Borchers."

Borchers: "Mr. Speaker and fellow Members of the House. I want to point out that this young man died trying to stop that riot and if we owe

any ah.... ah... life ah... and his brave action, we owe him at least a courtesy of investigating and trying to find out the truth. We owe this to him, so let's see those other three votes go up there." Speaker Redmond: "Have all voted that wished. Take the record. This

question there is 114 'ayes', 3 'no'. The motions carried. The gentleman moves the adoption of the Resolution 228... all in favor of the adoption vote 'aye', opposed vote 'no'. Take that.... did you take the record on the other one. The gentleman has moved the adoption of House Resolution 228, all in favor of the adoption vote 'aye', opposed vote 'no'. Roll call vote. Representative Macdonald, 'aye'. Have all voted who wised. Take the record. This question, 127 'ayes', 2 'nos'. Resolution is adopted."

Speaker Redmond: "Representative Madigan, do you desire recognition... no. Representative Shea.... Representative Totten, for what purpose do you rise? Totten."

Totten: "Thank you, Mr. Speaker. Ah... we have now gone through approximately, 4 months of what's normally 6 months of the General Assembly and the other day when I inquired of the Chair ah... as to where the new rules were, I was told that they would be on my desk the next morning at 11 o'clock. You know, I understand there was a large hue and cry for reforming the rules of the House and we have now gone through 2/3 of the Session and we haven't received the new

rules yet. I would like to inquire as to where they are." Speaker Redmond: "They are still in the process of being prepared in fin finality. A draft was given out to all the Members of the Rules

Committee, I understand. We will have a meeting of the Rules Committee. Totten: "Could you tell me when we could expect copies of the Rules." Speaker Redmond: "Well, I can't tell you precisely, but I will tell you

very shortly. Representative Choate."

Choate: "Ah... Mr. Speaker, while we're on the rules the ah... schedule

that I see that ah... the Speaker has had cause to place on the Membership desk. Does this take a vote to set Friday's schedule or is that at the direction of the Leadership."

Speaker Redmond: "As I understand it, it's the direction of the Leadership, I may be wrong but I've been before."

Choate: "Well then, Mr. Speaker I would like to address myself to the proposed schedule for Friday. If I can have a little order."

Speaker Redmond: "Proceed... proceed."

Choate: "Mr. Speaker, I invite every Member to look closely at the schedule and you will find that practically all Committees are meeting on Friday and then a footnote that the House Appropriations I and II are meeting at the same time as all of the other Committees meeting. House Appropriations I and II are meeting, I have been told to discuss probably the most important piece of legislation that will be heard in this Session, at least the largest, and that is the accellerated Building Program. If you will look at the Committees and I've had many Members come and talk to me... you will find that there is direct conflict with the schedule as far as the Appropriation Committee Members meeting in their duly assigned Committees and also discharging their duties on the Appropriation Committee. You will also find many Members of the Appropriation Committee who have Bills... in the other Committees. It's physically impossible for them to be in the same Committee, and Mr. Speaker, I would seriously urge you and the Leadership to consider the schedule for Friday, so that the Appropriation Committee can meet in full membership to discuss this all important issue and not be worried about their Bills and their responsibility of attending other Committees."

Speaker Redmond: "Representative Washburn."
Washburn: "Thank you ah... Mr. Speaker and Ladies and Gentlemen of the House. I do understand that the ah... leadership of both sides of the aisle are to meet this afternoon on several subjects and I'm certain that this will be one of them. I.... I hope that it can be ah... must be re-adjusted so that not only can the Members of the Appropriations Committee be available for their own Appropriation

Committee Meetings, but I'm sure that members who are not appropriation ah... Committee Members, also would want to appear and testify on... on this series of ah... Bills that would affect the State of Illinois, for years to come and ah... ah... places in debt ah... beyond our means for serveral generations so, this subject will be discussed this afternoon, I'm certain."

Speaker Redmond: "No question about it, it will be discussed. Representative Beatty.... Beatty."

Beatty: "Mr. Speaker ah... since you have been running the House, you have been doing a fine job informing the Membership of what is going on and I want to comtenp.... compliment you on it. I think the House is running much smoother than it did in the last Session. And with that in mind, I know the tentative schedule that was posted a number of weeks ago show us as being in Session Monday. I wondered whether or not there was any contemplated change, so that we might make plans if we were to have Monday off, I would like to know now, so that... I could... and I think other Members might, so I would appreciate it advising us if there would be any changes as soon as you would."

Speaker Redmond: "We will advise you with the earliest opportunity, it

isn't quite now but it will be tomorrow. Representative DiPrima." DiPrima: "Ah... Mr. Speaker, once again the Calendar inadvertently

lists Veterans' Affairs and Registration and Regulation as meeting on Wednesday, we're meeting at 4 o'clock this afternoon and we hope

to clear out all our Bills. 4 o'clock, Room 122-A today."

Speaker Redmond: "Representative Shea."

Shea: "Mr. Speaker, I move that we do now adjourn until 11:15 A. M. tomorrow."

Speaker Redmond: "The motion, all in favor indicate by saying 'aye', opposed 'no'. We stand adjourned."

Geo-Karis: "Mr. Speaker, Ladies and Gentlemen of the House. We just want to remind you that the Energy Seminar that was scheduled for tonight has been canceled. It will be resumed May 6. Thank You."
