Gerry', on your list it appears to me as though House Bills 2559 and 2812 are appropriation bills and it wouldn't be necessary to have them on your list. Maragos: "Well, I would like to have leave of the House, these are bipartisan bills, if I may, to keep these bills alive until the committee bill is generated out of the committee, because these bills have been worked on for two years and Skinner is a sponsor, Mr.

Beaupre is a sponsor, Mr. Schraeder and others, and they are of vital importance, but due to the lack of time, we didn't have the time to consider these bills. I would like to know if we could have leave of the House. I would like to have Representative Skinner and Representative Beaupre to give me support in this action and Representative Randolph and Representative LaFleur if they would do this because these are very vital bills; I'd like to have leave until the . . . the . . . ah . . . what is the deadline to get them out of the House?"

Speaker Redmond: "23rd of May."

Maragos: "until . . . ah . . . they be allowed to survive until the 23rd of May that those five bills and House Bill 1844."

Speaker Redmond: "Rep . . . Representative Beaupre."

Beaupre: "I . . . I was just concerned, Mr. Speaker, about the procedure that we would use. I think we all agreee what we want to do. What we want to do is to weigh the hearing of these bills for two weeks and if we need to put the committee on as sponsor that's no problem with any of them, I don't think. My question really is, do we need to introduce a new bill in order to have the sponsorship changed?"

Speaker Redmond: "Parliamentarian indicates that the answer is 'yes'.

Representative Hart. Representative Hart."

Hart: "Well, I just was gonna' object . . . ah . . . regardless of the importance of it or how long it's worked, I think we all feel the same about those bills that . . . that we've had to give up because of the rule, and so there is a way that the committee can come out with a bill and I just object to giving leave."

Speaker Redmond: "Representative Shea."

Shea: "Well, perhaps I didn't hear the gentleman's motion, but I thought I

Study Calendar. Well, then there is no way that those bills are subject to the joint rule; and if they're not reported on one way or
another, die; but its very simple. All the gentleman . . . all they

Speaker Redmond: "Representative Maragos."

Maragos: "The problem arises, there's a series of five bills. Shea: "Mr. Peters, you're on the Appropriation Committe, would you report out a companion bill with an appropriation bill if you killed . . . if you killed the appropriation by reporting it out do not pass? Would you report its companion bill any other way than do not pass?"

Peters: "No . . . no, I would not, Representative Shea, except I . . . I

don't think we ought to get in the position of making motions ahead

of time what we're going to do with series of bills if something else

doesn't happen. That . . . that's just my problem with it."

Shea: "I think it would be unfair to the Appropriation's Committee to . . .

if they acted on killing an appropriation, that the companion bill, if

it were in Appropriation's, would be killed. I've made my motion in

the form that I think is proper. I would like to now read the bill

numbers."

Speaker Redmond: "Proceed."

Shea: "The bill numbers that I have reference to are House Bills 175, 450, 724, 1264, 1414, 1521, 1584, 1615, 1716, 1761, 1795, 1815, 1828, 1871, 2054, 2075, 2102, 2119, 2438, 2451, 2455, 2462, 2470, 2477, 2555, 2558, 2579, 2702, 2789, 2811, 2835, 2891, 2928, 2954, 1524 and 2443."

Speaker Redmond: "Representative Telcser."

Telcser: "Representative Shea, now, does your motion contain that language with respect to tabling companion bills if the appropriation is defeated in committee?"

Shea: "Yes, sir."

Telcser: "Well, let me just . . . ah . . . say two things. In the first instance, this was not discussed yesterday on the floor . . . ah . . . when I was . . . ah . . . agreed to withhold the . . . ah . . . motion to discharge committee, this particular subject does not . . . ah . .



did not come up at that time. Obviously, now, that it's come up now, it's somewhat of an afterthought. Ah . . . I would like to remind you . . . ah . . . and the members that the first time I passed . . . ah . . . bills for the state for bilingual education, the appropriation was taken out of those bills and the bill became law without the appropriation. Now, . . . ah . . . I think this is something we ought to talk about and not take up necessarily on this particular motion.

Ah . . . Frankly, I think you're probably right in what you want to do, but you take members by surprise today . . . ah . . . when you include something else in the motion which we discussed yesterday."

Shea: "Well, Mr. Speaker, I think if there's any bill on the category the gentleman speaks of, at the time the appropriation bill is reported out do not pass and the bill was going to be tabled, the members to file an appropriate motion to prevent that bill from being tabled, and if he's joined in 89 members, it would not have to be tabled."

Speaker Redmond: "Representative Satterthwaite."

Satterthwaite: "Mr. Speaker, I'm unclear at this point of the status of a bill of mine on this list. It's 1761. It does not have a companion appropriation bill. The expectation is that the appropriation for this bill would come through the Office of Education Budget; and I don't know what will happen to my bill . . . ah . . . after this event."

Shea: "I would amadam . . . I would imagine that what would happen is that

you say that the appropriation bill for that agency has been amended

to include that appropriation and make a statement to move the bill to

Second Reading, Second Legislative Day."

Speaker Redmond: "Satisfied?"

Speaker Redmond: "Representative Shea."

Speaker Redmond: "Representative Shea."

Satterthwaite: "Does that mean that my bill will not automatically be tabled when there is no specific appropriation bill coming out in relation to

Shea: "Yes, that's what I would think."

Satterthwaite: "Thank you."

it?"

Speaker Redmond: "Representative Kane."

Kane: "Representative Shea, this may have been covered in your . . . in your



other . . . ah . . . answer, but . . . ah . . . what would happen to an appropriation . . . well, what would happen to the companion substantive bill if the Appropriation's Committee killed the appropriation but tha . . . the appropriation companion bill but passed out a committee bill that included an appropriation to fund that project?"

Shea: "I would imagine that those bills would then move."

Kane: "But under the terms of your motion, the substantive bill would die."

Shea: "I don't think so. Under the statement I made, that when either the companion appropriation or an appropriation came out of committee, and I think you have reference to the fact that there are several commission bills on here and the the omnibus appropriation bill comes out, those bills would then move."

Kane: "Mr. Speaker."

Speaker Redmond: "Representative Kane."

Kane: "Ah . . . There is a bill on this list, 2119, that was voted out of Appropriation's Committee . . . ah . . . yesterday or the day before.
Could the . . . ah . . . on Wednesday . . . could the Clerk verify that it's been reported so we can take it off this motion? Mr. Speak-

er?"

Speaker Redmond: "Representative Schlickman."

Kane: "Mr. Speaker?"

Speaker Redmond: "Oh, pardon me."

Kane: "Ah . . . House Bill 2119 was reported out of Appropriation's Committee Wednesday. Could the Clerk verify that it has been reported out so that we can take it off of this list?"

Speaker Redmond: "We're in the process of doing that, Representative Kane.

Representative Schlickman."

Kane: "Thank you."

Schlickman: "Well, Mr. Speaker and members of the House, I think the motion that the Majority Leader is making is one of the most responsible motions that a Majority Leader could make. Now, this motion serves as an accommodation, serves as an accommodation to the members who have the substantive bills in committee. We all know that if they aren't brought out by this motion, they will automatically die. We can't exted . . . extend the deadline because of the joint rules, which we,



alone, cannot . . . ah . . . suspend. Now, as he rightfully pointed out, none of us can imagine that the Appropriation's Committee would beat an appropriation's bill, but report out a substantive bill. For the motion to be in any other fashion, to my way thinking, would be subversive of the process; and I join with him in soliciting and securing the support of the membership relative to this motion."

Speaker Redmond: "Are you ready for the . . . Representative Kane."

Kane: "Yes, 2119, has that been reported out?"

Speaker Redmond: "Yes, it has?"

Kane: "Could we strike that off the list?"

Speaker Redmond: "Representative Shea."

Shea: "I will remove House Bill 2119 from the list that I have read."

Speaker Redmond: "Representative Hanahan."

Hanahan: "Once again, so I know exactly what I'm voting on on a very confusing point here. House . . . another House Bill 2558, which is the

Appropriation's Committee spent all morning on or most of the morning on and probably into the wee hours of the night is going to spend on the Housing Development Act. If this bill is allowed out on Second Reading through this motion, this is a bill of Representative Meyer

and Dan Houlihan, if this bill is put out on the floor on Second

Reading, is there a committment between the Majority Leader and this

House that this bill will not be used as a vehicle to amend the Illinois Housing Development Act in any other manner? I'm sure that that's

one of the problems of . . . of allowing bills of this nature to be put out on the floor of the House."

Speaker Redmond: "Representative Shea."

Shea: "As I said, Mr. Hanahan, the bill will not move unless the . . . the appropriation catches up with it, whether it be through a committee bill, Funding Commission, through an appropriation in a department appropriation or a companion appropriation bill. If the Appropriation Committee would move out the companion appropriation bill, and those two bills went to Second Reading, Second Legislative Day, they'd become part of the legislative process and could be amended any way."

Hanahan: "Well, well, then, Mr. Speaker, I'd like to speak against this motion."

Speaker Redmond: "Proceed."

Hanahan: "That's exactly the point, Mr. Speaker, I was trying to bring up, that a lot of these bills, if allowed on this unanimous motion, are going to be used a vehicles to the contrary position of many committee members that have taken their time to spend in committee and to debate the issue and to listen to the witnesses. All we're going to do now is move out bills that somehow if other positions on appropriations are taken that the bills will be out here on the Second Reading and could be amended to do any damn-well please that 89 votes or a majority of those votes on the House floor wants it to do. I object specifically to a bill to be brought out on the floor of the House in the guise of one thing and to be amended to do many other things to the detriment of the wishes of a committee when a member had all the time and opportunity like many of us did of moving bills in committee according to the rules that set down by the joint House rules; and I'm against this motion."

Speaker Redmond: "Representative Shea . . . Choate . . . Representative

Choate."

Choate: "I'm not as tall as Gerry."

Speaker Redmond: "Better looking."

Chaote: "I'm more handsome. Ah . . . Mr. Speaker, I think that we can
resolve this maybe and hopefully, and not . . . but I do agree with
what Representative Hanahan has said, we're running a grave danger of
bringing about things to happen that . . . ah . . . committees probably
maybe do not want to happen, however, I think, Gerry, that the big
question that needs to be asked here, will a substantive bill that
would be discharged under this motion be allowed to be amended to the
extent that it would hear . . . that it would carry an appropriation
and circumvent the . . . ah . . . rules that way."

Speaker Redmond: "Representative Shea."

Shea: "Appropriation bills must be separate bills."

Speaker Redmond: "Representative Matijevich."

Matijevich: "Well, as usual, you know, you can always agree with a little



bit of what every body says; and I agree with some of what . . . ah . . . Representative Hanahan says, except that I . . . I read on the Calendar where the companion bills to the bill that he's speaking of has already been ap . . . ah . . . reported out and on the Calendar and evidently reported by the Appropriation's Committee, isn't that true and then why is that on the Calendar and not the companion substantive bill? It appears to me that it would have been the more responsible thing for the Appropriation Committee to do to report both of the bills out or kill both of them. Ah . . . Well, I see one bill on the Calendar . . . ah . . . House Bill 2559 is on the order of Second Reading. Evidently, it's been reported out, that is the appropriation bill. The substantive bill, evidently, has not been reported out; . . . ah . . . and . . . ah . . . oh, it went back? How did it get on the Calendar? Oh, O.K. All I can do is go by what I see."

Speaker Redmond: "Representative Walsh."

Walsh: "Well, Mr. Speaker, and ladies and gentlemen of the House, I would like to concur, absolutely, with what Representative Hanahan said with respect to House Bill 2558; that bill, certainly, could be a vehicle for a bill that was defeated in the Appropriation's Committee just before we convene today; and I see no reason on Earth why we should put that bill on the Calendar. So I would object strongly to considering all of these at one time. I agree with Representative Schlickman that . . . ah . . . there's no point in passing a substantive bill if the appropriation's bill does not pass; and I think that that should be a part of the Majority Leader's motion; but I, strongly agree with Representative Hanahan that we ought to consider this motion by striking House Bill 2558."

Speaker Redmond: "Representative Beaupre."

Beaupre: "Mr. Speaker, this argument about these bills being potential vehicles is really a spurious argument. If the bill can get 90 . . . ah . . . 89 votes on this House floor, it would have enough votes to be discharged from any committee, if it can get 89 votes on this House floor, then it deserves to be passed and to suggest that we're going play political gamesmanship by beating bills in committee that can



get 89 votes on the floor is really a spurious agrument. I think that the . . . the Majority Leader, here, has made sound motion, which is fair to everybody in this Chamber; and we ought to pass it and get it over with."

Speaker Redmond: "Representative . . . Representative Telcser."

Telcser: "Ah . . . Mr. Speaker, just to . . . ah . . . inform the last speaker that if a motion, Representative Beaupre . . . Representative Beaupre, if a bill has a do pass motion in committee and that do pass motion fails, it would take 107 to discharge the committee, if that's the only action, I tell you that simply as a point of information."

Speaker Redmond: "Representative Lundy."

Lundy: "Mr. Speaker, Rule 67 of the Temporary Rule 67C says it takes 89 votes to discharge a committee."

Speaker Redmond: "Are you chastened, Representative Telcser? Are you ready for the question? Representative . . . Representative Madison."

Madison: "Mr. Speaker, . . . ah . . . would the . . . ah . . . Sponsor of the motion yield for a question?"

Speaker Redmond: "Yes, he will."

Madison: "Mr. Shea, . . . ah . . . I'd like to ask you a rather naive question. If an appropriation's bill fails in committee and a substantive bill is passed on this floor, is that substantive bill for all intention purposes meaningless?"

Shea: "No."

Madison: "Thank you."

Speaker Redmond: "Are you ready for the question? The question is on the adoption of the motion. Representative Kane."

Kane: "Could, if the Appropriation's Committee wanted to appropriate money
to fund one of these substantive bills, could not the Appropriation's
Committee pass out a substantive bill as a committee bill and it would
be exempt from the deadline?"

Speaker Redmond: "Representative Shea."

Shea: "Mr. Kane, knows full well that any committee bill, whether it comes out out of Appropriation's or any other committee is not subject to the deadlines."

Kane: "So if we defeated this motion and the Appropriation's Committee

wanted to appropriate, they could pass a substantive bill as a committee bill and the bills would not be dead."

Shea: "Mr. Kane, the reason I made it was so that all members would be treated alike and I would renew my motion."

Speaker Redmond: "The question is on the adoption of the motion. All those in favor vote 'aye', apposed vote 'no.' Representative Washburn."

Washburn: "Thank you, Mr. Speaker. Ladies and gentlemen of the House. I think there's some confusion or lack of understanding, at least. Just what are we voting on? Who's motion is it and how was it stated?"

Speaker Redmond: "Representative Shea, will you restate the motion?"

Shea: "I will try to, Mr. Washburn. Can I tell you what the intent to the

motion was and then I will try to phrase it in the appropriate language?"

Speaker Redmond: "Representative Shea, I didn't even know that it was your motion or Representative Hanahan's motion so if it is your motion, please restate it?"

Shea: "The intent is to take these bills that have been through a substantive

committee, and would or have been re-referred to Appropriations. Where the appropriation bill, companion appropriation bill is now resting and to take them from either the Appropriation's Committee or the committee on assignment, place them on the House calendar in a special order of first reading, second legislative day and hold ... Second reading, first legislative day and hold themand hold them in that category until such time the companion appropriation bill comes out of committee. If the companion appropriation bill is reported out—do not pass, the bill would be tabled."

Speaker Redmond: "Representative Duff."

Duff: "And that motion applies to all the bills on this list?"

Shea: "Yes, sir. To the bills, I read."

Duff: "Thank you."

Speaker Redmond: "Representative Hanahan."

Hanahan: "...Speaker, I once again might as well just, you know, say it how
it is instead of let's quit beatin around the bush. I've...I've never
even heard of such a suggestion as one of the former representatives
said, 'to hell with the committee system'. We've specifically stated that
if a bill is not before that of a committee it takes a 107 votes to
get it on the floor of the House. Now I want to tell the members of

Hanahan: "May I continue, sir. We already went through that Representative Myer and it is back in committee. And the motion that is before us will allow this bill, these two bills, if the Appropriation bill comes out to be used as a vehicle to do what a bill has been tied up in the committee after many hours of"

Speaker Redmond: "Representative Myer, for what purpose do you rise?"

Myer: "Mr. Speaker, if...if 2559 has been re-referred, all right, and Mr.

Hanahan is concerned that if the Appropriation's bill is defeated, I give him my personal word that I will table the substantive bill."

Speaker Redmond: "Representative Hanahan."

Hanahan: "That's not quite enough, Representative Myer. Because I...I...

I think, I very honestly would say and suggest that you could get
the thirteen votes on that appropriation bill from that committee that
we heard that you serve on. That I have no objection to the \$120,000
that you want. I would object though, if all of a sudden these two
bills or one of these bills are amended some time in the future to
include 600,000,000 or the 400,000,000 dollar bonded increase in the

to hear."

Myer: "I've... I will give you my personal commitment that these, I will



accept no amendment to either of these bills in either the House, Senate or a Conference Committee."

Speaker Redmond: "Representative Hanahan."

Hanahan: "Then I will remove my objection to this bill."

Speaker Redmond: "Sealed in blood. Everybody voted who wish? Representative

Washburn."

and proceed."

Washburn: "Thank you, Mr. Speaker and ladies and gentlemen of the House.

I have some reservations and some serious questions about the...ah...

...ah...tabling, automatic tabling of the bills on second reading if
the appropriations bill does not meet success in committee. I would
ask Representative Shea to re-consider that motion, to reword it...
ah...there is some...there are some substantive bills that could go
on and and be effective and...and be helpful to the general public
without an appropriation bill. Its been done in the past, two or three
have been pointed out to me while I've been standing here. So it's
really not an exceptional case or really a rare case where a substantive

Speaker Redmond: "All voted who wish? Representative Shea."

Shea: "Mr. Washburn, if, I think, it was phrased any other way, it might be to the detriment of the body. If when we talk, can I think there's perhaps, let's take one of the bills on the commission for the blind.

Although the appropriation bill might not come out, the commission be favorable or it might be a good idea. If you can 89 votes to pass that bill, you can get 89 votes to prevent it from being tabled."

Speaker Redmond: "Have all voted who wish? Take the record. On this question, there's 102 'yes', 18 'no' and the motion is adopted.

Representative Maragos."

Maragos: "Mr. Speaker, are you finished on this issue? Then I have another inquiry, Mr. Speaker, I want it for the record stated that all bills that have not been reported on a committee but have been adopted as do pass, do not automatically die today. Is that correct? As long as they are in a 10 day rule for reporting, I want that also corrected.



I want that also stated for the Record, because of many committee clerks are still working because of the . . . ah . . . landslide of business we've had the last two weeks . . . is I don't . . . I'm asking whether the ten-day rule to report bills out of committee, after they've been acted upon, will also be presented by their fact that they have to be on the Calendar as of today, and this effects all committee, not just . . ."

Speaker Redmond: "Representative Shea."

Shea: "The rule . . ."

Speaker Redmond: "Read the joint rule."

Shea: "... the rule is that they be reported out of committee as of today so that the action taken by the committee will be as of May the 2nd and be within the rule."

Speaker Redmond: "Representative Maragos."

Maragos: "Yes, my . . . my concern is, Mr. Shea, and members of the House and . . . ah . . . Mr. Speaker, that many of the clerks of all committees who have been acting on bills today have not reported them out today. So the question is, is there's a . . . do I understand, Mr. Shea to say, that if they have been acted upon by the committee as of today, they've got ten days to report them out and they'll be live bills on Second Reading next week?"

Speaker Redmond: "That is correct."

Shea: "That's correct."

Maragos: "I just want it for the Record so there'll be no misunderstanding.

Thank you."

Speaker Redmond: "Representative Skinner."

Skinner: "Mr. Speaker, along that same line, if . . . ah . . . motions are filed on a timely fashion with regard to bills that have not yet been reported to the floor, will they be considered as . . . ah . . . timely?"

Speaker Redmond: "Would you restate your inquiry, please?"

Skinner: "Well, for instance, there are lots of motions on the . . . on

Calendar to discharge, there are motions, I presume, to . . . ah . . .

Skinner: "And if it . . . if the motion prevails, then the bill would be reported within the deadlines onto the rules?"

Speaker Redmond: "Yes."

Skinner: "Thank you."

Speaker Redmond: "Representative Matijevich."

Matijevich: "Only to correct, Mr. Speaker, only to correct some of the statements on how many votes its takes. It takes 89 votes to discharge a committee. It also takes 89 votes to take from the Table as long as you have a written motion within two days of when it was reported out. Someone here said 107 and . . . and that's in error."

Walsh: "Well, Mr. Speaker, under the provisions of Rule 67, the gentleman's motion must be carried on the daily Calendar; and I don't see the motion on the daily Calendar."

Speaker Redmond: "Representative Matijevich."

Speaker Redmond: "Representative Walsh."

Matijevich: "I make the point of order that . . . ah . . . he refer to

Rule 67, and Rule 67 refers to a motion to discharge committee."

Speaker Redmond: "Committee Reports. Representative Totten."

Totten: "Thank you, Mr. Speaker, I have one inquiry of the Chair, if, at
the rate we're going and the Appropriation's I Committee has to meet
yet, if we should not vote until after midnight tonight, which is the
deadline for bills, what's the situation of those?"

Speaker Redmond: "I think that that's . . . ah . . . an improper question.

If . . . ah . . . if it happens, then I'll have to make the ruling, because I can't anticipate that; and if we don't stop pretty soon, we're not going to get to our . . . ah . . . meeting up in Arlington Park or

wherever we're going."

Totten: "Well, I think . . . I think a ruling might be appropriate seeing



the committee may be here . . . ah . . . that . . . ah "

Speaker Redmond: "Well, if it happens, then I'll rule on it; but I'm not going to rule in advance."

Totten: "I . . . will you be here at 12:00 o'clock?"

Speaker Redmond: "Surely, will you?"

Totten: "I intend to."

Speaker Redmond: "Committee Reports."

Jack O'Brien: "A report from the Committee on Rules at a meeting on the Committee on Rules held Thursday, May 1, 1975, persuant to notice the committee adopted the House resolution, which proposes permanent rules for the House of Representatives of the 79th General Assembly. Attached, hereto, is the committee resolution and reports the same to the House for introduction with the recommendation that the resolution be adopted. William A. Redmond, Chairman."

Speaker Redmond: "Representative Washburn."

Washburn: "Ah . . Mr. Speaker, I was trying to seek recognition here to ask for a verification to that Roll Call."

Washburn: "I sure didn't . . . I did . . . I was waiting for you to announce it; if you announced it, I certainly didn't hear it or were prepared to announce it, I didn't hear it at all."

Speaker Redmond: "It was . . ."

Washburn: "We got off on another subject before it was announced."

Speaker Redmond: "It was announced and cleared; it was adopted. How about the rules, where are we . . . read the resolution . . ."

Jack O'Brien: "House Resolution 237 admitted by the Rules Committee."

Speaker Redmond: "Speaker's Table. There's an announcement that . . . that
House Resolution 237, which has to do with the rules, has been . . .

is in preparation now. If you can pick them up, we have them here.

You can pick them up prior to 6 . . . around 6:00 o'clock, and if

you don't, we'll mail them to you at your home. Are they here? Well,
I guess they're here then, you can get them there. Representative Kane."

Kane: "Mr. Speaker, could you give us some indication of . . . ah . . . when you intend to call these rules for . . . ah . . . vote on the floor of

Speaker Redmond: "I would assume the members should be able to look them

over on the first part of the week, maybe Tuesday, let 'em have them

over the weekend, first part of the week."

Kane: "What will be the ruling on as far as the offering of amendments?"

Kane: "Would they have to be printed and distributed before the amendments could be voted on?"

Speaker Redmond: "Could be . . . they should be, yes. You have any problem with them . . ."

Speaker Redmond: "Well, they're in order, yes . . . ah . . ."

Kane: "Yeah, well, when would be timely filing for amendments?"

Speaker Redmond: "We'll give you the Wednesday on this or either Tuesday

or Wednesday."

Kane: "Thank you."

Speaker Redmond: "Representative Maragos."

Maragos: "Mr. Speaker, another inquiry because these are vital questions to all the committee chairmen and committee . . . I notice on the Calendar that you have . . . ah . . . distributed to the members of the House that you are not going to have any committee meetings set for next Tuesday and I think Wednesday and Thursday of next week according to the Calendar. Al, we were in Room Cl; we'll meet in Room Al. Now, that's for the convenience of members who are on both Judiciary I and II. It is my understanding that Judiciary II will meet in Dl, which is right across the hall."

Speaker Redmond: "Representative Lechowicz, do you have an announcement?"
Lechowicz: "Yes, Mr. Speaker, and ladies and gentlemen of the House,

Appropriation's Committee will reconvene immediately after adjournment on the House floor to . . . ah . . . reconsider . . . ah . . . to consider the accelerated bonding program."

Speaker Redmond: "Any further announcements? Representative Shea."

Shea: "Mr. Speaker, I move that the House do now adjourn until Monday, May the 5th 'til 12:00 o'clock noon for Perfunctory Session; and then will adjourn from that Perfunctory Session until Tuesday, May the 6th to 10:30."

Speaker Redmond: "You've heard the motion. The question is on the adoption of the motion. All in favor say 'aye', oppose 'no'; the 'ayes' have it. The motion's adopted. Representative Katz."

Katz: "Ah . . . Mr. Speaker, the rules are now on everyone's desk. House
Resolution 237. The cross index to the rule . . ."

Speaker Redmond: "I am advised the Republicans don't have them, Mr. Katz."
