The other major items are fourteen million dollars for substitute care, foster care, adoptions in the Department of Children and Family Services. We have other items of miscellaneous nature none of which exceed about two and a half million

dollars so with that unless there are specific questions I will conclude and ask for an 'aye' vote on this Amendment."
