Assembly of the State of Illinois, the Senate concurring herein: that there shall be submitted to the electors of the state for adoption or rejection at the General Election next occurring at least six months after the adoption of this Resolution, a Proposition to amend Sections VIII and XIII of Article I of the Constitution to read as follows: Article I, Bill of Rights; Section VIII, Rights after Indictment, in criminal prosecutions the accused shall have the right to appear and defend in person and by counsel to demand the nature and cause of the accusations and have a copy thereof, to meet the witness face to face, and to have process to compel the attendance of witnesses in his behalf, and to have a speedy public trial by an impartial jury of the county in which the offense is alleged to have been committed, except that the General Assembly by law may abolish the right to have jury trial for prosecutions of offenses which by law are punishable only by a fine of no more than \$500. Section XIII, Trial by Jury, the right of trial by jury is heretofor enjoyed shall remain....Repeating Section XIII, Trial by Jury, the right of the trial by jury as heretofor enjoyed shall remain inviolate except that the General Assembly by law may abolish the right of jury trial for prosecutions of offenses which by law are punishable only by a fine of no more than \$500. Scheduled this Amendment of Section VIII and XIII of Article I of the Constitution takes effect on January 1st following its approval by the electors of this state. Third Reading of this Constitutional Amendment."
