Speaker McPike: "Representative Black"

Black: "Yeah, thank you very much, Mr. Speaker. That's the question that I had. Basically, was, 'Does Amendment #1 remove the objections by the Department of Human Rights?'. As I understand it, Representative, this Amendment more or less has a Sunset clause. It kicks in until the federal government action gets in. Alright, thank you."

Clerk O'Brien: "House Bill 544, a Bill for an Act to amend the Insurance Code. Second Reading of the Bill. No Committee Amendments."

Speaker McPike: "Any Floor Amendments?"

Clerk O'Brien: "No Floor Amendments."

Speaker McPike: "Third Reading. House Bill 594, Representative Anthony Young. Read the Bill, Mr. Clerk."

Clerk O'Brien: "House Bill 594, a Bill for an Act to amend an Act concerning consumer credit. Second Reading of the Bill.

No Committee Amendments."

Speaker McPike: "Any Floor Amendments?"

Clerk O'Brien: "No Floor Amendments."

Speaker McPike: "Third Reading. House Bill 601, Representative Kirkland. Read the Bill, Mr. Clerk."

Clerk O'Brien: "House Bill 601, a Bill for an Act to amend the

School Code. Second Reading of the Bill. No Committee Amendments."

Speaker McPike: "Any Floor Amendments?"

Clerk O'Brien: "Floor Amendment #1, offered by Representative Kirkland."

Kirkland: "Thank you, Mr. Speaker. House Bill 601 deals with the authority of local school boards to set up experimental educational programs currently limited at the high school level. This would allow both the high school and elementary level, and the Amendment in both those cases sets it up that it would be in agreement with affected exclusive collective bargaining agents and it's agreed."

Speaker McPike: "Does anyone stand in opposition to the Amendment? Representative Homer."

Homer: "Yes. Will Gentleman yield?"

Kirkland: "Sure."

Homer: "Representative Kirkland, we haven't had a chance to analyze your Amendment. Was this something that was discussed in committee?"

Speaker McPike: "Representative Steczo."

Steczo: "Thank you, Mr. Speaker, Members of the House. Amendment #1 to House Bill 605 provides language that's an agreement between the state Board of Education and the Illinois Press Association that removes some superfluous language. That's all the Amendment does, and I move for its adoption."

Speaker McPike: "Any discussion? Being none the question is,
'Shall Amendment #1 be adopted?'. All in favor say 'aye',
opposed 'no'. The 'ayes' have it, and the Amendment's
adopted. Further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker McPike: "Third Reading. House Bill Third Reading. House Bill 7, Representative Klemm. Read the Bill, Mr. Clerk." Clerk O'Brien: "House Bill #7, a Bill for an Act to amend the

Security Deposit Interest Act. Third Reading of the Bill."

Speaker McPike: "Representative Klemm."

Thank you, Mr. Speaker. House Bill #7 amends the Security Deposit Interest Act on lessors of residential real property. What we have in the existing law that says that a rental building of twenty-five units that any interest that had been deposited in advance as security deposit for that particular rental would be required to have interest

earned on that rental. And at the end of the year, that interest would be credited to the person who's leasing that apartment. A recent, well not recent, but a few years ago, appelate court decision came down saying that buildings that had a complex of twenty-five apartments, even though it wasn't in one single building, would also be required to interest earned on security deposits. have the happens in my area, we don't have large, tall buildings. that are twenty-five stories high or something, but what they do have are maybe eight small two- or three- floor buildings each with maybe seven or eight or ten apartments in it. But it's a complex, it's a unit it's a community if you will, of all similar ownerships in apartments. And in that case they feel that the landlords don't need to give security or interest on that security deposit. Bill really clarifies that they would be included also. It codifies what the appellate court has decided and handed down that interest should be paid. We had an Amendment that clarified any questions that the Illinois Board of Realtors had pertaining to contiguous property. I think it's in the form that certainly meets everybody's concerns. There's no opposition that I'm aware of, and I would answer any questions, and I ask for your favorable vote."

Speaker McPike: "Does anyone stand in opposition to the Bill? Representative Homer.

Homer: "Speaker, question. Has the Amendment ever been printed?" Klemm: "The Amendment had been introduced in committee, Mr.

Speaker. The Amendment had been introduced in committee and had been adopted in the committee, Representative Homer. There's no Floor Amendments."

Homer: "No, I know, I'm on that committee but there's no Amendment in our Bill file, and I would like to know whether that Amendment was ever printed. It may have been

Speaker McPike: "Representative Homer, the Bill's on Third Reading, so...your request is not timely."

Homer: "The...one question to the Clerk. Is the Bill now in the enrolled and engrossed form?"

Speaker McPike: "Yes."

Homer: "I see. Well, I don't, I just have the original Bill. I don't have the enrolled, engrossed version, but Representative Klemm, just briefly, how did the Amendment change the Bill?"

Klemm: "Well, the Amendments, it was House Amendment #1, and it simply inserted on line 10, it deleted line 10 and inserted in lieu thereof the following: 'complex of buildings located on contiguous parcels of real property'. That was the additional words, and it went on to 'who receives a security deposit from a...' That was the Amendment, that was what was suggested by the realtors, that was an agreement with everybody in the committee as you know."

Homer: "So the realtors were in support of that Amendment?"

Klemm: "Actually that was their Amendment to prevent any confusion of what we're talking about of what the rental property would be."

Homer: "Alright, thank you. The Bill was heard in committee, Mr. Speaker, it's not controversial. It's a consumer Bill. The realtors are either for it or neutral, and so I would think it should be passed."

Speaker McPike: "Representative Black. The question is, 'Shall House Bill 7 pass?'. All in favor vote 'aye', opposed vote 'no'. Have all voted? Have all voted who wish? Clerk will take the Record. On this Bill lll 'ayes', no 'nays'.

Clerk O'Brien: "House Bill 123, a Bill for an Act to Amend an Act relating to employment. Third Reading of the Bill."

Speaker McPike: "Representative Currie."

Currie: "Thank you, Mr. Speaker and Members of the House. This is a Bill that would set up goals for hiring of severely disabled people through the division of Central Management Services through the state universities Civil Service Act and in the Secretary of State's office. There are

Dunn: "You don't know. Alright, thank you, Mr. Speaker, I think we ought, the Gentleman does have some legislation which consists of a very massive reform to the Uniform Commercial Code. And it may be very good legislation, but we should hear it thoroughly, and we should not put a vehicle out which would lend itself to that purpose. So, I think we should slow this Bill down until we find out what the Gentleman intends to do."

Parke: "Just an observation, Mr. Speaker and Ladies and Gentlemen of the House. McCracken: "There was one gap that was filled in and that was the definition of consumer lease. It was left up to the states to define that. It's defined by a dollar threshold. This Bill incorporates a \$40,000 dollar threshold. Anything below that is defined as a consumer lease when it's between individuals in a typical consumer transaction."

Lang: "Have any of the Bar Associations commented on the Bill?"

McCracken: "I sent the matter to Larry Suferdein for the Chicago

Bar, and he never got back to me. Honestly, I think he's

fine, but I, he just never got back to me."

Lang: "Thank you."

Speaker McPike: "Representative McCracken to close."

McCracken: "I just ask that the Bill be considered on its merits.

It's important for the uniformity of the law governing what is often an interstate transaction, and I ask for its passage."

Speaker McPike: "Question is, 'Shall this Bill pass?'. All those in favor vote 'aye', opposed vote 'no'. Have all voted?

Have all voted who wish? Have all voted who wish? Clerk will take the record. Representative Black, did you want to speak?"

Black: "Mr. Speaker, I would rise with a point of inquiry, if I
