- Matijevich: "Mr. Speaker, Ladies and Gentlemen, I rise to oppose the Amendment. Some of you may be aware if you were here last Session, this is very similar to a Bill where I've been trying to get property that the State of Illinois and the Department of Transportation has held for 25 years. It's been doing nothing, and I've been trying to get the property for the City of North Chicago for the purposes of economic development, to build a corporate corridor, a linear corporate park. As you know, when you transfer property from one public body to another, we don't have to get an appraisal, but I did that two years ago, and I will truly admit to you that my Second Amendment will convey the property to the City of North Chicago for \$800,000. That is less than the appraised value, I will admit that, but it's what the city can afford. It's about \$100,000 more than the State purchased the property 25 years ago, but the community is in dire straits, the property will never amount to anything for the State of Illinois, any now, it's going to sit there. And, it is immediately adjacent to other corporate interests, it would very much complement that area. So, I would urge the membership to defeat this Amendment and then, to adopt Amendment #2."

- Black: "Well, thank you very much, Mr. Speaker. The questioner was debating the Bill, and the issue here is the Amendment. Will the Sponsor yield for a question?"

Black: "Representative Wojcik, is not an appraisal and selling of state land at a fair market value, the accepted practice?" Wojcik: "Yes, it is."

- Wojcik: "I think the Amendment speaks for itself. I just would ask for its favorable passage."

Speaker Giglio: "Representative Matijevich on Amendment #2." Matijevich: "Yes, Mr. Speaker, Ladies and Gentlemen of the House.

Amendment #2 would provide that the City of North Chicago, the property would be conveyed to the City of North Chicago for \$800,000. I have admitted that that is less than the appraised value. I want to tell the membership that that property has been doing nothing for 25 years. The State of Illinois would get more than it paid for the property.

It's something that can be done to stimulate development of a corporate linear park corridor, and it would benefit the community, I can't tell you how much. This way something useful, to benefit the community and to benefit all taxpayers, can be done. I urge the adoption of Amendment #2."

Speaker Giglio: "You heard the Gentleman's Motion. Any discussion? Hearing none, all those in favor of the Amendment signify by saying 'aye', Representative Olson." Olson: "Question of the Sponsor."

Speaker Giglio: "Proceed."

- Olson: "Representative Matijevich, you mentioned the State would be getting more than they paid for the property? What did they pay?
- Matijevich: "I believe it was \$700,000, and we, the City og North Chicago would Government purchased it for \$800,000."
- Olson: "The City is offering \$800,000 for a purchase of property that the state paid \$700,000 for. What is the appraised value of the property?"
- Matijevich: "The appraised value, I believe, is about four and a half million dollars."

Olson: "Sounds like a..."

Matijevich: "Wait a minute. That was two years ago. Since then, it has been significantly reduced by the Wetlands Act and not much of the property that is wetlands can not be developed. And, I will admit that it is less than the appraised value, but let me tell you, the state will never get anything for it, because it's going to sit there another 25 or 50 years. But, the state can at least get a

little more than they paid for it, and this community, can. économically develop it, provide for jobs, it's much less than we did for Bloomington, what we did for other areas of the state in the matter of economic incentives. - Olson: "This...the state, this is the Department of Transportation, is the agency that possesses it, I believe."
- Matijevich: "Correct. And, I might add, Representative Olson, two years ago all I wanted to see was property development. Two years ago when Department, DOT, didn't want to go along with the Bill, my Bill then would be to transfer it to the Department of Commerce and Community Affairs so that it develop the property for economic purposes. They thought it was a good idea but they didn't want to get into a grudge match with another state agency. And, I think that if you got DDA site, they would admit that this is prime property for economic development."
- Olson: "The Department of Transportation. Have they blessed this transfer? Are they willing to give up the property? They will oppose it no matter what. I'll admit that. They never give up anything."
- Matijevich: "Okay. Well, to the Amendment, there's a difference of opinion here as to whether the State Department of Transportation still has a use for it, or whether the community has a use for it. I think you have to weigh those things out, but the thing that bothers me here is that, here is a piece of property that may worth as much as \$4,000,000. Most transfers that I've seen in my time here, the appraised value more or less establishes a price for something. Here, a \$4,000,000 piece of property for

- LeFlore: "The reason why I wanted your attention, you can't hear what the person is saying on the speaker. I didn't hear all the full contents of the Amendment. I'm not opposed to it. I would just like for the presenter to present it again."

Speaker Giglio: "Representative Balanoff."

- Balanoff: "You want me to present it, yes, a...what Amendment #1 is, is the, a, it would provide for goods purchased under the Act and shall be made in Illinois unless their cost of the Illinois made goods exceeds the cost of, by more 10%. The same would hold true for goods made in the United States, it would give them a 10% preference. This is a Bill designed to keep jobs in the State of Illinois."
- Speaker Giglio: "Any discussion on the Amendment? Hearing none, all those in favor signify by saying 'aye', opposed 'nay'.

It 'most favored nation's status, and that is a federally designated status, a nation which has that designation does not fall under the requirements of this Act. In other words, items which are, produced items which are made in those nations that have a 'most favored nation's status with the United States, those items could be indeed be used in products used here in the State of Illinois. - Clerk O'Brien: "House Bill 1448, a Bill for an Act to amend the Environmental Protection Act. Second Reading of the Bill. No Committee Amendments."

Speaker Giglio: "Any Floor Amendments?"

Clerk O'Brien: "Floor Amendment #1, offered by Representative Doederlein."

Speaker Giorgi: "The Lady from Kane, Representative Doederlein." Doederlein: "Mr. Speaker. Amendment #1 was the Amendment that was asked for in committee. It just adds to private residence."

- Speaker Giglio: "Any discussion on the Amendment? Hearing none, all those in favor signify by saying 'aye', opposed 'nay'. In the opinion of the Chair, the 'ayes' have it, the Amendment is adopted. Are there further Amendments?"
- Clerk O'Brien: "Floor Amendment #2, offered by Representative Doederlein."

Speaker Giorgi: "Amendment #2."

- Doederlein: "Amendment #2 makes an additional, that any additional capital costs incurred, specifically to comply with this section, would be added to the fees."
- Speaker Giglio: "Any discussion on Amendment #2? Gentleman from Fulton, Representative Homer."

- Doederlein: "Yes, this is for environmental health. We have so many homes on the outskirts of the cities that are with septic systems."
- Homer: "Well, and I guess we'll discuss that on Third Reading. But all your Amendment does, would be allow the city to add, in its fee that it charges, those capitalized expenses. So, I guess your Amendment makes the Bill a little more palatable. I have no objection to your Amendment."

Doederlein: "Thank you."

Speaker Giglio: "Any further discussion? All those in favor of the Amendment signify by saying 'aye', opposed 'nay'. Ιn the opinion of the Chair, the 'ayes' have it. The Amendment's adopted. - Clerk Leone: "House Bill 838, a Bill for an Act to amend the Counties Code. Third Reading of the Bill."
- Speaker Giglio: "Gentleman from Rockford, Representative Rotello on House Bill 838. This is Third Reading."
- Rotello: "Mr. Speaker, and Ladies and Gentlemen of the House. This Bill will just bring an elected official of the county level in line with other elected officials in terms of having internal control of their own office. It will be like for hiring secretaries or hiring staff, this would be an opportunity for that, for anyone elected to that position, to have an opportunity to do so. The way it stands now, the person can be elected and then the county

- Speaker Giglio: "He indicates he will."
- Black: "Thank you. Representative, you have a very interesting Bill here. Let me ask you just a couple of questions. Would House Bill 838, as you have it drafted, would that perhaps run afoul of the Rutan decision of the Supreme Court?"
- Rotello: "No, I don't believe so, there, Representative."
- Black: "Well, who...I don't see that the Bill mentions anything about a personnel code, or a, a hiring procedure, I mean, are you asking us to give the county executive just carte blanche authority to hire whoever he wants for his staff, or her staff?"
- Rotello: "That's correct, Sir."
- Black: "Oh, in other words, without going through a personnel code or anything."
- Rotello: "Well, I, that's correct. We have to, it's up to the perogative of the elected official to do what they wish, just like we do here, Sir."
- Black: "Alright, okay, thank you very much, Representative. Mr. Speaker, Ladies and Gentlemen of the House. To the Bill, I must rise in opposition to this. From the Gentleman's questions, and I appreciate his veracity, I think he was to the point, but you heard what he said, you're going to allow a county executive to hire, without the advise and consent of the elected county board, without perhaps reference to a personnel code or any fair hiring

- Rotello: "I think that we have to be concerned about the entire State of Illinois, and good government for all the people of the State of Illinois and I think that this Bill addresses that."
- Wennlund: "Well, I don't think it addresses it at all...Winnebago County is about two hours drive from Will County, do you have relatives in Will County?"
- Rotello: "No sir. We expect to present this position in Winnebago County soon, though, hopefully."

Wennlund: "I'm sorry, I couldn't hear that."

Rotello: "We'd like to have this kind of position in Winnebago County as soon as possible."

Wennlund: "Well, why don't you wait 'til Will County voters

decide to adopt the county executive form of government before you decide that you're going to change the law that now only affects the County of Will?"

Rotello: "Well, Representative McGuire is a Co-Sponsor here and he's from Will County, Sir, and maybe he'd like to address it."

Rotello: "No, no he didn't, but he certainly agrees with it." Wennlund: "Who requested that this legislation be sponsored?" Rotello: "Governor Edgar."

- Wennlund: "Well, you've got some, got some friends in some real high places, but I seriously doubt that Governor Edgar decided that this was an appropriate legislative initiative by residents of your legislative district when it doesn't, in fact, apply to them and does not apply to any other county in the State of Illinois."
- Rotello: "Well, we think that the county executive form of government is good for county governments, and it's a good government Bill and that's why I hope you'd support it."
- Wennlund: "Well, Ladies and Gentlemen of the House, first of all, to the Bill. The Governor's position has been seriously misrepresented in the House chambers because in fact, I know that the Governor has not placed this as a legislative initiative that should be Sponsored by Representative Rotello. The Bill only affects the County of Will, which is my home county. It does not affect, whatsoever, Winnebago County, which is where the Sponsor's from. I rise in opposition to the Bill, and ask for 'no' votes. There's no necessity for this Bill at the present time."
- Speaker Giglio: "The Gentleman from Winnebago, Representative Giorgi."

Giorgi: "Representative Wennlund, in Mike Rotello's innocence,

But, for many years here, those of us that were from counties that were of the opposite party, always wanted to be able to hire our own attorney, our own clerk, our own help, so that, at least, you know, we have our lines of defense demarcated very well. He's doing the work of the Republican Party of Winnebago County. They're going to go to Chief Executive and they've owned the County of Winnebago for 100 years and it's not going to change. Let's help the boy along. In his innocence, let's help him."

Speaker Giglio: "Representative Regan."

Regan: "Thank you, Mr. Chairman, Members of the Board. The Bill indicates it takes power away from the county board members that've been elected in Will County. Period. It removes advise and consent. What are we trying to do here? One county affected, one administrator and executive that wants to become a dictator. I think it's bad legislation all the way down the line. Now, Mr. Gorbachev may get away with it in Russia, but let's not do it in Will County. I've, 'no' vote, please."

Speaker Giglio: "Gentleman from Will, Representative McGuire."
McGuire: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, I rise in support of this Bill, I, too, am from Will County and although I'm a freshman Legislator here, I think I've lived in Will County more than the other speakers, because I'm older than they are. But, I think the Bill is

a good government Bill and I don't think it makes any difference that the Sponsor is from Winnebago or 'Upper Cupcake'. Hartke: "Thank you very much, Mr. Speaker. I stand in support of this legislation. I think it's only common sense that if you're the executive director elected in your county, that you're most intimate personnel and staff around you, that you should have the right to hire those individuals. If you're saddled with the opposition's secretary, and so forth, you're actually hampered in what you can do and cannot do to administrate your new office. And I think it's a very good piece of legislation, and I urge all Members to vote for it."

Speaker Giglio: "Representative Rotello, to close." Rotello: "Thank you, Mr. Speaker. I would point out that we're talking about an elected executive here, and it's already

Speaker Giglio: "The Lady from Cook, Representative Currie."

Currie: "Thank you, Mr. Speaker and Members of the House. Within the last several years, we have provided, by legislation, the private insurance, health insurance plans, and that the state, through its own welfare department, will provide preventive mammography, to women at and over the age of 35, at regularly scheduled intervals, as per the guidelines set by the American Cancer Society. There is one group that we could affect that we haven't. and those individuals are covered by the provisions of House Bill 542. These individuals are those who are either the dependents or the employees of self-insured local governments in the state. And, if we were to pass House Bill 542, we would close that particular loophole in our existing coverage of preventive mammography for women under health insurance plans in the State of Illinois. The statistics from the medical community are pretty overwhelming, with respect to the value of these baseline mammography programs that you can find out about a breast cancer three years, with the mammography, three years before there would be any other kind of evidence that might be available to a physician on an office or other physical examination. The survival rates, with mammography, are substantially better than they are without, and as I say this is not a new issue, we have provided this kind of protection in legislation before this

- Body over the last three years, and I hope I will enjoy your support for passage of House Bill 542."
- Speaker Giorgi: "Any discussion? Gentleman from Vermilion, Representative Black."
- Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Giorgi: "She indicates she will."

- Black: "Thank you. Representative, I think you have a good Bill here, and I hope to be able to vote with you on this Bill, I mean that in all sincerity, but I think we do need to pay attention to the fiscal note that was filed on March 21. You, perhaps, have had ample opportunity to review that. It carries, a, according to this note, a very expensive impact, and I thought perhaps you could maybe refute those figures or tell us what you have, to refute that fiscal impact of about \$8,000,000."

Ι think that this fiscal note assumes rather, that all local governments are self-insured governments for purposes of In fact, the numbers that I've been able to health care. obtain from the Municipal League suggests that probably only about 100 local governments in the State of Illinois are self-insured and thus would be subject to the provisions of House Bill 542. Of those local governments, some, I am sure, already provide this kind of preventive care in their current employee and dependent health I believe insurance programs. So, there was а misunderstanding when the Fiscal note was drafted. I would point out, further, Representative, that the savings that

can be expected to local communities, by virtue of providing adequate preventive care, will be very substantial. The costs of care and treatment of an advanced breast cancer are very substantial, not only in terms of the likely loss of life of the woman who is its victim, but also in terms of the dollars that those health insurers are going to pay for extensive hospital stays. extensive chemotherapy, and radiation therapies. So, I would argue that instead of costing any money, passage of this Bill will save these local communities dollars that they will not have to spend at the end stages of individual lives."

Speaker Giglio: "Next discussion."

Black: "Mr. Speaker, may I continue, please? As I recall, the a, as I recall the Sponsor's discussion in committee, I think she a, and she reminded me, I think that, and I appreciate that, that IMRF automatically included everybody, and I think that's what skews their figures, correct? Okay?"

Currie: "That's my understanding."

- Black: "I'm glad that you pointed that out. The only other question I have is the intent of Committee Amendment #1. I'm still a little unclear as to what that does."
- Currie: "Thank you, Representative. The point of Amendment #lis to say that a local government which wishes to comply with this provision, may do so either by permitting insurance reimbursement to cover the cost of these preventative mammographies, or, it may directly, itself, provide the mammography at a site and location of its own choosing. In effect, there are some local governments, Cook County is a good example, that has its own hospitals. If Cook County wanted to provide this coverage at Cook County Hospital, the Amendment would permit that as an alternate way of meeting the requirements of House Bill 542."

McCracken: "Thank you. Will the Sponsor yield?"

Speaker Giglio: "She indicates she will."

McCracken: "Is there anything under current law that prohibits a local unit of government from providing this service, or from providing this coverage if it's self-insured now?"

- Currie: "No."
- Black: "This would pre-empt home rule and require them to do that? Is that correct?"

Currie: "That's right."

- Black: "Parlimentary Inquiry, will this require 71 votes as pre-empting home rule? I'm sure the answer is 'yes'. I rise on a point of order then."
- Speaker Giglio: "The Parliamentarian informs the Chair that this will take 60 votes, Representative McCracken."
- McCracken: "Okay. You know that part of the Constitution in our House Rule is so confusing, I honestly never know whether it is 71 or 60. Can someone explain the Rule to me?"
- Speaker Giglio: "Well, it's nice that you are raising those questions again, McCracken. The Chair loves to hear your voice. Believe me."
- McCracken: "Okay. Well, I'll tell you, I rise in opposition to this Bill, and I know that I don't speak for anyone anymore but, nevertheless I feel I have to stand up and make a stand. Apparently, there is no requirement that these local units of government not do this. Meaning, that if the local unit of government chooses to do it, it may do so. There's no prohibition. Why do we have to mandate it?

Why do we have to pre-empt home rule? If the units of government should be doing it, isn't they who should be dealing with the employees via collective bargaining? This will require the cities or villages or counties to pay for this. And really, I suppose that you would have to call this a mandate, and it's something we should fund. But, we don't fund these things. We stand up, and we say nice things, we go home, we tell people we've done the right thing, and we put it on the backs of taxpayers who largely fund those local units of government via the property tax, the very property tax which is the problem in so many parts of this state. Regan: "Thank you, Mr. Chairman and Members of the House. Will the Sponsor yield for questions, please?"

- Matijevich: "Yes, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 802 as amended is different than it was as introduced. As introduced, it would have provided a state enforced through the Department of Labor Occupational Health and Safety Act. The Bill has been amended so that it shall only affect the public sector, and it is now actually the Administration Bill, because of the Department of Labor not only prepared the Amendment, but now supports the Bill fully because it gives statutory authority for the Department of Labor to do what it has been doing under intergovernmental agreement with the Industrial Commission. As I said, it only affects the public sector, and I would appreciate your support for House Bill 802."
- Speaker Giglio: "Any discussion? The Gentleman from Vermilion, Representative Black."
- Black: "Yes. Thank you very much, Mr. Speaker. Will the Sponsor yield? Thank you. Representative, as amended in committee, is it your understanding and intent that this Bill, as amended, only affects the public sector?"

Matijevich: "That is correct, Representative Black."

Black: "It does...It is your intent then, for the record, that this Bill as directed by you and your intent does not have any impact or effect on the private sector?"

Matijevich: "That is correct."

Hoffman, M.: "There's no substantial increase in cost on this." Ryder: "When you were Mayor of a Municipality of northeastern Illinois, did you ever have any words about state mandates? Did you say anything about the wisdom of the Legislature?" Hoffman, M.: "We had many discussions on mandates."

Ryder: "Would you care to share with us of those thoughts about the wisdom of the Legislature making mandates and now you're feeling the brunt of this federal mandate? I'm sorry, Representative Hoffman, I didn't hear your response."

Ryder: "No, I didn't ask you that. Your thoughts concerning state mandates when you were representing a municipality."

substantive changes in any of the Medicare benefits."

Hoffman: "It's not a substantive change."

Schakowsky: "Thank you."

Speaker Giglio: "Gentleman from Fulton Representative Homer."

Homer: "Question for the Sponsor...Representative Hoffman, I think the Lady raised a good question. I don't know that you've answered it. Ah, does the Bill remove the prohibition against providing duplicated benefits? In other words, under current law there's a prohibition against selling the supplemental policies that duplicate benefits that are provided by Medicare. The synopsis and on page 3 of the Bill would seem to indicate that

- Hoffman, M.: "I...I'm sorry. What was the question? All these hecklers are here."
- Homer: "I was asking the John Cullerton question, that he always asks and I'm sure he will if it gets to the Senate. Is, you're creating a Class 3 felony, that's a maximum of 5 years in prison, I believe, and 10,000 fine or both, and the question is whether to commit that offense is a person required to have knowledge or must the offense be committed knowingly, before they can be guilty of that offense?"

Hoffman, M.: "Yeah, that's fine."

- Homer: "I'm sure some justice somewhere will take that quote as the basis for a learned opinion."
- Hoffman, M.: "Yes, I have my attorney standing by here. Knowledge is a condition."

Homer: "For both the criminal penalty and the civil penalty?" Hoffman, M.: "Yes."

Homer: "You might suggest to the Senate Sponsor that they might want to put an Amendment in if that Bill gets over to the Senate. Finally, is this...is this was this Lolita Dedricson's Bill?"

Hoffman, M.: "No, no, it wasn't."

Have all voted who wish? Mr. Clerk, take the record. On this question there are 113 voting 'yes', 1 votina 'no' 1 voting 'present'. House Bill...Representative McGuire votes 'aye'. Representative Representative Woolard, Woolard Satterthwaite. votes 'aye'. On this question there are now 115 voting 'yes' none voting 'no' and none voting 'present', and House Bill 1691, having received the required Constitutional Majority is hereby declared passed. House Bill 1797 Representative Levin. Levin. Representative Curran on House Bill 1831. Mr. Clerk, read the Bill."
- Clerk Leone: "House Bill 1831, a Bill for an Act to amend an Act in relationship to Federal Income Tax Credit. Third Reading of the Bill."

Speaker Giglio: "Representative Curran."

Curran: "Thank you, Mr. Speaker. House Bill 1831 sponsored by Curran, Kubik, Young, and Currie. Requires that employers, at least those employers that are required to provide unemployment insurance to employees, should be required to notify all employees along with the employees W2 Tax Withholding Form, that they may be eligible for Earned Income Tax Credits. As you know Earned Income Tax Credits

This Bill passed out of committee 10 to 0. It's on Short Debate. Be Ask for favorable Roll glad to answer any questions. Call."

Giglio: "Any discussion? The Gentleman from Will Speaker Representative Wennlund."

Wennlund: "Will the Sponsor yield?"

.

Speaker Giglio: "He indicates he will."

Wennlund: "Does the Department of Public Aid have a position regarding this Bill, Representative Curran?"

Curran: "To be honest with you, Larry, I don't know."

- Wennlund: "My understanding is that the Department is opposed to the Bill because it's a duplication of what the Department already does. My understanding is that the Department currently sends notices to AFDC recipients...that, in fact, they are eligible for a federal Earned Income Tax Credit."
- Curran: "Larry, I don't doubt that. This would, this would include however people who are not on AFDC, people who are employed and not on AFDC but employers would tell them that they may be eligible for these federal dollars. Seems to me to be a good thing for us to do, to let Illinois residents, who are employed, become aware that they may be eligible for some federal dollars."

Wennlund: "How does the employer know whether or not the employee would be eligible for those federal dollars?"

Curran: "...the...the notice could come from the Internal Revenue Service or from the Illinois Department of Public Aid." Wennlund: "So does the Bill only require the employer to notify

the employee if the employer has been notified that, in fact, the employee is eligible?"

Curran: "I don't think so, I think what the Bill requires is that employers will notify all employees that they may be eligible for the Earned Income Tax Credit."

Curran: "Larry, there is nothing I see here that indicates any new penalty because of this Act."

Wennlund: "Thank you, no further questions."

- Speaker Giglio: "Further discussion? The Gentleman from McHenry, Representative Klemm."
- Klemm: "Thank you, Mr. Speaker. Will the Sponsor yield for a question?"

Speaker Giglio: "Proceed."

- Klemm: "How often does the employer, Representative Curran, have to notify the employee that there may possibly be a tax credit?"
- Curran: "It would just be on that occasion, when they receive the W2 that they would be notified that they may be elgible for Earned Income Tax Credit, in other words, once a year."
- Klemm: "Well, now the W2 is the earnings report. Is that what you're talking about, that every time the employer gives an earnings report to the employee they would have to again notify them that there may be tax credits available?"

Curran: "I'm sorry, would you ask your question again?"

Klemm: "Every time the employer gives the employee a wz, an income statement if you will, they would have to notify that employee?"

Curran: "Are you asking me to explain it another way..."

Klemm: "Is that when they would do it?"

Curran: "Yes, yes, what happens is that ah, the notice furnished to employers or created by employers, to notify their employees shall state as follows: 'If you earned less than'

(and whatever the number of dollars would be for that year) 'last year and have at least one child you may be eligible to receive a Tax Credit from the Federal Government. A Tax Credit maybe a refund from the Federal Government for as much as' (and then those dollars would change from year to year), 'you must file a Tax Return to claim the Earned Income Tax Credit.' That language is in the law."

- Klemm: "So the employer would have to fill in this form annually and give it to each employee, is that right?"
- Curran: "I don't think this law is changing that, this law doesn't change what... the language that I simply read to you is already in the law and is not changed. What the employer would do then is notify the employee when they are providing their W2 Tax Witholding Form."
- Klemm: "Alright, so as I understand it you have a relatively simple form, in your opinion?"
- Curran: "Simple in that I've just read it to you, and it's one paragraph."
- Klemm: "And the employer would be required to have these printed up, they're not provided by any state department or Department of Revenue or anything else. It could be in any form they want as long as they say substantially what you're saying. Do they have to give it to the employee every time the year-end earning report is sent to the employer? The State of Illinois will they send it to you and I when we get our W2s from the state. Would that be a part of it? Are we considered employees?"
- Curran: "I don't know if we're considered employees. But if we are, according to this law, then we have to be notified as well."

Klemm: "Alright, so everybody's covered then right?" Curran: "Yes."

Speaker Giglio: "Further discussion. Gentleman from Sangamon,

- "Would you look at Floor Amendment #1? Lets see if we're Black: looking at the same language here. As I look at your Amendment #1, it appears to me that you've deleted provisions which specifically require the Director of Public Health to administer this program, that...furthermore, you say that you 'allow' the director to make grants rather than say that the director 'shall' make grants and then put these grants under the program established by this Act, so if I'm reading this correctly, it would appear that you are, you have, in fact, taken some of the mandated aspects of the program out by Floor Amendment #1."
- White: Okay, the grants would be permissive, but we would like for there to be someone who would coordinate these programs, and the Bill asks that the Illinois Public Health Department be that agency."
- Black: "If I could, Representative, I'm not sure what...what the fiscal note might have shown, do you have any idea what the cost might be?"

White: "It's very, very small based on what this Bill seeks to

What I'm really trying to say to you, Representative Black, is this: that there are a lot of products out there, a lot of food that the people need, want and desire and are eligible for them, and most of these dollars or this food that we're talking about, is through the federal government. support of this Amendment. You know, this a dramatically scaled down version of the original Bill. There was a lot of controversy surrounding the original Bill, and because of the scaled down version I would venture to say that there's a dramatic decrease in the amount of opposition among some of the people that have contacted some of the Members on this Bill. They may still be against, but it certainly is a dramatic decrease, and it certainly is a much different...Amendment, much different Bill than used to be. And I think it's important to note that...we as Members of the General Assembly are always dealing with freedom of information and public access to public records. We have a stake in the appropriateness of keeping court files open, so the general public knows what's going on in courts. We're not debating the underlying Bill or the merits of that, we're debating Floor Amendment #2, and what Representative Matijevich has done and seeks to do with this Amendment is to address at least many of the concerns that were raised in Judiciary I Committee, for fear that this Bill went too far. So that this Bill
