He served at the highest levels of the Pentagon for several years, before coming back to Illinois to be the Assistant Adjutant General. He handled several key assignments with the Joint Chiefs of Staff. He earned numerous awards and decorations during his career. including the U.S. Legion of Merit, several Air Force awards and many Illinois National Guard ribbons. More than anything though, General Napolitan enjoyed his service with the Illinois National Guard. We have here in the State of
