- Johnson: "Everyone knows the rules, and he's in violation of the rules already."

Johnson: "He can't explain the Bill."

Balanoff: "I didn't attempt it..."

Johnson: "... Balanoff."

Speaker Giglio: "Representative Balanoff."

Balanoff: "I never attempted to explain the Bill. I'm...I'm attempting to explain why I filed the Discharge Motion. At any rate, as I said, some Bills demand that we have... that

- Balanoff: "Yes. Yes. At any rate, I would move that we discharge the Judiciary II Committee and bring Senate Bill 200 to the Order of Second Reading."
- Speaker Giglio: "Any discussion on the Gentleman's Motion?

 Representative Petka."
- Petka: "Thank you very much...Mr. Speaker and Members of the House. I would strongly urge the Members to pay attention to exactly what is transpiring here. The Representative basically urges that he has not had an opportunity to have his Bill presented. Last week, the...House Judiciary Committee adjourned an hour and a half early; not because we wanted to adjourn early, we were open for business, there was nobody there. We called out for people to come and present their Bills. Today the Gentleman was at the Judiciary Committee hearing, in fact he was there for a whole hour. We always had a quorum; we had a quorum all the way up to the time we adjourned... There was adequate opportunity. Everyone was given an opportunity to the Bill if they chose. The Gentleman chose not to go through the committee structure, so for maintaining and preserving the integrity of the committee structure, vote 'no'."
- Speaker Giglio: "Further discussion? Gentleman from Vermilion, Representative Black."
- Black: "Yeah. Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. I think you all better pay

This Bill could have been heard in committee, as the two previous speakers have related to, but it was not called, it was not heard in committee, and should not be discharged from committee and I would recommend a 'no' vote on the Discharge Motion."

Speaker Giglio: "Representative Currie."

Currie: "Thank you, Mr. Speaker and Members of the House. in support of the Gentleman's Motion. T do support a I do support our committee system, but committee system. sometimes some Bills, some ideas, come along for which committee system does not work effectively. I think when we deal... in this Legislature, on issues of gun which is what this Bill is about, we find the committee the way of same, sensible system gets in legislative For that reason. Speaker Giglio: "Representative Johnson."

Johnson: "...I don't have a...Calendar here in front of me, but

legislative days for Representative Balanoff to come into

present his Bill. He didn't do it. He didn't get a

So if you respect the committee structure, vote 'no'."

Speaker Giglio: "Representative Lang."

Lang: "Thank you, Mr. Speaker, Ladies and Gentlemen. ...I rise in support of the Gentleman's Motion. The Gentleman stated

very clearly that he did come before the committee, but that he did not have a full committee. I would just urge everybody to give this child protection Bill a full hearing and vote 'yes'."

Speaker Giglio: "Representative Weaver."

Weaver: "Thank YOU very much, Mr. Speaker and Ladies and Gentlemen of the House. Ι, too, am a member of the committee, was in the hearing TOOTB yesterday Representative Black came in. He did have other Bills to present yesterday and in the press of time he indicated would attempt to get back and have the Bill called. it back, and ыe adjourned the committee. as simply as we can put it. He did attempt to present the Bill the committee simply ran out of work adjourned before he had the opportunity to get back. I do think it deserves a fair hearing. Discharge... proper way to handle it, and I think a green vote is the right vote."

Speaker Giglio: "Representative Black to close."

Black: "Thank you very much, Mr. Speaker. Just to eliminate any confusion, the first week this Bill was posted, I agreed not to call the Bill because the city colleges of Chicago were not happy with the rate incorporated in this Bill, and I asked the city colleges of Chicago to get this worked out with the community colleges in the State of Illinois. As far as I know, they still have no agreement. I...I held

 you want to speak on this?"
- Satterthwaite: "Well, I was simply going to say that it is the custom in the Higher Education Committee, if a particular Sponsor is not available, that they give the responsibility to somebody else serving on the committee to handle the Bill for them. It was my understanding at yesterday's hearing that Representative Black did not intend to call this Bill. There is a vehicle Bill dealing with community colleges out of committee that can be used for this purpose, so we're not really going to lose anything if this Bill stays in committee, and I would suggest that a red vote is appropriate on the Motion."
- Speaker Giglio: "Representative Novak, did you have your light on before he closed or after he closed?"

Novak: "Pardon? Will the Sponsor yield?"

Speaker Giglio: "Well, the Gentleman closed, but he indicates he's courteous. He'll yield. Proceed."

Novak: "Representative Black, just one quick question. What does this do to the poor...poorer community college districts downstate?"

Black: "I believe that all community college districts in the State of Illinois are in absolute agreement with this Bill as it exists, except the city colleges of Chicago."

Speaker Giglio: "Representative McGann."

McGann: "That's alright."

Speaker Giglio: "Alright. The question is, 'Shall the Motion to

Black: "Speaker, I'd like to rise to a point of personal privilege."

Speaker Giglio: "Proceed."

The week before I agreed not to call the Bill, hoping that the city Chicago and the other 49 community colleges colleges of could reach an agreement on what is, in effect, \$3,500,000 disagreement. I made an attempt to get back to call this Bill yesterday. Speaker Giglio: "The question is, 'Shall the Gentleman's Motion prevail?' All those in favor vote 'aye', opposed, 'no'.

Representative Matijevich."

Matijevich: "Your Bill. Who's chairman of committee?"

Saltsman: "I'm chairman of the committee."

- Hartke: "Thank you very much, Mr. Speaker, Members of the House. Senate Bill 1361, as many of you know, is a Bill very near to my heart. We worked very hard, and I've lobbied many of you to support me on this Override Motion. at noon, Senator Joyce and myself and Illinois Petroleum Marketers, the Illinois Petroleum Council and the Ethanol Producers of Illinois, the Corn Growers Association, the Farm Bureau of Illinois have jointly agreed today to work on a compromise between now and June 25th to create a working committee and legislation for the production of ethanol incentive extensions and the ultimate use of more ethanol in Illinois. At this time I will not seek a vote on the ethanol mandates issue."
- Speaker Giglio: "Take it out. Take it out of the record, Mr. Clerk. Supplemental Calendar #1 on Motions appears Senate Bill #1, Representative Homer. On... on these...on two issues, the vote is 71. Vote is 71. This is not on the regular Calendar, so these two items will require 71 votes.

Representative Homer."

Homer: "Thank you, Mr. Speaker. Senate Bill 1, a Bill that would move the primary date from the...third Tuesday in March to the second Tuesday... to the first Tuesday after the second Monday in September for the year 1994 only, offered in Senate by Senate President Phil Rock, was heard in the Election Law Committee a week ago, where both Senator and I presented testimony. At that time we were told by the committee chair that no vote would be taken, but that testimony would be allowed on that date. The clear understanding was that we would be entitled to vote today. ... I checked with the committee after the committee adjourned today and was informed that no vote was taken. I think that was a clear violation of my right to have a vote on the Bill. The clear indication was that unnecessary for either the Senate or the House Sponsor to return the following week for the vote. We fully relied upon an expectation, to our detriment, that the committee would, in fact, entertain a vote on the Bill. Ыæ denied the opportunity to have a vote on the Bill when we presented it a week ago, and I feel that our rights were violated and that this Body should have the right to vote the merits of the Bill. It's а very simple, straightforward Bill, be voted for up or to...disallow us this opportunity is violating our rights under the rules of the House and the committee procedures,"

Speaker Giglio: "Representative Myron...Lee Olson...Myron Olson.
I'm sorry."

Olson, M.: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I'm vice-spokesman of the Elections Committee where Representative Homer brought this measure. ...There is plenty of opportunity...to listen to testimony. We heard about the Bill not once; we heard the Bill twice.

A...caucs check on both sides of the aisle indicated little or no support for this measure. As a consequence I think he's had plenty of opportunity to have this Bill heard, and we rejects the Motion for Discharge. The fact of the matter is, the Democratic Caucus, as far as elections are concerned, has done very well in recent years in bringing things to the table, and I think this is what their intention was. I oppose the Discharge Motion."

Speaker McPike: "The Lady from Lake, Representative Stern."

Stern: "Mr. Speaker and Members of the House, 1 opposition to the Motion. The Gentleman had a total hearing on this Bill last year...last week, ...It is my understanding that a second Roll...that a Roll Call, excuse is no t given to a Representative unless the Sponsor appears and asks for it. We're in Session this morning, discussed other issues;...the Bill was not called for a Roll Call vote, and I don't think committee should be discharged. I urge a 'no' vote on this."

Speaker McPike: "Representative Homer, to close."

Homer: "Thank you, Mr. Speaker. That would be fine had the Committee so instructed me of the necessity to return. What we were asking for last week was a presentation of our Bill and a Roll Call vote. We were told they would allow the for testimony to be given, but that there would be no opportunity to give a Roll Call vote last week. We relied on good faith that we would be given that opportunity this week. We were not, and I would urge the...Members to vote to discharge the Bill."

Speaker McPike: "The question is, 'Shall the Gentleman's Motion prevail?' All those in favor vote 'aye', opposed, 'no'.

The voting is open. This requires 71 votes. Have all voted who wish? Have all voted

"Thank you, Mr. Speaker. I would like to briefly explain Homer: my vote. You know, this Election Law Committee has basically bottled up all election initiatives, and this would be the one and only opportunity that you would have what I would suggest 90, 95 percent of do constituents want us to do, and that is to restrict and limit and shorten the campaign season in order to reduce the costs of campaigning and to allow for us to attend to our duties. If you don't vote to hear this Bill, you're voting for the status quo, and I think that's a shame because our voters and our constituents are going to be very unhappy that we haven't taken the necessary action to reform our election system. I urge a 'yes' vote."

Speaker Giglio: "Representative Myron Olson, one minute to explain your vote."

Olson, M.: "May I explain my vote briefly?"

Speaker Giglio: "You may."

Olson, M.: "In response to Representative Homer talking about the September primary, a principal and overriding concern is getting absentee ballot applications and ballots to people overseas. I had a transportation offer that also serves Dick Mautino as ship out of Fort Sheridan on December 28th; they received no mail as of February 12th. That's good enough reason there. Election contests are another reason, but I don't want to run the time."
