Judkins: "Mr. Speaker, Honorable Representatives and guests. I'm very pleased to be here today. Particularly, I want to thank you for the Resolution which was sponsored by Tom Ewing and which was voted through your House and through the Senate. I'll treasure that the rest of my life. I've seen this room on t.v. many, many times. I never dreamed that I'd be in it. I'm the mother of...the oldest of five children born in a parsonage. The Depression came during my years in high school, but with scholarships, loans, a money gift and working in the college library, I was able to graduate from MacMurray College with a degree in Home Economics. I taught for three years. Oh, thank you. In when you got married you were not employed those days, anymore. So, at the end of three years, my husband and I bought the local drugstore in Roberts, which had been there for 60 years. There was no drugstore for 15 miles on any side, and I began to become a registered pharmacist. We kept the store for 30 years and, with the change in traffic, we closed it. But, I continued to do relief work for my friends in the neighboring towns. So, I put a total of 47 years into pharmacy. I have two sons. The mothers judge you partly on your children, of course. My older son. Rodney, is graduate of the University а of Illinois/Industrial Education. He has his MBA from Stanford as a Sloan Fellow, has served two years in the Peace Corps and been with AT&T. After the divestiture, he went with AT&T International. he was director of international marketing for both Europe and the Orient and is now the president or director of all North America for telecommunications. My younger son is Norman. And he was quite the boy in high school but he graduated from ISU, got his administration. He started as a new graphics teacher in Addison Trail High School in DuPage County. He moved up

to administration. He has his doctorate without his written work and is now the assistant to the superintendent of one of the districts in DuPage County, which has Addison Trail Willowbrook and High Schools. I have four grandchildren. Now, I want to tell you something and I want you to listen to this very well. Among other things, the American Mothers Incorporated have an art show. They have a very fine collection of things brought in by members: sculpture, paintings and so forth. They give three \$1000 prizes and two Illinois women won those. So we got two of the three \$1000 prizes. They were ladies from Hoopeston and Rossville. At the end of 47 years of marriage, I lost my husband, and, some years later, to my surprise, I married again. The things that really concern me, that I want to work on during the time that I am active in Illinois with the mothers, are the young people. I am very upset to learn that one-fourth of our girls, under the age of 15, are sexually active. That as a pharmacist, we have 2.5 million new cases of VD among teenagers every year. We need to find, in your districts, the ladies who are outstanding as mothers, who would be candidates for mother of the year. And, so if you would see to it that some of us get these They must be 45 years of age, their youngest child names. 15 years of age and that they are active. They are judged on their involvement in religion, education, their civic affairs and how the kids turned out. Thank you for having me."
