Matijevich: "Let the record reflect the excused absence of Mary Flowers."

Speaker Giorgi: "Thank you, Representative. Representative Kubik."

Kubik: "Yes, Mr. Speaker. Let the record reflect the excused absence of Representative Klemm."

Speaker Giorgi: "Let the record show...so note. One hundred and sixteen Members being present, there is a quorum present. The House is in order. Representative Capparelli on House Bill 678."

Capparelli: "Mr. Speaker, I would refuse to accept..."

Speaker Giorgi: "Senate Bill 678. Senate Bill."

Capparelli: "...the First Conference Committee Report on 678 and ask for a Second Conference Committee. Thank you."

Clerk O'Brien: "Supplemental Calendar #1 is being distributed."

Speaker Giorgi: "House Bill 121, Representative Currie. Do you wanna run with that? Out of the record. Representative Steczo, do you wanna go with House Bill 1970? House Bill 1970, Mr. Clerk."

Steczko: "Thank you, Mr. Speaker. I would move for the adoption of the First Corrected Conference Committee Report on House Bill 1970. The provisions of this...this Bill are the same as they were when they passed the House and the Senate, and these are...provisions that have been specifically requested by the Department of Professional Regulation to deal with some of the Acts that they deal with, so Mr. Speaker, I'd answer any questions, and, if not, would ask for a favorable vote."

Speaker Giorgi: "Is there any discussion? First Supplemental Calendar, this is Corrected First Conference Committee Report, House Bill 1970. There being no requests for discussion, the question is, 'Shall this Bill pass?' All in favor signify by voting 'aye', and those opposed 'nay'. Voting is open. Have all voted who wish? Have all voted who wish? On this...Take the roll, Mr. Clerk. DeJaegher: "Thank you, Mr. Speaker, Members of the General Assembly. One fifty-one is similar to...1101, which...deals in LSD. There has been a Conference Committee Report all opposition seems to be removed from this particular Bill. There's been quite a bit of work for it, and for that reason, I ask for your support in passage of this legislation."

Speaker Giorgi: "Representative Black, on Senate Bill 151."

Black: "Thank you...thank you very much, Mr. Speaker. Inquiry of the Chair. Gentleman was making reference to a Conference Committee Report, and we don't have that Conference Committee Report in this file. If somebody could, perhaps, get it over to us or... Also, many Members...do not have the Supplemental Calendar, either."

Speaker Giorgi: "Your objection's well taken, Mr. Black. The Bill will be taken out of the record."

Black: "Thank you."

Speaker Giorgi: "Representative McAfee, on Senate Bill 728. Okay."

McAfee: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I move for the adoption..."

Speaker Giorgi: "Hold it, Representative. Just a moment. Representative McAfee, on Senate Bill 728."

McAfee: "Thank you again, Mr. Speaker, Ladies and Gentlemen of the House. I move for the adoption of Conference Committee Report #1 on Senate Bill 728. The Conference Committee Report, basically, cleared up some of the concerns that were raised by the Chicago Bar Association, Illinois State

Bar, and we have, also, passed this by the Commissioner of Banks and Trust Companies. I would like to state for the record with regards to the notice, and this deals with legislative intent...the notice which is going to be sent to the income beneficiaries, it is the intent of the legislation that the Commissioner of Banks and Trust Companies should consider issuing guidelines or promulgating rules for corporate fiduciaries governing the form and content of the notices required to be given as outlined in this Conference Committee Report in order to assure consistency throughout the State of Illinois, in regards to providing such notice, and this has been approved by the Commissioner of Banks and Trust Companies. I know of no opposition."

Speaker Giorgi: "Representative Black, on Senate Bill 728."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Giorgi: "Yes."

Black: "Representative, I...I think I'm in agreement with you. I don't think there's any opposition, but for the benefit of those Members who should, perhaps, take a look at this because the synopsis says we are repealing the prudent-person rule, and we all know what has gone on in banking and savings and loan, you may wish to enlighten the Body on if...if you are...doing away with the prudent-person rule on investments, what are you replacing it with?"

McAfee: "Representative, this is now referred to as the prudent investor rule. This, basically, reflects the work of the Chicago Bar and the Illinois State Bar, as well as the Corporate Fiduciaries Association, as well as the input of the Commissioner on Banks and Trust Companies. What we're really trying to do here is, based upon the second

restatement as it deals on the American Law Institute with respect to creating the...looking at the portfolio as a whole, as the corporate feduciaries would be investing in...the corporate or the trust property. In other words, it would not be looking at one investment but looking at the portfolio as a whole, and this is, up to this point, had bipartisan support."

Black: "Okay, then...there...there isn't anything in here that some would construe as loosening the regulatory provisions so that a financial institution could over invest, let's say, in junk bonds or...investments not backed by the full faith and credit of a governmental entity; that's certainly not your intent in this Bill, correct?"

McAfee: "No, Representative, it's not. Quite the contrary. This provides the flexibility and, also, sets out safeguards such that that will not be the intention of this legislation at all."

Black: "Well, Representative, I thank you for your answers, because I think that's put some of the Member's concerns at rest. You've done an excellent job, and I certainly plan to support your...your Bill."

Speaker Giorgi: "The question is, 'Shall Senate Bill 728 pass?' All those in favor will signify by voting 'aye' and those opposed by voting 'nay'. Voting is open. Have all voted who wish? Have all voted who wish? Take the record, Mr. Clerk. Hultgren: "...Representative, on page 2 of the Conference Committee Report, lines 3 to 8, there is an exception for services mandated under Section 356-M of the Insurance Code. My recollection is that we passed that similar exemption yesterday or maybe Saturday. Are we doing the same thing twice?"

Balthis: "I believe that was added to the two different reports, just to make sure it got passed, yes."

Satterthwaite: "Mr. Speaker, many of us have not been able to find the Amendment that just went on. I wonder if the Gentleman would give us some idea of the substance of the Bill, now?"

Speaker McPike: "On the Gentleman's Motion, Representative Hultgren."

Hultgren: "Representative, do I understand that the...provisions of this Bill would permit criminal penalties to be doubled...doubled for any person convicted of delivering or possessing cannabis or controlled substances in a work place situation? Is that right?"

DeJaegher: "Yes, Sir."

Hultgren: "So, for example. In the Workmen's Compensation Act, where I understand it defines work place, would that include a farm that if there's possession or delivery of controlled substances in a farm, which would be a business or a work place setting, that that would mean that the penalties would be doubled?"

DeJaegher: "When I think...I think when we refer to work place, I think, basically, they more or less distinguish common work places, and I think that they...they want to resolve the fact that they don't want that spread in the work place. I think that provision is put in there for that reason."

Hultgren: "Thank you, Representative."

DeJaegher: "Well, there's also a provision in there for a fining of a...from \$5,000 to \$15,000 that carries a...term of...4 to 15 years and a fine up to \$250,000."

Lang: "Well, thank you for answering the questions. To the Bill. I rise in opposition to this. I think this Bill needs a

If you represent a university community, if you represent a variety of communities in this state, where the...for...for decades, if not centuries, the private sector has been providing low-cost, reasonable alternatives and services to state government, to the universities and otherwise, for about a third of the cost that the state would, the last thing we need to be doing is to creating an agency that has, among other authorities, the authority to negotiate contracts with lodging, travel and transportation providers, and, ultimately, to provide recommendations that would dismantle a number of private providers, a number of providers in the private sector and eliminate those businesses and all the people they employ and all the people that do business with them. Is that correct?"

Younger: "That is correct, Representative McNamara, but the...provisions of the bailout Bill did not provide for any kind of new income for the City of East St. Louis, and this Amendment is necessary so that the...so houses can be built, and...it is very important for there to be new income so there can be economic growth and economic development. We're...going to be the subject matter of a light rail complex and there is a need for development around. There is a tremendous opportunity for business development around light rail, and so it is very important to exempt...these funds...these TIF district funds from that agreement, and it will, ultimately, lead to a stability of the economics of the city so that it can be in a better position to repay debt more quickly, and so that's the point."

McNamara: "Okay. Let me...let me just see what it says. It says, 'accept the payments of money equal to the net state sales tax increment and deposit it into municipalities special tax allocation fund. Now, what my understanding is, is that those funds were issued with the full faith and credit of the State of Illinois based upon the agreement' that was signed that said that the dollars would be pledged, and that the tax increment financing authority would be able to try to straighten out the financial areas of East St. Louis, which we're all trying to do, and I understand it of what you're trying to do because you've worked very...very hard and diligently for your district.

My problem is this, that an agreement, my understanding is, that the agreement has been agreed to, has been signed and it is in effect, and now we're coming back after the agreement and taking some of those funds out of that agreement by law. That seems to me that we are using the law to disturb a contractual agreement that was made, and I, reluctantly, have to oppose that type of legislation. I do not think it is either prudent or wise for us to do this because what, in effect, it does do is it calls into question this General Assembly calling on making any further agreements with any towns in the State of Illinois, and I think that that is a terrible thing for us to be under that thing that we can come back later and change those agreements. I reluct I...understand that the Representative work's very difficult, does a lot of work for her...her district, and, in this case, I think it's bad legislation, and I would urge that this report be rejected."

Young: "Well, in response I would say that there is more than an adequate amount of intercept...moneys under the various taxes that come from the state to the municipality. There has to be economic growth in order to increase the tax base of East St. Louis, and the only way that that can happen is through...business development. Businesses will develop in and around the light rail facility if there is a...this change."
