Representative Homer, House Bill 1415. Representative Curran House Bill 1499. Representative Representative Keane in the chamber? Capparelli, Senate Bill 908. Representative Obrzut. page 3 of the Calendar, Senate Bills, Third Reading, appears Senate Bill 1421, Representative Wyvetter Younge. Read the Bill, Mr. Clerk."
- Clerk O'Brien: "Senate Bill 1421, a Bill for an Act in relation to tax increment allocation redevelopment. Third Reading of the Bill."
- Speaker Giglio: "The Lady from St. Clair, Representative Younge."

 Younge: "Thank you, Mr. Speaker. Senate Bill 1421 is an Agreed

 Bill at this point. It effects only East St. Louis. And
 the only provision is to extend the planning and bonding
 time for the tax increment finance district, from 23 years
 to up to 35 years. Everything else has been taken out of
 the Bill that was controversial. And I move for the
 adoption of this Bill...passage."
- Speaker Giglio: "Any discussion? The Gentleman from Cook, Representative Kubik."
- Kubik: "Thank you, Mr. Speaker. I rise in support of the Lady's Motion. We have made considerable changes in this Bill with some Amendments. And it's a good Bill. I would urge your support of Senate Bill 1421."
- Speaker Giglio: "Any discussion...Further discussion? Hearing none, the question is, 'Shall Senate Bill 1421 pass?' All

Ronan: "Thank you, Mr. Speaker. House Bill 1960, the Conference Committee Report, is another attempt by the Illinois General Assembly to get a transportation Bill passed this Session. Every project that's on this Bill has passed out of the House unanimously. We're trying to get the Senate to concur with something. As usual, the Senate is absolutely dead wrong on how they do government. As far as I'm concerned we should abolish the Senate but, if we can't get that accomplished, let's at least pass House Bill 1960. To let them know that we're trying to do something for transportation policy. Be glad to answer any questions."

Speaker Giglio: "Any discussion? The Lady from Kane, Representative Doederlein."

Doederlein: "Yes, would the Sponsor yield for a question?"

Speaker Giglio: "He indicates he will."

Doederlein: "I think it's a good idea but I do have some questions on page 71, with the high speed rail. Would this

Representative. Does not. We did quick take, remember, I
did that last week. You didn't like it last week any more
than you like it this week. But I did it last week to you
already, so this has no quick take provision in it."

Doederlein: "Well, we had that in another Bill, right?"

Ronan: "Yeah, I passed quick take out of here last week, which you voted against, but this week we're not going to try to do it again. I only like to do things once a Session, since I did it last week, why do it this week?"

Doederlein: "So, with the other Bill and this one combined it could be quick take?"

Ronan: "Excuse me, Representative?"

Doederlein: "With the other Bill and this one, this Bill."

Ronan: "No. No. The other Bill dealt with highway projects, this is a high speed rail project. So this...this no...What I want you to understand is this has nothing to do with quick take provisions. So, that...this has...your...your...Your question is, this does not deal with quick take provisions in that part of the statute."

Speaker Giglio: "Representative Deering."

Ronan: "So you can vote for it."

Speaker Giglio: "Representative Deering."

Deering: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Giglio: "Indicates he will."

Deering: "One question, Representative Ronan. On the front page,

Bill 523 allows for a referendum to levy taxes for salaries

is this a front door or back door referendum?"

Ronan: "Front door."

Deering: "Thank you."

Speaker Giglio: "The Gentleman from Cook, Representative Kubik."

Kubik: "Would the Sponsor yield?"

Ronan: "Sure."

Speaker Giglio: "Indicates he will."

Kubik: "Representative, you indicated in your initial remarks that everything in this...everything in this Conference Committee has passed this House already. Is that correct?"

Ronan: "Correct."

Kubik: "Correct me if I'm wrong, but on page 58 of the Bill, there is a provision which would limit the Pollution Control Board from placing...adopting any rules on tarps on trucks. And I don't recall passing a Bill which would do that out of this House. So, that seems to me to be a new provision. Perhaps you could shed some light on that."

Ronan: "Representative, I'm sorry to say you're wrong on that, this was House Bill 401. It passed out of the House unanimously with your support. And, consequently, we're looking forward to your support again. You voted for it once this Session."

Kubik: "Well, I guess, maybe it was one of those Bills on the Agreed Bill list that we should look a little bit closer at. And I'm looking a little bit closer at this one and I will be in opposition to this particular Bill."

Ronan: "Representative, it wasn't on the Agreed Bill list that was part of the omnibus Bill process in the House

Transportation Committee. And it was supported by every Republican Member on the House Transportation Committee, led by one of the finest Minority Spokesmen's ever in the history of this state, Representative Hensel. So, if you've got a problem, you should go talk to Representative Hensel."

Wennlund: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Preston: "Thank you, Mr. Speaker and Ladies and Gentlemen of the This Senate Bill 1564 is the Charitable Trust and Solicitation Act of 1991 that has undergone substantial discussions. And to my knowledge now all the pertinent parties, the veterans organizations, are all in agreement. This Bill requires paid, professional fund raisers to report to the Attorney General the percentage of charitable donations that go to administrative and public education expenses and the percentage that actually goes to the charity for its charitable purposes. It requires the charitable organization to annually account to the Attorney General for the receipt and expenditure of charitable funds. And it increases the reporting threshold from \$100,000, so that small community based \$50,000 to charities will not be burdened with accounting and requirements. I'd be glad to answer reporting questions concerning this. It's been debated and discussed ad nauseam. But the organizations involved have been party to the negotiations and, as I said, to my knowledge major veterans organizations have all signed off on this Bill."

Speaker Giglio: "Any discussion? Hearing none, the question is,

And we have an immediate effective date for the entire report. Be happy to answer any questions and move the adoption of Conference Committee Report #1."

Peterson, 'aye', Bill Peterson. on this side okay? 'aye'. Everybody Representative else? 'no'. Obrzut, 'aye'. Anybody Steczo, Representative Deuchler, 'aye'. Matijevich: "Well, you've had enough time to think about You've got now until 4:00 to think about all of that. you've got all the time in the world. We've been spending a lot of time in Springfield here doing virtually nothing, waiting for the Governor to act, waiting for the Governor, I guess, to get national media attention. I guess that's what he was after. We Legislators are getting blamed for being in Springfield! We don't want to be in Springfield! We want to be home! You tell me who wants to be in...You give me one good reason why you want to be in Springfield when you don't have to be. Give me one good reason. Governor lives here! He can stay here all he wants! Now I know it hurts! I know it hurts! But you've got 'til 4:00 to think it over. You've got some time now. You've been wasting enough time! You've got some more time to waste! Go ahead, waste some more time!"

Speaker Giglio: "Alright. Representative Black."

Black: "Thank you very much, Mr. Speaker. No one in this chamber wants to go home anymore than I do. But I am asking the Chair, I am asking the Chair, are you ignoring our request for a conference?"

Speaker Giglio: "No, I'm not."

Black: "Alright, I would further submit to the Chair, that on the Calendar dated Thursday, July 11th, 1991, First Special

Speaker Giglio: "He was trying to make it but there was to much hollering on that side of the aisle. The Chair couldn't even here you."

Black: "No, he wasn't!"

Speaker Giglio: "The Chair couldn't even here you, Representative Black."

Black: "No!"

Speaker Giglio: "Representative Olson. Olson."

Olson: "Thank you. Thank you, Mr. Speaker. Thank you, Mr. Speaker. In reply to previous remarks, I believe the Constitution of this state says, that the General Assembly appropriates. The Governor either goes up and down on our actions. Any inaction down here falls right back on all of us in this chamber. We're here to do the appropriation process."
