- Speaker Madigan: "Roll Call for Attendance. Representative Hannig. Mr. Hannig."
- Hannig: "Yes. Thank you, Mr. Speaker. Let the record show that all Democrats are here today."

Speaker Madigan: "Mr. Cross."

- Cross: "Thank you, Mr. Speaker. We're all here today, as well." Speaker Madigan: "Let the record show that there are no excused absences. Mr. Clerk, take the record. On this question there are 118 Members responding to the Attendance Roll Call. There is a quorum present. Mr. Clerk. Representative Younge. Representative Wyvetter Younge."
- Younge: "Yes. Thank you, Mr. Speaker. The Calendar shows that the Appropriations-Education Committee is to meet at 8:00 a.m. tomorrow morning. I'm changing that to 9:00 a.m., because there are witnesses that are coming long distances. So the Appropriations-Education Committee will meet tomorrow morning in Room 118 at 9:00 a.m. rather than 8:00 a.m."
- Speaker Madigan: "Representative, there's been a lot of noise in the Chamber, could you repeat that. Thank you. If the Members could give their attention to Representative Younge. Please."
- Younge: "Thank you, Mr. Speaker. The Appropriations-Education Committee is scheduled to meet at 8:00 a.m. tomorrow morning. I am changing that to 9:00 a.m. Thursday morning, rather than tomorrow morning. It's Thursday morning at 9:00 a.m. rather than Thursday morning at 8:00 a.m. Thank you."

Speaker Madigan: "Committee Reports." Clerk Rossi: "Representative Morrow, Chairman from the Committee

- Jones, S.: "Mr. Speaker, Public Utilities will be cancelled until next week, Tuesday, because the Sponsor of the Bill is not ready to call it. So, Public Utilities will be cancelled until next week, Tuesday."
- Speaker Madigan: "The Lady has announced that the meeting of the Public Utilities Committee scheduled for 2:00 this afternoon has been cancelled. Supplemental Calendar Announcement."

Clerk Rossi: "Supplemental Calendar #1 is being distributed."

- Speaker Madigan: "On the Order of Supplemental Calendar #1 there appears Senate Bill 87. Mr. Ryder. Mr. Clerk, what is the status of the Bill?"
- Clerk Rossi: "Senate Bill 87 amends the General Obligation Bond

Speaker Madigan: "Are there any Motions?"

Clerk Rossi: "No Motions."

- Speaker Madigan: "Third Reading. Representative Davis, are you seeking recognition? Thank you. Senate Bill 143...143."
- Clerk Rossi: "Senate Bill 143. A Bill for an Act making appropriations, supplemental appropriations, and legislative transfers. Second Reading of this Senate Bill. No Committee Amendments. No Floor Amendments. No Motions filed."
- Speaker Madigan: "Third Reading. The Chair is prepared to adjourn. There will be a Democratic Caucus. Mr. Hartke."
- Hartke: "Yes, there will be a Democratic Caucus in Room 114 immediately upon adjournment."

Speaker Madigan: "Mr. Black."

Black: "Yes. Thank you very much, Mr. Speaker. An inquiry of the Chair."

And then concerning the Rules to be used in conducting the meeting. The Committee, since it's a Committee of the House, will be governed by the Rules of the House as they relate to Committees. And if they are silent, then Robert's Rules will apply. Is there anything further to come before the Body? Mr. Cross."
- Cross: "Thank you, Mr. Speaker. As I'm looking through the Calendar today, I notice that on House Bill 66 I am showing as the lead Sponsor on that Bill. About two weeks ago I sent in a slip taking my name off House Bill 66. And I don't know if there was a mistake on the Calendar, but if the Record could reflect that I don't wish to be the lead Sponsor on 66."
- Speaker Madigan: "The Clerk advises me that Mr. Dart has resumed sponsorship of the Bill."

Cross: "Thank you, very much."

Speaker Madigan: "Representative Biggert."

- Biggert: "Thank you, Mr. Speaker. My question is very similar. On House Bill 165, I filed a slip to remove my name, and it was not posted in the Calendar."
- Speaker Madigan: "The Clerk advises me that Mr. Dart has resumed sponsorship of the Bill."

Biggert: "Thank you, very much."

Speaker Madigan: "Thank you. Representative Currie."

Currie: "Thank you, Speaker. I move that the House convene as a Committee of the Whole tomorrow at 8:30 a.m. in order to

Speaker Madigan: "Mr. Black."

Black: "Yes. Thank you very much, Mr. Speaker. A question to the Motion if I might. The Lady's Motion is to create a Committee of the Whole, then would that not have to be posted? And might we be, I wonder if we wouldn't have to waive some posting requirements if we are creating a Committee of the Whole on Tuesday and meeting as such on Wednesday."

Speaker Madigan: "Representative Currie."

- Currie: "Thank you, Speaker. We have posted for this Committee of the Whole and my Motion isn't to do this as a sort of new topic, but merely that we do convene as a Committee of the Whole tomorrow."
- Black: "Representative, I think for purposes of expediency we'll go along with you on this. I think we do have a point that we could make if we chose to do so, but I'm sure witnesses have been notified and I think all of us want to hear ideas and concepts that we need to wrestle with in the coming months. Would you care to comment on that interpretation?"
- Currie: "Thank you. I appreciate your graciousness in moving this idea forward, but I think the distinction is that we are not creating a Committee of the Whole. We are merely 'convening' as a Committee of the Whole. I think that

- Black: "Well, one further question then. In an earlier Inquiry to the Chair it was relayed to us that the House Committee Rules shall function tomorrow, and in the absence of any particular Committee Rule, Robert's will then be the limiting or deciding factor. It's my understanding of Committee Rules that there is no ready mechanism to tell a witness that he or she only has five minutes or two minutes. Correct me if I'm wrong, but witnesses then would probably, under existing House Rules, be able to offer testimony for as long as they thought necessary."
- Currie: "Well, Representative, all the witnesses we will hear from tomorrow have been invited to testify, and they are all most anxious to do so. They are really thrilled at this opportunity to share good information with all of us. And, as part of the invitation, because the time schedule is so tight, they were all asked please to keep their remarks brief. So I don't, there may be an issue Representative, but I don't think any of our witnesses tomorrow will raise it."
- Black: "Well thank you very much, Mr. Speaker and Majority Leader. We appreciate you listening to our concerns on this issue. We look forward to the activities tomorrow, and if your legal counsel, outstanding young man that he is, will have his copy of Robert's, I promise that I'll have my copy of Robert's and we will proceed with the
