- Black: "It happens very seldom. So, what this does, then the airport will just continue to operate. It isn't going to

- Madigan: "Mr. Speaker and Ladies and Gentlemen of the House, this Resolution would constitute an Amendment to the Rules, and it provides for three changes in the Rules. #1) The Rules for this Session provide that Members can file statements with the Clerk that would speak to legislative intent. A point was raised during the debate on the Rules which argued that if a statement was filed with the Clerk and a Member was named in that statement the Member named in the statement ought to have an opportunity to prepare a

response before the entire document was made public. So this Amendment would provide that where a Member is identified in the statement they will have one Legislative day or three business days, whichever is shorter, after notification by the Clerk to file a response. #2) This Amendment would provide that Members must always be on the Floor when they are voting, which was a provision of Rules of the last Session and which is also a Section of State Law. And lastly, this would provide that the Committee appointments are for the duration of the term. three points, #1) Where a statement is filed and a Member is named they have an opportunity to respond before the original statement is made public, #2) Members must be on the Floor when they vote, #3) Appointments to Committee are for the duration of the term. I move for the adoption of the Resolution."

Speaker Granberg: "Speaker moves for the adoption of House Resolution 32. Are there any questions? The Gentleman from Jersey, Representative Ryder."

Ryder: "Thank you Mr. Speaker. Would the Sponsor yield to questions please?"

Speaker: "He indicates he will."

Ryder: "Mr. Speaker, I congratulate you for taking seriously the comments that we made in our arguments concerning the Rules that you proposed for the House. While I may disagree with the Statement concept that you placed in the Rules, which is a new concept to us, you have done your best to take our suggestions to make what I consider a bad situation better, and I appreciate that. But I have some questions on that process, because the Clerk has the responsibility of notification in this matter. Your Rules are silent as to the method of notification. It does not say orally, in

writing, nor is there indicated if the notification has to be personally made to the Representative that's mentioned in those statements. For purposes of intent, could you tell me your intention sir?"

Madigan: "Mr. Ryder, I'm advised that there will be a cover sheet that will be attached to the Statement which is first filed, and there's a section of that cover sheet which requires that any other Legislator named in the Statement must also be named in the cover sheet. That cover sheet will be delivered to the office of the named Legislator here in Springfield. Delivered by the Clerk. If you have any suggestions as to how we could improve the system we're very interested in that."

Ryder: "Mr. Speaker, I thank you for that we have made some suggestions. Our first suggestion was that we shouldn't be doing the Statements at all, but since you're persisting in that, I guess my concern, Sir is if this notice goes to an office at the end of a Legislative day then we're relying on someone other than a Legislator to communicate the notice from the Clerk. I would have preferred, I suppose for the Clerk to personally hand that document to a Legislator. Rather than delivering to the office. Statement is silent as to the method of delivery that you just mentioned. I do acknowledge the cover sheet as a means of communication, I understand that. Is there a reason, excuse me, is it your intention that the cover sheet would also contain the Statement at the time it's delivered to the Legislator that is mentioned?"

Madigan: "Mr. Ryder, this is a partial explanation. The one day and the three days, they don't start to run until the named Legislator has actually received the Statement. Now again, if there's some way that the system can be perfected, we're

interested in doing that."

Ryder: "Mr. Speaker, I understand that, and you have shown an accommodation to our request by modifying the Rules to this extent and we agree. I have some conceptual problems in trying to take a Rule that I don't think is appropriate and trying to somehow mechanically making it work and that's the reason for my questions. You and I philosophically differ about this Rule itself. My simple concern is the mechanical part of showing to the Legislator that their name has been mentioned, how it has been mentioned, and I'm wondering if, because I didn't have an opportunity to hear, if the Statement of the proposing Legislator will be attached to the cover sheet that you describe that is delivered to the mentioned Legislator."

Madigan: "The answer to that question is 'yes'."

Ryder: "Ok. That is good, I think that is an improvement. The Clerk, under your proposal then delivers that to the office of the Legislator in order to start the clock running. Is that my understanding, or your understanding?"

Madigan: "Well it's delivered to the office of the Legislator.

The clock starts to run when that Legislator has received the cover sheet and the Statements."

Ryder: "I apologize for the series of questions. I intend to support your Rule, your modifications, because they are making a certain circumstance about which I complained, somewhat better. I still have the philosophical problems with the concept of Member Statements and I thank you for the explanation. As I think of, or perhaps as practiced, will see, perhaps we may have some additional suggestions on how to make it work. Right now we're simply attempting to suggest your response to a limitation on debate to allow Members to put in Statements I think would be unnecessary

if we did not have, originally, that limitation on debate. So you're attempting to accommodate that. I understand that. You've attempted to make it better. I appreciate that. And lastly, this would provide that the Committee appointments are for the duration of the term. So three points, #1) Where a statement is filed and a Member is named they have an opportunity to respond before the original statement is made public, #2) Members must be on the Floor when they vote, #3) Appointments to Committee are for the duration of the term. I move for the adoption of the Resolution."

Speaker Granberg: "Speaker moves for the adoption of House Resolution 32. Are there any questions? The Gentleman from Jersey, Representative Ryder."

Ryder: "Thank you, Mr. Speaker. Would the Sponsor yield to questions please?"

Speaker: "He indicates he will."

Ryder: "Mr. Speaker, I congratulate you for taking seriously the comments that we made in our arguments concerning the Rules that you proposed for the House. While I may disagree with the Statement concept that you placed in the Rules, which is a new concept to us, you have done your best to take our suggestions to make what I consider a bad situation better, and I appreciate that. But I have some questions on that process, because the Clerk has the responsibility of notification in this matter. Your Rules are silent as to the method of notification. It does not say orally, in writing, nor is there indicated if the notification has to be personally made to the Representative that's mentioned

in those statements. For purposes of intent, could you tell me your intention, sir?"

That cover sheet will be delivered to the office of the named Legislator here in Springfield. Delivered by the Clerk. If you have any suggestions as to how we could improve the system we're very interested in that."

Ryder: "Mr. Speaker, I thank you for that. We have made some suggestions. Our first suggestion was that we shouldn't be doing the Statements at all, but since you're persisting in that, I guess my concern, Sir, is if this notice goes to an office at the end of a Legislative day then we're relying on someone other than a Legislator to communicate the notice from the Clerk. I would have preferred, I suppose for the Clerk to personally hand that document to a Legislator. Rather than delivering to the office. Your Statement is silent as to the method of delivery that you just mentioned. I do acknowledge the cover sheet as a Is there a means of communication, I understand that. reason, excuse me, is it your intention that the cover sheet would also contain the Statement at the time it's delivered to the Legislator that is mentioned?"

Madigan: "Mr. Ryder, this is a partial explanation. The one day and the three days, they don't start to run until the named Legislator has actually received the Statement. Now again, if there's some way that the system can be perfected, we're interested in doing that."

Ryder: "Mr. Speaker I understand that and you have shown an

My simple concern is the mechanical part of showing to the Legislator that their name has been mentioned, how it has been mentioned, and I'm wondering if, because I didn't have an opportunity to hear, if the Statement of the proposing Legislator will be attached to the cover sheet that you describe that is delivered to the mentioned Legislator."

Madigan: "The answer to that question is yes."

Ryder: "Ok. That is good, I think that is an improvement. The Clerk, under your proposal then delivers that to the office of the Legislator in order to start the clock running. Is that my understanding, or your understanding?"

Madigan: "Well it's delivered to the office of the Legislator.

The clock starts to run when that Legislator has received the cover sheet and the Statements."

Ryder: "I apologize for the series of questions. I intend to support your Rule, your modifications, because they are making a certain circumstance about which I complained, somewhat better. I still have the philosophical problems with the concept of Member Statements and I thank you for the explanation. As I think of, or perhaps as practice will see, perhaps we may have some additional suggestions on how to make it work. Right now we're simply attempting to suggest your response to a limitation on debate to allow Members to put in Statements I think would be unnecessary if we did not have, originally, that limitation on debate. So you're attempting to accommodate that. I understand
