She was crowned queen by Governor Edgar in January at the Illinois Association of County Fairs Association, at their convention here in Springfield. Athena is the daughter of Randall and Karen Taylor of Havana. She's an 18 year-old senior at Havana High School and will be... and has earned many academic honors. House Bill 1372. Representative Winters moves to waive the appropriate posting notice for House Bill 1372. Is there any discussion? There being no discussion, the rule is appropriately waived. The Representative from Cook, Representative Currie, for what reason do you arise, Ma'am?"

Currie: "Thank you, Speaker, Members of the House. I rise on what I think is a pretty important issue to face this General Assembly, this House of Representatives. Yesterday in one of our House committees, apparently somebody had forged the signature of another person on a witness slip, suggesting that that person wanted to be on record in favor of a particular House Bill. Well, we all know forgery is a pretty serious offense. In fact, it's a criminal offense. And I would hope, Speaker, that we would be able to make sure that the committee records reflect the fact that that witness slip was a forged slip and that the records would not continue to contain that particular slip. Further, I would hope that the committee, when it next convenes, would want to read into the record the information that that particular witness slip was read in error, as it was a forged witness slip. I would hope further, that Committee Chairs would be careful to make sure that those in Committee Hearing Rooms, recognize that they are only entitled to sign their own names to witness slips, unless they have some kind of confirmation, written confirmation from someone else who wishes to be listed as well. Finally, I would imagine that the Sangamon County State's Attorney is looking into this particular offense. But most importantly, in order to protect the integrity of this House of Representatives, I would hope that the Clerk's office would see to it that this forged slip, as I say, is

Black: "Bear with me, Representative. In the underlying Bill, do you deal with fees of any kind on these transfers? Representative, maybe you didn't hear the question. Does it deal with any fees in the underlying Bill?"

Bugielski: "In the underlying Bill, while it talks about the disclosure of the ATM surcharges, where they have to declare, where the ATM owners would have to declare all the fees that are, you know, being charged. But it's no public fees. The only fee that this Amendment is, where the owner of the ATM would have to pay the fee. All bank owned ATM's right now, pay a fee for the administering through the Commissioner of Banks. And this is being added as the owner of the ATMs. It is not a fee to the general public."

Black: "Representative, I, all the Bill does in that respect is to ask that the fees clearly be posted. Is that correct?"

Bugielski: "Correct."

Black: "Alright. Now, the part of the Bill that I'm concerned about, you're enhancing the penalties by considerably, some would say, on any offense that involves a credit or debit card. And many of these are going from a misdemeanor to a felony. I see the Correctional Budget Note has been filed. I, you may want to ask your staff, I don't know if this figure is correct, but the Correctional Impact Note says that this could cost \$14 million over the next 10 years. Is that your intent?"

Bugielski: "Well, we're not wor... on this Amendment that I'm doing now, this is just an add on to the other Amendment

ARTICLE IV  
THE LEGISLATURE

Art. IV, Sec. 8.1

Section 8.1. Passage of Revenue Bills.

(a) A bill that would result in the increase of revenue to the State may become law only with the concurrence of two-thirds of the members elected to each house of the General Assembly.

(b) The General Assembly may not vote upon a bill that would result in the increase of revenue to the State until a public hearing on the bill has been held. Reasonable notice of the hearing, in no event less than 2 weeks, shall be given to the public.
