- Myers: "I would like to welcome, seated in the Gallery, several members of the College Republicans from Western Illinois University who are down here today to view the process of the legislative action."
- Speaker Granberg: "Where are they seated, the Democrats want to know?
- Myers: "On the Republican side, Mr. Speaker."
- Speaker Granberg: "Now Mr. Black moves that the House stands adjourned until... Mr. Ryder moves that the House stand adjourned until Tuesday, May 6, at the hour of 12:30. All in favor say 'aye'; opposed 'nay'. The 'ayes' have it and the House stands adjourned, allowing perfunctory time for the Clerk."
- Clerk Rossi: "House Perfunctory Session will come to order. Introduction of Resolutions. House Resolution 138, offered by Representative Currie. House Resolution 139, offered by Representative Morrow. House Joint Resolution 22, offered by Representative Schakowsky. Resolutions are assigned to the Rules Committee. There being no further business, the House Perfunctory Session stands adjourned. The House will reconvene in Regular Session, Tuesday, May 6, at 12:30 p.m."
