As you know, Mr. Speaker, or at least I believe you know, this Bill deals with pensions for downstate police officers. Downstate police officers would be any police officers and chiefs outside the County of Cook. We... We... a year ago, dealt with this issue in a similar fashion for firefighters throughout the State of Illinois. House Bill 2963 would create some equity and parity for police officers throughout the rest of the State of Illinois, other than Cook County. It's my understanding, and I have in front of me, a letter from Leader Daniels to you, requesting that police pension enhancement package, specifically contained in House Bill 2963, be sent to the House Floor immediately. I also understand that the Rules Committee this morning met and there was a move... or a Motion made to have this discharged, also, out on the House Floor, and it was defeated. I would point out, Mr. Speaker, that this also has been approved by the Pension Laws Committee, if I'm not mistaken, a bipartisan Pension Laws Committee, and

accordingly, I would move that we discharge from committee immediately, House Bill 2963 and move it to the House Floor."

Speaker Madigan: "Mr. Tenhouse."

Tenhouse: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I also rise in support of Representative Cross' Discharge Motion in relation to House Bill 2963. Again, it is a question of fairness. We talk about our downstate policemen and they're at risk everyday. All we're doing here is allowing them to really be able to get the same benefits we provided last year to the firefighters. I certainly think that anyone involved in a downstate community would really have a hard time not supporting this Motion. And we would certainly ask that the Members of both sides join with us on this Discharge Motion."

Speaker Madigan: "Mr. Murphy, Chair of the Committee."

Murphy: "Thank you, Mr. Speaker. I rise in opposition to the Gentleman's Motion because that Bill never came before my committee, and I rise in strong opposition."

Speaker Madigan: "Mr. Daniels."

Daniels: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I rise in support of Representative Cross' Motion on House Bill 2963 to be released from Rules immediately. This legislation will make improvements to the downstate police pension formula that are similar to the pension improvements that were passed into law for downstate firefighters during the Spring 1999 Session. The provisions in this proposal overwhelmingly passed the Pension Laws Commission which this Body set up in order to study pension increases, and it passed last November and deserves our immediate attention. There's nothing new in this legislation that every person in this Body doesn't

fully understand. Don't our downstate police officers deserve equal treatment with their brothers and sisters firefighters? How in the world can we say that either group that put their lives on the line on a daily basis should be treated better than the other? How can we say to the police officers in Harrisburg or West Frankfort or Champaign or Springfield that they don't deserve equity with firefighters? Mr. Speaker, I once again ask for your immediate consideration of this matter to show our downstate police officers that we care. I think that by bringing it immediately to the floor we can act on this, send it to the Senate, and then they will be able to further act on it, as well. The time is now to act for our that put their lives in harms way for our protection. Thank you."

Speaker Madigan: "Mr. Biggins."

Biggins: "Thank you, Mr. Speaker. And I rise also in support of Representative Cross' Motion. The Illinois Pension Laws Commission has approved this recommendation. We're just trying to make this issue of fairness between the firemen and the policemen, the downstaters. It's not a regional issue, we shouldn't make it such. Objections from Cook County shouldn't prevail. We should treat our policemen the best way we can in their pension program."

Speaker Madigan: "Mr. Black."

Black: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. I simply rise to lend my voice of support to the Motion to Discharge. I think it's most disingenuous of a Committee Chair on your side of the aisle to say the Bill hasn't had a hearing in his committee. Well, gee, no kidding, there's a bulletin. We can't have a hearing on the Bill if you won't let it out of Rules. I thought we

set up the Pension Laws Commission to separate those pension Bills that had merit from those that have no merit and obviously, they must have thought this Bill had merit. It passed with 14 'aye' votes, 0 voting 'no' and 2 Members voting 'present'. So the Pension Laws Commission felt that the Bill was worthy of passage from their committee or If the Bill would be released from Rules and posted for a hearing in the Pension Committee, I'm sure that it would get the requisite number of votes to come to the floor. But once again, we're stymied in our inability get a hearing on certain Bills that are not only of interest to our side of the aisle. This isn't a partisan I don't think you ask any police officer in the State of Illinois, whether they're a Republican or a Democrat or an Independent or a John McCain supporter or a Bill Bradley supporter, when they put on that uniform and strap on their equipment and go out in the street, they are there to protect the people of the State of Illinois. And I don't think politics has anything to do with whether or not those police officers would have access to a reasonable pension when they retire. You know, I read the report. was well over 150 police officers nationwide were killed in the line of duty last year alone. This is not a job without some inherent risk and danger and we ask them to do it day after day after day and they come to us and ask us see that their pension might enable them to live a life in retirement with some basic dignity. And we can't even get a hearing on a simple Bill that would enhance a police officer's retirement, assuming that he or she can survive 20 or more years on the street today and that would not be an easy task. So, Mr. Speaker, pursuant to Rule 49, I'm joined by five Members on my side of the aisle to request a

record vote on the Motion to discharge House Bill 2963 from Rules Committee. And we ask that this Bill be discharged pursuant to Rule 18(g) and I again ask for a record vote on the Motion to Discharge."

Speaker Madigan: "Mr. Hoeft."

Hoeft: "Thank you, Mr. Speaker and fellow Members. As a matter of public policy we have set up, in this state for a long period of time, that the firefighters and the police officers of this state, those people who protect us on a daily basis, will have equal pensions. A year and a half ago we passed a package for the firefighters and in the Pension Laws Commission we said we would follow this up quickly with the police officers. That we have done. There is no argument in the Pension Laws Commission about the fact that we ought to continue to have this policy of equality, equality from these individuals. Unfortunately, the Pension Committee has not had the ability to debate this Bill, or many, many other Bills that are necessary to help protect our workers. This is a symbolic Bill in terms of the backlog that we have. I think it's a good Motion to bring this out and let it be debated. This is gonna help our police officers in every community which represented by people on both sides of the aisle. I can't understand why we can't have a policy in this state of equal protection for our law enforcement officials. Please let's bring this out."

Speaker Madigan: "Leader Granberg."

Granberg: "Thank you, Mr. Speaker. Good to see you. One of the previous Gentlemen talked about a couple of issues, one of which was the Pension Laws Study Commission. I would remind that Gentleman that this side of the aisle did not support the Pension Laws Study Commission. That was your

side of the aisle when you were in the Majority. thought it was ludicrous to have it set up. So, that was your idea, and now you see how well it's worked. Secondly, we talked about the downstate firefighters, I was involved in those negotiations. We reached an agreement with the Municipal League, that is the way the Pension Laws supposed to work. You bring consensus, you arrive at an agreement. They have not reached an agreement on this issue. All of us are in favor of supporting our police. There is no question. And we want to see a similar package given to them, but until they reach an agreement, we should not do that. That's why we force them to sit down and negotiate in good faith. That's what this process is about. We force them to sit and negotiate and come up with a package. That's what we did with the downstate fire. That's what we should do with the downstate police. that will happen. They will go to the table, and we will force them to reach an agreement. To bring this Bill out now, will not help that negotiating process."

Speaker Madigan: "There's a Motion before the Body to discharge the Rules Committee. Representative Murphy has objected to that Motion. And then there's a request for a record vote on the Motion, but because of the rules, the rules provide given the objection, that the Gentleman's Motion and the request are out of order. Mr. Black."

Black: "Well, thank you, Mr. Speaker. I am not surprised. So, pursuant to House Rule 57(a) we disagree with your interpretation of the House Rules. I don't know who objected. You never do until you get a record vote. So, pursuant to House Rule 57(a), I ask for a record vote, under our right to do so as embodied in Rule 49 to overrule the Chair."

- Speaker Madigan: "The Gentleman moves to overrule the Chair. And the question to the Body is, 'Shall the Chair be sustained?' Those who wish to support the Chair will vote 'yes'; those opposed vote 'no'. Have all voted who wish? Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question, there are 60 'ayes', and 53 'noes', and the Motion fails. Mr. Daniels. Mr. Daniels."
- Daniels: "Mr. Speaker, now that that has failed, I would ask if you would consider having an immediate Rules Committee, and then so that we could bring this Bill out and have a Rules Committee hearing, so we could have this Bill before the Rules Committee and then you could discharge... or you could bring the Bill out of Rules Committee so we could act on this carefully?"
- Speaker Madigan: "Mr. Daniels, I think our position was pretty well explained by Representative... excuse me, Leader Granberg. Is the Leader still on the floor?"
- Daniels: "Which... which... could you reiterate that again, please?"
- Speaker Madigan: "Well, as I recall, I think he explained that he's been meeting with these parties for a long time, trying to bring about an agreement between the parties. I presume he's hopeful that he'll be able to do that. He's the one that mediated the matter with the firefighters and their employers."
- Daniels: "Our concern, of course, is that if we don't act in this Session, we'll end up after the election and traditionally, there has been an onslaught of Pension Bills, and this could get caught up in that. And so, from the Republican side of the aisle, we don't want to misrepresent to you, this is a very important issue to us. We'd like it acted

- upon immediately and we will be bringing this up as you might expect on a daily basis. So, I would encourage Representative Granberg, if he would like to work with us, fine, but we do need immediate action on this so we can act on this legislation prior to the scheduled adjournment date of April 14th."
