- Hamos: "Thank you, Mr. Speaker and Ladies and Gentlemen. This is a simple Resolution that congratulates Margaret Black Scheer as the first president of the State Federation of Labor AFL-CIO. And I ask for your concurrence."
- Speaker Madigan: "You've all heard the Lady present the Resolution. Mr. Black."
- Black: "Yes. Thank you, Mr. Speaker. Will the Sponsor yield?"

- Black: "Yes. Representative, did you sponsor one when Don Johnson was elected president?"
- Hamos: "If I had been here, I certainly would have sponsored it."

- Speaker Madigan: "The Lady moves for the adoption of the Resolution. Those in favor say 'aye'; those opposed say 'no'. The 'ayes' have it. The Resolution is adopted. Mr. Clerk, what is the status of Senate Bill 1550?"
- Clerk Bolin: "Senate Bill 1550 is on the Order of Senate Bills-Third Reading."
- Speaker Madigan: "Mr. Clerk, place that Bill on the Order of Second Reading. On the Order of Senate Bills-Second Reading, there appears Senate Bill 1319. Representative

Monique Davis. Is Representative Davis in the chamber? Is Representative Silva in the chamber? Is Representative Lopez in the chamber? Mr. Brosnahan. Did you wish to call Senate Bill 1638 on the Order of Third Reading? Mr. Clerk, read the Bill. Senate, 1638."

Clerk Bolin: "Senate Bill 1638, a Bill for an Act to amend the Illinois Public Aid Code. Third Reading of this Senate Bill."

Speaker Madigan: "Mr. Brosnahan."

Brosnahan: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Senate Bill 1638 addresses a situation that occurs when a person that's entitled to child support payments either does not received a payment from the State Disbursement Unit or the payment is delayed and that person's credit rating is adversely affected. What this Bill would do upon the request of the adversely affected recipient, the Illinois Department of Public Aid would send a letter verifying that the delayed or undisbursed child support payment was their fault and then at that point the recipient could give it to the appropriate credit agency. I know of no opposition to the Bill and I'd be happy to answer any questions."

Speaker Madigan: "Mr. Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "Sponsor yields."

Black: "Representative, take me through the steps. I have people in my office, in my district, excuse me, that have worked with my office and they have been negatively impacted by the ungodly delay in the child support checks. The result, I might add, of a misguided federal mandate, but that's a whole other story. And I do have people whose credit

ratings have been impacted, I'm sure of it. Now, what do they have to do to get this letter?"

Brosnahan: "They would have to contact the Illinois Department of Public Aid, request a letter that the payment, the delayed payment, was the fault of the Department of Public Aid and at that point, the Department would obviously verify that information and send a letter on to the recipient. Then, at that point, it would be the recipient who then... The Bill was originally written that the Department of Public Aid would write the letter to the credit agency, but I think, a good idea was we're not gonna let them do that. We'll give it to the recipient and then the recipient could then forward the letter to the appropriate credit agency."

Black: "Okay. The only thing that scares me about that is having the constituent contact the Department of Public Aid. I mean, I've had people contact the Department of Public Aid and they've never been heard from again. You know, I mean, that sometimes can be the black hole of Calcutta, no offense. You're liable to get lost. Is there gonna be a contact person set aside in the agency to respond to these people? Because you can contact the Department of Public Aid now and get a form letter and say we're reviewing your case, sometime between now and 2010, we're gonna get back to you."

Brosnahan: "I would think that'd be an excellent idea and I know the Department is gonna implement the rules. And I would definitely suggest to them that they should have an individual that'd be in charge of this. And I'd think..."

Black: "Yeah. I would think that that would be critically important because if you simply, 'if that constituent simply sends a letter to the Department', quote unquote, I doubt that they'll ever hear another word. It's gonna have

to be directed to somebody's attention who will be instructed by the director to expedite these requests and I think, these are reasonable requests. And I do appreciate your advancing the legislation. The only other question I have, has anybody contacted the various credit bureaus and informed them of the difficulty and in fact, that some of these letters might be forthcoming because I anticipate a problem with some of those agencies, as well? Say, oh, yeah, sure, you've got this letter, but thanks but no thanks. You're a bad credit risk and you're gonna stay that way."

Brosnahan: "Representative, I'm sorry, I didn't hear the question. I didn't hear the beginning of that question."

Black: "Yeah. Has anyone bothered to check with any of the credit rating bureaus because eventually, you know, like the credit bureau of your home county or mine, if they're not aware of this letter, my fear is that it'll either be canned or put in a file and no notation made and a damaged credit rating remains intact. I know there are things in law people can do, but we're not... some of these people harmed by this child support fiasco... what's the word I want to say? They're not used to having to do this and I'm not sure that they're going to be on top of the situation and get their credit rating reviewed and or revised. So I wonder if anybody has thought to contact the association that represents these credit reporting bureaus so that they know what's coming. That they're gonna cooperate with them."

Brosnahan: "Representative, I've just been told, by
Representative Scully, that under Federal Law the Fair
Credit Reporting Act, that Federal Law mandates that that
letter has to be in the file."

Black: "Yeah. All right, I understand that and there are other laws that these people can utilize. My fear is, don't work with these associations, the letter will go in the file, but the credit reporting unit won't make any change in their credit rating and then you open up a whole other can of worms. I mean, I'm gonna vote for your Bill. I'm not trying to raise any red herrings, here. There are people who have had their credit rating seriously impacted by this fiasco that the Federal Government mandated on all the states. I just want to make sure that we have some kind of hook... Well, let me ask you this. If we need to, would you and the Senate Sponsor be willing to do a trailer Bill if some of these people get caught up in the bureaucracy and it isn't working, hopefully, we could come back in the fall Session and do a trailer Bill 'cause I have some hunch that I just have a feeling that some people are really gonna get caught up in this bureaucratic mess."

Brosnahan: "I, obviously, can't speak for the Senate Sponsor, but

I certainly would agree to that."

Black: "Okay. Fine. Thank you very much."

Brosnahan: "Thank you."

Speaker Madigan: "Mr. Brosnahan moves for the passage of the Bill. Those in favor signify by voting 'yes'; those opposed by voting 'no'. Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this question, there are 117 people voting 'yes', 0 voting 'no'. This Bill, having received a Constitutional Majority, is hereby declared passed. Mr. Holbrook."

  Representative, there was some concern about the dermatologists had some concerns about the Bill, I think that's been addressed by what, Committee Amendment #1?"
- Saviano: "Representative, Committee Amendment #1 removed the opposition from the Illinois Society of Dermatologists and

the Illinois State Medical Society. What was in the Bill previous, was that cosmetologists could perform this dead skin removing process. They had some concerns about it and I think, at this point in time it was decided, with Committee Amendment #1, to take that out so over the next several months we could sort of educate all parties concerned on what extent that procedure would entail so for now, we took that out of the Bill. The remaining underlying Bill stayed intact and then we added the two day window for cosmetologists, with Amendment #2."

Black: "All right. Representative, it doesn't do anything with the... I can remember a few years ago we did a relatively minor Bill for cosmetology and then we found out there was a continuing ed requirement in it that, particularly in the downstate areas, really created a problem. This Bill doesn't change or impact the continuing ed requirements in any way, does it?"

Saviano: "Representative, you remember back then, we reduced the number of hours for continuing ed requirements because of the hardships it provided for downstate cosmetologists.

That provision stays intact and this Bill, by no means, addresses that issue."

Black: "Refresh my memory. Didn't we go back and finally grandfather some people? If they'd had a license for like 40 years and they were... been practicing continuously and they were at a certain age, we grandfathered them on the continuing ed requirements, didn't we?"

Saviano: "That's true. I think, that was back in around '93 or maybe '94 we did that and with the added Amendment #2, this would address additional people who didn't take advantage of it at that time 'cause they simply did not know..."

Black: "Okay."

Current law, Illinois law, provides that few protections for consumers, unlike credit card transactions, Illinois law caps recovery on fraudulent credit card charges at \$50 per charge, but no such consumer protection exists for a bank account. And what is happening is some seniors and other people have been having their accounts wiped out. So I ask your...
