HOUSE JOINT RESOLUTION

CONSTITUTIONAL AMENDMENT

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 25 to Article I of the Illinois Constitution as follows:

BILL OF RIGHTS

SECTION 25. TAXPAYER SUITS

Notwithstanding any other provision of this Constitution, each taxpayer of this State, of a unit of local government in this State, of a school district in this State, or of any other taxing district in this State has standing to bring suit in the circuit court to enforce the rights of taxpayers recognized at common law or granted by the General Assembly by law.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act. Messages from the Governor to the Honorable Members of the Illinois House of Representatives, 92nd General Assembly, pursuant to Article IV, Section 9d of the Illinois Constitution of 1970. I hereby veto and return several appropriation items included in the following Bill, House Bill 6061. In addition to these specific item vetoes, I hereby approve all other appropriation items in this Bill. Sincerely, George H. Ryan, Governor of Illinois. Pursuant to Article IV, Section 9b of the Illinois Constitution of 1970. I hereby veto and return the following House Bills: House Bill 4397, House Bill 4466, House Bill 5004, House Bill 5278, and House Bill 5961. Sincerely, George H. Ryan, Governor of Illinois. Pursuant to the authority vested in the Governor by Article IV, Section 9e of the Illinois Constitution of 1970, and reaffirmed by the people of the State of Illinois by popular referendum in 1974 and conforming to the standard articulated by the Illinois Supreme Court in Klingler v. Howlett, Continental Illinois National Bank and Trust v. Zagel, People v. City of Canton v. Crouch, and the County of Kane v. Carlson. The gubernatorial action be consistent with the
