I rise today simply because before soon we will be dealing with the measure that will rid the state of guns like the ones that killed these children. The Leadership in the Senate has decided to turn its back on this issue for this year, but soon we'll be voting on this issue, each of us will make a decision. And today I rise simply to say this. In a good faith effort, that those of us in this Body that have reasonable concerns about the legislation, that we take those concerns to
