It had some technical cleanups for the local Mass Transit Act and it transitioned the Department of Lottery into the Department of Revenue. In the Senate it was amended so that it could ... so that we could insure that the businesses in the State of Illinois could claim all the depreciation that was entitled to them. There's been some mathematical problems on how this is calculated, but the bottom line is that the business community in... in the State of Illinois came to us and showed that the formula will need to be changed ... it needs to be changed by statute. And so, this is the mechanism to change the law so that businesses in the State of Illinois can claim all the depreciation that they're entitled to. That's all it does. And I'd be happy to answer any questions, and I'd ask for your 'yes' vote."

- Speaker Turner: "The Gentleman from Vermilion, Representative Black, for what reason..."
- Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield? Representative, in Senate Amendment #1, if I can find it, is there lang... is there language in here dealing with the way cigarettes will be handled in the case of bankruptcy or was that in the underlying Bill?"
- Hannig: "Well, the underlying Bill dealt with the idea… with the concept of disposing of confiscated and forfeiture… and forfeited cigarettes, cigarette vending machines, and other tobacco products. So, that… that was an item that we had sent over originally in the Bill. And… and may very well

have been polished up a little bit in the Senate but the underlying concept is still in there."

- Black: "So, if... if I understand it then, the only reference to cigarettes according to staff, if they are confiscated for the lack of a proper tax stamp et cetera, they are to be destroyed. Correct, not made available for resale?"
- Hannig: "Well, yeah, the current law says that they... they must be sold. Well, who wants to buy those? So what this... this says is that... that they... that they can be destroyed or incinerated, that they could use... could be used for contraband, for example, in a... in a cigarette sting operation that the state might carry out. Okay. And..."
- Black: "All right. That... that clears that up. I appreciate that, Representative. Mr. Speaker, to the Bill or to the Concurrence Motion. Staff has taken a look at this, it's a necessary and vital Bill. The only comment I have is that this chamber passed out the bonus... the depreciation Bill last year as a stand-alone Bill. I think it ... I think it passed the House unanimously, was an initiative of the Illinois CPA Society, and the Senate in their infinite wisdom decided to hold the Bill. So, now a year later, they send back a Bill that we should've passed a year ago and at least my ... my thanks to the Senate and to the House Sponsor, at least they're letting the owners who would suffer if we did not get back in sync with the depreciation law, at least they're going to let them go back that year and claim the depreciation. It ... it's ... it's a commonsense measure, but the longer I'm here the less I understand about why we do these things. We should have put this on the Governor's office or

Governor's desk last year and for some reason the Senate didn't, then this year they send it back on a unanimous vote. Mr. Speaker, at some point in the future I would appreciate a private and personal conversation with you and perhaps you can explain the workings of the Senate to me. But otherwise I stand in support of the Bill."

Speaker Turner: "It's gonna take a couple of days, but I'll be glad to do that. The Gentleman from Cook, Representative Parke, for what reason do you rise?"

Parke: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "He indicates he will."

Parke: "Representative, in this legislation is there anything in here that the proceeds of the tobacco sales are gonna be used for stem cell research?"
