Is Representative Munson in the chamber? Do you have a microphone, Representative? Okay. Representative Munson on the Motion."
- Munson: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I move for an override of the Governor's Veto of House Bill 5377."
- Speaker Madigan: "The Lady moves to override the Governor's Veto. And Representative, did you wish to speak to the Motion?"
- "First, I'd like to thank the Body for their support of Munson: House Bill 5377 in the Spring Session. It passed overwhelmingly with 83 votes and nothing has changed since that Bill was introduced. House Bill 5377 will help keep senior citizens in their homes by providing consumer protection provisions for people throughout the State of live in Illinois who choose to manufactured communities, more commonly known as mobile home parks. This Bill only applies to the unique nature of living in a manufactured home community because of the homeowner's dual role as owner and renter. It is clear that our pop... as our population ages many of our senior citizens will consider manufactured home communities as an affordable housing alternative for their retirement years. Given this fact, it is imperative that we act now to insure consumer protections

are in place. I ask for your 'aye' vote and will take any questions."

Speaker Madigan: "The Lady moves that this Bill pass, the Veto of the Governor notwithstanding. The Motion requires 71 votes. Is there any debate? Mr. Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "Sponsor yields."

Franks: "Representative, can you tell us why the Governor vetoed this Bill?"

Munson: "The Governor's Veto message indicated it was because it only affected a small number of individuals in the State of Illinois. His... he quoted that it only affected three communities, in fact, it affects 11 communities and more than 3 thousand people."

Franks: "How many mobile home parks are there in the State of Illinois?"

Munson: "I am unsure of that number. Many, many mobile home parks, about 300 thousand people are estimated to live in manufactured home communities throughout the state."

Franks: "So, this will just apply to about 1 percent?"

Munson: "Estimated, yes."

Franks: "Okay. How did we... how did we decide on that 1 percent being the ones that it was going to apply to?"

Munson: "The difficulty that we are trying to address with this Bill were landlords increasing rents beyond market rate in order to force vacancies. This would only deal with those kinds of situations. These tended to be large, publicly traded corporations."

- Franks: "And what about for smaller ones where they're not publicly traded? Do they have that problem as well?"
- Munson: "We've not seen that problem. Small mom and pop communities are trying to fill their communities not create vacancies."
- Franks: "Did the Governor indicate that if you amended the Bill to include all mobile home parks that he would sign the… that he would sign that legislation?"
- Munson: "He did not make that indication. He only indicated because it applied only to a small number of communities he would not support the Bill. However, he could have pro... he could have amendatorally vetoed it and did not."
- Franks: "Okay. 'Cause I'm just wondering if you... if you did amend it and just included everyone, that might be more comprehensive."
- Munson: "I would imagine that if he believed that he would support that he would have applied the Amendatory Veto himself."
- Franks: "Thank you."
- Speaker Madigan: "Is there anyone else seeking recognition? Mr. Black."
- Black: "Thank you very... thank you very much, Mr. Speaker. Will the Sponsor yield? Representative, it's even harder to hear in here than it is in our other chamber. Your response to the Governor's Veto, it only impacts 3 of 900, your response was, you don't agree with that figure?"
- Munson: "Yes, Representative, it appears to affect at minimum amount and including."

Munson: "This is a unique relationship in of in residential..."

Munson: "The homeowner owns the actual physical home but leases the small amount of land upon which it sets and so, the landlord has an unusual amount of power in determining rents and fees. What this Bill does is provide a small provision of relief for... for those who are living in manufactured home communities."

Black: "Thank you, Representative. Ladies and Gentlemen of the House, I rise in strong support of the Lady's Motion to override. You are dealing with some of our most vulnerable population who have chosen to buy a mobile home, put it on land that they do not own."

Speaker Madigan: "Ladies and Gentlemen, could you give your attention to Mr. Black. We do need to... to lower the noise level. Mr. Black is seeking to address the Bill. Mr. Black."

Black: "Thank you. I'm not sure Abraham Lincoln had to put up with this noise and I served with him, I should know. The Lady's request for an override makes sense if you look at what a mobile home community is. You buy a mobile home and you do so because the price is generally a fraction of a

carpenter built or stick built home. You then move this mobile home onto a piece of property that you do not own and it is hooked up to water and electricity and then that becomes your home. If for any reason the owner of that park decides that the value of the land is more than the rent, one of the great injustices that has taken part... taken place throughout the country is that the owner of the mobile home park will simply raise rents to the point where no one can They often then don't have the money to hire someone to come in and move the home and they are, for lack of a better word, evicted. The owner then sells the mobile home, if he can get clear title and it is... it is a personal property issue, that's not right and that's not fair. not the same due process as you or I would have in a condominium or the home on which we live because it's built on land that we own. I don't think we should be encouraging landowners to raise the rent above fair market value simply to get out a tenant that they don't like or to get all of the tenants out so that he or she can then sell the land to a developer at a much better price than the rent that is This gives the mobile home owner a modicum of due process. The Lady has already explained that the Governor is not quite right on his figures and I've had people call me today and said, well, it would impact a manufactured home. I don't think so. If you put a manufactured home on a piece of ground, you generally own the land. We're... we're not talking apples to apples in modular, manufactured or true mobile homes. I think it gives vital protection to those people who saw an opportunity to own the dwelling in

which they live at a reasonable price but now are being taken advantage of because they don't own the land or what we... and I used to live in a mobile home when I was at college... we don't own the pad on which it sits and that rent can go up and up and up and up. I think it's a reasonable Bill. I think more than 80 of us voted for it when the... the last time we saw it and I hope the Lady will get the requisite number of votes to give people who need our protection that measure of protection that I think is fair. I think it's fair to the owner of the mobile home; I think it's fair to the owner of the park because he or she can raise the rent on any fair market value after an appraisal. It doesn't deny that individual a fair return on his or her investment either. I intend to vote 'aye'. I hope you'll join me in doing so."

- Speaker Madigan: "Ladies and Gentlemen, again, we have to keep the noise level down. Representative Dugan. Representative Turner in the Chair."
- Dugan: "Thank you, Speaker. I also stand in strong support of this Bill. Representative, some have said that this is a rent control piece of legislation. Is that so?"
- Munson: "No, it is not. It provides no caps on market rate rent for any of the homeowners or landlords. So, as long as it's market rate, it can go as high as it needs to be."
- Dugan: "And so really the legislation as far as manufactured home communities, of which there's many of 'em, and manufactured home communities, of course, when they came into Illinois they were brought into Illinois as a way for us to have what I considered affordable housing for senior

citizens. Many of our seniors wanted to stay in Illinois but not own their home and this was a way that developers brought to communities a way to give affordable housing for seniors. It was a very good thought. Many communities were a little bit concerned about it because of the fact of the way the taxing goes on the property, as we all know, they don't pay the real estate tax as a homeowner would. But assume we provided then did it not a way for seniors to have a nice community to live in along with other seniors?"

Munson: "This indeed is an affordable option for senior citizens many who have sold their primary home and used some of their proceeds to purchase manufactured and mobile homes and then find themselves in a situation where they no longer can afford to live in what should have been an affordable community and what was sold to them as an affordable community. They have their market rate rents indicated in their contract and yet these rents are now being based on assisted living facilities and active adult communities."

Dugan: "Correct. And so, just... to the Bill. Again, I wanna say, this is a particular piece of legislation that did pass the House with 87 votes. It is a way to provide to the seniors of this state something that was given to this state as affordable housing for seniors. I have many manufactured home parks in my district and it certainly is a way to have affordable housing for senior citizens and to have that change in the midstream to where now the whole concept has changed is not fair to the seniors and to the people that have moved into these mobile home communities. They are taking the rent and the owners are doing things that are

taking seniors to where they're losing their homes, a place where they expected to retire and enjoy living with other seniors. So, again, this is... it passed the House before. I ask and encourage all of you to vote for this particular piece of legislation. Look at it as affordable housing which is how it was presented to this state. It is good for our seniors and it is good for anyone that has to have that kind of housing in order to have a nice, safe place to live. So, I commend the Sponsor of this Bill and I ask for an 'aye' vote on it."

Speaker Turner: "Representative Eddie Washington."

Washington: "Thank you, Mr. Speaker. Representative, I noticed that when the Governor first vetoed this legislation... I was a 'yes' vote before. This is uniformity piece of legislation now it's not just three, it's across the state, right?"

Munson: "It is ac... it is across the state, every publicly traded corporation across the state."

Washington: "Okay. I'm glad that we could come up with a piece of legislation that we can jointly do and I hope where we can do it again. I just called the mayor of one of my districts, Park City, which has a lot of mobile homes and they definitely say this would be a good piece of legislation. So, I, too, encourage a 'yes' vote. Thank you."

Davis, M.: "Thank you, Mr. Speaker. I hope that people can hear me. And I think you will frame the question of do we support the Governor's Total Veto. Is that correct?"

"This legislation establishes in the State of Davis, M.: Illinois, for the first time, rent controls. The Illinois Realtors feel that an agreement or contract between the owner of a property and the renter of a property should be between those two parties and for us to establish a precedent of allowing another party to make that agreement is really very bad for the State of Illinois. I think when the Governor put a Total Veto of this Bill, he realizes that a renter and an owner enter a contract no one else should be allowed to determine what the owner can charge the renter. If the renter feels the cost is too much, he shouldn't be able to go and say, well, I don't like that amount; therefore, someone should intervene. The renter, in my opinion, should just find some place else to live. believe the Sponsor is extremely well intended; however, this kind of legislation could become pervasive in our state and we could start to say it already exists so we may as

well expand it. I think an excellent vote would be to support the Governor's Total Veto of this Bill. Thank you, Mr. Speaker."

Speaker Turner: "Represen... Representative Munson."

"In response, the... in fact, the situation that exists between mobile home owners and the landlord is a unique one. The mobile home owner cannot just simply move like a renter in an apartment situation. In fact, before that mobile home owner can move, they must sell their home. What we have occurring is rents that are beyond the marketability, so rents have been increased to the point where no one will buy this home, a mobile home owner cannot sell their home, they cannot afford to live there, they would love to leave. they continue paying rents that they can't afford for a year or more in an effort to try to sell their home and when they cannot sell their home, they turn over the keys to the Now, these homes are valued in our community landlord. between 30 and 60 thousand dollars. They are giving away an asset because they can't afford the rents that are ranging between \$730 and 11 hundred and 35 hundred dollars. This is just too expensive for senior citizens on fixed incomes and then they have no recourse. They are in a Catch-22. There is not an even playing field between owners of mobile home communities and the homeowners who choose to live there."

Davis, M.: "Well, it is the belief... it is the belief of the realtors that this legislation will irreparably harm the owners and the community and that the taxing district in which the communities are located will also be harmed."

Munson: "They don't understand their argument about why taxing bodies would be harmed. If the communities are increasing vacancies, they are not collecting any rent. In Willow Lake Estates in Elgin where for 40 years they had a 1 or 2 percent vacancy rate, they now have a 30 percent vacancy rate, seems to me the landlord would be losing money as would the taxing bodies."

Davis, M.: "Well, I do believe that with the communities in which these are located that perhaps those small two or three groups can meet and reach some accord, but to blanketly pass this legislation, would establish a very harmful precedent in our state and that is one of... what would we... regulated rents, rent controls, things that we really don't want in our state."

Speaker Turner: "Representative..."

Davis, M.: "Thank you."

Black: "Mr. Speaker, in all due respect, the gentle Lady on your side of the aisle made her point. The gentle Lady on our side of the aisle made a response. This not then is not a debate. She made her point; she was done. The Sponsor of the Motion had a right to respond to erroneous information that was presented on behalf of the realtors..."

The apartment is still there; you don't own it. And so there's no problem there. So, I don't see how it would be a correlation or a piece of legislation that would provide any kind of rent control. think they're totally wrong. On the other hand, with a manufactured house in some instances in years gone by the owners of these mobile home parks or manufactured housing parks have enticed seniors and other people to come, buy a home which they say is low-income which will save you money and then they proceed to raise the rent and there is no place once you are pushed out. You cannot pick up that mobile home and move it, no parks will take old homes. it's a total loss of their money. So, they have not just lost what they have, as Representative Munson has said, they've lost an asset. This is totally different and certainly departs legally from any kind of rent control for an apartment for the simple reason that you're not losing an asset if you're forced out of an apartment. You're losing an asset, your home that you paid a great deal of money and

in some instances you may be paying it off and haven't even finished paying it and you're going to lose it. So, I stand in strong support of this Bill. It was a good Bill to begin with, the Body passed it before. I think we should pass it again. If you're gonna stand up for the small people in this state and campaign on promises that you're for the small people and helping them, then you don't veto a Bill like this. You help with the small people. I think this deserves an override. I urge an 'aye' vote. This is really helping people that are up against a... their back's up against a wall with losing their home or having rents raised beyond their ability to pay for them."

This Bill simply provides that residents have a fair market value to pay in their rents so that they can sell their asset when it becomes time for them to sell. This protects our senior citizens in this state. It's an important piece of legislation, legislation like others you have put in place to protect senior citizens. I ask for your 'aye' vote."
